The Coronavirus crisis and my International Court of Justice trial

By the end of March 2020, I have become convinced that the current Coronavirus crisis is indeed the result of my first International Court of Justice trial. Namely it is the beginning of the Macrospherian (or BOL's) program which the CIA is obliged to implement given their secret conviction in December 2010 in the International Court of Justice. Although I have said in my "2020 Rewrite" that I didn't see how anything was happening to result in any Macrospherian program to change the world, now I do see it. The Macrospherian program, you recall, consists, roughly speaking, of two objectives: (1) to destroy global consumerism in order to make human civilization sustainable and (2) to make people smarter (at least smart enough to know that they are stupid, so that the sentiment that one is stupid and worthless will become widespread among the common people). These two objectives will require, in the meantime, the establishment of authoritarian, right-wing governments everywhere in the Western world.¹


I finished Document 5 of my "The creation of autism, Sonophobia, Hispanophobia..." on 4 November 2019 (despite a few corrections afterwards). That should have been the day that the CIA – whatever had happened in the second ICJ trial over me – was *totally* convicted in my first ICJ trial. Namely they were convicted of conspiring with a terrorist (me) to destroy the first ICJ trial in order to destroy BOL's program. From that day onward the CIA was thus obliged to implement BOL's program as a way to compensate her. It's interesting to note that COVID-19 cases first appeared in Wuhan in either late November or early December.

The Coronavirus crisis will accomplish the first objective of BOL's program in that it will lead to the break-up of the world system and the destruction of globalization. Since the CIA cannot let anybody else know that they are implementing BOL's program, when other people from the US Establishment are allowed to peek into what the CIA is doing, the CIA will tell them a different story. Only the CIA will know the true purpose of the plan; the rest of the US government will merely believe it is orchestrated to destroy China's One Belt/ One Road initiative. (On the apparent level, the plan is: (1) to destroy China's One Belt/ One Road initiative (hence the attack on China, Iran, and Italy) and (2) to reprogram the world economy (hence the shutdown of Western economies as well).) The CIA will employ the method of "congruence": they will pretend to carry out the Establishment plan – destroying the increasingly China-centered world economy in order to prevent the rise of China – while secretly distorting the process so that it will in the end result in something else unforeseen by everyone else, i.e. BOL's sustainable civilization.

The Internet is now full of conspiracy theories that the Coronavirus is biological weapon which the US has unleashed to – as one website succinctly puts it – "ruin the Chinese economy and reprogram the

global economy"². What is noteworthy this time is that these theories are championed not only by conspiracy theories websites such as Klagemauer TV or Corbett Report or Infowars but also by mainstream politicians albeit from nations hostile to the US. Several Russian DUMA officials have so accused the US,³ so did the former Iranian president Ahmadinejad,⁴ and the Venezuelan president Nicolás Maduro also said so to his people on national television. My past experience has been that, whenever the Russians accuse the US of some evil deeds, it always turns out to be true. This time the Russians have pointed out that the US has been preparing biological warfare against Russia since the 1990s: when the USSR collapsed, the US immediately moved in and established biological weapon laboratories in many former Soviet republics in order to surround Russia with "launching points".⁵ The Russians always know what the US is up to, and perhaps Ahmadineiad and Maduro only said what they said because they have been briefed by the Russian intelligence service. For this reason, I suspect these prominent figures might be hinting at the truth.

Kim Iversen has been especially thoughtful as to discern that the US does have a motive for decimating Italy with the Coronavirus because Italy has just signed up for China's Belt and Road initiative despite US and EU objections.⁶ After this crisis, the Italians will certainly rethink about engaging in such massive commerce with the Chinese.

There are also several scientists who have pointed out that the Corornavirus seems to have been made in the laboratory (e.g. an American⁷, an Indian,⁸ an Israelite and a Taiwanese⁹) although the eminent Kristian Andersen and his team have, in response, published definitive studies demonstrating that the virus has evolved naturally in the wild.¹⁰ The dissenting voices claim that the virus could have been accidentally leaked from the Wuhan Institute of Virology,¹¹ but this would not support the claim that it is US bio-weapon, nor would another kind of dissenting voice such as Wolfgang Wodarg's ("Nations are making something out of nothing").¹² Klagemauer TV has however pointed out that there is another "Wuxi Pharmatech" in Wuhan which also studies Coronavirus but which is funded by George Soros.¹³ Since I have always had the impression that the Russian intelligence service is feeding information to Klagemauer TV, I take its broadcasts very seriously (and thus remain unpersuaded by Kristian Andersen's team).¹⁴

My suggestion is that the CIA has caused the virus to be leaked in Wuhan some time in November last year. Should the affair eventually be discovered, however, it might turn out to be more complicated, with the involvement of other entities from other nations that would seem to have nothing to do with the CIA, and certainly not with any International Court of Justice trial. But the hidden source of it all would still be the CIA's obligation to implement the Macrospherian program for sustainable civilization.¹⁵

The fact that US senators were already briefed back in January that the pandemic was coming to the US and would soon cause massive shutdown of the economy and yet the US government did absolutely nothing (unlike the quick actions taken by the Taiwanese government) certainly suggests that the US Establishment did intend to intensify the situation into a national emergency. Aside from destroying the world economy, it would seem that the *apparent* US plan is also to seek another opportunity for the US government to grow more totalitarian. The US government has planned for the Coronavirus crisis to change the world and the US more than 911 ever did.

And yet the ultimate result years from now - as if unforeseen by the US government - should be the end of globalization and the relocalization of nations and local communities (all nations producing everything for themselves instead of specializing in one commodity in a scheme of global division of labor). While it is already reported that China is forced to put its Belt and Road initiative on hold,¹⁶ some right-wing leaders such as Marion Maréchal have already noticed that the crisis might be a blessing in disguise and declared that supranational entities and globalization are hereby called into question. In another place Marion also mentions how the right-wing call for reindustrialization of France is now justified: "La nécessité de relocaliser des pans essentiels de l'économie".¹⁷ BOL has indeed wanted right-wing notions of things to become the dominant reality and, thanks to this virus, right-wing populists will most likely come to power everywhere in the Western world and see their agendas become reality: there will be no more massive international commerce, no more mass immigration, no more mass tourism. The progressive liberals will lose influence everywhere and authoritarian right-wing governments will become the rule in all nations. No more feminism, no more immigrant rights, and no more "political correctness". This is how our civilization will become sustainable: not through climate change activism. The Coronavirus crisis has already caused significant reduction in oil consumption around the world, such that oil producer nations are now suffering. CO2 emission will significantly decrease in the post-Coronavirus era.

Not to forget that Russia should also rise again in power and glory years from now as another ultimate, seemingly unforeseen, consequence of the Coronavirus crisis. The remaining question is: how is BOL going to make people smarter? (Or make the recognition that one is stupid widespread among the masses?)

In the end I must note that I'm currently still listed by the US Department of Homeland Security as a very dangerous misogynist terrorist and serial stalker suffering from severe paranoid schizophrenia and hence prone to become passionate about the most bizarre conspiracy theories, and that the vigilante network which a certain DHS official has put in place to target me (the "Secret Society women") continues to warn people with whom I come into contact that nothing I say should be believed. My situation should remain unchanged until the end.

The Coronavirus crisis and my International Court of Justice trial II

- An analogy to describe the Coronavirus plan

As new information about the current Coronavirus crisis continues to mount, I should attempt to update my view as to how the crisis might be part of the "Macrospherian program" of which I have frequently spoken.

Again, my belief is that the Macrospherian program of sustainable civilization is hidden behind an *apparent* program on which the conspiracy theorists speculate and will not become visible until many years down the line. It is the *deep* program. There is not much more to say about this *deep* program – except to add that the objective of making people smarter must also include the goal of making them stronger, so that the fear-mongering culture, the culture of *misoponos* which Jonathan Haidt and Greg Lukianoff have so well documented in their *The Coddling of the American Mind*, will entirely disappear along with political correctness.¹⁸ Instead, all my updates shall naturally concern only the *apparent* program. As noted, this apparent program seems to consist of two objectives. The first is to dethrone China from its status as the "factory of the world" and dismantle the increasingly Chinacentered global system in order to prevent the further rise of China. After this crisis, nations around the world will drastically reduce trade with China. People around the world will also have developed such negative impression of China that China will become increasingly isolated in the world. Many class-action lawsuits against China in Western countries might result in the freezing of Chinese assets in these countries and so on. The foundation on which China has risen to become a world power in the past three decades – commerce with nations around the world – will have definitively been dismantled.

The second objective is to transform the US (and Western) economy and society into a higher level digital economic system and surveillance state that could rival, and even surpass, India and China. Once again, by orchestrating this pandemic, the US Establishment can implement programs which the American people would otherwise never accept, foremost the cashless economy and biometric identification system (AADHAAR) of India and the total surveillance society of China.

Now it appears that the CIA has not simply planned this pandemic with the rest of the US national security Establishment, but also in concert with the Bilderberg people. This would explain, for example, Bill Gates' intimate involvement in the design and execution of the plan as well as the readiness of European leaders like Merkel and Macron to go along with the fear-mongering.

The most popular conspiracy theories have focused on the higher level economic system and surveillance state which the pandemic shall make it possible to implement. I have been following the reporting especially of Norbert Häring, Whitney Webb, and James Corbett. Norbert Häring (https://norberthaering.de/) has been focusing on the Bilderberg side of the plan, such as the World Economic Forum's "Known Traveler Digital Identity Program", ID2020, Rockefeller Foundation's "National Covid-19 Testing Action Plan", and so on. Whitney Webb has focused on the work of National Security Commission on Artificial Intelligence, namely on the side of the US national security Establishment, how they have planned to use the Coronavirus crisis as an opportunity to implement in the US the sort of AI-driven total surveillance state that is now the norm in China – so that the US can eventually rival China in AI development and surveillance of population.¹⁹ (According to her report, the US Establishment would like to see the currently in-use infrastructure or "legacy systems" replaced by (a) a cashless economy (digital wallets on smartphones). (b) online shopping as the only possible way to shop, (c) ride-sharing with fleets of self-driving cars, (d) mass surveillance the Chinese style, with facial recognition at every corner of society, and (e) AI hospitals with no more human doctors.) James Corbett has produced a whole series on Bill Gates' involvement (The Corbett Report 378. "Bill Gates' plan to vaccinate the world"; 379. "Bill Gates and the population control grid", and 380. "Meet Bill Gates"). Bill Gates has also wanted to bring to the US the sort of digital ID system (including "quantum dot tattoos") which he has been promoting in India and the under-developed world under the pretext of vaccination and to link it to a cashless, digital economy. James Corbett is thus also talking about the plan on the side of the Bilderbergers.²⁰ The pandemic thus seems to have been a joint project between the US national security Establishment and the Bilderberg Group. It appears that they did intend to sacrifice, for the sake of the planned transformation, sectors of the economy that are allied with their opponents, namely the Republicans. They have thus let the pandemic destroy the US shale oil industry. Now my hypothesis is, again, that one participant in the planning of this pandemic, the CIA, is going to secretly steer the program onto a different direction some time in the future.

We can conceive of the pandemic as progressing through two stages, first the leaking of the virus in China and then the fear-mongering about its deadliness. As for the first, the controversy as to how the virus has actually originated has drastically intensified in the past two months. It would seem that each party is promoting an answer in conformity to its interest. Trump favors the answer that the virus, although naturally occurring, was nonetheless leaked from a laboratory (the Wuhan Institute for Virology). The US Establishment continues to promote the simplistic view that it has originated in nature. After claiming that it was the US military athletes who have brought the virus to China in October 2019, China is increasingly, along with Russia, promoting the "conspiracy theory" that the virus is a US bio-weapon originally manufactured in Fort Detrick. This has culminated in the "10 questions the US must answer" which *People's Daily* published on 2 May, of which the first four

concern the US experiments on Influenza virus, the temporary shut-down of Fort Detrick's laboratory in September 2019, the Crimson Contagion and Event 201 simulations, and the US intelligence officials' warning of a pandemic as early as November 2019. If we are to believe that the Coronavirus pandemic is a joint venture between the US national security Establishment and the Bilderberg Group, we are naturally inclined to think that China and Russia are on the right track here instead of fomenting disinformation. Again, my experience has been that, whenever Russia makes bizarre claims about the evil America is perpetrating, they always turn out to be true. For me, the most important evidence is Defense Intelligence Agency's National Center for Medical Intelligence's early warning about the Coronavirus epidemic in Wuhan in November 2019.²¹ The US national security Establishment has clearly been expecting the pandemic late last year, and it might very well have been their athletes who have first leaked the virus in Wuhan in October 2019.

What is important for me is the fact that the US national security Establishment and the Bilderberg Group must have been planning for this pandemic *for many years*. If my hypothesis is correct, it would then mean that the CIA has merely adapted an ongoing program to their obligation, under UN Resolution 1373, to implement the "Macrospherian program".

As for the second stage of the plan: once the virus is released and allowed to reach global proportion, the US Establishment and other Western governments must then exaggerate the damage so that people may consent to the ground-breaking transformation that has been planned. The Coronavirus is in fact only moderately harmful. When the government intends to harm its people in order to persuade them to

give up their rights and so on, it is kind enough to decide to not actually harm them very much but simply to drive up their paranoia. What is minimally harmful is good enough, as long as the people are gullible enough as to believe they are really and very much harmed. The current technique seems very similar to that used in the aftermath of the 911 attacks: simply reinterpret what is in fact normal to make it look like something extraordinary is taking place. I first heard Kim Iversen state that, once antibody test is conducted on a large scale, we will find that the virus is in fact very widespread and so hardly as deadly as Western governments have made it to seem. But the Establishment would of course want to prevent this. The first antibody test came out of a small town in Germany to attest to this fact, and of course the German Establishment quickly tried to discredit the doctors involved. Klagemauer TV then hosted more doctors in Germany who protested against the government's fear-mongering. More antibody tests in the US also attest to the possibility that millions of people might have already been infected so that the kill rate of this virus is probably only 0.1 percent, i.e. just like a regular flu. James Corbett also reported on the many doctors in the US who think it is all a hype over nothing in particular. It has become increasingly clear that governments could only have maintained the hype through fraudulent counting methods, i.e., requiring all doctors to report any patient who died while being tested positive (with Coronavirus) as dying of Coronavirus whether or not the virus is really the cause of death. While Coronavirus is not any deadlier than a regular flu, you can teach the people to fear for their life by simply reporting on Coronavirus deaths even though the same number of deaths from a regular flu has never caused any hysteria because these have never been reported on. Meanwhile, accounting tricks are applied in order to make the virus appear indeed deadlier than a regular flu.

Such must have been the "Plan". There is only this mystery remaining: if the virus is not so deadly at all, what exactly happened in Wuhan such that the Chinese government was finally compelled to shut down the whole city?

I have been following those right-wing commentaries on the Great Reset,²² the global plan for our post-Covid-19 world first proposed by the World Economic Forum in May and then published as *Covid-19: The Great Reset* (Klaus Schwab and Thierry Malleret) in July, and it does now seem to me that the Coronavirus crisis was indeed orchestrated by the Bilderbergers in concert with the US Establishment to bring about the Bilderberg version of sustainable civilization (or what conspiracy theorists have called the "New World Order"), which has been prefigured by United Nations' Agenda 2030. Recall that, in my writings, I have noted three versions of sustainable civilization: the Bilderberg version, the Macrospherian version (BOL's), and Cheney's version. The Great Reset is thus the prelude to the Bilderberg version – and I shall read this book, already a best-seller on Amazon, in this light. My thesis, remember, is that, as the "Plan" is being implemented, perhaps when it is almost complete, rebels in the CIA would suddenly and clandestinely derail it so that, in the end, it shall turn into the
