INTRODUCTION

Summary of the preceding: The ICJ trial about me was closed to observers on October 3 2010. When it was opened again, all government officials around the world saw that the case was dissolved, or dismissed. What they didn't know was that this ICJ case, although dismissed, was never closed. The Russians back in October 2010 prevented the French from closing it by declaring France's every act of closure or erasure of evidence a "conspiracy" against them. Every time the French destroyed a piece of evidence, the Russian team would input the argument: "The subject will know about this in the future, in which case, his future knowledge can be taken backward in time to make the present French act into a conspiracy against Russia." Between October 2 and October 19, 2010, the trial basically alternated between French destruction of evidences and Russian declaration of the destruction in such terms.

When the second run was officially terminated, the Russian plan was: let me persist in false belief about Russia's victory, the replacement of evidence, and the existence of the Macrospherian Order (with its Sustainable Civilization program), and let the Monkey Mr B find his way back inside the control center to pursue his evil scheme of revenge. When the SVR and the CIA shall find Monkey's computer in the control center, its data can be re-entered into the dismissed case using the law "new evidence found; former judgment should be reconsidered". My false beliefs can then be taken up and made into reality using the law "the victim of the conspiracy can exploit the resources of the conspirators to benefit himself": "Monkey's causing him the genius to be delusional is a terrorist conspiracy against us; his delusional idea about using the repeated episodes to replace past episodes is a good suggestion: use it." Replacement happens, it cannot be objected because it is resource found in the conspiracy to harm the victim of the conspiracy and exploited (reversed) now to benefit the victim. Since the case is formally

dismissed, all the agency of the “Macrospherians” referred to in the false beliefs has no reality – because those Macrospherians have no legal status as “Macrospherians” insofar as there is no such case anymore. Thus Macrospherians do not exist in the “replacement of evidences”, and so no objection can possibly be raised, when the case is restored, that I have conspired with the Macrospherians. At the time of the replacement of evidence, there is no case in which conspiracy can even be an issue. Presumably, the Macrospherians have wanted me to persist, for the next three years, in the delusion that Russia had won the ICJ trial, not just for this reason, but also for the reason that France’s destruction of evidences from October 3 to October 19 (2010) was so complete that they cannot be retrieved except as delusional materials from the delusional mind of the terrorist suspect. Furthermore, they have wanted me to remain “delusional” about the matter in order to satisfy the sadistic desires of both some Republicans (like M Chertoff) and, eventually, the Monkey. As for M. Chertoff, although the dismissal of the ICJ trial had saved his ass, he still wanted to destroy me (or my mind) as a matter of vengeance.

There was thus a secret Macrospherian plan for the reactivation of the ICJ trial. Very few people among the victors’ side knew about this plan. Thus, only a handful of officials in the CIA knew about it – and only a handful of officials in the SVR and the Chinese government knew about it. The rest of the CIA, for example, were made to believe that the case was really dismissed without any plan to revive it in the future. And so most of the CIA and the SVR, along with the rest of the world, conducted business in the same old way for the next three years. The handful of officials among them who knew there was more to the story never revealed anything.

This sort of secrecy was necessary presumably because the evidences were so destroyed that very many of them had to be replaced without disruption in order to revive the whole case. If the enemy got tipped off, they could do something easily to disrupt the process, resulting in the loss, forever, of the possibility for reviving the trial. The Macrospherians’ plan was to use the Monkey to torture me to result in the secret replacement of all the evidences necessary for the possibility of revival of the trial.

In the last days of December 2010 and early January 2011 all that the Macrospherians (chiefly the Russians) did was to replace evidences in such a way that they were fixed to the point that the entire evidentiary record can be retrieved later from my delusions. And this was merely the first stage. This “fixing” I mistook for the replacement of evidences to win the trial. After fixing, the Macrospherians went ahead to dismiss the trial. The second stage would be the period between 2011 and 2013, when more evidences would be generated secretly and without disruption to obtain the complete possibility of the revival of the ICJ trial.

This tiny group of Macrospherians is like a secret society of revolutionaries. Evidently, toward the end of 2010, the Russians had invited D. Higgins and the CIA (along with few Clintonites on their side) – and some Chinese as well – to form this “secret society

for the purpose of reviving the lost ICJ trial”. They waited in secrecy for the day when the trial could be reactivated. Throughout 2011, 2012, and 2013, they continued to simulate a course of events (using the super version of Sentient World Simulation) which, with myself in the center of the events, would result in a “story” containing all the evidences needed, first to obtain the complete possibility of revival, and then, as the story transited into a new ICJ trial (the Syrian nuclear terrorism scandal), secondly to replace all the previous evidences in the lost ICJ trial. Meanwhile they continued to work on sustainable civilization and new New World Order by simulating the future state of the world on their super version of Sentient World Simulation.

The dominant theme which runs through this story from beginning to end is the complete brain death of ordinary people in post-modern American society. Ordinary people’s intelligence has so deteriorated, and they have become so stupid, that so many of them are actually convinced that they are absolute geniuses. And they laughed at people who are more educated and intellectually superior to them, believing, strangely, that the smarter people are more stupid than they are. Cognitive psychologists have noticed this problem for a long time already. A study which you must read while you embark on absorbing the following narrative is Cornell University psychologists Justin Kruger and David Dunning’s 1999 study, “Unskilled and Unaware of It: How Difficulties in Recognizing One’s Own Incompetence Lead to Inflated Self-Assessments”, in *Journal of Personality and Social Psychology*, 1999, Vol. 77, No. 6, 1121 – 1134.¹ This most bizarre overestimation of one’s intellectual ability constitutes the greatest threat to humanity’s future, so much so that the Macrospherians want to make it into the most important part of the current terrorist conspiracy once the ICJ trial shall be reactivated.

This dominant theme of the subsequent narrative – the stupidity of the common people and the “revolt of the mass” (Planet of the Apes) – is in fact intimately related to the final shape of the “deal” which the CIA (with their Clintonite backers) and the Russians had brokered in the last days of 2010. We must imagine that, in the last days of 2010, attempting to save the ICJ trial, Putin had decided to get both the CIA and D. Higgins on his side so that the saving of this lawsuit would not just be in his interests but in the interests of Higgins’ team and some of the Americans as well. This is the formation of the “Macrospherian order”. Putin would then hand the “key” over to D. Higgins. It’s easy to surmise that, as he gave the ultimate authority away, he gave only two conditions: (1) Russia’s recovery of parity with the United States at all cost – he would never forgo this dream of his, even when everything (the entire disaster) was his fault (so that he hardly had anymore the ethical ground, although he still had the legal ground, on which to make this demand); (2) nothing shall happen to his daughters. Nobody of course cared about the second condition, so there wouldn’t be any controversy over that. But the first condition would be problematic. When Russia won the ICJ lawsuit over France in February 2010, its parity with the West was already guaranteed then. But through his own mistake (letting Monkey get inside the control center), Putin had lost it

– like the way Gilgamesh had lost the potion of immortality he had so luckily found at the end of the myth. And yet he was not willing to accept this. He wanted to recover the “potion of immortality”. And of course he wouldn’t care if he could only do so by destroying me, his very savior.

With this condition, however, D. Higgins had constructed a “program” for the future – to be implemented once the ICJ trial was reactivated – whereby all parties (the CIA/ Clintonites, Russia, China, and D. Higgins herself) were able to obtain what they had wanted. This must have been Putin’s plan: to also give the American party an incentive so that everybody would work together to help him recover his lost “potion of immortality”. (Otherwise, where did he get the face to demand “parity”?) The primary interest of the party of the CIA (led by the Invisible Hand, et al) was the preservation of the Agency and the recovery of their power from the neocons, and the Clintonites also the recovery of their power (presumably also the recovery of United States’ reputation). The Russians’ interest was the recovery of parity with United States, as noted. Meanwhile, D. Higgins’ primary interest lay in the preservation of the human brain and the sustainability of human civilization. D Higgins wanted to construct a geopolitical architecture covering the whole world which would be stable enough, and functional in such a way, as to serve as a milieu within which the human brain may develop its full potential, presumably under a new culture and political regime. The stable geopolitical architecture for the world she had thus chosen was the Cold War structure where Russia and United States will be the two super-powers opposed to each other like the way they were during the last Cold War period. This structure will satisfy the wishes of all the parties involved: Putin will have his dream realized – this we can obviously see. The reactivation of the ICJ trial shall involve a “scandal” within the United States by which the CIA/ Clintonites shall seize power, root out all neoconservative influences, and push the Republicans to the margin. They will then maintain their power and authority within the new context of the Cold War, in which the antagonism with Russia shall replace the War on Terror as the new basis of their political authority. While the politicians find their meaning of life in staying in power and/or projecting their ego onto their nation (*état fort* and *politique de grandeur* are essentially what Putin has been pursuing for Russia, just like the Gaullists were for France), D. Higgins saw these politicians’ dreams as a means to her own end, which is the “salvation of the human soul” (or the human brain).

We have spoken somewhat of her (or UN Study Group’s) concern with the destruction of the human brain under the impact of digital technology. Another thing which her team had discovered must have been the detrimental effects of democracy and the democratic regime – in combination with consumerism – on the human brain. The surprising conclusion of the Study Group was that all the things you have been taught to think of as good – political correctness, Internet and computers and cellphones, free-market and prosperity, and democracy – are very bad in the sense that they make people increasingly stupid. (Or allowing the most stupid portion of the population to become the dominant force of society, which is almost the same thing.) D Higgins also found the root cause for the evil which United States has represented – the most “sophisticated form of hypocrisy” – in the increasing stupidity of the common people in combination with democracy. Since, in democratic regimes, people have the right to oppose government’s decisions, and yet they do so without understanding anything which the

government does, and without understanding that they don't understand anything and have no business in opposing anything, the government officials in United States and Western regimes in general have learned to circumvent ordinary people's worthless oppositions to whatever they are doing by deceiving the latter onto the right path, sometimes even with false flag terrorism attacks (like 911 attacks). Seeing that – like many other intellectuals before her – democracy is an extremely pernicious system when the common people are too stupid to understand anything and too stupid to know that they are stupid, D. Higgins must have decided that a certain new form of authoritarian regime (some hybrid forms of authoritarian government and culture with a certain degree of transparency) is the best form (the best regime, or *politeia* in Plato's sense) under which the intelligence of the common people may be raised to a level where genuine democracy might actually become a healthy form of government. A climate of enlightened authoritarianism must therefore be what she has decreed both parties (Putinites and CIA/ Clintonites) to carry out in their respective nations. A Cold War architecture would be the necessary geopolitical context within which this can be accomplished – in this way she would have thus fulfilled her promise to Putin – because the government can best consolidate its authority when the nation is under threat from an external enemy. D. Higgins' method must be to cause the common people to become more dependent on the authority under threat from an enemy state – in this she was in agreement with Cheney – but then to comprehend the infinite wisdom and power of the government vis-à-vis their own – this people have barely any capacity of comprehending, as is evidenced in their readiness to criticize and protest the government's decision with complete righteousness – and to learn to take orders rather than protest and criticize as the norm, and finally to cause the governments to explain their decisions to the people rather than to simply manipulate them as the norm. This is the “hybrid form” of authoritarianism that is meant, and this condition shall persist until the common people can actually understand the government's actions enough as to be in the position to protest anything with any meaningfulness – only at which time can democracy become something healthy rather than a breeding ground for stupidity and the Western version of evil: democracy on appearance but totalitarianism underneath.

The chain of events narrated in the following story is therefore specifically orchestrated to expose common people's worthlessness and stupidity as a consequence of growing up in a “democracy”. Their worthlessness is most manifested in the pathetic situation where everybody is so full of himself or herself, thinks so highly of himself or herself, and is so ready to assert his or her interest or point of view vis-à-vis the governmental authority, and yet is so easily manipulated by the powerful people in the government, so powerless vis-à-vis the governmental authority. The more the stupid common people think they are in control of the government, the more they are being controlled by the government like puppets. Contradiction? Already seen in people's paradoxical obedience to any instruction which the government gave them, which is like one of the dominant themes in the preceding “Secret History”. Consider Rousseau's ancient observation:

Il est très difficile de réduire à l'obéissance celui qui ne cherche point à commander, et le politique le plus adroit ne viendrait pas à bout d'assujettir des hommes qui ne voudraient qu'être libre; mais l'inégalité s'étend sans peine parmi des âmes ambitieuses et lâches, toujours prête à

courir les risques de la fortune, et à dominer ou servir presque indifféremment selon qu'elle leur devient favorable ou contraire.²

Since Higgins' purpose was saving human civilization as well as the human brain, the unsustainable consumption of earth's resources under global consumerism must be curbed under this program for parity and the human brain. It's convenient that the causes for the deterioration of the human brain and the collapse of human civilization are all the same: global consumerism foremost. If you can destroy consumerism, democracy, and people's addiction to digital technology, then you can save both their brain and human civilization itself.

You must familiarize yourself with the "concept of congruence" as explained in "Kiersten's vengeance, Part I" and "The international background of the 'K Affair': The Ukrainian crisis, following upon Ukraine – EU Association Agreement in Vilnius (the capital of Lithuania)" (the blog post for June 9, 2014). Parallel with the preparation of the coming scandal on my side, the Macrospherians were also planning for the partitioning of Ukraine from 2011 to 2013. The plan was this. At the end of the Ukrainian crisis, both the United States and Russia would use this opportunity to intentionally escalate tension rather than negotiate. By escalating tension over Ukraine, Russia can isolate itself further from the West, and US the same – aided by various other scandals, like the Snowden Affair. Eventually, as the world goes into a Cold War between super-powers once more, global trade will break down, and energy trade will be lessened, resulting in the decline of living standard worldwide, and thus the end of consumerism.

Consider some descriptions of the aftermath of the Ukrainian crisis (from Fyodor Lukyanov's "Russia's Asymmetrical Response" in "The cost of a new cold war", ed. Paul J Saunders, 2014):³

"The White House's decision to impose sanctions against the Russian officials it sees as being closest to Vladimir Putin led to sanctions being imposed against four Russian commercial banks. The payment systems Visa and MasterCard complied with the sanctions and blocked credit card services to these banks, which caused problems for the banks and fueled long-discussed plans to establish a national payment system in Russia. Also, Russia's Ministry of Finance tightened rules for the two credit card companies, demanding that they make a huge security deposit as protection against force majeure. The possible outcome of the conflict is unclear; the credit card companies are threatening to leave the Russian market, but in the context of this discussion, this is not the most important consideration. Denying banks access to international transactions is a powerful lever, but demonstrating who the master in our shared global home is has a downside. U.S. world leadership is based on the conceptual premise that it not only ensures prosperity for all but that it is also just—it is not someone's subjective will that decides everything; instead, the laws of the free market are supposedly decisive. Excluding Russian banks from payment systems, limiting the use of software produced by major IT companies, or shutting Russia out of the SWIFT system of international

banking payments, a measure that was earlier taken against Iran, demonstrate an indisputable fact: one power has dominant influence and uses it for political purposes. As long as such measures were used against countries like Iran, not to mention odious governments like Gadhafi's in Libya, they did not have such a strong effect. But when such pressure is put on one of the most important and influential countries in the world, it means that no one can feel safe. It also means that, in a heated conflict with the United States, global rules can be changed and directed to work against any target Washington desires.

“This stimulates new trends—the fragmentation of the global economy and society, the creation of zones of preferential trade rules and national or regional payment systems, and hedging against non-economic methods of global competition. American efforts to establish the Transatlantic Trade and Investment Partnership (TTIP) and the Trans-Pacific Partnership (TPP) trade zones actually undermine the WTO’s principle of universal rules for world trade. The rapidly strengthening partnership between Russia and China suggests that in response to U.S.-centric economic zones, they may try to compete with their own major projects—Russia’s Eurasian Economic Union and China’s Silk Road Economic Belt. Coordinating Russia’s and China’s interests in order to facilitate cooperation between these two entities will be difficult, yet hardly more so than is reaching an agreement between the U.S and the EU on new trade rules...

“At the global level, new Russian-Chinese cooperation is likely to spur systemic efforts by the two countries—albeit very cautious at first—to erode the global domination of institutions and practices of the Washington Consensus. A gradual weakening of the U.S. dollar in trade settlements among members of the SCO and the BRICS and the development and mutual recognition of national payment systems by them, the establishment by the BRICS of their own development bank, and the creation by Russia and China of an international rating agency to compete with the Big Three—Moody’s, Fitch, and Standard & Poor’s—could be the first signs of *a restructuring of the global economy....*

“Russia’s post-Crimea turn towards China may have another unexpected effect with serious consequences: the “nationalization” of the Internet. In addition to the two countries’ close positions on the role of the Internet Corporation for Assigned Names and Numbers (ICANN) and on Internet governance (the need to delegate the governance functions from a private U.S. company to international institutions), the Russian government’s determination to establish a Russian analog of the Great Firewall of China can be a kind of revenge of the Westphalian order on the World Wide Web. As noted by Russian researcher Dmitry Yefremenko, “the famous principle *cuius regio eius religi* (‘Whose realm, his religion’) in the middle of the 2010s can be reformulated as ‘Whose server, his Internet’.”

The Macrospherian plan must be to break up the so-called “World System”,⁴ which is

designed to suck the earth completely dry – and then collapse of its own weight. Again, while everybody is celebrating the decreasing distance between peoples from different parts of the world – “The world is getting smaller and smaller” – Higgins’ Group must have discovered just how deadly the shortening of distance among peoples and nations really is.

The concept of “congruence” means that while the Macrospherians were aiming for the break-up of global trade, they would never do the dirty work themselves, but would manipulate others to do it. These other people would be doing things to worsen US-Russia relations because they like to see the world in disorder. This would be the “congruence” phase – just as the Republicans have wanted to destabilize Ukraine for some other purpose than that which the Macrospherians have aimed for. But once the US-Russia relation worsens to such an extent as to result in the breakdown of global trade, this would be actually what the Macrospherians have secretly wanted. More on this method, in “cunning of Reason”.

To sum up. Higgins’ Study Group has discovered a relationship among the deterioration of the human brain, impending energy and resources crisis, and United States’ unipolar world-domination, and has hammered out a solution which will reverse all three “gravest threats to humanity’s future” and which will satisfy at once the desires of all three parties in the Macrospherian secret order. The human brain is deteriorating under the combined effects of digital technology, consumerism, and democracy. The intentional creation of a new Cold War by restoring Russia’s parity with the United States could serve not only to satisfy Putin’s wish but also to destroy consumerism by breaking up global trade. This will save the human civilization from inescapable collapse. The intentional orchestration of the following “scandal” would furthermore demolish people’s traditional good impression of democracy and digital technology. All those “good things” which have been poisoning the human brain will soon be properly demonized as what they really are: poisons for the human brain.

The break-up of the world system would entail the isolation of the United States. Higgins’ Study Group must have also concluded that United States is the center of world-destruction – that United States is in the process of destroying the entire human civilization, and doing so using the simple method called “wasting”. The United States has invented this triangular structure of “digital technology, democracy, and consumerism” in order to waste itself away. In regard to the human brain, while American people’s brain is deteriorating under the combined assault of Internet, consumerist life-style and method (including “MacDonaldization”), and democracy, the American society continues to function by importing functional human brains from oversea – just as American consumers continue to suck in world’s resources and waste

its unipolar world-domination, and is the principal motor for the impending collapse of human civilization. “Third, interaction capacity increased out of all recognition. New physical technologies brought unheard-of speeds and carrying capacities to old dimensions, and occupied new ones in air and space. New social technologies in the form of diplomacy, law, IGOs, and liberalism arose which both complemented and facilitated new physical technologies, and made possible a much stronger international society than ever seen before. Fourth, most international processes underwent massive expansion, intensification, and diversification. In particular, warfare became far more destructive; international trade and finance grew hugely in relation to domestic economies... a system of formal global diplomacy became universal; cross cultural contact increased to the point where the truly foreign has become almost extinct...” Buzan and Little can be said to have defined here all the mechanisms which are working for the eventual collapse of our world.

them. The brains that are imported, after being used to develop the technology for wasting,⁵ eventually get wasted too. This, until there are neither brains nor resources left in the entire world. In other words, the United States is the “trash can of the world.” The Republicans have so far not too much problem with this, since their thinking must be to stop the wasting only at the last moment – when no more brain nor resources are left in the world, at which point, when the United States stops wasting, it will be the “last man (brain) standing”. Higgins’ program must be to stop the cycle of waste, and save the United States from its function as the “trash can of the world” – where everything good in the world is sucked in and then disposed of. Thus, to save both human civilization and the human brain, Higgins’ group will have to oblige the CIA and their Clintonite allies to conduct a thorough reform of the American system while the “world system” is broken up. The reform would run concurrently with CIA’s recovery of power from the Republicans. It will be convenient that CIA’s most prominent political enemy (or “competitor”) just happens to be the “supreme master of waste”, like the Department of Homeland Security. While the Agency, with its Ivy League traditions, has always been offended by the table-wiping Hispanics and white trash trailer park convicts who are employed by Homeland Security to step on their turf, as they tried to orchestrate a “scandal” to reform the American system, they can at the same time get rid of these human garbage thriving on the anti-terrorism industrial complex for another purpose as well, i.e. getting rid of “waste”. The deal with the Russians and Higgins must have been concluded thusly. More on “reform” in “terra inverta”.

The following events will also be orchestrated with women’s actions, and culture, in the center. The most offensive part of Higgins’ Study Group’s conclusions is certainly that American feminism is also a most efficient dispositive for “wasting”. While in my Thermodynamic Interpretation of History American feminism is shown to be a consumerist method for extracting productive and consumptive forces from women as well as their reproductive function, in the “Conclusion” to the Syrian nuclear terrorism scandal it is similarly identified but with the qualification that its promotion of fear is the basis on which the War on Terrorism has found its root. What has not been mentioned is feminism’s function in wasting away society by wasting away productive men, and then women’s own brain, and finally earth’s resources. Because this reality is extremely offensive to everybody but to the minority of hard core Republicans, the CIA will have to carefully choose the most brain-wasted women in society and set them up to waste me, and then society’s resources, away in a most ugly and disgusting “stalking scandal”, in front of everybody, just in order to be convincing. It’s simply impossible for anyone on the left, without thorough education in Foucault, Weber, and the Frankfurt School – i.e. the self-critical apparatus that has grown up within the left itself – to accept

the reality that the “social justice” everybody has been fighting for (i.e. political correctness) is merely some sort deceptive scheme proposed by the big corporations to waste the world away for the sake of their profit margins. Everybody concerned with “justice” (feminism and racial equality) has been committing suicide in order to benefit what everybody has thought is the dethroned Enemy. American feminism since the second wave must have ranked as the most sorrowful product of deception ever in human history.

Now how is the CIA going to orchestrate such scandal? We start our narrative from February 10 2011. I was out of the mental hospital, being assigned to a Board and Care on Lull Street, Sun Valley, run by an Armenian woman named “Reima”. I was disposed of like a feeble-minded garbage in a group home filled with convicts and druggies in order to conform to the modified version of Monkey’s profile of me: mentally and developmentally retarded autistic schizophrenic while the requirement to be physically dangerous to others is replaced by the inability to harm people despite malevolent intention and displacement of harming others into perpetual self-mutilation – this, until I can learn to commit crimes. At the end of the “first stage”, I had to at least look something like Monkey’s false profile of me, even though, when you scan the brain of this developmentally retarded autistic schizophrenic who constantly cuts himself, his brain functioning patterns look nothing like those which the Monkey had forged for me by altering the setting of the mind-reading computer. If I succeeded in looking like this creature, then the Macrospherians would obtain the justification for the “second stage”.

The process of making me look like Monkey’s false profile of me would last the entirety of 2011. The most difficult part of the process, for me, was that I also needed to be programmed to suffer bad grammar for at least a year. For, since the Monkey had forged evidences showing me to be illiterate, I the literary genius must not be allowed to write proper English for at least a year until I had fulfilled this “requirement”. Furthermore, the Agency must have also instructed Wes to go along with me and mislead me whenever possible in order to help me look crazier and crazier. This is not just to satisfy Monkey’s forgery. The Republicans had wanted this, and ordered the CIA to do so.

I write in order to document the never-ending process of others’ victimization of me. I’m the “serial victim” par excellence. By the beginning of 2011, I had already been tormented by government operations for seven years – even though in the beginning it was my own fault – and I would suffer government or government-related operations for another four years. The deal struck among the Russians, the CIA, and Higgins certainly sounds very pretty – Russia’s recovery of parity, CIA’s recovery of power from the neocons, and Higgins’ plan to save human civilization and the human brain – but the deal cannot come into being through a ICJ judgment unless the evidences which the French have destroyed are fixed, the trial is reactivated, and then all the rest of the evidences are replaced. To fix and replace all the evidences, this means that I will have to conform as closely as possible to Monkey’s false profile of me, i.e. become mentally retarded, look crazy, have no friends in order to look autistic, cut myself all the time, and generally be miserable; and, finally, begin to commit crimes every single day as the sole purpose of my life. This, when I was originally the most intelligent and educated person around, of the most sound-mind, and had never had anything to do with crimes or the police. That is, saving the world and nations sounds very pretty to the Macrospherians

because they simply push the cost of it onto me. And so, in order to realize their programs, the Macrospherians will authorize another four years of severe torture of me to make me miserable and waste my life away. Thank God you don't have to become retarded, crazy, criminal, and detested by every single human being around in order to help save the world, huh?

The Russians had never succeeded in 2010 in making me conform to Monkey's slander of me by provoking me to harm people and get jailed because I didn't know how to do this and was terrified of imprisonment. During the "second stage" the Macrospherians must succeed in making me conform to Monkey's claim about my being a danger to others. Since the success of the Macrospherian program depended on my becoming a dangerous and disgusting person, and since I had had no experience in harming people, committing crimes, and becoming a danger to others, the revolutionary elites' most important goal for the next three years was to provide me with a safe, stable environment so that I could slowly learn how to commit crimes and get away with them. (Obviously, I wasn't interested in committing crimes if this meant imprisonment.) The Russians didn't succeed in 2010 because I was homeless and didn't have time, energy, and resources to learn to commit crimes in such fashion. Now the Macrospherians would carefully cultivate me into a criminal. This is a program of "criminalization" – the inverse of rehabilitation – and just as much care and expertise need to be exercised to criminalize a safe nerd into a dangerous criminal as when you try to rehabilitate a dangerous criminal into a safe person.

Once I had become truly a criminal – you will see how I eventually was forced to learn to commit effective but petty vandalism crimes against people in order to fulfill Macrospherians' "plan for my life" – the ICJ trial could then be reactivated. This, in the end of 2013, after three years of torture. Then, during my fourth year of torture, the Macrospherians would switch to a more complex strategy, the "third stage". By then what they would want from me would be simply the brain scan images of my criminal and tortured mind, rather than the criminal acts and tortures themselves. By then, they would have obtained the legal ground to confirm Monkey's forgery of my thoughts as genuine by artificially composing the forgery using the intercepts of thoughts from different people. (Even this is a simplified statement of the strategy. But you'll see.)

Besides this, the Macrospherians would let someone else do the dirty work of "criminalizing" me – the Monkey. For this, refer to the conclusion to the "Syrian nuclear terrorism scandal".⁶ There I have summarized Monkey's journey back into the control center some time in 2011. I'm not going to repeat the matter here. Hence, as you read on, it's presupposed that you are already familiar with everything in the conclusion (plus the course of the ICJ trial recounted in the previous five volumes of "The Secret History").

So, as the Monkey found his way back into the control center, he wanted revenge against me, the Russians, and the CIA – for, the Monkey practiced "Ape Morality" (see later); when he tried to harm me and the Russians and got caught, obviously, he was "wronged", for harming others is his "right", and the Russians have "wronged him" by

depriving him of his “natural rights”. The Macrospherians understood this, and so let him sneak back inside the control center, for they knew that he would, from there, “chip” me again and begin programming me to conform to his April 2010 false profile of me – just what the Macrospherians wanted during the “second stage”. He began programming me, from 2012 onward, to look crazy, delusional, and dangerous to myself and others: violent and delusional – what else is there?

Monkey’s subscription to “Ape Morality” means that, if he lied to people saying I was insane and people punished him for lying, then people had “wronged him”, and that, to correct this “injustice”, he should make me crazy and insane and attack the people who had wronged him. And after he had “chipped him”, his computer would show him how to do so. Since I wasn’t crazy, Monkey would have to “train” me to become crazy. I will thus not only learn to become a criminal, but also learn to become insane. Monkey’s computer must have shown him that the way you train people to look crazy is to deceive them in conformity with their false preconceptions. I had this erroneous preconception that Russia had won the ICJ lawsuit. The Monkey, sitting in front of his computer, would then continually send me signals making me believe that it was the Russians and the CIA who were inside the control center sending me signals and orchestrating events in my life to replace evidences (which is what the winning party always does after winning a trial). I will then keep saying to others: “Russians and the CIA are remotely controlling me to repeat past, painful episodes of my life in order to replace evidences” which would make no sense to other people and which would thereby make me look crazy to them. Since there was no replacement of evidences in any case, I would really become “crazy”, in a sense. From 2012 onwards until the end of 2013, as I was being tortured, my mind would also be filled with erroneous interpretations of the reasons for these tortures as the replacement of evidences – making myself look truly crazy. And the Monkey would be laughing and clapping his hands inside the control center. In the following I would often note down many of these sorts of “delusional beliefs” – partly because this would be Macrospherians’ strategy to obtain the legal justification for whatever they wanted to accomplish once the ICJ trial was reactivated.

For me, the gravest offense here lies in the incorrect understanding of the current geopolitical events which I was thus “trained” to develop in my mind – foremost among which was my erroneous understanding of the Arab Spring as orchestrated by the Macrospherians themselves to replace evidences – just in order to make myself look crazy and ridiculous. I would thereby become like “everybody” – upset that I alone was the genius who understood the true meaning of these geopolitical events and seeing others as idiots, when it was *I* who was the idiot (who had the wrong understanding). For everybody else is also convinced that s/he is genius and makes fun of real geniuses as “idiots”. The vast majority of the human beings on the planet are in fact “insane” – in the sense that their conception of reality, people, and society is completely wrong-headed – and yet I, who don’t suffer the same defect, will have to be specifically “trained” to suffer the same defect.

Then it would be the Monkey who would “train” me to become a criminal. Whenever I meet people, I want nothing but to please them in order to make them like me. How do you make somebody like me into a dangerous criminal who only wants to harm people? The Monkey didn’t understand anything about human psychology, but his computer

would show him how to do this. Namely, inflict a massive amount of pain on him, and encourage him to talk about it with others. Since nobody would believe anything he said about the “control center”, “ICJ trial”, or the “replacement of evidences”, he will feel alienated, and eventually hate all people. And eventually he will learn to take out his anger caused by continual pain upon others rather than upon himself (self-mutilation).

I would become, between 2012 and 2014, a genuine case of “mind-control torture victim” or “targeted individual”. The most unfortunate fact about this kind of victims is that everyone is totally confused about what has happened. Although my intelligence surpassed that of my fellow citizens by leaps of species, I constantly tried to explain to them my wrong theory about why the control center was torturing me (programming my thought-process and remotely controlling my movements in order for me to experience perpetual pain, continual frustration, and violent desires). People then wrongly judged me insane, while I wasn’t really explaining things correctly anyway – because part of the torture consisted precisely in deceiving me as to the reason for the torture and the persons doing the torture. Then I jumped around believing I was the only sound-mind around who understood what was real, meanwhile I was wrong just as much as everybody else was. Everybody was wrong: when it comes to “targeted individuals”, the most terrible thing is the complete breakdown of communication and intersubjectivity. Torture victims of other totalitarian regimes at least don’t have this kind of problem: not knowing how and why they are tortured. They can at least comprehend that government agents have roughed them up because they say something offensive, etc.

Since the goal of torture is to cause the victim suffering and yet to deprive him of any chance to complain to others, when the Monkey asked his computer how to torture me, the computer naturally responded that it would simply program my thought-process to experience the same world differently, to program me to become less tolerant of the same unpleasant experiences, rather than to cause me more suffering than I have before experienced. This is usually the case, although not always. In this way, as you complain about nothing, you can look also crazy, like people suffering from obsessive compulsive disorder (e.g. to suffer agony over non-existent dirt on your hand). This also fit in with the ultimate goal: to drive you to criminal activities, as if you were a bad person by nature, rather than by provocation or abuse. Thus, the method employed, just as in 2010, is to lower your tolerance rather than to increase intolerant events in your life.

As noted in the conclusion, the Monkey was training me to look insane and become criminal not just in order to correct the injustice that he got caught, and punished, for slandering me as insane and dangerous, but also as part of a greater plan for his revenge against the CIA and the Russians and restoration of his relationship with his daughters. While his computer was showing him how to do this, the “filter” inside was secretly steering the orchestrated course of events into a lesson about America as the “Opposite Land” (*terra inverta*) or “Planet of the Apes”. This shall be the most dominant theme in the following narrative. While what is meant by “terra inverta” will be borne out

gradually in the story, here it suffices to briefly characterize it as a “society in blatant violation of the law of nature” – a society which inverts the natural order of things. Again, refer to Rousseau’s *Discours* for the meaning of “law of nature”:

Il suit encore que l’inégalité morale, autorisée par le seul droit positif, est contraire au droit naturel, toutes les fois qu’elle ne concourt pas en même proportion avec l’inégalité physique; distinction qui détermine suffisamment ce qu’on doit penser à cet égard de la sorte d’inégalité qui règne parmi tous les peuples policés; puisqu’il est manifestement contre la loi de nature, de quelque manière qu’on la définisse, qu’un enfant commande à un vieillard, qu’un imbécile conduise un homme sage et qu’une poignée de gens regorge de superfluités, tandis que la multitude affamée manque du nécessaire.

Such blatant violation of the “law of nature” has happened several times in human history, such as during the Cultural Revolution in China (where uneducated youngsters, the Red Guards, were for a moment the master judges of the experienced members of intelligentsia) or during the early years of Khmer Rouge’s “paradise” (where children were recruited as guardians to judge which laborers on the field were too lazy). These were radical times, of course. People don’t know that United States, since the 1970s, is quietly undergoing the same change; nobody has noticed it because it’s moving very slowly, whereas the changes in the Cultural Revolution or Khmer Rouge’s paradise happened suddenly. The Macrospherians, or the CIA, when they shall allow the Monkey to carry out his plan for revenge – and to torture me – will secretly program his computer in such a way that his acts will blend into the “current trend” as a most conspicuous instance of “terra inverta” or “violation of the laws of nature” – so as to achieve the didactic effects which shall lead to the aforementioned “reform”.

This “Opposite World” is the end result of the “revolt against authority” which has been the very substance of the Western civilization – which, in the beginning, has produced splendid results (from Enlightenment to the onset of World War Two) but which, now, as the process comes to an end, has transited into the most grotesque “violation of the laws of nature”. Yet this is masked because the violation is veiled under the beautiful covers of “democracy”, “human rights”, “women’s rights”, “prosperity”, “racial equality”, and so on. You have to expose the most explicit product of “rights”, i.e. “Ape Morality”: hurting others is a “right”, and being punished for it is “injustice”. This is the complete inverse of “traditional morality” (“Human Morality”) such as is encompassed in the Chinese proverb:

受罚者刑之而不怨, 诛之而不怒
Those that are punished,
They are jailed and yet do not groan

They are executed and yet are not angry.⁷

Thus, when the Monkey “trained” me to become crazy and criminal, the Monkey is in effect pursuing “terra inverta” – or “violating the laws of nature” in the above sense:

- (1) Competent people need to be “trained” to lose their competence; thus, sane people need to be trained to look insane, and intelligent people need to be trained to become stupid. A skinny nerd needs to be trained to commit crimes, and people need to be trained to see him as dangerous, if he can’t be trained to become actually dangerous. Criminals need to be rehabilitated, such as joining the Department of Homeland Security to become the protectors of the nations. And people need to be trained to recognize stupid and insane people as geniuses and mentally sound.⁸
- (2) In this way, the competent people can be dumped away and the incompetent people can take their place in society. The purpose is to decrease the efficiency of society’s working, resulting in more waste, and finally in the death of society altogether. Meanwhile, incompetent people get to become happy members of society.

Why is the American society becoming inverted? Because it encourages “waste”, and so is good for corporations’ profit margin; and because it makes people increasingly stupid, which the ruling elites like (it makes it easier to manipulate people) and so make no attempt to stop – until now. This is because the American society is not only wasting itself away, but, through exporting the American way to the rest of the world, is also teaching other societies how to waste themselves away.

My story is also about the “making of a subhuman”. The “subhuman phenomenon” is but another facet of “terra inverta”. When a society becomes inverted, Apes rule over humans. The “last human” the Apes then dispose of as a “subhuman” while they call themselves “human beings”. I’m the “last human” – who understands what is true and real, embodies the right values and right morals, and that’s why the Apes regard me as having no rights ordinarily accorded to human beings and attempt to dispose of me as

Once you perform such comparison – strange though it is: how do you compare the mind of a postmodern American woman with that of a dynastic Chinese woman? – you will notice that what seem to be totally unrelated, incommensurable “minds” are in fact very much related: in the sense that one is simply the systematic inversion of the other. Almost like the systematic inversion which Lévi-Strauss has claimed to have discovered in primitive myths – allowing us to claim that the “American way” is the most precise *structural transformation* of the “ancient Chinese way” (which may be regarded as a most extreme instance of the “traditional way”).

Please note that the “Chinese way” noted here is but one instance of the “traditional ethics”. You can in fact see chancellor Zhuge Liang’s justice (the submissiveness of the subjects) everywhere in feudal cultures. For instance, in the preaching of Jewish prophets, e.g. Daniel 3:27: “For You are righteous in all You did for us.... The judgments You made are true, according to all You brought on us and on the holy city of our fathers, because in truth and judgment You did all these things on account of our sins. For we sinned and acted lawlessly to depart from You. We sinned in every way and did not obey Your commandments, neither did we treasure or do as You commanded.” This is Daniel’s prayer to Yahweh, that Nebuchadnezzar’s destruction of Judah was in fact quite justified.

“insane, mentally retarded dangerous psychopath”. The “Apes” who come to rule society through the ideology of “equality” and “human rights” (by shouting to their superiors “I have rights”) have absolutely no interest in sharing “equality” or “human rights” with someone they regard as inferior to themselves. Hypocrites. In the preceding narrative of “The Secret History”, I have also been a subhuman. But only for government officials. Why is it that, when it comes to other whistleblowers who have got government secrets to share, the government persecutes them “in broad daylight” – gagging them with “State Secret Privilege” (c.f. my favorite “Sibel Edmonds” below) or charging them with “Violation of the Espionage Act”, etc. – but that, when it comes to me, the government simply framed me for some imaginary scenario (dangerous schizophrenic, etc.) and forbade everybody around me to admit that what I knew was real? (Namely, I have been “persecuted in the dark”.) Well, part of the reason is that the “government secrets” I have to share are much more serious and go so much deeper than the small pieces of government wrongdoings which other whistleblowers (including Edward Snowden) have to share. But another reason is that the Republicans simply looked down on me – and the CIA people I knew were too elite to ever admit anything. M. Chertoff had always regarded me as a “subhuman” – he is so ugly, and is not part of society’s institutions; we therefore don’t even prosecute him or jail him when he fucks with us. We simply don’t confirm anything, in order to make him believe that nothing he knows is real; meanwhile, we tell everybody else that he is crazy. As I examined, throughout the next three years, the two dozen cases of “secret-leakers”, I can only find one case which even approximated to my treatment (Susan Lindauer). I have definitely got “special treatment” because of my “subhuman” status. Now, in the following journey leading up to the reactivation of the ICJ trial, however, the CIA would intentionally permit the Monkey to transfer the treatment I have got from the US government onto the ordinary American people themselves. This time it would be the junky ordinary Americans whom I meet as “friends” who would treat me as a “subhuman” by shutting me off from their reality and calling me “crazy” if I dare peek into it. This time it would be the ordinary American people who will demonstrate to me that, because they are superior to me, they have “rights” and I don’t, and that they can hurt me whenever they feel like, whereas, if I fight back, they will use society’s mechanism (law enforcement) to dispose of me like a piece of trash. I will be taught the lesson that I have in fact no “rights” in a society where everybody is presumably equal before the law. How to explain this? You mean there are people in America who in fact have no rights? Yeah, you just don’t notice them. I can illustrate the situation by using an analogy with the situation of my cat Samantha.

We have been taught that, in American society, animals are granted some “rights”. If you see a dog on the street and beat it with a stick, you will be arrested and charged with “animal cruelty”, which is a felony. But, in fact, animals have no rights. We are not just talking about the billions of cows, pigs, and chickens that are slaughtered in some remote factory every year under the worst condition – without anybody caring about it, save some weird radicals in PETA. In 1998 this girl, Jen, gave me her cat, “Samantha”. She’s so cute, and everybody who has ever seen her hugs her and kisses her. So did I. She has thus grown up with the attitude: “I’m the Queen. I’m so cute. Every human being around loves me.” She is the most arrogant and selfish brat I have ever seen among cats. But I don’t mind, and nobody does, for nobody passes judgments on cats’ bad character. She thinks she is so important, because everybody caters to her every

whim. Until, one day, I got pissed off, by some other unrelated events, and took it out on Samantha. I gave her away to the animal shelter. Later I found out from the shelter that, because she had been living like a Queen and was so unused to the shelter condition, she got sick on the second day, and the shelter people promptly euthanized her. Well, the Queen must have been very surprised: all her life she thought she was important because everybody loved her – and anyone who beat her could be legally prosecuted for a felony offense – and yet all that was but an illusion. When human beings got tired of her, they could simply dispose of her like a piece of trash, as long as they were using the “system” – and nothing will ever happen to the human beings who did so. Not to me, nor to the city employees working in the shelter. Animals have no “right to life”. The protection which “animal cruelty” has offered, and American people’s general nicety toward dogs and cats, serve simply as a smoke screen to confuse the real situation, which is that human beings can dispose of animals for the slightest reason, such as: there is no more room!

I offer this example not only in order to clarify to you my situation in regard to other members of the American society – as you shall see in the following “stalking scandal”, everybody around me has the “right” to get the authority to dispose of me for the slightest reason, for the slightest annoyance I may cause them, even though nobody has the right to simply murder me: just as, while human beings in American society do not have the “right” to kill animals randomly on the street, they have the “right” to dispose of them for the slightest reason if they are using the “system” – but also in order to clarify to you the situation of ordinary American people vis-à-vis their “democratic government”. The American people have grown up believing that they have “rights” toward the government, and the government always caters to them by telling them “We respect your constitutional rights; meanwhile, we want to protect you.” And the American people really believe it. Just as Samantha has grown up believing that she is the “Queen” – until, one day, the Truth hit her in the face: when human beings treat you like a Queen, that’s merely acting; they can in fact dispose of you like a piece of trash any time they feel like. Only a tiny minority of American citizens have ever noticed that they have in fact no “rights” vis-à-vis their government which has been catering to them. I am one of them: I can never hold the American officials who have abused me accountable. The government can in fact hurt its citizens with complete impunity, even though it can’t send agents to shoot them on the street. (It’s the “system”, again.) Many American citizens in the past, who have been forced to suffer government’s malice, have also noticed their complete powerlessness to get their abusers prosecuted. The American government will never send agents to shoot you on the street – just as human beings are not allowed to kick dogs on the sidewalk. But this doesn’t mean you have “rights to life” vis-à-vis the government. Your “rights” is but a chimera just as “animal cruelty” is a chimera about “animal rights”. Your government can dispose of you in so many other ways you have never thought of. (For mind-control victims: the implantation of electronic chips into your brain: who will ever believe you when you complain?)

The ultimate moral of the following story is that ordinary people in democratic regimes have been completely spoiled by the “constitutional guarantees” which the government has offered them. This, in two ways. These guarantees have conditioned them to develop an erroneous sense of “invincibility” and “inviolability”, as if they were kings and queens of society. And they run around deriding and beating up anybody they can in

order to demonstrate their “superiority”, and they protest anything the authority does in order to give vent to their “invincibility” and “inviolability”. And yet this “invincibility” and “inviolability” have blinded them to their extraordinary vulnerability vis-à-vis those who truly have power in society: in corporations and, especially, in the government. They have no idea how their democratic government is manipulating them and treating them like trash from behind the scene. Just like Samantha, and many pet dogs and cats I have observed: spoiled by their masters’ kindness, they have never noticed how vulnerable they are toward human beings. Human beings shower love upon them today simply because these greater beings are in the mood. Whenever they are not, you are doomed. You have never had any protection than your masters’ temporary mood for your cuteness. You have never noticed what your masters are doing to other beings of your kind in factory farms or animal shelters.

We are again referring to the strange contradiction which has been pointed out earlier: the more the citizens are assertive toward their authority, the more obedient they are to it, and the more powerless. You don’t notice this unless you have an accurate idea of the aims and capabilities of the government. When the Snowden affair exploded – and when similar exposures followed in on the same trail, like the “Stellar Wind” and ICREACH scandal – people protested against the government for violating their privacy, and the government tried to put off the protest with more excuses (only “meta-data”, etc.). People protested because they actually believed they had “rights” toward the government, and the government wanted them to believe likewise, and pretended to agree with them. In reality, the government didn’t believe people deserved any rights, and didn’t *have to* respect their rights at all. It does whatever it pleases. And it never explains to the “people” the real reason why it is violating people’s privacy: it needs to collect everyone’s data because of the necessity of knowing about the present in order to predict, and control, the future. It does it for the same reason as when it conducts census, and of course none of this has anything to do with terrorism. But, because the “people” are noting but children, why explain anything to them? When they protest, just feed them with some story, and say “We are investigating”, “We are making new rules”; meanwhile, we do the same thing as before – and there is nothing the “people” can ever do about it. The “people” simply never learn that they don’t have any “rights” and are wasting their time when they protest – and they have no idea what they are protesting about anyway. The whole “democracy” is but “make-believe” – just as my having citizen’s “rights” like everybody else in American society is simply “make-believe”.

If you recall how my troubles began – how I pissed off the Department of Homeland Security in autumn 2006 – it was essentially also because I was “spoiled”, or deceived, by the “democratic regime”. I assumed, wrongly, that United States was a democratic system where people hold onto jobs according to merits and treat their jobs as a service to the system rather than as a personal possession from which to derive profits; I assumed, wrongly, that I, as a citizens, had certain inalienable rights vis-à-vis the government. I didn’t know that all this was on papers only, and “make-believe”. When the chief of the Department was offended by me because I exposed his incompetence, I thought he would simply back off in a professional manner like the FBI had done – that he would not take personal offense because he was merely servicing the system. Only later did I realize that United States was in fact like every other country, i.e. a *feudal system*, which fact was veiled by all the constitutional guarantees on papers – and that

my fate depended more on the whim of a feudal lord, like M. Chertoff, than on laws and professionalism on papers. It was then too late for me to learn the truth – like Samantha. This is how unrealistic expectation about democracy can harm you.

Amidst all the “inversion of the natural order” which the Macrospherians allowed the Monkey to effect, however, there was one thing which they let him do which was actually the “continual development of the natural order”. While the Macrospherians allowed the Monkey to “train me” to lose the few domains of competence or goodness I actually had, they made sure that he “trained me” as well to become more intelligent in regard to one thing, i.e. the past course of the ICJ trial. Namely, they let him program me to become gradually capable of “terrorist conspiracy” on a larger scale. To reactivate the ICJ trial, the Macrospherians had to make me a “terrorist conspirator” with France. But, of course, if the French government explains to you what the “terrorist plan” is, you wouldn’t even understand it – because you aren’t educated enough: how then could you have “conspired” with France to harm the world? You thus need to be educated first. At the beginning of 2011, I didn’t know that the previous course of the ICJ trial was in fact a lot more complex than I had thought, that the “objection” in May 2010 was of a different nature than my erroneous notion about “defense team objecting to the prosecuting team”, and that the entire ICJ trial was only *one* episode in a much larger war between the West and Russia, and between competing approaches to the demolition of Russia within the Western camp, which had begun in earnest since the 1980s, and of which the collapse of the USSR was only the mid-point, not the end-point, of the struggle. In order to realize Higgins’ program once the ICJ trial should be reactivated, I needed to understand all of this. The safe, and stable, environment with which the Macrospherians allowed the Monkey to provide me, is designed not just to allow me to learn to “safely” commit crimes, but also to reflect, research, and write. For this end, in the following three years, I would be programmed to familiarize myself with conspiracy theories, and then to understand in more details the ICJ trial and to comprehend the true nature of France’s objection. I needed to understand the real nature of international relations and the role which intelligence agencies have played in them. I would only learn that, for this purpose, you must not only absorb the works of experts from Think Tanks, but must also get yourself into conspiracy theories. While the academic discourse on international politics from Think Tanks and university departments constitutes a more realistic picture of the object of discourse, it treads only the lines of “official stories” and so is always “lopsided” (mentioning nothing of the criminal and secret things which the governments do). Only people in “conspiracy theories” talk about these “forbidden topics”, but this discursive domain is too unorganized. You thus cannot get a true picture of things regarding government and international politics unless you carefully combine the two, making up the deficiencies in one domain with the superiority of the other. Finally, in three years, I will have pretty much “graduated”, gaining a “clear eye” on the true picture of the power struggle between nations and obtaining a peek into the worldview of the “power elites” which cannot be found either in academia or in conspiracy theories. When you have acquired such wisdom, however, you will find yourself in a rather sad state. The portrayal, in conspiracy theories, of the extraordinary arrogance of the “power elites” (e.g. the Bilderberg) vis-à-vis the common people is indeed correct; and yet the disdain which the “power elites” have for the common people (Kissenger’s “worthless eaters”; Rockefeller’s “People are stupid, and we need to dupe them for their own good”) is also the most reasonable attitude – people are *really*

so stupid that they are not capable of knowing what is in their best interest. If you are a “true democrat”, you have nowhere to turn, really. You cannot but hate both sides. You’ll end up exactly like Emma Goldman, running to the newly founded USSR because she hated capitalism, only to be disappointed by the disorganized and failing state of the “socialist revolution”, where injustice was actually greater than in the sick system which it was meant to correct.

The principle of the “cunning of Reason” (List der Vernunft)

Note that in the preceding I have been speaking only of the Monkey’s desire to torture me for revenge. The fact is that, by early 2011, I was practically doomed, because the Republicans, foremost M. Chertoff, wanted to “get me” too. When the CIA allowed the Monkey to torture me, the necessity of this was not only laid down by the Russians, but the torture was also the inevitable fate for me because of Republicans’ ascendancy during late 2010 thanks to France’s objection. The CIA’s responsibility was virtually null, while it’s all Russians’ fault.

Now the method by which the Macrospherians used the Monkey to accomplish their purpose is the “cunning of Reason”, a deeper characterization of the method I have named as “congruence”: the insertion of a “filter” in the computer inside the control center to cause its performance for the Monkey to become increasingly distorted toward the end of the process, resulting in the accomplishment of his enemy’s goal. See the blog post of 6 July 2014 for a concise explanation.⁹ There I have cited Ludwig von Mises’ explanation. But you of course first see the principle at work in Biblical texts whenever “Providence” is expressed. The example I especially like is one of Paul’s expressions in Philippians, 1.12:

Γινώσκειν δε υμας βούλομαι, αδελφοί, ότι τά κατ’εμε μαλλον εις προκοπην του ευαγγελίου ελήλυθεν, ώστε τους δεσμούς μου φανερούς εν Χριστώ γενέσθαι εν όλωι τωι πραιτωρίω και τοις λοιποίς πάσι, και τους πλείονας των αδελφών εν Κυρίωι πεποιθότας τοις δεσμοίς μου

⁹ There I noted: “It’s again, the principle of List der Vernunft on which Monkey’s computer operates: while he is trying to accomplish his own purpose of harming people, the computer is secretly carrying out the other, Macrospherian, purpose of the replacement of evidences.

As they see it, Providence resorted to a cunning device. It implanted in every man’s mind certain impulses the operation of which must necessarily result in the realization of its own plan. The individual thinks that he goes his own way and strives after his own ends. But unwittingly he contributes his share to the realization of the end Providence wants to attain. Such was the method of Kant. It was restated by Hegel and later adopted by many Hegelians, among them by Marx. It was Hegel who coined the phrase ‘cunning of reason’ (List der Vernunft). (From Ludwig von Mises, Theory and History, Ch. 8, The Philosophy of History: <https://mises.org/th/chapter8.asp>.)

The contemporary musician Tatyana Ryzhkova is, in a sense, singing about the “cunning of the Providence”, or List der Vernunft, in her song ‘Kazda’ (When). See 2:00 in her concert video (Bremen, Germany, 15 January, 2011, St. Stephani: <https://www.youtube.com/watch?v=gDUrUEUOqQ0>). This is how the same principle is manifested in everyday experience.

Basically, the CIA’s method of seeking ‘congruence’ with the Republicans’ plans works on the same principle – and they are able to obtain this power of Providence because they have, without anyone’s knowing, got hold of the true version of Sentient World Simulation during the end of 2010.”

περισσότερως τολμάν ἀφόβως τον λόγον λαλεῖν.

But I want you to know, brethren, that the things which happened to me have actually turned out for the furtherance of the gospel, so that it has become evident to the whole palace guard, and to all the rest, that my chains are in Christ; and most of the brethren in the Lord, having become confident by my chains, are much more bold to speak the word without fear.

Paul was, at the time, under house arrest in Rome (AD 61 – 63). The Macrospherians' plan was basically to orchestrate (indirectly, through the Monkey and, in a sense, the Republicans) a process where people will victimize me for their own purpose of hurting me and harming the world, but where their actions will somehow become increasingly distorted into actions for the furtherance of the “gospel” (εὐαγγέλιον, λόγον). Like the way in which, the harder the Romans oppressed Christianity, the more Christianity flourished, in the end becoming the official religion of the Roman empire.¹⁰

The other important theme of the following narrative is thus that technology has advanced to such state that the scenario of Paul's divine inspiration can actually be accomplished by a bunch of human beings in possession of the right technology (in this case, the monopoly over the super version of Sentient World Simulation). The technology of “Dick Cheney's Utopia”, as I have named it elsewhere – which allows you to become God over the entire earth. While the Monkey thought he was “playing God” on me and all those people whom he had chipped, the Macrospherians were playing God on him and thus, indirectly, on all of us. This is the ultimate form of the “cunning of Reason” – taking control of “Providence”, hitherto God's domain.

The following scandal is presumably the first time where something like the “Sentient World Simulation” is used, not simply to predict the future, but to orchestrate, or create, it. The use of a super computer to create, not just to predict, the future is made possible by the implantation of nano computer chips into the brains of a certain selected actors in the drama (e.g. me and my “stalking victims”), while the reaction of others who are not “chipped” to the drama of the “chipped” can virtually be predicted with an accuracy up to one hundred percent (e.g. the Republicans, the French, the Mexicans, and Homeland Security personnel). The orchestration is so natural that the actors who are chipped will never even notice that they are not acting “naturally”, according to their free will, but have been programmed by somebody playing God on them – and all this is because, as said elsewhere, phenomenologically speaking, there is no difference between “chip-induced” desires and “naturally occurring” desires. Whoever is in control of the genuine version of Sentient World Simulation and brain-computer interface technology is, truly, indistinguishable from God.

¹⁰ It has often been said that Putin derives his geopolitical techniques from his favorite pastime, Judo. In the words of Igor Yurgens (in “Targeted sanctions with an unclear target”, in “The Cost of A New Cold War”, *ibid.*): “As masters of judo teach, it is better to not rely on one's own strength but to instead use your opponent's strength against him. Formulating an alternative approach to global governance when disappointment over the present leader's approaches is increasing is consistent with this teaching. Russia can become a catalyst of this process, which has already begun. This does not guarantee an immediate effect, but it could be quite successful over time.” This is very similar, also, to the approach “cunning of Reason”.

Remember that what the Macrospherians have wanted is a *story* of how I have become a criminal and society's reject – a story which contains all the evidences they have wanted when the ICJ trial shall be reactivated. They have written (or simulated) a “script” of my life, and would cause the Monkey (and later, the French and the Republicans) to program me to play it out. If anyone has access to the “script”, he can in fact come out and prophesize: “Lawrence will soon suffer severe victimization, demonization, by Mexicans and Kiersten-led white females – and become like Christ many years from now, the founder of a great ‘religion’ to save the world” – and people in the future will indeed see the “prophesy fulfilled”: as if the Macrospherians were really my “God”. Consider Act 13:27 - 29, where Paul was summarizing to the synagogue folks in Antioch:

οι γαρ κατοικουντες εν Ιερουσαλημ και οι αρχοντες αυτων τουτον
αγνοησαντες και τας φωνας των προφητων τας κατα παν σαββατον
αναγινωσκομενας κριναντες επληρωσαν. και μηδεμια αιτιαν θανατου
ευροντες ητησαντο Πιλατον αναιρεθηναι αυτον. ως δε ετελεσαν απαντα
τα περι αυτου γεγραμμενα καθελοντες απο του ξυλου εθηκαν εις
μνημειον...

Refer to Wes' words to me on April 12 2014: “They have made a movie about you; it's a true story; they are waiting for you to fulfill the ‘script’ so that they can release it and claim ‘It's a true story...’” The people I shall meet, and I, will “fulfill” what has been “written” about me – as predicted by a super computer. Because my Thermodynamic Interpretation of History and Scientific Enlightenment contain the insights which can save the world from destruction, the Macrospherians were indeed planning to make me into a “Christ figure”: I'm here to “fulfill” some “Plan”, what has been written, or prophesized, about me. “Written” here means: the course of events has been simulated on a super computer, and the simulation is guaranteed to be accurate. People in the government have become “God” via a super computer.¹¹

I want you to appreciate just how disgusting this “playing God” is, even when it is supposedly done for “good purpose” – for the Macrospherians are “playing God” to save human civilization, while the Monkey is “playing God” to destroy it. I would not recognize this immediately. For the next three and a half years I would agonize over the contradiction that, while it is clearly wrong for you to assume God's power when you are merely a human being – and while they (at least indirectly) were controlling my freewill like God could and were causing me to suffer severe harm in this way: who wants to be “Jesus”, rejected by his own people, only rectified by foreigners after death? – the Macrospherians are doing so “for a good purpose”. Until I began learning the Christian opinion. The unanimous Christian opinion is that “the end does not justify the means”. The Macrospherians, and D. Higgins in particular, would allow the “program” (the reactivation of the ICJ trial) to continue essentially under the assumption

¹¹ The analogy with Christ of course runs further. Paul makes it clear that the purpose of believing in Christ is to avoid “decay” (διαφθοραν): ον δε ο θεος ηγειρεν ουκ ειδεν διαφθοραν (Acts, 13:37). The idea is that those who have “sinned” have fallen into disorder, and those who “believe” will be restored to order and will never again fall into disorder and decay to death. A thermodynamic concept, as I have noted in my thermodynamic genealogy of religions. If human civilization believes in my thermodynamic interpretation of history, and practices its spirit, then it will avoid “decay to death”.

that the end does justify the means. They have thus made themselves subject to the criticism that there is a tremendous corruption in the interior of their soul – just as, for Putin, when he has lost the “potion of immortality” that he has found through my effort, he should have simply accepted it. You are essentially transgressing what nature, or God, has set down for you as your limit. And the Macrospherians were of course quite aware of this since the very beginning – since it is part of their programming that I would eventually come to this conclusion after abandoning their point of view (“It’s okay to assume God’s power if you are trying to do good”, or “if you are sacrificing one person for the benefits of the many”, etc.).
