There has once existed a secret lawsuit originating in the International Court of Justice between the United States and its allies on the one hand and China, Russia, and perhaps some other countries on the other. It was to this lawsuit that I, Lawrence C. Chin, trace my current extraordinary predicament. This suit commenced according to my belief in November 2007 when I obtained a Visa from the consulate of the People's Republic of China in Los Angeles to get ready to fly to China, and eventually so I did on December 29 2007. Concurrent with my attainment of the said Visa the United States Department of Homeland Security passed a warning to the Chinese representative about me, most likely alleging that I suffered from schizophrenic delusion about once being *erroneously* investigated by the United States authority as a "terrorist suspect". The representative entity of the PRC however had evidence to believe otherwise -- a FBI document showing that Plaintiff's "delusion" was in fact reality -- and duly filed suit against the United States and Canada in the International Court of Justice for intentionally not sharing the correct information about me, namely that I have once been investigated by the Federal Bureau of Investigation and its Canadian partners as such "terrorist suspect".

The dispute eventually evolved by early 2008 to consist in this. While first China and then the Russian Federation sued the United States (among others) for intentionally providing false information about me when I flew into and over their territories, the United States countered that the suit initiated by the Chinese and the Russian authorities against the United States was in fact a conspiratorial intelligence operation devised to unjustly hurt the United States; that I was in fact a covert operative for both China and Russia (among other nations) who was sent on this "mission" in late 2007; that I was in fact not who I was at all, Lawrence Chin the terrorist suspect (also a talented artist and writer) but someone else, namely my older brother who was a computer programmer (and who was made a "twin brother" of mine), thus relieving the United States from the charge of lying and breaking international law; and finally that the "mission" consists just in pretending to be my little brother Lawrence Chin and flying to China etc to get the United States sued. (The US authority was thus claiming that I was my older brother pretending to be myself the little brother per the design of Chinese and Russian intelligence services, among the intelligence services of many other nations that were also alleged to be conspirators against the United States.)

From February 2008 to July 2009 I wandered through American society like a ghost having the entire population play pranks on me -- just about every person I met has been either recruited or instructed by the then Secretary of DHS to speak gibberish to me so as to generate evidence to show that I was this "David Chin secret agent of China and Russia" pretending to be Lawrence Chin. You must understand that the former Bush administration had for my case especially installed in the International Court a system of surveillance upon me for use of "gathering" (actually generating) evidence which can only be called the "faulty surveillance machine". The Machine was especially wired up to my location to conduct surveillance on me but, without the knowledge of the judges, it persistently confused someone else with me so that evidence can be had of my performing clandestine operations for foreign powers even when I did nothing of the sort. The US authority had merely to send someone next to me doing something similar to whatever evidence it needed in order to convict the nations under suit in the International Court.

The affair is made more complex by the fact that the Central Intelligence Agency has once approached me for study and recruitment in July 2006. The operation failed due to internal strife between the Agency and the Department of Homeland Security (notably its then Secretary) in the autumn of 2006, and the Department then duly sent out secret alerts about my supposed schizophrenia in 2007 in order to keep the affair a secret. ("Secret" because everyone was to keep it a secret from me.) This I shall boldly assert here without the ability to confirm to your satisfaction perhaps, for it's the 'Agency's policy to deny everything and confirm nothing and the pictures which I have taken with Agency's personnel would not suffice to prove that the person in question was indeed Agency's person. The whole matter took a turn in July 2009, however. By uploading to my website for the purpose of being intercepted by Russian diplomatic protection service what appeared to be Agency's signal for me to fly to Nicaragua in August 2009 as a way to advance Agency's and Department's continuing lawsuit against the Russian Federation in the International Court -- the signal consisting in an email which an Agency's agent sent to me -- I was able to allow the Russians to reverse the conspiratorial scenario into its truer form, namely that I was really Lawrence Chin running a conspiratorial scheme to allow the United States to sue China, Russia, and any other country of its choosing. What I then needed to do was nothing more than stay in an apartment rented out by Agency's cover hotel in Granada, Nicaragua, and withstand further strange faulty surveillance. (The Agency would be forced by International Court order to furnish this service to me in order to allow the evidentiary process to continue.) I returned to Los Angeles in October 2009. To briefly summarize what happened later, I shall just say that, with my help the Agency was able to break away from the yoke of the by then former Secretary of Homeland Security with some strange tricks in cooperation with their Russian counterpart and some key Democrats in the International Court and that the then former Secretary of Homeland Security and a few key Neoconservatives had lost the suit. Whatever other result of this lawsuit is not of issue here -- although I do need to mention that something like a world-government has then been established right from the International Court from which the survivors of the suit -- the Russians and their new American and international partners -- are able to command the governmental elites around the world. What is however important to note for your attention is that the Agency, the Russian intelligence, some key Democrats, and perhaps more of an international team -- namely, the "survivors" -- have since February this year maintained an umbrella of centralized command over the infrastructure and population of the city I lived in (i.e. Los Angeles). A command structure which was built up during the three previous busy months for the sake of the production of the intercepts needed for the International Court and maintained thereafter, frequently if only for my sake, or so it seems. This command structure is part of the "world-government" commanding all the elites of virtually all the countries around the world.

To briefly describe the working of this command structure. During the course of lawsuit regarding me the so-called terrorist suspect, anyone convicted of conspiracy with me in the manner of communication between me and the person in question so as to defraud the Court to unfairly convict the other side, is called to the Court to receive the judgment of falling under the command of the other side. This is usual enough. But in extreme cases this conviction would be enforced with the machinery for remotely controlling people. The details of this machinery for remotely controlling people are given in part of my autobiographical account herein attached. When a foreign dignitary was for example

found committing conspiracy with me by having his or her images flashed in front of me as if in the manner of passing secret message to me, that foreign dignitary would then be called to the Court to have remote control devices installed in him or her so that the other side against which I was supposedly working may then command the dignitary with the remote control machineries located right inside the Court. When all the foreign dignitaries of the world have been found guilty of conspiracy with me in this manner, the governmental elites of the entire world would then have been implanted with remote control devices and be remotely controlled by the victim side in the lawsuit in the International Court -- right from the court house, it seems. This is how a "universal command structure" or the "world government" was built up during the course of lawsuit between October 2009 and February 2010. What one sees as international politics on TV news (such as when the head of one state shakes the hand of the head of another state to broke a deal) is in fact just a puppet show orchestrated from the International Court of Justice where the survivors of the lawsuit are remotely controlling these heads of states to put up a show as a way to deceive ordinary people into thinking that all this is real or "natural". These survivors are the hidden real power elites on the planet hiding in the International Court of Justice. Concomitant with this universal command structure is the command structure which can remotely direct the movement of every little thing in my environment. Since late 2009 and early 2010, under the command of the Agency, the Russians, and some Democrates, the residents around me have been implanted with some of the devices of the remote control set and told to move around when I have produced a correct intercept or said something right for the evidentiary record, for example. The trees in my environment have all already been wired up, in the beginning with listening devices to procure my monologues as testimonies, but then later on to cause leaves to fall in front of me during the right moment (such as when I have said something right). Even the weather above me has been remotely controlled from the command center -- to make cold or simply to blow wind near me so as to cause the movements of papers and leaves as a way to signal to me that I have said something right or wrong. Even the animals in my environment have been planted with remote control devices so that those in the command structure can remotely cause the birds to fly when I have said something right or dogs to bark or run as part of the signal systems, for example. This is the frightening Neoconservative technology, with which the winning party in the lawsuit at the International Court has been sealing me up in an artificial bubble of existence solely in order for me to perform as a way to produce the evidence needed to redeem Russia from its conviction in March 2009 and free the Agency from the yoke of Mr former Secretary's Neoconservative domination. Please note that this two-sided command structure has a domestic political dimension already hinted at. The Neoconservatives have since the beginning of 2009 planted remote control devices inside the heads of some Democrates, so that, while everyone thinks that we have a government of Democrates, it is in fact the elites in the Republican Party who are ruling by remotely controlling these Democrates.

With respect to the residents and local government and law enforcement personnel of Los Angeles, it must be said that the scariest part about this system of remote command is that those who are commanded, even when still conscious, i.e. without the ultimate remote control chip implanted in his or her head, would not know who is giving them command. Please also note that the International Court in regard to my case has been very mobile in location, following me whenever I went and its control center in Los Angeles, at least until February when I last witnessed its occupants, has been located underground in downtown Los Angeles somewhere between the Pershing Square and the Superior

Court.

This "scariest part" will now become the biggest problem in my current predicament, which began when I started going to the ~~Los Angeles County Law~~ Library again on February 6 this year. Just then I came to the knowledge that new "Russian-Agency-Democrates axis" had the intention to pair me up with an attractive supervisor working there by the name of Angela ~~_____~~ because of some operation planned in Mexico. It seems that Ms ~~Buenrostro~~ was so chosen because her father, Mr ~~Buenrostro~~, a wealthy and cunning businessman with a very aggressive personality of approximately 64 year-old, had some very important political connections in Mexico. As the lawsuit at the International Court had finally come to an end on February 13 or so this year and all the nations had been subdued and all governments in the world unified, the recruiter(s) of Ms ~~Buenrostro~~ (from the so-named axis of survivors) thus embarked upon the preparation for the coming operation in Mexico as one of the last places on earth which were still not entirely in reach from the universal command structure hitherto established in the International Court of Justice. Just soon Ms ~~Buenrostro~~'s father began vehemently objecting to the pair-up, mostly because of the disintegrated state into which I had fallen after the previous battle at the International Court. I believe that Ms ~~Buenrostro~~'s father had been coveting the power of the planner(s) in this coming operation in Mexico, especially in regard to the use of the machines to give commands over the city and beyond in North America. (The original planner(s) or recruiter(s) of Ms ~~Buenrostro~~ seem to have command over the entire North American region, the new "world-government" from the base in International Court perhaps functioning by dividing the world into various regional Districts.) It seems that what has happened is that Mr ~~Buenrostro~~ thus duped his daughter Ms ~~Buenrostro~~ as to the nature of my character through especially malicious slander in order to wrestle her away from her recruiter(s). With the use of environmental changes around me when I had become accustomed to believing that these constituted signals of encouragement, Mr ~~Buenrostro~~ had led me to believe that Ms ~~Buenrostro~~'s recruiter wanted me to write out the reasons and request for letter-exchange on a portrait which I had drawn of Ms ~~Buenrostro~~ and to give it to her as a way to initiate letter-exchange. Little however did ~~_____~~ know that Mr ~~Buenrostro~~ had in fact told Ms ~~Buenrostro~~ untrue story about the portrait -- probably in the nature that I was planning on severe physical harm of her with his letter-exchange idea. Hence on April 9 when I handed the portrait to Ms ~~Buenrostro~~ while in the library the latter duly rejected it and had the security guards throw me out of the place, calling the drawing an act of "stalking". I was on the next day informed by the security guard that I was from now on permanently banned from the library.

It seems that Mr ~~Buenrostro~~'s motive was to insinuate himself into the aforementioned command structure already set up in the International Court. He has most likely temporarily taken over the machines in the command structure since April 2, and has physically altered the setting of the computer systems there in order to produce fraudulent intercepts of my thoughts, words, and actions so as to slander me before Ms ~~Buenrostro~~ and to enmesh himself with the machines, thus pushing out the original recruiter(s) of Ms ~~Buenrostro~~. I believe that Mr ~~Buenrostro~~ was -- and is continually -- producing faulty evidence for the evidentiary record of International Court showing that I am not who I am at all (not Lawrence Chin) and not possessing all the talents I do possess in reality. The forged and faulty evidence Mr ~~Buenrostro~~ has produced slanders me as this David Chin and in most cases as the opposite of myself, saying I am murderous, stupid, autistic, pornographic, uneducated, and pedophilic

when I happen to be the exact opposite of these. With these false evidences, after April 10 and by the middle of May, through a series of battle with Ms Buenrostro's recruiter(s) (the aforementioned planner(s) for the upcoming operation in Mexico) in the evidentiary process in the International Court, Mr Buenrostro was eventually able to take over completely the command structure of at least the North American District of the International Court and thus the whole of my environment -- namely the post originally held by the aforementioned planner(s) for the upcoming operations in Mexico. It seems that all he has had to do to keep this post in the International Court command structure is to maintain me as the disgusting figure which his slandering false evidences say I am, and to argue successfully in Court that the better profile which the original planner(s) have presented of me in the evidentiary record there is false (inversion of truth, that is). This would mean that no one in the city save myself and Ms Buenrostro would even know that it's Mr Buenrostro who has been giving commands to everyone since then. The worst part of this is that, with the aforementioned remote control of foreign elites and domestic politicians, Mr Buenrostro is in effect secretly remotely controlling at least many parts of the US governments like his puppets and orchestrating domestic politics without anyone knowing so. Often times plaintiff doesn't even think that any of the US government personnel know that the entire thing over them from the International Court has already been hijacked by a business man of Mexican origin who has hitherto had nothing to do with the US government, namely Ms Angelica Buenrostro's father Mr Buenrostro.

After hijacking the command structure, Ms Ang [REDACTED]'s father, has been giving commands to people in the city as to how to behave toward me, both to get me into troubles but also to produce orchestrated evidence for the International Court. It seems that his deepest fear is for those in the local and federal government to know that it was in fact not Agency's personnel but he, a businessman of Mexican descent, who has been commanding the entire government and infrastructure of the United States. From the control center in DHS or the International Court (in downtown Los Angeles, it used to be) he has the ability to remotely turn off my computers at any time. Lately (May) Mr Buenrostro seems to have begun orchestrating a series of slandering alert against me with the view of secretly removing me so that his secret command would not be known. He has ordered the harassment of me by security guard intentionally via mistaken identity on May 12 in order to produce faulty evidence in the International Court arena as a way to maintain his command of the International Court District. It seems furthermore after May 12 that Mr Buenrostro has continued orchestrating more instances of mistaken identities among law enforcement and security industry in order for the personnel to confuse me with other criminal elements, thus building up a very bad profile of me by attributing to me criminal and disturbing acts of others many of whom were his agents anyway. Whether the goal would include legal problems for me in this "real world" I could not say, but his immediate goal seems to be producing faulty evidence in the International Court to keep his secret command afloat. I can mention May 25, past midnight, when his agent came to me selling crystals by the entrance of the cybercafe located on Wilshire and Normandie, and by early morning, when fire trucks showed up nearby, it would seem that he had ordered his agents to make false report in order for law enforcement and fire department personnel to not believe me should I report to the police about what happened with my recording of the event. (The problem is that, since law enforcement personnel did not know that the command system from the International Court and thus from Homeland Security has been hijacked, they might find surprises should they investigate crimes around me or be told from unknown command

to not investigate such crimes.) I should remind you that I out of extraordinary need of self-defense have had to record myself 24 hours a day, usually not a single second missed, due to executive authority's widespread instruction of people to make false reports about me or to talk about non-existent reality for the sake of producing faulty intercept evidence for the International Court, or of police officers to mistake my identity for the same purpose. This has been going on since early 2008 and now is continuing under the command of Mr Buenrostro. I have a large collection of recordings proving such to be the case, recordings in which people and police would speak completely nonsensical gibberish as if with diminished mental capacity beyond the natural level. Any sort of law enforcement bad records about me may easily be falsified by my round-the-clock recording of my every breath and constant videotaping of myself for the past many years. I doubt that any of the police officers, government workers, and the population and so on know that it is in fact Mr Buenrostro who has been giving them command about when to pursue me and talk nonexistent reality in front of me. Everyone probably just thought that it was the same old Mr former Secretary of DHS or the same old DHS officials that are telling them to slander me for the sake of the same old International Court case against the Russians. In fact, the very reason why Mr Buenrostro has chosen to revive the old false profile of myself as the criminal and perverted Russian and Chinese agent David Chin is probably just his continual effort to revive the old lawsuit against the Russians -- he is thus taking on the old Neoconservative capacity to sue the Russian recruiter(s) of Ms Angelica Buenrostro with the false profile of myself as the criminal Russian agent -- so that he may take over the entire universal command structure installed in the International Court and thus become the effective ruler of the entire world.

Knowing that I record myself 24 hours a day to prove my innocence of the characteristics which Mr Buenrostro attempts to secretly instruct people to talk about me as possessing, Mr Buenrostro has resorted to the tactic of forging recordings and then instructing government agents and officers to confuse that as mine. When I lost a USB flash drive at the cybercafe on Normandie and Wilshire on the night of May 9 and early morning of May 10 (the content of the USB flash drive was videotaped that night just before I forgot to take it with me when I left the place), it seems that Mr Buenrostro may very well have used this as an opportunity to forge recording of my self-talk. It seems that the forged recording is flowing about somewhere in the law enforcement and security industry and that Department of Homeland Security is investigating me and conducting surveillance on me on account of this forged recording. I cannot really guess at the content of the forged recording, but it's safe to assume that it's forged to frame me for horrifying criminal character -- angry, violent, pornographic, stupid, vulgar, uneducated, murderous, and pedophilic etc. Furthermore, I believe that the method used to forge the recording consists more likely in finding someone that sounds like me to make the recording than in actually using softwares to produce fake recording of conversations that have never existed. In pointing out that I have been recording myself 24 hours a day 7 days a week since the latter part of 2008 -- and this is widely known among the population and government personnel -- I wish to note that there have been very few gaps in this continuous recording of my life for almost 2 years. The gaps are usually due to my recorder running out of batteries unexpectedly, but at times it's due to its being remotely shut off by Mr Buenrostro from his Homeland Security or International Court control center. **Please note that the sheer volume of my recordings -- totaling almost 10,000 hours -- is proof that I couldn't have forged any of it.** I have even videotaped instances of how the recorder looked like when

it was remotely turned off in such fashion. Mr Buenrostro, when trying to prevent counter-evidence of my recording of my activities from entering the evidentiary record of the International Court, frequently resorts to the tactic of remotely turning off my recorder (such as freezing it). Another instance which I can cite occurred on June 4 on 8:12 PM when I called up my former best friend on my cellphone only to find that my recorder was subsequently frozen and that the recording of the conversation was thus lost -- a clear sign that Mr Buenrostro was planning on changing the NSA or Homeland Security intercept of my conversation with my friend -- making me say something bad which I have in fact never said -- and then presenting it to the International Court as "evidence" of my non-existent criminal and Russian-hating character. (I wish to point out to you that the only way for me to submit evidence to the International Court has been uploading my files to my website so as to be intercepted by domestic and foreign authority for presentation in the International Court as evidence.)

I finally wish to note that I have been regularly and for years videotaping moments of my writing process and have always recorded myself whenever I write so as to have proof against Mr Buenrostro's agents forging my writings and impersonating my works. This is necessary because the false profile of me which Mr Buenrostro has been spreading about in both the secret world of International Court and in the real world here among the population and law enforcement personnel includes just this horrifying slander that I have never written all my writings which total by now more than 3,000 pages -- almost 1,000 of which are devoted to describing intelligence operations on me since 2005. Moreover, it also seems that law enforcement and Homeland Security is investigating me as a pedophile of some sort -- or pretending to investigate me as such insofar as everyone should know that I was being framed. The secret commander of Department of Homeland Security, Mr Buenrostro, has been sending in children to my vicinity whenever I go knowing that I hate children and record myself 24 hours a day. Children thus show up in all sorts of most unexpected settings: in university's library and campus, at disabled people's housing facility, in Starbucks at 12 AM at night, and quite often he would send in police officers at the same time to serve as artificial witness -- most likely so that the law enforcement officer may then rumor in his official setting that I was seen again following children and trying to record them. Because of the ongoing International Court case about me, I have been on the official records as a pedophile of some sort without ever going near any settings that have any natural connections with children but are always near settings where children would be the most unexpected figures -- and this latter assertion can be clearly proven by the 10,000 hours or so of recording and videotaping of my whereabouts and activities in the past 2 years or so. The current strange situation is certainly thanks to Mr Buenrostro's orchestration. Lastly, Mr Buenrostro thus has ingenious ways to go round such problem. For example, he has sent in an agent past midnight of June 13 to drop me a message outside the cybercafe on Normandie and Wilshire, seemingly offering me a chance to meet someone in Brentwood. When I went there in the morning, however, I only found that the place of meeting was near a school area and while I was going there I was spotted and videotaped by several police cars which were obviously sent in on the command of DHS (and therefore under the secret command of the second defendant) to produce evidence of my non-existent love for hangout near such places. (My 10,000 hours or so of recording of my past two years would of course demonstrate that I have never had such love.) When discovering what was going on I quickly left the area, and the whole event, from the message-dropping to the going, has of course been recorded which will demonstrate once again how Mr Buenrostro deceived me. It is only not clear to me whether such act of framing was

merely to produce faulty evidence for the secret International Court or was to have "real world" consequences (namely, legal problems) for me.

The damage and danger which Mr Buenrostro has inflicted upon and poses to me since April 2010 consists just in the secret slander of me in the law enforcement and intelligence industry effected by the forged recording and constant presence of minors in my environment, but more: the Homeland Security alert which Mr Buenrostro has commanded the DHS to spread about me -- presenting me as a criminal and stupid and pornographic schizophrenic, in addition to saying (as is likely) that I am a foreign agent pretending to be myself, that I am not Lawrence Chin but my own twin brother of some sort pretending to be myself -- not just in this country, but very likely overseas as well and throughout the travel industry, making it impossible for me to have any sort of social standing anywhere in the world in the future. Moreover, most likely through slandering me before my family members and then commanding them to speak gibberish falsehood about me while under surveillance so as to produce faulty evidence for the International Court, Mr Buenrostro has effectively cut off all help and connections from my very family members. In other words, Mr Buenrostro has effectively disabled almost every aspect of my environment, including frequently the very electronics which I own. He has been also commanding DHS to put me under extremely strict surveillance (many of which I have videotaped as proof, though decoys are likely) and constantly sending agents to provoke me with aggressive advances wherever I go (all of this I have of course also recorded right in front of them), hoping that I would get in fights and thus have causes to be arrested. Last but not least, Mr Buenrostro's frequent remote shut-off of my laptop for about a dozen times causing destruction of my discs of data, and his agents' theft of my things, added further financial hardship to me when I am already dead broke.

A most horrifying prospect about Mr Buenrostro's actions toward me has been his access to the "thought-reading machine" in the International Court to which I have unfortunately been wired since early January this year. You must understand that Mr Buenrostro is a con man and a scammer and is in the habit of changing the setting of that "thought-reading machine" in order to produce fake intercepts of my thoughts that are the opposites of my "real thoughts". This problem has been a grave concern for, unlike my words, I do not have the ability to record my own thoughts. When I read out loud my thoughts to be recorded, I have no proof that I am actually doing so rather than saying one thing while thinking another. While Mr Buenrostro's slandering of me in thus manner would normally only have effect in the arena of the International Court of Justice to which only the elites around the world would have access, it is imaginable that he might alert the population to the fact that the US government has already produced the technology to read people's thoughts with extreme accuracy by the end of 2008, and that he may then tell the population around me that I have constantly thought this pornographic and criminal thoughts while in reality I have never thought such. The worst part is that I would never know I have been slandered this way if indeed I have been, because Mr Buenrostro would simply command DHS to order people to keep what they have been told about my thoughts a secret from me.
