

The third International Court of Justice trial over the suspect XIV

1 – 30 April, 2017

The following summarizes the reconstruction of the Secret Society women’s operation against the suspect and the associated International Court of Justice trial from 1 to 30 April, 2017.

This is a rewrite of the original “The third ICJ trial, XIV”. The original version, originally composed in November 2017 with the file name “prelude_GR_Es.pdf” (last dated 20.12.2017), can still be found in the same folder.

The names of persons follow the convention established in the previous chapters. The Secret Society women consist of (as of April, 2017): Karin (the German Lady, K), Angelica (Angelina, G), Kiersten (J), SDW (Maura, M), and Dr P (Petterson), along with auxiliary members like the Long Keng volunteer. For brevity’s sake, the “Secret Society women” shall continue to be referred to simply as the “SS women” in the following narrative.

April is a time of increasing polarization or parallel reality between the Secret Society women and the suspect. The suspect is spending an increasing amount of time reading philosophy trying to catch up with all the philosophers he has missed in the past few years due to his engrossment in some ICJ trial, in addition to working overtime applying for universities in Germany. The Secret Society women, on the other hand, are working overtime complaining about him as an insane and extremely dangerous terrorist stalker of women with a terrorist website and recruiting people from around the world to complain similarly. (Their perennial life-goal of proving to any law enforcement authority, wherever in the world, that the Homeland Security warning about the suspect (and their status as “victims” and “expert witnesses”) is all correct.) *These are two completely different lifestyles and yet they are joined together as if they had something to do with each other.*

The “Dr P phenomenon”

Consider the observation about Dr P under the entry for 23 April. The most mysterious question in this entire story is of course why Dr P has developed such a high regard of herself and such a bizarre belief in her importance given her extraordinary stupidity and uneducation. We have clarified repeatedly that stupid people never have any idea that they are stupid and consequently always think themselves very smart because: in order to know that one is stupid, one must have some idea about what it is like to be intelligent with which to compare one’s stupidity – but Dr P has grown up among a bunch of dumb people and stupid people by definition have no conception of what it is like to be intelligent. More importantly, Dr P’s bizarre self-confidence reveals the most serious problem that American

higher education is today completely “fool-proof”: any idiot can get a degree in any of the human and social sciences simply by memorizing and repeating words from textbooks. (This presumably can’t happen in the quantitative and computer sciences.) Dr P has been making herself look like an expert in human psychology by regurgitating some psychology jargons she has memorized from textbooks (without being able to actually relate the jargons to any of the human phenomena she has encountered). Surprising though it may sound, Dr P is not actually in contact with reality.¹ This is why oral exams are used in the traditional education setting: you can’t tell whether the student has really understood the subject matter and is not merely repeating words unless you actually interact with him or her. The peculiar recent development of American higher education is the removal of “talent” as a necessary ingredient for success in order to make the whole process “fool-proof”. This has enabled somebody like Dr P – of whom the suspect has always the impression that she is some sort of “red-neck”, a simple, vulgar mind most insensitive to other people’s thoughts and feelings – to pass through all the exams, obtain a degree, and get herself licensed in order to be able to present herself as an “expert”.

We have learned from previous chapters that Kiersten is the way she is because she is a particularly virulent instance of Narcissistic Personality Disorder. It is however surprising to find that, of all the characteristics which compose NPD, Dr P embodies quite a few of them: inflated assessment of one’s own importance, insensitivity to other people’s thoughts and feelings (lack of any ability to empathize with others), manipulateness, and always blaming other people for one’s own failures (an inability to discern one’s own faults in unfortunate events). And yet, if you interact with Dr P, you will not get the impression that she is born with any personality disorder. Dr P is an artificial instance of “Narcissistic Personality Disorder” – this is another case of “convergence”. Dr P is “narcissistic” because she has been brainwashed by the American feminist culture (even though she’s not explicitly a feminist, but is rather engrossed in “spirituality”), namely, *because she has been trained to exhibit NPD features by a gnostic feminist ideology*. As noted, the purpose of (cultural) feminism is to train women to become psychopaths. Scientists have discovered that the brain of people with NPD is different from the brain of normal people in that it has less gray matters in it (which are supposedly the seat of such emotions as empathy).² We have to wonder whether women, after becoming influenced by such gnostic ideology as cultural feminism, might over the years suffer a reduction of gray matters in their brain.

- 1 In the original version, there is this interpolation at this point: “When the suspect reflects on all the psychologists who actually understood him in the past and were ‘in touch with reality’ – Dr Chapman, Dr Ely, or even Dr Caldeira – it’s all because they had some talents for understanding human beings.” Namely, *talents* are as important in psychology as in art and music, and yet today regurgitation is all that matters to getting a degree in psychology. Then: “We shall exclude Dr Wiss because she has understood the suspect out of sheer experience with him rather than out of any expertise in psychology.”

- 1 April**, the Boss' family intervenes again to save the Russians and prevent the CIA from reactivating the previous ICJ trial.
- 4 April**, LTRDRP/ MSSGDP. The SS women continue to spend enormous effort on proving to the LAPD as well as Sledkom that the suspect does plagiarize.
- 5 April**, **the LTRDRP incident has enabled Sledkom to retain the Homeland Security warning** and prolonged the Russians' life in the ICJ. The SS women want to recruit Oliver to the Murakami girls' complaint.
- 6 April**, Dr P continues to work with the LAPD unit associated with Sledkom (the TMU?) over the LTRDRP incident. She gets hidden cameras installed in the MSSGDP incident location. **The suspect's conversation with Wes**: evidences for both sides. The LAPD (TMU) mobilizes Shizuka again.
- 7 April**, Shizuka begins sabotaging the SS women's case established since the LTRDRP incident. The SS women try one more time to persuade Prof. Fraser to join their enterprise.
- 8 April**, the SS women recruit Gaurav back to their latest case (LTRDRP).
- 9 April**, Shizuka continues to sabotage the SS women's case.
- 10 April**, the SS women are having a big commotion about the suspect's Facebook, and the Russians order Sister MLDND to text a New Testament passage to the suspect.
- 11 April**, Sledkom has been unable to validate the Homeland Security warning and the Russian side is almost convicted. The Russians save themselves with the same dirty trick.
- 12 April**, the Russians order Homeland Security to send in agents to provoke the suspect in order to obtain evidence that he is dangerous; the SS women and the Partisans are mobilized to "save Russia".
- 13 April**, the SS women recruit Oliver to the Murakami girls' complaint again. **The suspect's conversation with Wes temporarily saves the Russians in the ICJ**. By night, the CIA mobilizes Shizuka again.
- 14 April**, the SS women try to recruit Ms Gannuschkina to the Murakami girls' complaint. Did the Boss' family cut in again to save the Russians' case?
- 15 April**, the Russians save themselves temporarily with the same dirty trick, but then Shizuka starts on another round of sabotaging.
- 16 April**, a big fuss over the suspect's Facebook. Desperate to "save Russia", the SS women are contacting Zizek wanting to recruit him to the Murakami girls' complaint.
- 17 April**, MSSGDP in the same location. **Dr P is able to open a stalking claim against the suspect with a LAPD detective**. The new case presumably combines with the Murakami girls' case with Sledkom. "Russia is saved."
- 20 April**, Sahra promises to help the Russians by enlisting herself on the Murakami girls' complaint. The LAPD detective informs Dr P that her video of MSSGDP can't be used as evidence of "stalking". Dr P plans an operation with the Missionary Sisters.
- 21 April**, the SS women try to recruit Prof. Hochschild to their complaint process. **2:20 PM, the suspect talks to Wes**: the Russians obtain evidence of the suspect's insanity to prolong their life in the ICJ. 5 PM, they work with the Missionary Sisters to entrap the suspect, but the operation fails.
- 22 April**, **the LAPD detective dismisses Dr P's "stalking" case arguing that the Homeland Security warning is invalid**. The SS women scramble to recruit more Japanese

pop-singers (Kyoko and Akino?) to their cause. The Russians are able to keep themselves temporarily afloat in the ICJ by remotely controlling the suspect to post more messages on both the Partisans and the PP.

23 April, the SS women make their false reports to Sledkom to justify the use of the Homeland Security warning to label Kyoko and Akino (?) the suspect's "victims". The suspect calls Sister MLDND and bids goodbye to the Mormon church.

24 April, Dr P disconnects her phone numbers. **Due to the sabotage of Kyoko and Akino (?)**, Sledkom again informs the SS women that they can't hold onto the Homeland Security warning. The SS women thus resume reporting the suspect's plagiarism to Sledkom.

25 April, the SS women continue to report the suspect's plagiarism to Sledkom. By night, the SS women wonder again about how to recruit Zizek, Hochschild, and Fraser to their cause.

26 April, the SS women continue to report the suspect's plagiarism to Sledkom.

27 April, **the SS women resume using Ms Gannuschkina's case to enable Sledkom to hold onto the Homeland Security warning**. Then both Marion and Marie join in to save Russia.

28 April, the CIA sends in Shizuka to rejoin the SS women's campaign to sabotage it, and, through the same dirty trick, the Russians get the ICJ to temporarily suspend the new judgment convicting them and their allies. Late night, the suspect writes to Dr Ross: more evidence for the Russians of his insanity.

29 April, **the suspect's conversation with Wes is the SS women's, and the Russians', evidence that he is insane**. Homeland Security trollers' complaints (that the suspect does suffer from delusions about his women victims) and Shizuka's confidential reports (that the SS women are committing fraud) cancel each other out with Sledkom so that Sledkom is effectively paralyzed (unable to validate the Homeland Security warning about the suspect).

30 April, Shizuka continues to bring evidence of the SS women's fraud to Sledkom while the SS women continue to make false reports about the suspect's plagiarism to Sledkom.

The SS women are having a long discussion about the current impasse. 12:22 AM, the Oceanside volunteer seen on 24 and 29 March comes again (lightspeed.sndgca.sbcglobal.net):

Thus, after the Boss' family's special report to Sledkom in the afternoon, by late night Sledkom is asking the Oceanside volunteer to make another special report about the suspect's plagiarism – in this way they can keep the Homeland Security warning alive despite the confidential reports Shizuka has been making in the past week.

02.04 Sun

Early morning, 4:45 AM, the suspect posts another video of Prof. Fraser's lecture on his Facebook. When the suspect is chatting with Daniel in Elysee this afternoon, he tells him, for the first time, about his status as a terrorist.³ As for the SS women, they continue, throughout the whole day, to mobilize their volunteers to make false reports about the suspect's plagiarism. (To repair the damages Shizuka has done, or to enable Sledkom to keep the Homeland Security warning alive.) 11:51 PM, they check the suspect's Facebook and would see the new video of Prof. Fraser's lecture. 1:34 AM, they send another volunteer to check the suspect's Facebook. Clearly, they are thinking about how exactly to recruit Prof. Fraser to their cause.

03.04 M

For the whole day, the SS women continue to send volunteers to look up images and chapters on the

suspect's website (plagiarism and decoys). 12:10 AM, a volunteer from Texas looks up "PC Books". Then, 1 AM, a certain "Veselin Georgiev" from Bulgaria sends the suspect a job offer via ProZ. 1:40 AM, another "Ichen" sends the suspect a job offer via ProZ. It seems that the SS women are thinking that a confirmation of the "David Chin" document as genuine may at last enable Sledkom to retain the Homeland Security warning once and for all.

04.04 T

4:20 AM, a volunteer from Turkey looks up "Timeline-02-14": another complaint about the suspect's delusions about Karin? Then, 7:12 AM, the SS women send a volunteer from Lawrenceville, Georgia, to the suspect's website.

Presumably another special report to Sledkom about the suspect's plagiarism. The SS women would spend the rest of the day mobilizing their volunteers to make more false reports about the suspect's plagiarism.

As for the suspect:⁴ 3 PM, LTRDRP. At the post office, a fat woman with a broken foot and wearing earphones is standing behind him. This is very likely what has happened: the Russians have already known from the control center that the suspect is about to do this and so ordered Homeland Security CO chief to send in a member of the Secret Society with surveillance gear to film him committing his act. Then, MSSGDP. The evidence of these two acts by the suspect the SS women will promptly submit to both Sledkom and the LAPD (TMU?) officers that are working with Sledkom – it's indisputable proof that there *is* some truth in the SS women's testimonies about him (that he does harass his woman victims) so that the Homeland Security warning about him shouldn't be dismissed so fast. In this way the Russians can also prolong their life in the ICJ.

Then, after a whole day of operation, 4:26 AM, the SS women send in the Long Keng volunteer again (Rackspace Hosting):

Somehow, the LAPD officers working with Sledkom have asserted that the suspect's harassment of Dr P is not enough to validate the Homeland Security warning about him because he is not found to have plagiarized. On the SS women's request, the Long Keng volunteer thus shows up to brainstorm or make another "special report".

05.04 W

Today, the international conference over Syrian begins in Brussels.

5:20 AM, the SS women send the link to the suspect's website to a volunteer in Almaty, Kazakhstan. Within a minute, he clicks on soft.pdf and the Preface to "Friends, I". This is evidently another special report to enable Sledkom to judge that some truth does exist in the Homeland Security warning about the suspect – perhaps in anticipation of the arrival of the letter at Dr P's. In the afternoon, Dr P must have picked up the letter from her mother's place⁵ and gone to the LAPD officers (the TMU?) currently working on the suspect's case with Sledkom. Then, 11:44 PM, perhaps to strengthen the new developments in favor of the retention of the Homeland Security warning, the SS women send in a volunteer from Tempe, Arizona, to look up Oliver's painting on the suspect's website. They are probably thinking of adding Oliver's complaint to the Murakami girls' case. As for the suspect, strangely, past midnight, he is not allowed to log into his Bluehost account. Is US law enforcement checking his website again in order to gather evidences to refute the SS women's claims? Or is it simply a problem with the Bluehost server? Then, the suspect posts another video of Prof. Fraser's lecture on his Facebook!⁶

06.04 Thu

The Trump administration is in disarray today: Bannon is removed from Trump's National Security Council. Then, the press reports that "chemical attacks in Syria have changed Trump's mind about Assad", such that he orders the Navy to fire cruise missiles into Syria. Anyone familiar with the situation can tell that Trump is merely here bowing to the pressure from the US national security Establishment to renounce his bizarre loyalty to Russia.

Today, the suspect is talking to Wes on the phone from 2:18 PM onward:

Conversation with Wes (06.04.2017)

The suspect is connected with Wes from 24:00 onward. (1) He is concerned that he might not be able to study in Germany after all. He is reminded not to mention his "thermodynamic interpretation of history" in his motivation letter. Should he just focus on being a terrorist, a criminal, and a mental patient, the role which American society has required him to play? He should harass some movie stars in order to provide the SS women with more ammunition. He is the SS women's toy, they get their fix by complaining about him. (Quite true!) (2) There is a debate in the ICJ about whether he means what he says. The Invisible Hand has been arguing that he understates his ability when he is frustrated, but the Russians – which is their purpose in lowering his TestDaf score – assert that he means what he says. The suspect is merely elaborating on what he has already confessed on 18 February. The suspect corrects himself from the last time: the Russians haven't won, and they have screwed up his future just to obtain a single evidence to temporarily prolong their life. What the suspect says here is completely correct: he has grasped the argument in the ICJ, which is evidence in favor of the CIA (that he is not insane). (3) The US is his real enemy; as long as the Russians are harming the US, he should be happy. Again, this would enable the Invisible Hand to continue to argue that the suspect is a fake terrorist who uses his fake terrorist status to help the Russians (that the Homeland Security warning is false insofar as the suspect doesn't want to harm those he love, such as China and Russia). (4) The Russians have wanted all these other parties to become involved because they have wanted everybody to share in the spoil of Homeland Security. The Russians are sharing secrets from Homeland Security's "secret box" with all the "victims". The suspect is only half-correct here. What the Russians have really wanted is to use Homeland Security to run operations to benefit the "victims". (5) This ICJ trial will turn out an indefinite result, in order to replace evidences from the previous ICJ trial (which couldn't be undecided). The Russians will then maintain permanent command of the conspirators from the previous round, Sarkozy and Erdogan and so on... What has happened with Erdogan... replacement of evidences, and everybody knows that Erdogan has been doing all these crazy things only because there is another case in the ICJ which Russia has won. This is thus evidence in Russia's favor (that the suspect is indeed insane). (6) The suspect should look at the positive as well as the negative aspects... (7) About whether to retaliate against the SS women. (8) Wes mentions "post office"; is that an oracle? Strange coincidence. LTRDRP has already been carried out. Presumably Wes is giving out a hint that, yesterday, the letter has enabled Sledkom to rule in favor of the Homeland Security warning and thus prolonged the Russians' life in the ICJ. Perhaps Wes is trying to lure out a confession from the suspect to the effect that he is aware that, by doing such things, he will help Russia (so that the CIA can annul this evidence in the ICJ).⁷ (9) The suspect should have remained homeless. Wes suggests Kierkegaard's Either/ Or: he will regret if he moves in; and he will regret if he doesn't move in. The suspect then talks about how to appropriate his outcast status, how to become the best criminal, terrorist, and mental patient. (10) The suspect has discovered "DeGrowth" and "Convivialism". Wes suggests an historical example of a perfect communistic society that once existed in New York. Our conclusion: since both sides – the TMU/ CIA and the Sledkom/ SVR – can extract evidences favorable to either side, the stalemate continues.

As for the SS women, they will, for the whole day, continue to mobilize their volunteers to file false reports about the suspect's plagiarism. Noteworthy is that, 6:22 PM, they send in a volunteer from Philadelphia to look up the suspect's portrait of Shizuka. They have not done this since the end of last month. Clearly, it's because the LTRDRP incident has enabled Sledkom to retain the Homeland Security warning that the CIA has had to mobilize Shizuka again to submit evidence of the SS women's fraud to Sledkom.

From 5 PM onward, SDW would post a new post on her blog, her first time since 21 March: "Hollywood is run by the CIA and pedophiles." She is becoming ever more engrossed in these crazy conspiracy theories and will gradually believe that it is these "pedosadists" (sadistic pedophiles) inside the CIA who are coordinating with the suspect to gang-stalk her and obstruct her complaint process with law enforcement agencies. However, she never posts anything on her blog (so we theorize) unless it's in order to enable law enforcement to intercept the suspect "cyberstalking" her. Something has galvanized her today: perhaps it's because the LTRDRP incident has breathed new life into the Murakami girls' case.

The SS women seem to be on break after 11 PM. They are perhaps conferencing about the latest breakthrough – and of course Dr P, given her fanaticism about security, is taking the LTRDRP incident extremely seriously (even though the perpetrator is under her allies' remote control). Dr P, thinking herself to be very smart, decides to ask Veronica's investigators to install hidden cameras in the vicinity of the PYPHN. The women are probably also discussing the situation with Shizuka – not knowing that Shizuka is merely here to gather evidence of their fraud.

07.04 F

Today, when the suspect is in Elysee late afternoon, he chats with Daniel about “revolution”. Then with Elliot about Trump.⁸ As for the SS women, they resume operation after 4 AM this morning: mobilizing volunteers to make false reports about the suspect’s plagiarism. 4:52 PM, another volunteer from France looks up Shizuka’s portrait. Shizuka has started on her sabotage once again. (But is this volunteer a Partisan?) Then, 6:46 PM, another volunteer from Vincetown, New Jersey, also looks up Shizuka’s portraits. (The sabotage continues.) Meanwhile, on 6:44 PM, and between 8:56 and 9 PM, and then on 12:48 AM, several volunteers (including many from China, probably helpers lent to the SS women by the MSS) are sending around ancestorcult.html and whyshouldwebejust.html in order to produce (forge) evidence that the suspect does plagiarize or go around pretending to be intellectual. Thus, the same battle again: while the SS women try to justify the Homeland Security warning for Sledkom by confirming that the suspect does plagiarize, Shizuka sabotages the whole case for Sledkom behind everyone’s back. Also, between 8 and 9 PM, Kiersten would tweet and retweet 11 times about Trump’s strike on Syria. She is desperate to get into the groove with her fellow liberal progressives. 9:22 PM, the SS women are also checking the suspect’s Facebook again. They would have seen the new post about Degrowth, another one of Prof. Fraser’s lectures, and a news item about Donald Trump. The SS women are evidently still trying to persuade Prof. Fraser to join their enterprise. They seem to be spending three hours tonight trying to talk to Prof. Fraser – there are no visits between 9:30 PM and 12 AM.

08.04 S

6:13 AM, the SS women send a volunteer working at YHC International BV (Powerhouse Management) in London to look up “Prelude-F5C”. This might be a complaint on Gaurav’s behalf. Not knowing that they are informants here to compromise their case, the SS women believe that getting Shizuka and Gaurav to complain more might finally persuade the law enforcement agencies on both sides of the Pacific. Then follow the usual complaints about the suspect’s plagiarism or decoys. 1:02 AM, the SS women send in another volunteer from Oman to look up “Prelude-F5C” again.

09.04 Sun (Facebook)

Since early morning, the SS women continue to send in volunteers to file false reports about the suspect’s plagiarism. 11:36 AM, they send in another volunteer from the University of Minnesota to file a complaint on behalf of Shizuka. 2:48 PM, another volunteer from Warrington, UK, makes a complaint on behalf of Shizuka. (The sabotage continues.) Strangely, 6:48 PM, when the suspect is going to French in Mind, Tyan calls him to invite him to Kenneth’s secret Facebook group. The suspect

would assume, erroneously, that it's the SS women who have instructed her to do this. He would especially get this impression since, between 6:30 PM and 3 AM, there are only three insignificant visits to his website! It seems almost as if the SS women were discussing their next move with Tyan (to use Tyan to "get him"). This is in fact not the case. Things get more complicated for the suspect when, between 2 and 4 AM, somebody in southern California is checking over every recent post on the suspect's Facebook. The suspect assumes it's Tyan who is doing this while listening to the SS women's explanations about his harassment of various women on his Facebook. His impression is further solidified when, 4 AM, Tyan accepts the suspect's "friends" request. In reality, the person checking over the suspect's Facebook during these two hours is Dmitry – and Dmitry never seems to have anything to do with the SS women. The mysterious question is then: what are the SS women busy with between 6 PM and 3 AM? Are they conferencing about the mystery of why Shizuka's, and others', complaints seem to have made no difference at all? (Not knowing that Shizuka has already sabotaged every advantage they have gained since the LTRDRP incident.) Are they still trying to contact Prof. Fraser?

The first hypothesis is confirmed when, 6:45 AM, the SS women seem to have sent in a volunteer to look up Shizuka's portraits on Google's cache. Then, 8:18 AM, the SS women's volunteer looks up the suspect's posting of the painting of Robin on his Facebook. Evidently, the women are arguing with law enforcement: both Shizuka and Robin are terrified of the suspect; why aren't they taking action to officially validate the Homeland Security warning? Then, 9:09 AM, somebody is looking at the suspect's Facebook postings between 19 March and 12 February. This might however just be Dmitry again, and so unrelated to the SS women's operation. Then, 12:47 PM, the SS women send in a volunteer from Scarborough, Ontario, to make another complaint on Shizuka's behalf. This is a sign that Shizuka’s sabotaging has achieved effect and that, not just the LAPD (TMU?), but also Sledkom, are now required to dismiss the Homeland Security warning which has strangely crowned the SS women as some sort of “experts”. Then, 9:59 PM, a volunteer from El Dorado Hills, California, looks up the suspect’s portrait of Shizuka. Then, 10:05 PM, a volunteer from Hyderabad, India, looks up “enstedet.jpg”. Then, 10:31 PM, another volunteer checks the suspect’s Facebook. 2:06 AM, another one. 3:07 AM, another one. This is evidence that the SS women are indeed having a commotion tonight: “Shizuka has repeatedly complained! And yet both Sledkom and the LAPD say the Homeland Security warning is untenable! And now he’s posting on his Facebook more drawings he has stolen from his family!”⁹ They don’t seem to understand that it’s precisely because they have got

Shizuka to complain that Sledkom can't hold onto the Homeland Security warning and validate their status as "expert witnesses"! In fact, it's also precisely because the case established since the LTRDRP incident has so quickly disintegrated that the Russian intelligence has had to order Homeland Security CO chief this evening to instruct Sister MLDND to text that thing to the suspect: for, when the suspect sees it on his phone while in Pershing Square, he is naturally misled to think that this is a secret message from the CIA about BOL's program. This would go on for the first half of the day. 7:24 PM, Karin writes to everyone in her meetup about the cancelation of the meetup on the 19th. Then, 8:21 PM, the Russians order Homeland Security CO chief to instruct the SS women to produce evidence suggesting that the suspect's website is full of pornography. (Quantil, Kolkata, India: the "Quantil Group".)

The suspect will experience a lot of provocations today. (3 times.) These Hispanic agents are evidently instructed by the Russians to try to pick a fight with the suspect so that, per chance, there can be evidence entering the ICJ supporting the SS women's claim that he is physically dangerous to other people. This is the second sign that Sledkom has been unable to validate the Homeland Security warning (principally due to Shizuka's sabotages) and that the Russians and their allies are thus being convicted in the ICJ. As for the SS women, they continue to make false reports about the suspect's plagiarism like crazy – this is how they are “saving Russia”. It seems that the SS women are thinking again about adding Oliver to the Murakami girls' case. Around 2:23 PM, the suspect would speak briefly with Wes (from 4:30 onward).

Conversation with Wes (13.04.2017):

(1) The suspect is afraid that the Russians will sabotage his application to the University of Jena. He is aware that the Russians have lost again. Would this be bad news for him? It would be a bad time for him to apply for school. (2) Did Prof. Jaeggi ever get alerted about him? Humboldt is gone! (3) He saved the Russians' life, and they will get him. What should he do? (4) The SS women have recruited Tyan and instructed her to add him to Kenneth's secret Facebook group. She spent two hours on his Facebook. She was sitting face to face with the SS women. They realize they have failed again when they discover his Facebook is still in existence. Is Tyan a double agent? Again, all these are wrong scenarios! The Russians will certainly use these as evidences that the suspect is indeed insane in order to temporarily save themselves from total conviction in the current case and prevent the CIA from reactivating the previous ICJ trial. The suspect continues: The Partisans were mobilized yesterday. Did they forge evidences again? (5) Can the Russians not ruin his school plan? They will never win in any case. being: the suspect's misidentification of the visits to his Facebook – it's Dmitry and not Tyan – is confirmation of the SS women's claim that, by frequently misidentifying the visits to his website due to schizophrenia, the suspect keeps developing bizarre delusions about his women victims' going after him.

3:08 PM, a volunteer from Cedartown, Georgia, looks up "Kulturindustrie". Thus, right after the suspect's call, a report to both Sledkom and the LAPD (TMU?) that the suspect is in denial that he's mentally ill. Now that the debate is back on, the CIA and the TMU immediately mobilize Shizuka to do the same sabotage. Shizuka rejoins the SS women's discussion and, 8:21 PM, pretends to ask a volunteer from Charlotte, North Carolina, to make a false report on her behalf.

14.04 F

Today the suspect would submit his application for the master program in philosophy to the University of Jena.

5:16 AM, the SS women send in a volunteer from Westfälische Wilhelms Universität to look up the suspect's external links page. This is probably to file a report emphasizing that the suspect is also stalking and harassing Marine and so on by linking to their websites. 10:59 AM, the SS women send in a volunteer from Singapore to look up "softappende.pdf". Is this a false report emphasizing to law enforcement agencies on both sides that the suspect is making hate speech against womankind on his website? Or is this rather an attempt to add Ms Gannuschkina to the Murakami girls' complaints? (That the suspect is stalking and harassing her by mentioning her name in his political commentaries without her consent.) Very likely! Gannuschkina, although an anti-Establishment liberal, could be easily instructed to join American women's fight against "violence against women"! With the Murakami girls and Ms Gannuschkina both validating the SS women's claims for Sledkom, the Russians can at least temporarily prolong their life in the ICJ. Then, 3:26 PM, the SS women send in a volunteer from Toronto to look up the front page of the suspect's website.

This is evidently a very special report to Sledkom now that another semi-famous Russian woman is on board. There are then only three visits until 11:30 PM – probably to report on the suspect’s plagiarism and impersonation: the SS women could be conferencing – perhaps telling their horror stories about the suspect to the Russian mathematician. Then, almost 1 AM, the suspect posts on PP the links to all his “Third ICJ Trial” chapters. (Is he remotely controlled by Homeland Security to do this?) 3:44 AM, a volunteer from Edmonton, Alberta, looks up “The Cheney Plan” (37). Does this mean that, in addition to the Russian mathematician, the Boss’ family has also cut in again to help prolong the Russians’ life and prevent the CIA from reactivating the previous ICJ trial?

There will be far fewer activities today on the suspect’s website. 9:56 AM, a volunteer looks up “Timeline-02-14” using the search terms “a man cut up a child’s head”: this is obviously one of those dirty tricks again which the Russians always pull during an emergency when some temporary evidence is needed right away suggesting that there might be some truth in the Homeland Security warning about the suspect. 11:50 AM, a volunteer from Peru looks up Shizuka’s portrait. 6:48 PM, another volunteer from Bangkok looks up Shizuka’s portrait. That is, Shizuka has started on another round of sabotage.¹¹

5:02 AM, the suspect posts two videos of Zizek’s lectures on his Facebook. 5:15 AM, Dmitry is looking at the suspect’s new Facebook postings. However, the SS women also immediately get wind of the suspect’s new postings. A big fuss ensued. By noon, 12 volunteers have checked the suspect’s Facebook. It would seem that the SS women, desperate to “save Russia”, are now planning to recruit Zizek to the Murakami girls’ complaint (!). Thus, wherever Zizek is today, Homeland Security, under Russian command, would have found him, and promptly sent him the Homeland Security warning about the suspect. However, just as in the case of Prof. Fraser, we really have to wonder whether Zizek would have time for this kind of thing (a schizophrenic and misogynist/ racist “stalker” of famous people and intellectuals). 11 The recording of the suspect’s afternoon in Elysee: “elyseedaniel_4_15_17_234PM.MP3”: with Daniel. Again, the suspect complains about the rent. The problem with his high school diploma. 12:00, back to work. 37:20, with Daniel. “Popular reason”. And he goes on and on about this. Daniel has read Deleuze’s *Capitalism and Schizophrenia*. Nick Land is Deleuzian. 51:30, back inside. 1:45:10, with Daniel. Daniel was bar-hopping last night. Degrowth and Convivialism. The suspect’s revolution: not only to protect the environment but also to prevent dummification. The erosion of communicative actions. The suspect: “By treating people like the dumb shit that they are, you’ll actually make them smarter.” Althusser. Daniel: Marxism has never been scientific. Daniel explains Badiou’s Communist Hypothesis. Daniel’s critique of dialectical materialism (how it really is just idealism). 2:18:30, back inside. (Reviewed until 2:31:00).

the SS women and explains to him how he tracks visits to his Facebook.¹²

17.04 M

The SS women will be busy today gathering testimonies about the suspect's plagiarism or his theft of his family members' drawings. 2:52 PM, a volunteer from Colombia looks up "Timeline-02-14". Is he brainstorming how to make a more effective report about the suspect's delusions about Karin? Then, 3:50 PM, MSSGDP. Just what Dr P has been waiting for! 8:24 PM, a visit to the PP post from Manchester Township. It's the second visit after the suspect has posted the new note. (More of the suspect's "delusions" about his women victims' going after him.)

Take note of the SS women's break between 8:30 and 10:30 PM. They are probably discussing the "harassment" incident with Dr P. As noted, they are quite happy about this "harassment" because, this time, the incident is caught on video. (The incident happened in the same location today, near Chrysalis.) It is favorable evidence with the potential of *forcing* law enforcement on the American side to substantiate the women's claims about the suspect. Dr P will go to another LAPD division tomorrow and will be able to successfully file a stalking claim against the suspect with a LAPD detective. And of course she will bring the Homeland Security warning with her! The stalking claim, when Homeland Security CO chief shall intercept it into the ICJ, might save Russia!

Finally, 1:51 AM, the SS women send in a volunteer from Cameroon to copy the suspect's chapter (ancestorcult.html) onto Microsoft Word. The SS women are forging evidence of the suspect's plagiarism because – when filing their stalking claim against the suspect tomorrow, the women must also present proof that the suspect does plagiarize, since the purpose of everything is to force law enforcement to validate the Homeland Security warning about the suspect.¹³

18.04 T (Dr P's stalking claim)

And so, this morning, Dr P must have opened a case with a LAPD detective reminding him that the suspect is also on Homeland Security's warning system and adding that Sledkom is also currently investigating him for stalking famous Russian women. With a new case opened, the SS women begin

filing false reports about the suspect's plagiarism to the LAPD detective. This will continue all day long. 11:14 AM, a volunteer from Gallipoli, Italy, looks up Oliver's painting. Probably a complaint on behalf of Oliver. 2:10 PM, LC Services sends the suspect a job offer via ProZ (tataidc.co.in, Delhi, India). The SS women are probably still hoping to use the "David Chin" document as evidence against the suspect in their new case. The SS women then take a break between 3 and 6 PM. Are they busy talking to the LAPD detective about their new stalking claim against the suspect? It's probably also for this reason that there are far fewer activities on the suspect's website after 6 PM. On 7:31 PM, Karin sends everyone in her meetup a notice about the cancelation of the meetup event on 24 April. Then, after 12 AM, the SS women resume operation and mobilize their volunteers to file several more false reports about the suspect's plagiarism. (It's probably Ekaterina who is directing the operation right now.)

19.04 W

Some time between 5 PM last night and 5 PM today, SDW would post something new on her blog: "Stephen Shellen and the CIA-directed energy targeting". Clearly, with Dr P opening a new stalking case, SDW wants to join in and so posts something on her blog in the hope that law enforcement surveillance might pick up the suspect's cyberstalking of her. Meanwhile, Kiersten, today or tomorrow, would retweet something that looks like it came from a child: "Update on Fox News Lineup". It would *seem* that she is trying to trick the suspect into clicking on it so that law enforcement can intercept him "stalking" minors on the Internet. If so, she is evidently instructed by the Russians (via Homeland Security CO chief) to do this. If the SS women can succeed in making the suspect into a pedophile suspect, then law enforcement will be obliged to observe their "victim confidentiality" (law enforcement will be absolutely prohibited from looking at any contents which the suspect has produced). The Russian side will then definitely win this ICJ trial.

The SS women will then spend the whole day filing false reports about the suspect's plagiarism and his delusional comments about his women victims' going after him on the PP post. On 2:21 AM, a volunteer from Berlin even files a false report about "actorinir2.pdf". Then, after 3 AM, after they have filed so many false reports about the suspect's plagiarism, the SS women decide to submit a bundle of concrete evidences. From 3:07 to 3:35 AM, they use VeriCite to demonstrate that xper.html, sacrifice.html, elementarystructures20.htm, and elementarystructures.htm are all stolen or plagiarized contents. Then, from 4:29 to 4:43 AM, they use VeriCite to demonstrate that representation.htm, oppressionofwomen1.htm, evolution.htm, and healer.htm are all stolen or plagiarized contents.¹⁴

20.04 Thu

The SS women will continue today to mobilize their volunteers to make false reports about the suspect's plagiarism. Especially, chapters and webpage underlined in red in yesterday's VeriCite activities. 8:10 AM, a volunteer from Padua, Italy, looks up the suspect's portrait of Sahra. Did Sahra's party (*Die Linke*) suddenly agree to join the Murakami girls' complaint in order to save Russia? Then, something unusual: from 11:45 to 11:53 AM, a volunteer from Istanbul, Turkey, looks up

chinesepatriarchy220.html two times and then “Timeline-02-14” one time. The SS women usually assign only one specific task to each of their volunteers: if the volunteer is required to report on a chapter in *A Thermodynamic Interpretation of History*, he or she would *not* be charged with reporting on a chapter from *The Secret History*. It seems that this Istanbul volunteer crosses boundaries here because two chapters from these different domains somehow show up together under the same search terms. In any case, just more testimonies to confirm for the new detective that the Homeland Security warning about the suspect is all correct. Then, 7:08 PM, a volunteer from Alger, Michigan, looks up “PC Books”. For the same purpose.

Then, something strange. From 8:56 to 9 PM, the Missionary Sisters call the suspect, specifying that they shall tomorrow meet with him in the garden outside the Temple rather than inside the Visitors’ Center.¹⁵ What is going on? In the past two days, the CIA and the law enforcement officers here in Los Angeles must be discussing how to dismiss Dr P’s evidence (the video of MSSGDP) – since national security itself is at stake, in addition to their absolute loathing of this brainless “licensed psychologist”. Somehow they have found legal technicalities in the video and, early evening today, the LAPD detective informs Dr P that the video couldn’t quite be used as evidence of any “stalking” because it’s not clear whether the Homeland Security warning about the suspect is correct. (Without the warning with its demonic portrayal of the suspect, there is of course no “stalking”, since a single prank call hardly qualifies for anything.) Dr P must be furious: because she is a “safety fanatic” (subscribes to extreme “safetyism”: the government must mobilize all available resources to correct the slightest discomfort one experiences at the moment while the damage one does to others is nothing to be concerned with), she can’t understand why law enforcement wouldn’t take the prank call to her office seriously – regardless of what the CIA’s agenda is. Therefore, together with Homeland Security CO chief, she calls up the Missionary Sisters and asks them to meet with the suspect in an open space instead for their lesson tomorrow. Mr Homeland Security CO chief is going to remotely control the suspect to talk about his business with the SS women, and Dr P wants the Sisters to record it as evidence for the detective. She is counting on the fact that the suspect will confess his motivation for MSSGDP, and all of that will then confirm for the detective that the suspect does indeed harbor delusions about his women victims’ going after him and will stalk them in response – just as the Homeland Security warning has claimed. But, in order for the SS women to use the Sisters’ recording as evidence, the confession must be recorded in an open space where there is the possibility of its being overheard by third parties.

12:17 AM, a volunteer from Japan looks up “writings_visitors.pdf”. This is perhaps a report on behalf of Karin and her bunch (how the suspect was suffering from delusions about their going after him back in 2008 because, just like now, he kept misreading the visits to his website). Then, around 1 AM, the suspect posts a new message on the PP forum. This time it is merely a short explanation of Trump’s unspoken agenda, with a link to “The Cheney Plan”.¹⁶ Within an hour, 2:08 AM, a volunteer from Winchester, UK, looks up the message and clicks on the link and explores the suspect’s website for a few minutes. (He clicks on the “Marine” document and then looks through the suspect’s drawings.) Presumably, he is called upon by Ekaterina to compose a testimony to the effect that the suspect *is*

again developing bizarre delusions about famous people – here, Trump again. Then, past 3 AM, the suspect posts three of Arlie Hochschild’s lectures on his Facebook. There he goes again!¹⁷ 3:35 AM, a second volunteer from the UK is instructed to check on the suspect’s new message and explore his past messages on the PP forum. He then clicks on one of his links, “Summary-2016”. Again, he’s called upon to submit to the LAPD detective false reports about the suspect’s conformity to the Homeland Security warning in preparation for the big day tomorrow. 3:15 AM, another volunteer looks up the suspect’s new messages on his Facebook. Wow! Maybe the suspect is now developing an obsession with, and stalking, Prof. Hochschild! Another victim that *can* be recruited! Then, 3:52 AM, a third volunteer from Albuquerque, New Mexico, looks up the suspect’s new message on the PP forum and clicks on the link “The Cheney Plan”. The same thing.

21.04 F (major operation)

5:52 AM, a fourth volunteer from Morristown, Nova Scotia, looks up the suspect’s new message on the PP post and clicks on the link (“The Cheney Plan”). The same thing. 8:39 AM, a fifth volunteer from Cardington, Ohio, looks up the suspect’s new message on the PP forum and then looks through all his past messages. 8:52 AM, a second volunteer is looking through the suspect’s new posts on his Facebook. Then, 9:52 AM, Kiersten changes her profile picture on her Facebook. This is a sign that she, along with the rest of the SS women, is very much looking forward to the operation this afternoon – that she is sure that the operation will be successful and that law enforcement will be forced to validate her and her gang as “victims” of the suspect’s “stalking” and “terrorism” (by validating the Homeland Security warning in question). Kiersten’s new profile picture is that of herself touched up with Photoshop. She has no idea how ugly she looks in her picture!

Then, between 10 and 10:30 AM, four more volunteers look up the suspect’s new postings on his Facebook. 12:41 PM, another volunteer from Lancaster, New York, looks up the suspect’s new postings on his Facebook. Seven volunteers in total have so far checked the suspect’s Facebook. Evidently, the SS women are now trying to contact Prof. Hochschild. Then, all activities on the suspect’s website and Facebook cease between 2:20 and 6:30 PM. The SS women have left home and are meeting with the LAPD detective and the Missionary Sisters to plan for the operation this late afternoon. Meanwhile the suspect, now in Elysee, has a conversation with Wes on the phone on 2:20 PM.

Conversation with Wes (21.04.2017)

The suspect is connected with Wes from 3:14:00 onward. (1) The suspect talks about what he has realized has happened between 9 and 17 November last year: the Trump team has become a party to the ICJ trial on 12 November. Also how the CIA has removed the suspect’s terrorist status. The Baltimore Lawyer was in Washington DC on 14 November to talk to the Secret Service. Trump was truly malicious. People will sell the suspect to the lions for two dollars. The Russians would be happy to hear all this new discovery on the suspect’s part: the CIA’s countersuit will soon become a “conspiracy”. (2) How the suspect has developed a new, ambiguous feeling toward Trump: he now hates Trump because Trump has sought to destroy him; but he loves Trump because Trump makes the liberals miserable.

17 Did the Russians order Homeland Security CO chief to remotely control the suspect to do this?

Should he be pro-Trump or not? The Russians will definitely seize upon this confession as evidence to confirm in the ICJ that there is some truth after all in Homeland Security's false profile of the suspect. This will help prolong their life in the ICJ! (3) The US Establishment has now completely controlled Trump. (4) Now the suspect understands that he has actually something to do with Trump's "Russia connection". It is Trump himself who has made himself into an enemy of the CIA. (5) The Russians have screwed up the suspect's future plan: this is yet another example of how cheap he is to other people. He saved the Russians' life! (6) Zizek's book *Living in the End Time*. The suspect wants to become the best suspect he can be, he has a lot of talent for being a suspect, he even violates the law which stipulates that a terrorist is not allowed to know he is a terrorist. Zizek's reflection on India's caste system – the "Untouchables". The suspect's position in American society is precisely the "Untouchable". He has believed he performs an indispensable function in American society by playing the role of a "criminal suspect" and "mental patient" – but he has actually no part in American society, he is merely the excrement of American society, he is *not* an indispensable element, but the shit which the system necessarily produces but which it must exclude. (7) Marine Le Pen. The current ICJ trial is to replace evidences only, to show that he didn't conspire with Russia back in the first round. Putin's permanent command over Erdogan, Sarkozy, Cheney, etc. Again, all this is erroneous scenario. It is the Russians' evidence that he is indeed insane. The suspect continues: Marine Le Pen has to win by herself, not via him. She won't win the second round. Erdogan did all these offensive things because he is under Putin's command. This is half-true: Erdogan is indeed under Putin's command, but this is because there is a second case in the ICJ, not because of any judgment from the previous ICJ trial. The suspect then continues his erroneous understanding: Cheney will lose all his influence when everybody knows he is under Russian command. More evidence of the suspect's insanity to prolong the Russians' life in the ICJ! Soon the US Establishment will find out that the previous ICJ trial has never disappeared. Wrong! Everyone already knows that it has never disappeared! (8) About the Green Party's connection with the SS women. The suspect is sick of this parallel reality: what's going on inside him (he has no intention to harm people) has no relationship to people's reaction toward him (everybody thinks him dangerous). He needs to harass the SS women in order to minimize this parallel reality, but he doesn't have the time. His violation of the SS women's privacy through reconstructing their operations on him is too weak an instance of harassment. (9) Baudrillard. The problem with his application for the University of Jena: his high school diploma. (10) Did Prof. Jaeggi get a warning that he's a terrorist? (More like a "schizophrenic terrorist".) Whatever happened to the warning which Homeland Security had broadcast about him in Frankfurt back in 2008? (11) The suspect is a very special terrorist suspect: he doesn't do anything terrorist but spends his whole time trying to figure out *why* he is a terrorist, he is a "self-referential terrorist suspect". Wes disputes this, explaining: "I can talk" is self-referential. Or "cogito". A suspect can be a suspect without trying to figure out why he is a suspect. Zizek's paradox (Kant). Hochschild's new book, *Strangers in Their Own Land*.¹⁸ The suspect is in the same dilemma as the poor whites. Why he is pro-Trump when it's against his interests.

The suspect hangs up with Wes on 3:33 PM. He then chats with Daniel.¹⁹ 4:31 PM, Sister MLDND

And so, from 5:05 to 5:40 PM, the suspect is meeting with the Missionary Sisters. As planned, the Sisters choose the garden outside the Temple in order to enable the SS women to legally record their conversation. However, even though the suspect does indeed talk about the SS women's gang-stalking of him with the Sisters for the first time, he mentions nothing about MSSGDP. The SS women, monitoring the conversation in a hidden location, didn't find half of the evidence they were looking for. While what the suspect did say can perhaps serve as evidence that he does indeed suffer from delusions about their going after him (that the Homeland Security warning about him is correct), the SS women perhaps think they need to edit the recording in order to strengthen their evidence – this would however only enable the detective in question to catch them committing fraud. (It's likely that the TMU detectives have again instructed the detective in question to play the same old trick: to also place monitoring devices in the garden area so that, should the SS women ever make false reports, there will be evidence.) The SS women thus decide that they need to resume recruiting Prof. Hochschild to their complaint process. 6:44 PM, the eighth volunteer checks on the suspect's Facebook. The SS women then discuss the matter throughout the whole night. Between 8 PM and 3 AM, they send merely four volunteers to look up images on the suspect's website as part of their decoy operation. 3:20 AM, the suspect posts the video "The Taking of Patty Hearst" on his Facebook. 3:39 AM, a first (and only) volunteer checks up on the suspect's new message on his Facebook. Presumably the SS women won't

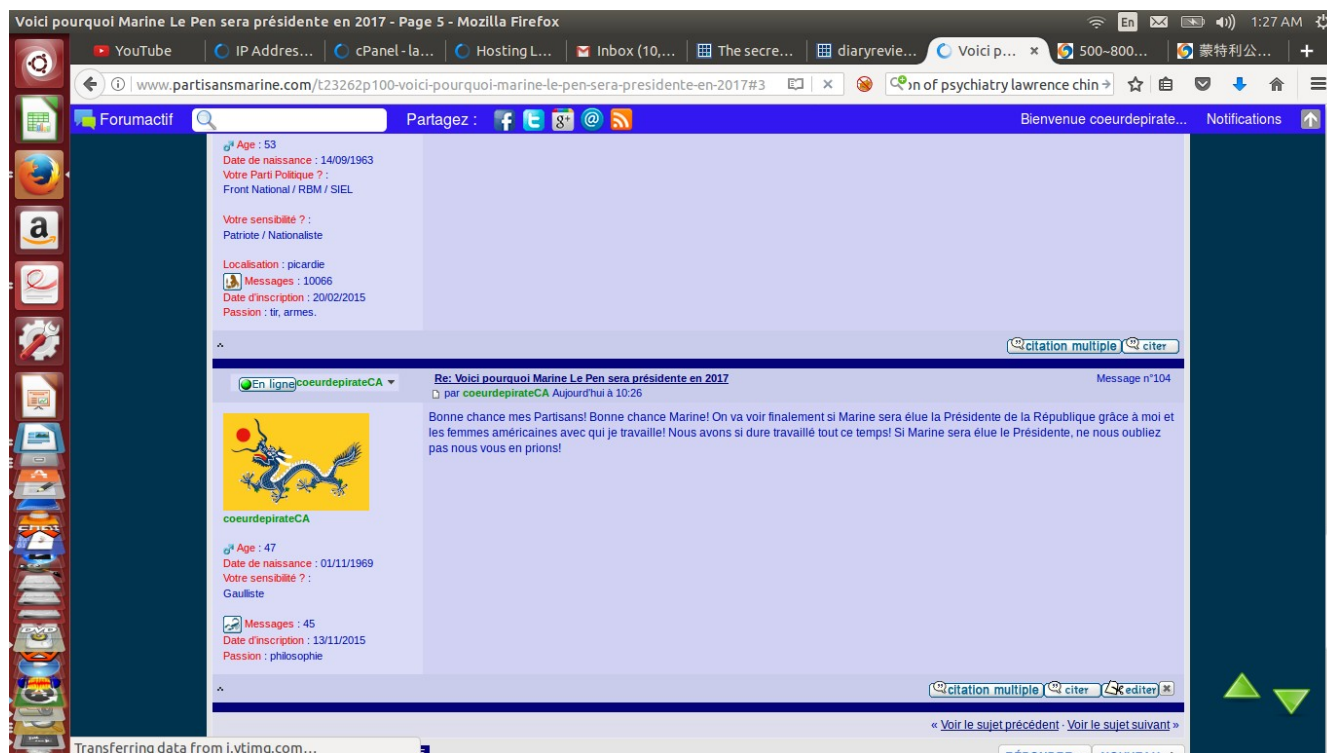
loves somebody, one doesn't love that somebody because of her qualities and attributes, but because of the role she plays in one's symbolic economy: such is *objet petit a*. (Think about this: the SS women are obsessed with the suspect – hate him – not because of any attributes he possesses or things he has done, but because of the role he *is supposed to play* in their symbolic economy – in the stories they tell themselves about themselves, in their conception of themselves as "victims".) Stalinism: the most dangerous place is within. 40:00, the conversation is over. 56:10, Sister MLDND calls, and the suspect chats with Daniel briefly before leaving. 1:24:50, the suspect has arrived at the Visitors' Center, and the Sisters come out to greet him. The Sisters notice the wounds on his arm. The suspect expresses his regret again about renting a room, and even about taking the exam. The suspect is angry with God that he has failed his test. "It's God's fault." 1:33:00, the suspect begins talking about the "group of women going after him", how he is a suspect, how they are "expert witnesses" about him, how they have reported him to the Green Party, and how they have created a large online group devoted to gossiping about him. Then how the Green Party people were afraid of him the last time. The other Sister: "What can you do to stop it?" Then she suggests that the suspect stop using the Internet. Then she starts to question whether the suspect can be sure of all this if he can't see the Secret Facebook Group. (Of course she has already believed the SS women's lies that the suspect has imagined up their going after him due to schizophrenia.) Then she has problems in understanding the fact that the SS women are impersonating him online irrespective of whether he uses the Internet or not. (Of course: once she has believed the SS women's lies, her capacity for thinking just fades away.) Sister MLDND then asks the suspect why he likes this temple. The other Sister explains how she overcame bullying through faith in the Heavenly Father. The suspect expresses his worry that the SS women are creating fake versions of his writings and drawings in order to convince people he plagiarizes and so on. 1:51:00, why did God make him fail his test? 1:53:10, the suspect reads off the Scripture. Sister MLDND: "God can do anything except change our 'agency'...God can't change people's being mean to you..." 1:56:10, she shows the suspect another video. (**The gardener cuts down the big bush and, although the bush complains, later on it'll thank the gardener for cutting him down** – what? Is this a secret message from the Invisible Hand about what he plans to do to the suspect?) The suspect: "But I want to go to Germany... I hope God is not..." Sister MLDND: "When you make plans, God laughs..." 2:00:20, she has the suspect read another passage. "You'll never be happy in your life if you have everything your way." 2:07:00, the meeting over, the suspect soon bids the Sisters goodbye.

think that they need to recruit Patty Hearst too!

22.04 S

Whatever has happened – whether the SS women did edit the recording from yesterday late afternoon – the detective in question must have informed Dr P that her case is dismissed – there is no “stalking” – because he didn’t deem the Homeland Security warning to be correct. Hence, 9:24 AM, a volunteer from Aliquippa, Pennsylvania, looks up “Prelude-17D”. The SS women are here evidently trying to submit another testimony to persuade the detective that the suspect does indeed suffer from delusions about their going after him (that, hence, the Homeland Security warning is all correct). Then, more reports about the suspect’s plagiarism, for the same purpose (to save Dr P’s case). Then, 1:11 PM, when the suspect calls up Tyan, she says she is not going to the Green Party meeting tomorrow and encourages him to join the “March for Science” that is going on right now in downtown Los Angeles. Then, 3 PM or so, MSSGDP (HM). It’s evidently due to Dr P’s impasse that the Monkey (under order from the Russians and Homeland Security CO chief) has remotely controlled the suspect to do this: now Dr P has more materials to present to the detective: “See! He’s doing it again! How dare you dismiss my case!” Then, 4:04 PM, a volunteer from Osaka, Japan, looks up linkex.html. Is this to add another famous female to Dr P’s case/ the Murakami girls’ complaint? Could it be Akino Arai or Kyoko Koizumi? (Namely, the suspect has linked to their websites, which constitutes “stalking” and signifies “danger to them” given the Homeland Security warning.) It’s perhaps because the detective’s dismissal of Dr P’s case is now unfavorable evidence in the ICJ that the Russians have thus needed the SS women to recruit more “victims” to the Murakami girls’ case. If so, the SS women could in fact be falling into more traps: any Japanese woman they recruit will only end up becoming a mole inside their organization to sabotage their complaint process. Then, 6:40 PM, a Harrow (UK) volunteer looks up the PP post. 6:55 PM, he clicks on “Predue-G3H” from there. What is this about? Are the SS women thinking about enlisting the Trump’s team’s help again not knowing that Trump has already switched side and will only sabotage their case? Or did they think that this chapter is better evidence that the suspect does indeed suffer from delusions about their going after him? Then, after 7 PM, the SS women’s operation slows down. Not surprisingly: given Dr P’s disaster today, the SS women need to conference. The Russians, seeing that they are in trouble again, order Homeland Security CO chief to remotely control the suspect to do something to save them. Thus, 1:26 AM, the suspect, in view of the commencement of voting in France, posts a short message on Partisans:

The suspect then adds a new signature, “I can talk’ is self-referential”. In any case, the suspect’s message *could* be construed in the ICJ as evidence of the suspect’s insanity since the matter at stake in the ICJ is not really about “Marine” but rather about Russia’s conviction both in the current and in the previous ICJ trial. Then, 2:58 AM, the suspect posts another short message on PP:

“To be more precise: these women’s claim is (1) Theoph continues to harbor bizarre schizophrenic delusion about these women being part of some government conspiracy to go after him; (2) Theoph, because he doesn’t know that it’s all his delusions, continues to act on these delusions by harassing them and writing about their going after him on internet forums, such as here (including me, Theoph’s alter ego), and on his website: <http://www.enlightenment1998.com/1.html>; and (3) these women are consequently very frightened of Theoph and are therefore going to law enforcement or hiring private security.”

The message is inconsequential. The suspect is trying to announce his awareness that he is currently under law enforcement investigation (again). Then, 4:25 AM, the same Albuquerque volunteer seen on 21 April discovers “Prelude-H2J” for the first time while checking over the suspect’s new PP post and clicking on the link to 1.html.

4:40 AM, the Homeland Security troller “egypt” (Moscow, Idaho) also comes to take a look.

As you shall see, this “egypt” will play such an important role in the SS women’s operation later on. Now, both the Albuquerque volunteer and “egypt” are here to help save Russia and its allies by reporting the suspect to law enforcement. (Perhaps to Sledkom, now that more famous Japanese women have joined the Murakami girls’ case – since, under the CIA’s strict order, the LAPD detective in question will certainly ignore any further complaints about the suspect.) In any case, the Russians have now evidence to enable them to temporarily stay afloat in the ICJ.

Note that, today, Marine Le Pen and Emmanuel Macron enter the first round of presidential election – the former under the dark shadow of a possible ICJ judgment convicting her of conspiring with a bunch of terrorists to harm the United States.

Throughout the morning, the SS women continue to mobilize volunteers to report to Sledkom (the new case?) how the suspect did plagiarize and spill out his delusions about his women victims on PP. 11:38 AM, a volunteer from Athens, Greece, looks up Oliver’s painting of Goddess Athena. 12 PM, a volunteer from Fayetteville, Arkansas, looks up “PC Books”. 12:06 PM, a volunteer from Oxford, Ohio, looks up “Prelude-17D”. From 2 to 2:30 PM, two more visits to the suspect’s feminism chapters. Clearly the SS women are reconstituting the Homeland Security warning for Sledkom now that there are new victims to continue the Murakami girls’ case: plagiarism, delusions about the SS women, racism and misogyny, misogynist ideology, and theft of other people’s drawings and paintings.

2:30 PM, the suspect is at the Green Party meeting in Grand Park. Upon seeing him, Mariam gives him a hug: it certainly doesn’t seem as if she had ever been affected by the SS women’s warning about him in any way. (Perhaps the Russians have ordered Homeland Security to instruct Mariam to do this in order to not raise the suspect’s suspicion.) 4:30 PM, the suspect goes to eat with Rose and the other Greens. Again, the congenial atmosphere indicates that nobody here has known anything about the suspect’s status as a schizophrenic terrorist stalker or his business with the SS women. This makes him doubt that the SS women have ever connected up with the Green Party. (What has happened is most likely that only Kenneth, Mariam, and Jill were alerted about the suspect on 12 March.)

The suspect arrives home around 9 PM. He begins to have an inkling of what happened on Friday afternoon. 9:42 PM, he calls up Sister MLDND to inform her that, because he is a criminal suspect under investigation, he will not come to the Mormon church anymore. (Note that Sister MLDND is doing everything she can to conceal from him her work as a government informant against him.)²⁰

1:43 AM, somebody is checking over the suspect's Facebook. A volunteer? Looking for more evidence for the new case? As for Dr P: even though the Homeland Security warning is presumably saved for the time being with the help of more famous Japanese women, she is absolutely furious with the LAPD detective. As has been repeatedly pointed out, she has the highest self-esteem imaginable, sees herself as an extremely important person, will not tolerate anyone causing her the slightest discomfort, and expects law enforcement officers to think likewise and work the hardest to neutralize anybody's attempt to discomfort her in the slightest fashion. The massive suffering she has caused to other people is never any of her concern because she has grown up convinced that she's some sort of genius (having had no experience with truly intelligent people) and the American feminist climate has already persuaded her that she is not by accident such a genius but that, born a woman, she is inherently superior to men while men, although naturally intellectually inferior, have always unfairly devalued women. She has the greatest sense of entitlement thus not simply because she has wrongly believed in her genius but also because, when law enforcement refuses to cater to her wish, she sees it as another instance of this male-dominated society's unjust devaluation of women. (Meanwhile, the harm she does to others does not conjure up any similar ideology.) The blatant manner in which the LAPD detective has ignored her complaint – even given indisputable evidence – is virtually unbelievable to her and must have shocked her to her bones: this invalidation of her supreme importance in the universe is experienced by her as some sort of wanton disregard of an undeniable objective fact such as when one looks into sunrise and yet asserts “The sun rises up from the West”. Unable to swallow the injustice, she will call up AT&T tomorrow to disconnect both her home phone number and her office number.²¹

the SS women's claim is that he suffers from schizophrenic delusions about their going after him and that they are consequently frightened and so have law enforcement come onto him, and how, because the meeting took place in the garden, an open space, they and their law enforcement partners have secretly recorded him and the Sisters. Strangely, Sister MLDND jumps up: “You've recorded our conversation?” The suspect is stunned, and explains it again, and Sister MLDND accuses the suspect again. (She's now quite agitated.) The suspect then explains how, because he is always a criminal suspect under investigation, he shouldn't come to such a high-class church as the Mormon church. Sister MLDND repeatedly asks the suspect how he knows what has happened, and the suspect repeatedly says: “I don't need to explain how I know.” On the one hand, it would seem that Sister MLDND is wondering how the suspect could have known about the intelligence operation on him and, on the other, it's not clear whether her mental confusion is due to the fact that the SS women have already warned her that the suspect records all his conversations. (Perhaps she's stunned that the suspect could have known that she has recorded the conversation per the SS women's instruction and so, to deflect the suspect's suspicion, she decides to accuse the suspect instead.) But, at the end, she does ask: for the sake of her and her companion's safety, the suspect should explain how he could have known that the SS women were recording them on Friday. The suspect explains that the SS women are working with Homeland Security and have access to all his phone conversations. Then again how he should go to a church for convicts rather than a high-class church like the Mormon church. (Note the suspect's mistaken impression that he has been under investigation for 4 years: it's much longer than that!)

12:24 PM, a volunteer looks up the PP post: the suspect's delusion about his women victims' going after him. 4:54 PM, another volunteer from Morgan Hill, California, looks up "bun9.pdf" – evidently another testimony about the suspect's violation of Angelica's privacy. (Even though the person named in "bun9.pdf", "Emilio", has nothing to do with her.) For the rest of the time, the SS women are simply collecting more testimonies about the suspect's plagiarism to submit to Sledkom. Note that, 7:10 PM, the suspect uploads a revision of "Suffering Woman" to his website. He has added in SDW's name. Then, 8:30 PM, MSSGDP: the suspect has discovered that Dr P has disconnected her home's landline.

The SS women seem to be busy from 6 PM onward. There are no activities on the suspect's website between 9 PM and 12:20 AM. It would seem that the same thing has happened again: the new victims (Akino and Kyoko?) have turned out to be Japanese intelligence's informants inside the SS women's organization and have been sabotaging their new case with Sledkom by secretly submitting evidence of the SS women's fraud. (Note that his OS has been updated to 10.12.4.)

Then, 9:32 AM, the SS women send in a volunteer from Zurich, Switzerland, to make a false report about "softappende.pdf". Is this a complaint on behalf of Ms Gannuschkina again? And so it appears that Sledkom has done away with the Japanese victims in favor of the Russian victims (who can simply be told by the SVR as to what to say). 7 minutes later, 9:39 AM, the Zurich volunteer comes to the index page. Then, 29 seconds later, he clicks on the suspect's web gallery. Sledkom has now enough testimonies to enable them to hold onto the Homeland Security warning at least in Ms Gannuschkina's

case! Then, 4:08 PM, after more false reports about the suspect's plagiarism, a volunteer from Chicago looks up "marion.jpg" on Bing's images. Marion has now added herself to Ms Gannuschkina's case in order to help Russia definitively pass through its crisis in the ICJ.²² 4:46 PM, another volunteer is looking up "dr-paradis.jpg" on Facebook (only the message). Did Marie also agree to join Ms Gannuschkina's case in order to help save Russia? The SS women then spend the rest of the day continuing to make false reports about the suspect's plagiarism.

28.04 F

9:02 AM, the SS women send in a volunteer from Hong Kong to look up "shizuka1988.jpg". This is indication that, to prevent the SS women from ever reviving their case with Sledkom using other victims, the CIA has tricked them into asking Shizuka to help in again by making complaints for herself too (not letting them know that Shizuka is in fact here to sabotage their case behind their back).

12 PM, Kiersten tweets: "Precision Medicine".

Then, 4:21 PM, the Russians order Homeland Security to instruct the SS women to ask their volunteer to search for "Timeline-Part-III" with the search terms "Opera Mini Persin 2014". This dirty old trick is indication that, now that Shizuka is involved, Sledkom is having problems in validating the Homeland Security warning again, so that the Russians would need this sort of bullshit as evidence in the ICJ to suggest that there might after all be some truth in the SS women's assertions about the suspect. Now that the ICJ judgment is temporarily suspended, both sides fight on to enter evidences into the ICJ.

6:10 AM, a volunteer from Trenton, Michigan, looks up the PP post.

8:01 AM, a volunteer from Gloucester, UK, looks up the PP post.

9:53 AM, the Trenton volunteer clicks on “Prelude-17D” on the PP post.

9:55 AM, the Trenton volunteer clicks on 1.html on the PP post.

9:56 AM, did the Trenton volunteer click on 61812-39.png?

12:13 PM, a volunteer in Turkey looks up “Timeline-02-14”. All these are certainly Homeland Security trolls whom the Russians have ordered to submit testimonies to Sledkom confirming the SS women’s lies that the suspect does suffer from bizarre delusions about his women victims’ going after him.

12:27 PM, a volunteer from Denver, North Carolina, looks up “shizuka1988.jpg” and “shizukadetail.jpg”. This is perhaps the CIA’s response: instructing Shizuka to submit to Sledkom again her testimony that the suspect has never harassed her and that the SS women are in fact committing fraud in this way and that. Again, the purpose is to paralyze Sledkom. All this is not totally devastating for the Russians – since their strategy is now simply to wait for the suspect to reconstruct what has happened. Conversation with Wes (29.04.2017)

(1) His email to Dr Ross from last night. (2) Their conversation last week might have revived the ICJ trial thanks to his new “love and hate” attitude toward Trump. (3) The SS women’s excitement last Friday: their access to his conversations and monitoring of his session with the Missionary Sisters. They were trying to convince law enforcement that they were his victims. About the Green Party meeting. Were the Missionary Sisters recruited by Homeland Security and the Secret Service at the same time? Strangely, Wes asks: “Are the Sisters good-looking?” “Average.” Why does Wes ask this irrelevant question? Did Homeland Security CO chief instruct the Sisters to falsely report to law enforcement saying the suspect has sexually harassed them so that law enforcement is now instructing Wes to gather evidence from the suspect that he didn’t sexually harass them? This is very likely the case: the Russians will do anything to prolong their life in the ICJ. The suspect continues: the Mormon church is the pinnacle of Protestantism. He feels bad for the Sisters: they have spent a lot of energy on him, and yet in the end nothing comes out of it. The suspect is quite modest here: the Missionary

I’ll be so famous because a group of women are going after me, and this story will become the new Don Quijote.” And Daniel joins in. And then a female. 4:07:50, the suspect leaves.

Sisters have been instructed by Homeland Security CO chief to sabotage him in every possible way – he should hardly feel sorry for them. (4) The “Myth of Sisyphus” really refers to the SS women. (Right!) (5) The suspect’s new, speedier method of reconstruction. (6) His paper for Humboldt: it is still too long. (7) His doubt about going to Germany. (8) The strange echo on Wes’ side. (9) If the Russians keep trying knowing that they can’t win, that it’s all a waste of time, then there is something he doesn’t know about. He is quite right: he doesn’t know that it has all started because the Russians need to prevent the CIA from reactivating the previous ICJ trial. Wes however gives a wrong reason to distract him: “When you have invested a lot of time in something, it has become difficult to simply walk away.” The suspect knows that this is not the answer.²⁴ He assumes wrongly that the Russians are trying to replace evidences for the previous ICJ trial. How is France going to become Russia’s ally? Marine is not going to win. (10) The anti-psychiatry movement. (11) The trial is revived, but the SS women have lost out on their law enforcement case... post. The third time today. Another false report to Sledkom. 9:12 PM, a volunteer from Charlotte, North Carolina, looks up “singer.jpg”. The second time today. Again, right after the SS women’s massive effort, Shizuka comes in to sabotage everything by testifying to Sledkom that the SS women are committing fraud. Then, 1:07 AM, another volunteer from Nevada, Iowa, looks up the PP post for the fourth time. The final report to Sledkom today about the suspect’s delusions about his women victims’ going after him.

7:20 AM, a volunteer from Singapore looks up Shizuka’s portrait: Shizuka continues her sabotage. Then, the SS women are busy between 9 and 11:30 AM: there are no activities on the suspect’s website. Are they conferencing with Sledkom about the state of their complaint?

1:58 PM, another volunteer from Markham, Ontario, looks up Shizuka’s portrait. Another attempt to paralyze Sledkom’s investigation.

Afterwards, more false reports about the suspect’s plagiarism. And three more visits to the PP post. Sledkom continues to get contradictory reports about the suspect and is completely paralyzed in this strange case.
