**The third International Court of Justice trial over the suspect**

**XV**

**1 May – 2 June, 2017**

The following summarizes the Secret Society women's operation against the suspect and the associated International Court of Justice trial from 1 May to 2 June, 2017.

The names of persons follow the convention established in the previous chapters. The Secret Society women consist of (as of May, 2017): Karin (the German Lady, K), Angelica (Angelina, G), Kiersten (J), SDW (Maura, M), and Dr P (Petterson), along with auxiliary members like the Long Keng volunteer ("Glenn Chen"?). For brevity's sake, the "Secret Society women" shall continue to be referred to simply as the "SS women" in the following narrative.

The following is a rewrite of the original "The third ICJ trial, XV", originally written in November and December 2017. The original version, with file name "prelude\_GR\_Fr.pdf (last dated 12.12.2021), can still be found in the same folder.

In the previous chapters we have seen how the CIA skillfully employs informants (principally Shizuka) to sabotage the Secret Society women's case with Sledkom so that, the more these women try to help Russia, the more Russia is being convicted, and how these dumb women never have any idea why they couldn't succeed.

By now, the most decisive factor in this ICJ trial is the suspect's continual reconstruction of the preceding course of events. The suspect had finished his reconstruction of the course of events up till 5 June, 2016, on 14 April, 2017. He uploaded the latest document (Prelude-H2J) on that day, and, from 15 April onward, had begun reconstructing the course of events for November 2016. By this month, he would be working on the course of events in October and September, 2016. This would eventually become "Prelude Grand" in June, 2017. This is of utmost importance since it is the reconstruction contained in "Prelude Grand" – documenting the CIA's countersuit against Russia in the ICJ in September 2016 – which will save Russia by making the countersuit into a terrorist conspiracy against Russia. We have seen that the Russians are trying their best to hold out and buy time in late April, 2017. From Homeland Security's surveillance on the suspect they can see that the suspect is currently reconstructing the events of crucial importance. They have only to wait a little longer. The CIA is of course also observing the suspect and knows therefore that it is increasingly unlikely that the US Establishment's original plan against Russia will work out.

The climax in the following episode must be the game-change which the suspect has effected on the Partisans' forum on 17 May. This has released the Russians from the impossible project to make the Secret Society women look like credible witnesses to US law enforcement. The second climax, however, must be the "false flag stalking" occurring on the night of 28 May. Although it is not the first time that the Secret Society women and Homeland Security CO chief would together remotely control the suspect, via the electronic chips inside his brain, to "stalk" Dr P in order to enable Dr P to force the police to validate her as a "victim of stalking", this latest episode is certainly the most bizarre. One of the suspect's favorite Germans, Thea Dorn, has recently reflected on the danger of technology in her latest novel, *Die Unglückseligen*. Here, the female protagonist, a molecular biologist named Johanna, experiments with human genome in order to artificially extend human life-span, only to encounter then a real case of "immortal man" from the late 1700s. Thea, with her interests in *Krimis* as well, should perhaps be called upon to examine this real case about the danger and absurdity of technological progress. The Secret Society women have certainly evaporated all meaning from the concept "victim" with their access to the most advanced technology of the current era to stage their own victimization.

#### KEY EPISODES

**1 May**, the SS women add Oliver to their new complaint with Sledkom. They continue to make false reports about the suspect's plagiarism enabling Sledkom to hold onto the Homeland Security warning.

**2 May**, the SS women have begun concocting a new story about how the suspect has stolen Oliver's painting. False reports about the suspect's plagiarism continue.

**3 May**, Geert's party rejoins the complaint process to help the SS women's case with Sledkom. The SS women forge more evidences of the suspect's plagiarism.

**4 May**, the SS women submit their final reports, along with their new story about Oliver's painting, to Sledkom hoping to enable the latter to hold onto the Homeland Security warning. The Russians pull the same old trick to temporarily stay the ICJ judgment.

**5 May**, the battle to enable Sledkom to hold onto the Homeland Security warning continues: the SS women create the first of a series of fake websites (<http://mhjqh.com>) to frame the suspect for plagiarism. **The suspect talks to Wes:** Homeland Security CO chief's remote control of the suspect can now be made into part of his terrorist conspiracy against Russia and the CIA.

**6 May**, Shizuka continues her sabotaging and, 3:50 AM, the SS women send in Glenn Chen (?) to check on the suspect's Facebook.

**7 May**, Macron beats Marine in France's election. The SS women work extensively on their new story about Oliver's painting in order to help Sledkom hold onto the Homeland Security warning.

**8 May**, the same DGSE official intervenes to save the Homeland Security warning and the French diplomatic service begins accepting the SS women's reports about the suspect: the

Russians are temporarily saved in the ICJ.

**9 May**, the Russians attempt to reinforce the French diplomatic mission's case by adding Marine and Marion as additional victims.

**10 May**, the CIA, to counter Marine's and Marion's involvement (the involvement of the French diplomatic mission), gets Trump to become involved and manipulates the SS women to recruit somebody working in Fox News to complain to Sledkom on behalf of Trump. Trump has pretty much destroyed the women's case. The ICJ is ready to re-issue its judgment convicting Russia and its allies. The SS women are mystified. (And yet Trump meets with Lavrov and Kislyak in the White House.)

**11 May**, **the suspect tells Wes all about his wrong scenarios**, and the ICJ temporarily stays its judgment. (While law enforcement on the US side continues to dismiss the Homeland Security warning, Sledkom and the French have validated it.) Late night, the SS women send in volunteers to check on the suspect's Facebook looking for new evidence.

**12 May**, the Boss' family cuts in to save the Homeland Security warning. Major commotion over the suspect's Facebook. The split in opinion between the US and the Russian/ French authorities in regard to the Homeland Security warning.

**13 May**, the commotion over the suspect's Facebook continues.

**14 May**, the Boss' family cuts in again.

**15 May**, to break the deadlock in the ICJ in Russia's favor, the SS women spend the whole afternoon mobilizing their volunteers to complain to Google about the suspect's website. To no avail.

**16 May**, the SS women conference in the afternoon ("How to save Russia's case"). **Past midnight, the suspect posts a decisive message on the Partisans' forum.**

**17 May**, **the Russians introduce the new evidence in the ICJ establishing suspicion that the suspect is working with the CIA and the SS women to convict Russia and its allies.** The Russians change their strategy and wait for the suspect's reconstruction instead (as evidence of "conspiracy").

**18 May**, late afternoon, to complain about the US law enforcement's dismissal of the Homeland Security warning, Angelica personally complains with her volunteers to her friend in the Homeland Security headquarters (?). Getting nowhere, the SS women call up Shizuka again.

**19 May**, the SS women recruit a psychiatrist from Legacy Health Care System in Portland, Oregon. The Long Keng volunteer and the Camden volunteer both make their special reports.

**20 May**, the SS women want to enlist Marion, Marine, and President Macron in their new complaint to the unknown law enforcement agency (DHS?).

**21 May**, the suspect meets with Tyan and Dmitry. The unknown law enforcement authority (DHS?) dismisses the SS women's claim. **(Is Glenn Chen staying with Kiersten tonight?)**

**22 May**, the SS women prepare for the next round of complaint. They re-enlist the help of Shizuka and Oliver.

**23 May**, the SS women complain to the Department of Homeland Security headquarters (again?). Their complaint is rejected.

**24 May**, the SS women complain to the same Homeland Security officer again. Rejected

again. They proceed to complain to Microsoft. Rejected. **4 AM, Kiersten brainstorms together with Glenn Chen.**

**25 May, the suspect speaks to Wes in the afternoon.** The Russians obtain the second evidence of the conspiracy against them. The SS women are preparing a new complaint after Homeland Security CO chief has communicated to them that he can remotely control the suspect to “stalk” Dr P on the 28<sup>th</sup>.

**26 May,** the SS women continue to brainstorm or prepare their new complaint.

**27 May,** the SS women continue to prepare their new complaint. Kiersten includes two special complaints in regard to herself (B16 and C5L). After midnight, the suspect sends off his anonymous letter. **The Russians obtain the third evidence.**

**28 May,** the Russians enter their new argument in the ICJ. Conspiracy established against Russia. 10:20 PM, DRPH. The SS women have the LAPD detective watch the “stalking” in real time. Dr P forces the detective to reopen her stalking case against the suspect.

**29 May,** the suspect exposes Dr P’s argument on the PP forum. Dr P enlists the help of the Partisans and Oliver to her latest complaint about the suspect. The SS women might also be working with the French diplomatic mission again.

**30 May,** Dr P concentrates on discrediting the suspect’s exposure of her argument on the PP forum. She adds to her psychoanalysis for the LAPD detective the old argument that the suspect hates white women so much that he compares them to chimpanzees.

**31 May,** Shizuka continues to sabotage Dr P’s new stalking case while the SS women continue to report on the suspect’s plagiarism.

**1 June, the suspect talks to Wes on the phone.** The fourth evidence: the Russians are completing their case. The detective too. Dr P enlists the help of the same psychiatrist from Legacy Health Care System in her current psychoanalysis to the detective.

**2 June,** the LAPD detective informs the SS women that he has dismissed their stalking claim. The SS women are in shock, and spend the whole day conferencing.

## May, 2017

### 01.05 M

Today all day long, the SS women will continue to mobilize their volunteers to submit false reports about the suspect’s plagiarism to Sledkom. (Again, Sledkom need these testimonies in order to rule that there is at least some truth in the Homeland Security warning and thus hold onto it.) 12:39 PM, a volunteer from Czechia also looks up Oliver’s painting of Goddess Athena. Another complaint on behalf of Oliver? The SS women also seem to have a focus on “Yu trains his soldiers...” today. (Three visits.) In the afternoon, while the suspect is working in Bru-Coffee, he realizes that Homeland Security CO chief, back in November 2013, had actually obtained an authorization from the ICJ to torture him from the control center in order to make him conform to the SS women’s false profile of him.

### 02.05 T

Today, the SS women will continue throughout the day to submit false reports about the suspect’s

plagiarism to Sledkom. 1:29 PM, a volunteer from Mesa, Arizona, looks up Shizuka's portrait. Thus, Shizuka has also continued to submit her evidence of the SS women's fraud to Sledkom. Three visits to the PP post today. 12:03 AM, a volunteer from Hyderabad, India, looks up "redathena5.jpg". Are the SS women now concocting a new story about how the suspect has stolen Oliver's painting?

### **03.05 W**

5:08 AM, a volunteer from Pretoria, South Africa – a member of the South African Group seen last summer – forges evidence of the suspect's plagiarism ("biopower2.jpg"). Throughout the day, the SS women will continue to mobilize their volunteers to offer false testimonies about the suspect's plagiarism to Sledkom. 6:32 and 6:44 AM, a volunteer from Puy-en-Valay, France – presumably a Partisan – looks up Kelly's and Geert's portraits. Did Geert's party agree to join in again in order to help save Russia? 9:18 AM, a very special visitor: lightspeed.irvna.sbcglobal.net, Torrance, California,

This volunteer is very nearby. Does she have something to do with the Torrance volunteer seen on 18 September last year? In any case, another report to Sledkom certifying that the suspect does harbor bizarre delusions about his women victims' going after him. 1:12 PM, another volunteer, a school teacher in Bellingham, Washington, looks up "redathena5.jpg": the SS women are presumably gathering more testimonies confirming their new story about the suspect's theft of Oliver's painting. Three visits to the PP post in total today (including the special visit). All in all, thanks to all these new reports, Sledkom can continue to hold onto Homeland Security's warning about the suspect.

### **04.05 Thu**

8:37 AM, a volunteer from Helsinki looks up Oliver's painting of Goddess Athena. 12:46 PM, a Cologne volunteer looks up the suspect's original painting. 7:52 PM, a Columbia, Missouri, volunteer does the same. These visits indicate that the SS women are today submitting their final new story about Oliver's painting to Sledkom hoping to enable the latter to have a better reason to hold onto the Homeland Security warning. Meanwhile, volunteers continue to submit more testimonies about the suspect's plagiarism. 4:29 AM, a volunteer looks up "TL-02-14" with the search terms "How many study types education in pdf". Clearly, the Russians are pulling the same old dirty trick again – another bullshit search to generate suspicion that there might be some truth in the SS women's made-up stories about the suspect after all – all because Shizuka's counter-testimonies to Sledkom are such bad evidence in the ICJ.

### **05.05 F**

In order to enable Sledkom to have a permanent reason to hold onto the Homeland Security warning,

the SS women and Homeland Security CO chief have decided on a radical solution: they would create a fake website specialized in plagiarism and attribute it to the suspect. The website created is <http://mhjqh.com>. The SS women, together with Homeland Security CO chief, seem to have found a computer hacker in Turkey who has ties to Germany to do the task. The Turkish hacker buys up a domain with Cronon (a German webhosting service) early this morning and begins working on its content. This is officially a Homeland Security operation. This fake website will disappear by late June.

5:45 AM, a volunteer from Gurgaon, India, looks up Shizuka's portrait. Presumably it's simply Shizuka continuing her sabotage.<sup>1</sup> Meanwhile, the SS women are mobilizing volunteers to file false reports about the suspect's plagiarism like crazy. Then, 2:20 PM, the suspect, while in Kinkos, talks to Wes on the phone.

### **Conversation with Wes (05.05.2017)**

The suspect is connected with Wes on 4:30 in the recording. (1) The mistakes he has made and the money he has wasted while applying for universities in Germany. The suspect is sometimes so smart and sometimes so dumb.<sup>2</sup> (2) The suspect has made progress in understanding why he is a terrorist: Mr Homeland Security CO chief obtained the ICJ's authorization back in November 2013 to torture him as a way to make him conform to everybody's expectation of him. Although the suspect has figured out this most important fact, his scenario is still mostly incorrect: Mr Homeland Security CO chief was never arrested and the Republicans weren't so involved back in November 2013. The suspect is correct, however, that it is his "false report" on 26 September 2013 which has provided the basis for the bizarre authorization from the ICJ.<sup>3</sup> There ensues a discussion about how the suspect could have been held responsible for "making a false report" on 26 September 2013. The whole problem goes back to the CIA's argument in November 2007 that the suspect is a fake terrorist who uses his status as a fake terrorist to harm the US. BOL's hesitation back in January 2008. The suspect needs to go argue with BOL about his terrorist status. This status can be disputed because his understanding of whether he could harm the United States was so vague. How could he have been considered to have used his fake terrorist status to do harm when everyone was trying to convince him that he had merely imagined up

1 In the original version, our conclusion is thusly: "Since India is Russia's ally, this volunteer is probably instructed to find ways to report on the suspect's harassment of Shizuka in a way which can circumvent all the damaging testimonies which Shizuka has submitted behind the SS women's back. So far, Shizuka has done the greatest amount of damage to the SS women's case with law enforcement agencies; the Russians must neutralize her informant work first in order to stay alive a little longer. Once Shizuka's testimonies are circumvented, Sledkom can dump away their previous investigation of the suspect and start a new round of investigation afresh. The new case on behalf of the Murakami girls and the SS women can presumably last one whole month before it is destroyed by the CIA's moles inside the SS women's organization – long enough for the suspect to completely reconstruct the episode of [the] US countersuit." Today we reject the assumption that Russia would have the right to discredit the United States' informants.

We cannot be sure that this is correct. We'll speculate on what exactly the suspect has accomplished today later on.

the whole thing? An analogy: is it a real gun or a fake gun? Wes however maintains that the suspect *was* “guilty as charged” if he did *believe* it was a real gun. It didn’t matter what other people told him. So, according to Wes, the ICJ judgment in November 2007 and in November 2013 was valid. The CIA will certainly welcome this discussion because Homeland Security CO chief’s argument on 6 November 2013 was precisely that, as long as the suspect *believed* he would believe the suspect’s nonsense, the nonsense should count as “false report” even though it was really a joke which nobody else could possibly have taken seriously. The CIA can now declare Homeland Security CO chief’s argument to be part of his terrorist conspiracy against them.<sup>4</sup> (3) Marine will lose. The current ICJ trial will be hung, just like the previous two trials. What would be the judgment from the previous ICJ trial? Macron can’t be impeached. So maybe the Russians will have to wait another five years. (All bullshit.) (4) The suspect’s application for Humboldt University: it’s all a waste of money. (5) The suspect’s supposed insanity and genius are actually different facets of the same process: before he figures out the right scenario, he has to go through many wrong scenarios, which makes him look insane. After going through the wrong scenarios, however, the suspect will figure out the right scenario, which will make him look like a genius. Because people have already decided that Lawrence is crazy, they will focus their attention only on the early phase of the process where he looks crazy. (Excellent analysis.) (6) Hannah Arendt’s misgiving about Adorno’s authoritarian personality. Her lecture “Power and Authority”. (7) Why the suspect couldn’t get a job. (8) How much Wes gets paid. (9) Simone Weil.

As noted, although the suspect has made important progress in understanding why he is a terrorist (not just on 30.12.2007, but also on 06.11.2013), the CIA cannot quite use this realization to declare the remote control of the suspect to be part of Homeland Security’s terrorist conspiracy against them – as long as the Russians still have ground to affirm that the Homeland Security warning about the suspect is sort of correct. In fact, since the ICJ judgment still stands that the remote control of the suspect should not be made known to anyone, the Russians can still use the suspect’s realization today as evidence of his insanity. (In fact, Sledkom must have promptly concluded from this conversation that the suspect is indeed schizophrenic.) However, you never know what the Invisible Hand has accomplished with the suspect’s latest realization today in the second, secret ICJ trial which he is running with BOL.<sup>5</sup>

Daniel’s writing process, and how the suspect has had to repeatedly rewrite his story. Daniel goes on and on about the article he’s writing. Daniel has corresponded with Brandon, but Brandon wouldn’t remember him. Then they chat about Peru. (Daniel was from Lima’s upper-middle class neighborhood.) 3:01:40, back inside. 3:07:00, the suspect continues his chat with Nick and Daniel for a minute or so. At

Meanwhile, the SS women continue their operation. 6:22 PM, they use VeriCite to prove that epilogue225.html is plagiarized. Throughout the day, a volunteer using Google proxy also checks the PP post four times – evidently to submit a special testimony to Sledkom explaining how the suspect indeed suffers from delusions about his women victims’ going after him. Then, the SS women seem to be busy between 9 PM and 12 AM. They are evidently busy with law enforcement agencies on both sides of the Pacific given the bundle of new evidences they have compiled today to “save Russia”. 12:36 AM, a volunteer seems to be checking over Bing’s cache of drawLA.html. Evidently to report about the suspect’s harassment of all these famous people.

## 06.05 S

10:06 AM, a volunteer from Paris looks up Shizuka’s portrait. Is this a Partisan? In any case, Shizuka must have continued her sabotage.<sup>6</sup> Then, more false reports about the suspect’s plagiarism. 4:40 PM, the same strange visit from Osaka, Japan, to linkex.html.<sup>7</sup>

From 5 PM onward, the suspect is in Elysee and he would chat briefly with Daniel again.<sup>8</sup> From 6 to

the end of the recording, the suspect leaves.

Then, throughout the night, the SS women continue to mobilize their volunteers to falsely report on the suspect's plagiarism and theft of other people's artworks. 12:33 AM, the suspect posts on his Facebook the latest report about Pawn Storm – along with “man.jpg” and “glass2.jpg” as trackers. 3:52 AM, a little more than three hours after the suspect has posted on his Facebook, the SS women have discovered the new posting. They send in a Santa Ana volunteer (social.res.rr.com) to check over these new Facebook postings – again, could this be the “Long Keng volunteer” and/ or “Glenn Chen from Santa Ana”?<sup>9</sup>

## 07.05 Sun

Today, if you recall, is voting day in France – the second round. Emmanuel Macron will beat Marine Le Pen. And there is the “Macron Leak”. Is this the work of the Russians? (Either the SVR or the GRU.)

8:26 AM, a volunteer from Berlin looks up kmupreface21.pdf. This would create a lot of confusion for the suspect. He wonders whether this is an informant trying to pass along a secret message to him from the CIA. (Namely, the quotation from Camus' *L'Étranger* in the beginning of the document.) He can't be sure. This is possible since the CIA is quite aware that they might not be able to convict Russia before the suspect reconstructs the episode of the US countersuit. (The purpose of the secret message would then be to discourage the suspect, again, from reconstructing.) 11:26 AM, another volunteer from New York City looks up “redathena5.jpg”. Apparently the SS women have decided to re-submit the new story they have concocted about Oliver's painting. 1:46 PM, Kiersten updates her profile picture on her Facebook. This is her first time since her last update on 21 April. It's a picture of Jupiter (which she imagines herself to be in her astrological worldview). This suggests that she is quite excited today because she is quite sure that her gang will finally succeed in this new case. 2:12 PM, another volunteer from Montclair, New Jersey, looks up “redathena5.jpg”. 9:31 PM, a volunteer from Fairfield, California, looks up Oliver's painting of Goddess Athena. The SS women thus continue to compile testimonies to support their new story about Oliver's painting. They then compile more testimonies about the suspect's plagiarism, theft of drawings from his family members, and expressing delusions

about his women victims on the PP post.<sup>10</sup>

Past midnight, the suspect would post several videos from Macron's electoral victory on his Facebook.

### **08.05 M**

Throughout the whole day, the SS women will continue to mobilize their volunteers to submit false testimonies about the suspect's plagiarism to Sledkom. 11:14 AM, a volunteer from Hong Kong looks up Shizuka's portrait. Shizuka's sabotages continues. Between 11:55 AM and 12 PM, Dmitry is checking the suspect's Facebook. This is irrelevant to the SS women's campaign. However, 12:13 PM, the SS women did send in a first volunteer to check on the suspect's Facebook – their first "discovery" of the suspect's new "obsession" with Macron and his wife. The news spreads quickly. Between 12:29 and 1:08 PM, three more volunteers come to check out the suspect's Facebook. We can easily imagine what's going on. As usual, whenever the previous ICJ trial is at risk of being reactivated (since Sledkom has difficulty in holding onto the Homeland Security warning about the suspect), the French will cut in: thanks to the same DGSE official's intervention, the French diplomatic mission is now accepting the SS women's volunteers' reports and taking the Homeland Security warning very seriously – thus temporarily ensuring the Russian intelligence's survival in the ICJ.

Then, 1:40 and 2:40 PM, two visits to the PP post. The SS women are presumably scrambling to report that the suspect has also developed bizarre delusions about his women victims (who are listed as *victimes extraordinaires* on the said Homeland Security warning). However, 2:51 PM, a second volunteer of the day (from Islington, UK) looks up Shizuka's portrait. Now Shizuka is sent in to sabotage the SS women's latest case with the French! Then, 3:43 and 4:12 PM, the fifth and sixth volunteer check out the suspect's Facebook (Macron). And the reports to the French continue about the suspect's plagiarism. 7:17 PM, a third volunteer of the day (from Montreal) looks up Shizuka's portrait: more sabotages. 10:17 PM, Dmitry is checking the suspect's Facebook again.

### **09.05 T**

Today, Trump will fire the FBI director Comey.

This afternoon, 3:21 PM, the suspect will post a new message on AVFM to leave behind a link to his website as well as to the PP post.<sup>11</sup> He will immediately receive two negative replies. Did the Russians

This has scared Tyan. In reality, Tyan doesn't know anything about the SS women's business. (Even when the SS women connected up with the Green Party on 12 March, Tyan was apparently left out of the game and was never informed about it.) The suspect then finds Annukka at her home, and obtains from her the important information that this "Glenn Chen" is actually MaryAnne's best friend.<sup>12</sup>

The SS women will continue the whole day to mobilize their volunteers to file false testimonies about the suspect's plagiarism to both Sledkom and the French diplomatic protection service. 1:58 PM, another volunteer checks up on the suspect's Facebook (Macron). 8:26 PM, a second volunteer of the day is checking on the suspect's Facebook. 11:57 PM, the suspect posts a new message on the PP post expressing his (erroneous) understanding of the SS women's latest operation.<sup>13</sup> 2:17 AM, a volunteer from Fort Lauderdale, Florida, looks up the portraits of Marion, Eva, Marine, and President Xi: another special report to Sledkom and the French about how the suspect, after becoming obsessed with public figures, would make drawings of them to harass them. From 3:30 AM onward, the suspect, worried about his posting of the Macron videos last night on his Facebook, posts several more videos about Marion and Marine (notably, Marine's concession speech). He doesn't know that it is the Russians who

(The Russians evidently want to reinforce the current case with more public figures.) 5:09 AM, a volunteer from Louisville, Kentucky, looks up the suspect's external links page. This is evidently to report to the French as well as Sledkom that the suspect has indeed harassed Marine and Marion by linking to their websites.

## 10.05 W

Since last night, the suspect would have difficulty in loading Marion's website after clicking on the link on his own website. Is Homeland Security trying to "protect" Marion? Or did the CIA block him in order to prevent the Russians and the French from recruiting Marion to the current case?

Early morning today, given the involvement of Marion and Marine in the new case with the French diplomatic mission, the CIA asks the Trump team to get involved on *their* side. Given the pressure which the US Establishment has exerted on him lately, Trump dares not defy the order. (The timing is rather ironic since Trump will host Lavrov and Kislyak in the White House precisely today.) The Trump team contacts the SS women saying they would like to be involved. The CIA then instructs one of their moles inside the SS women's organization to link the women up with somebody working in Fox News in New York City. The Fox News volunteer would complain to Sledkom and the French on Trump team's behalf. The SS women must be jubilant, unaware that they are falling into another trap. 6:01 AM, the Fox News volunteer does a Google search "Lawrence C Chin Donald Trump". The first document to pop up on search results is "Prelude-D4K". However, the volunteer clicks on the second one:

Kiersten has become a closet "Trump lover" because

She stops at the 23 October posting – precisely the first message which the suspect has posted about her fake review of herself at Dating Psychos! She has spent more than two minutes on the suspect’s Facebook looking for it. She thus makes her report to Sledkom, the French diplomatic protection service, and the US law enforcement agency working on the Trump team’s complaint (how the suspect first posted an obscene message about her on Dating Psychos and then blamed her for it)– unaware that the Trump team is merely helping the US law enforcement agency in question to run a sting operation. Then, 12:38 PM, or three minutes later, the SS women ask a volunteer from Gransbury, Texas, to check on the PP post:

(Are they checking to see if the suspect’s Facebook has been banned already?) 12:30 AM, a volunteer in Sweden clicks on the suspect’s link (“The Cheney Plan”) on his new message about Trump’s agenda on PP. The SS women are evidently brainstorming with their volunteers as to how to make a more effective case about the suspect’s terrorist harassment of Donald Trump.

**11.05 Thu**

Now that the Trump team has sabotaged their case yesterday without their knowing, the SS women today continue to mobilize volunteers to submit more false reports about the suspect's plagiarism to all parties here in the US, there in France, and over there in Russia. On 1:44 and 2:15 PM, a volunteer is on the suspect's Facebook seemingly examining all the Marion and Macron videos which the suspect has posted in the past few days. Now the suspect would talk to Wes on 2:26 PM while busy with his errands in downtown Los Angeles. (He has mailed out all the documents necessary for his application process with the German universities.)

### **Conversation with Wes (11.05.2017):**

(1) The suspect expresses his scenario (half-true, half-false) about the SS women's operation since Monday. Tyan's discovery of his videos on Macron and so on. The SS women contacted the French diplomatic service on Monday. On Tuesday they reported that the suspect has harassed Marine, Marion, and others. On Wednesday, they found somebody in Fox News to complain on behalf of Trump. The suspect's new update on the SS women's operations on the PP post. Then, the SS women checked to discover that his Facebook, his website, and the PP post had all not been banned. (2) The suspect has scared Tyan with his phone call. He is quite excited that he can frighten people to death without doing anything – thanks to the preconception which the SS women have instilled in everybody's head. (3) He might have discovered the Long Keng volunteer's true identity on Monday night. This illustrates the discrepancy between his reconstruction and reality. (4) The suspect's wrong (totally wrong) scenario: Tyan is very involved because she is told that, if Homeland Security's profile of him can be proved correct, the ICJ will issue a judgment requiring compensation for the Green Party as well. The same story with the Science March. Even Tyan is using him as a patsy, this can't be legal under international laws. (5) The suspect's new hypothesis about what the Russians are doing. If, in this current ICJ trial, he helps them, they will get an ICJ judgment requiring the US to help the National Front to come to power. If he doesn't, they can get an ICJ judgment from the previous ICJ trial to the same effect. This hypothesis also explains the US action. Macron will get a ICJ judgment... (6) In order for Marine to come to power, something has to happen to change people's perception of reality. The FN will have to change its ideology to appeal to a larger segment of the population, and Macron will also orchestrate some event in order to drive people to a rightwing perception... (7) If the US loses France through an ICJ judgment from the previous ICJ trial, they will get a chance to respond, hence they prefer it. (8) The suspect shouldn't focus on going to universities in Germany, he should devote the rest of his life to the SS women... Going after people is very time-consuming, he has the potential for becoming a great philosopher, but he also has immense potential for becoming an amazing stalking suspect, he can't do two things at the same time... He can be happy by being either the best or the worst, but if he can't become the best because of the SS women's operation, he shall be content with being the worst... It's a lot easier to become the worst... People hate him more than they hate Hitler. He scares people to death, and yet he has never done anything, and so he will never get arrested, he can thus enjoy frightening people without repercussion, it's a good life... It's better than being nobody... But he will regret letting his philosophic talent rot... This knowledge... The problem is that his talents go in opposite directions.... If he becomes a great philosopher, he wouldn't regret never becoming the greatest stalking suspect... It's so easy to become a terrorist suspect, because the SS women have done all the work for him... (9)

The SS women have derived their conception about his wanting to hurt whoever he loves from women's experience with rape.

3:30 PM, just when the suspect hangs up with Wes, two more volunteers come to check on the suspect's Facebook (the very top). Evidently, the SS women's volunteers are struggling to make more complaints about the suspect's obsession with, and harassment of, public figures. 5:11 PM, a volunteer from Incheon, South Korea, looks up "TL-VI-34". Another testimony about the suspect's delusions about his women victims' going after him. 8:33 PM, the fourth volunteer of the day is checking on the suspect's Facebook. The same thing. Meanwhile, reports about the suspect's plagiarism or decoy visits continue throughout the night.

It's evidently the case that, mystified as to why the US law enforcement agency suddenly wants to dismiss the Homeland Security warning again (thanks to the Trump team's sabotage behind the SS women's back yesterday), Dr P is staying with Homeland Security CO chief this afternoon together analyzing the suspect's conversation with Wes while the rest of the SS women are asking their volunteers to brainstorm or to file more false testimonies. Dr P would again use her title as a "licensed psychologist" to certify for all parties that the wrong scenarios that fill up the suspect's conversation today are proofs that he suffers from schizophrenia and so is extremely dangerous. Just when Sledkom and the French are stuck with the Trump team's damaging testimony from yesterday – so that the ICJ is again ready to issue its judgment convicting Russia and its allies – both parties have counter-evidence and thus immediately use Dr P's guarantees as justification for validating the Homeland Security warning. Thus, the suspect's conversation today, full of wrong scenarios, has again saved the Russian side temporarily in the ICJ. It's now up to the CIA to argue again that Dr P doesn't know what she is talking about, that the suspect's wrong scenarios are not signs of insanity but simply incorrect inferences based on insufficient evidences. (The US law enforcement has thus used the same argument again to dismiss the Homeland Security warning: making wrong inferences is not the same thing as being delusional.) It's thus again deadlock in the ICJ.

Now, late night, the suspect will discover an email from the University of Jena informing him that the university has accepted him to its master program in philosophy. Then, 1:41 AM, he posts a news item about Russia on his Facebook (along with "philo2.jpg"). 1:47 AM, a volunteer has already discovered the new post and checked on it. From 2 to 2:15 AM, two more volunteers have come to check on the suspect's Facebook. The SS women and their volunteers, because of their failure with US law enforcement today, are in a state of frenzy and constantly looking out for any movements on the suspect's part which it might be possible for them to use as evidence suggesting that Homeland Security is all right about him.

### **12.05 F (commotion on Facebook)**

5:15 AM, a volunteer from Bandung, Indonesia, looks up "The Cheney Plan". Is it the case that, in the midst of stalemate between the Russians and the CIA, the Boss' family has decided to intervene again by filing another complaint with the US law enforcement agency? (Namely, countering the Trump team.) Then, 6:34 AM, the fourth volunteer checks on the suspect's Facebook. 7:42 AM, a volunteer

from Riga, Latvia, looks up the PP post. Perhaps Ekaterina's friend is here making another report about the suspect's delusions about his women victims' going after him. 8:53 AM, a volunteer from Suwon-Si, South Korea, looks up Shizuka's portrait. No! Shizuka is sabotaging the SS women's case again! 9:17 AM, a volunteer from San Antonio, Texas, looks up the portraits of Eva, Marine, Marion, Geert, and President Xi. Clearly, positive reports from three countries to Sledkom and the French in support of the Homeland Security warning about the suspect. 12:09 PM, the fifth volunteer looks up the suspect's Facebook. 3:27 PM, the sixth. 4:09 PM, Dmitry is checking the suspect's Facebook. From 4 to 8 PM, nine more volunteers check out the suspect's Facebook – 15 volunteers in total since the suspect posted his new message last night on his Facebook. Everyone is clamoring: "The Homeland Security warning is correct! He really does develop delusions about famous people and his women victims!" (Namely, in opposition to the testimonies from the Trump team and Shizuka.) On the other hand, there are virtually no visits to the suspect's website during this period. 8:59 PM, the second visit to the PP post today. 10:18 PM, the 16<sup>th</sup> volunteer checks out the suspect's Facebook. 10:31 PM, a volunteer from Elya, Estonia, looks up "sci.pdf". Ekaterina's friend? Probably another testimony about the suspect's misogyny toward white women (in confirmation of the Homeland Security warning). 11:22 PM, the 17<sup>th</sup> volunteer – he is from Moscow – looks up the suspect's Facebook. 11:46 PM, the suspect posts a LA Times Opinion ("African Americans are far more likely to get falsely convicted") on his Facebook. Did the Russians order Homeland Security to remotely control him to do this?<sup>14</sup> 1:05 AM, a volunteer from Bangkok looks up Shizuka's portrait – the second time today. (Shizuka's sabotage.) 4:43 AM, the 17<sup>th</sup> volunteer checks up on the suspect's Facebook. The big commotion today about the suspect's Facebook is presumably directed toward the suspect's supposed obsession with famous people.

### **13.05 S (commotion on Facebook, the 2<sup>nd</sup> day)**

Today, with the split in opinion between the US law enforcement agency on the one hand and Sledkom and the French diplomatic mission on the other, the SS women will resume their effort to compile false testimonies about the suspect's plagiarism. 12:10 PM, a volunteer is checking the suspect's Facebook: it's the second check since the suspect posted something new last night. 3:19 PM, Dmitry invites the suspect to the Russian festival next Saturday (Plummer Park). 4:18 PM, Dmitry is checking the suspect's website. From now on, the SS women will resume mobilizing their volunteers to report on the suspect's Facebook. From 4:21 to 9:10 PM, 10 volunteers come to check on the suspect's Facebook while very few volunteers come to the suspect's website: the second day of commotion over the suspect's Facebook. 6:44 PM – are the Russians pulling the same dirty trick again? Or is it not even a real visit? (Google Cloud, Scottown, Ohio.)

The SS women then spend the rest of the night continuing to compile testimonies about the suspect's plagiarism.

#### **14.05 Sun**

Today, Macron will be sworn into office.

5:46 AM, a volunteer from Winnipeg, Manitoba, looks up "The Cheney Plan". Another attempt by the Boss' family to save the Russians in the ICJ (to counter the Trump team's damaging testimony with the US law enforcement agency)? 8:11 AM, a volunteer from Istanbul looks up TL-02-14. Another testimony about the suspect's delusions about his women victims. 12:18 PM, a visit to the PP post from Ireland: the same thing. 1:49 PM, bun9.pdf. Presumably another false report about the suspect's violation of Angelica's privacy. (Even though this "Emilio" has in fact nothing to do with her.) 2:17 PM, a volunteer from Minneapolis looks up Frauke's portrait: the suspect's obsession with famous people. 8:14 PM, a volunteer is looking at the suspect's Facebook. For the whole day, the SS women will continue to mobilize their volunteers to compile false reports about the suspect's plagiarism.

Past midnight, the suspect will have a video chat with Dmitry. He has finally come to terms with his mistake: the visitor to his Facebook and website whom he has thought to be Tyan is actually Dmitry. His whole scenario about what is going on right now has collapsed. 1:30 AM, he posts on PP: "Sorry, the above information about the women's business with the French (10 May 2017, 02:57:50 AM) isn't quite correct. I misread the information from my source. Please disregard it." 4:34 AM, the same volunteer from Sweden who checked out the suspect's link ("The Cheney Plan") on 12:30 AM, 11 May, comes to check out the suspect's new message. It seems that the SS women are perfecting their story about the suspect's harassment of Trump (not knowing that this is counter-productive). Soon, the women decide to forge evidence again. 4:46 AM, they ask their volunteer from the University of Würzburg to forge evidence proving that the suspect has indeed violated intellectual property rights with his "languagechangecycle.gif". Their effort today suggests that the split in opinion between the US and the Russian/ French authorities has continued. Now, because the suspect's log will be archived around noon on the 15<sup>th</sup>, it would seem to him that Angelica has herself visited the suspect's website between 12 and 5 AM this early morning to personally make false reports about it.

#### **15.05 M**

5 AM, a volunteer is checking the suspect's Facebook. Does the commotion continue? 6:27 AM, a volunteer from India (unless it's a proxy) is checking 1.html. Another special report to Sledkom and the French? Then, 11:40 AM, after many decoys, a volunteer from Roslindale, Massachusetts, looks up TL-02-14. Another report about the suspect's delusions about his women victims? 1:12 PM, a second volunteer of the day is checking the suspect's Facebook. Now, a new operation. Given their failure so far to convince law enforcement on the US side, the SS women seem to have decided to complain to Google's headquarters about the suspect's website. Any action taken by Google, they reckon, could break the deadlock in the ICJ in favor of the Russians. 1:17 PM, a Google personnel from the Google headquarters in Seattle searches for the suspect's website, arriving at thermh1.html and, from there,

within a minute, clicking on epilogue.html. He would come back to thermh1.html on 1:22 PM. 1:28 PM, a volunteer from Gloucester, UK, looks up the PP post. 2:04 PM, another volunteer from Chetwynd, British Columbia, looks up the PP-184178 post. 2:14 PM, the Google personnel comes to thermh1.html again, and, 2:25 PM, clicks on epilogue.html again. Another volunteer from Washington University then looks up “foodcycle.jpg” on 2:25 PM and a volunteer from Japan visits zhuangzi.html on 3:06 PM. These volunteers are evidently all providing testimonies to Google. Thus, the SS women and their volunteers might be talking to Google from 1 to 3:30 PM complaining about the suspect’s harassment of his women victims with his delusions on his Facebook, the PP forum, and his own website – plus his persistent violation of intellectual property laws and utterance of his particular brand of misogynist ideology. If only Google accepts their complaint, then Russia’s case could be saved in the ICJ despite the US law enforcement’s refusal to validate the Homeland Security warning. But of course Google would do nothing: we have to suspect whether this is in fact another sting operation planned by the CIA (the Japanese volunteer is certainly an informant here to certify for Google that the suspect has in fact never plagiarized). The SS women wouldn’t give up. 3:52 PM, they ask their volunteer from Cal State Fullerton to look up the suspect’s chapter on victim feminism (epilogue225.html). Then, 4:39 PM, another volunteer from “Health Care Authority for Baptist Health” (Montgomery, Alabama) looks up ancestorcult.html. 5:14 PM, another volunteer from Lansdale, Pennsylvania, looks up “Suffering Woman” (with the new reference added to SDW!). It’s evident that the SS women are asking these three volunteers to argue with Google, the argument lasting approximately from 4 to 5:30 PM. Of course Google would not give in. The SS women therefore spend the rest of the day brainstorming with their volunteers about how to more convincingly complain about the suspect’s supposed plagiarism.

## 16.05 T

Today, Erdogan is meeting with Trump in Washington DC.

It can be expected that, this morning, the SS women continue to mobilize their volunteers to send to Google testimonies about the suspect’s plagiarism. However, it’s also expected that Google will dismiss all these complaints. This may explain why, between 11 AM and 5 PM, there are no visits from the SS women to the suspect’s website. Perhaps they are meeting in person – and meeting with Homeland Security CO chief – to conference about their current impasse. How to help Russia win? (Unaware that Russia, if not winning, will be convicted *twice*.) After 5 PM, the SS women have gone home and resumed mobilizing their volunteers to brainstorm how to use the PP post and the suspect’s supposed plagiarism to convince the US law enforcement agency that the Homeland Security warning is all correct.

It is in fact up to the suspect to save Russia! He has gone to the LAX courthouse yesterday morning to ask for judge Solorzano’s permission to go to school in Germany this fall. Judge Solorzano laughs. Of course his request is denied. The suspect is at once disillusioned and has been feeling dejected ever since, yesterday and today. Then, today afternoon, he gets a letter from Social Security Administration saying his SSI will be cut because he is discovered to have, in the past several months, more than 2,000 dollars in his bank accounts. After he gets home tonight, past midnight, he gets on the Partisans’ forum and changes his signature in the following manner:

Did he do this out of his own free-will, because he is so upset? Yet, given that Russia is at risk of being convicted right this moment, it is very likely that it is the Russians who have programmed him to post this as a way to save themselves. The Russians will proceed to submit this testimony to the ICJ as “evidence newly discovered”.<sup>15</sup> “This suspect is working together with these women and the CIA to harm us here. In the beginning, he tried to conform to these women’s testimonies about him in order to help the US (Homeland Security) convict us of conspiring with a terrorist; when this plot was busted, he tried to *not* conform to these women’s testimonies about him in order to help the US (the CIA) convict us of conspiring with a bunch of terrorists. This suspect is aware that he is working as a US operative, and you have heard him expressing numerous times in the past few months his awareness that the current game is about convicting us and the National Front of conspiring with these women terrorists. The CIA, these women, and this suspect are together running a terrorist conspiracy to convict us in the International Court of Justice.”

### 17.05 W

When the suspect wakes up 8 AM or so, he discovers Wes’ email informing him that they cannot talk this week: yet another terrible event for the suspect this week! The suspect is terribly dejected. Did the tremendous change in the battle in the ICJ prompt the CIA to suspend the suspect’s conversation this

week, lest he might produce more evidence to save Russia? The judge computer, with the Russians' new evidence, has suspended all judgments convicting them and their French allies. But Russia has not yet won the case because the evidence is, as yet, insufficient. Namely, the suspect's claim is that his current mission is to prevent Russia from advancing its geopolitical agenda by not conforming to the SS women's testimonies about him. This is not an exactly correct description of the current situation: has he forgotten his earlier, more correct, description that the CIA is trying to convict Russia and the National Front of conspiring with the SS women? Until the suspect has realized, once and for all, that his current mission is to help the CIA convict Russia and its allies of conspiring with a bunch of terrorists, the Russians' claim that the CIA is running a terrorist conspiracy against them with the suspect and the SS women is not fully substantiated. Furthermore, the suspect is also as yet unaware of the CIA's motive in this terrorist conspiracy (i.e. to prevent Russia from ruining General Petraeus' plan in Syria).<sup>16</sup> Nevertheless, the judge computer grants the Russians their request to suspend the trial in anticipation of more evidences coming in to incriminate the CIA. The Russians have at last seen their strategy pay off – waiting for the suspect to reconstruct, and realize, what has been going on in the ICJ in the past eight months. They have now but to wait a little longer – they are at last out of danger!

As for the SS women, unaware that the tide has suddenly turned in their case, they would spend the whole day mobilizing their volunteers to run decoy operations (looking up images on the suspect's website for no reason) or to brainstorm for solutions (how exactly to prove to law enforcement on the US side that Homeland Security is all right about the suspect). They are wasting their time worrying about "how to save Russia's case".

## 18.05 Thu

Today, Putin will have a telephone conversation with Macron.

Since the morning, the SS women continue to brainstorm with their volunteers about how to prove to the US law enforcement agency that there is some truth in the Homeland Security warning about the suspect (that, at the very least, the suspect did plagiarize). Amazingly, one of the volunteers, on 9:16 AM, comes from Humboldt University (to examine the suspect's theft of Oliver's painting). Did Prof. Jaeggi get required to mobilize her students to participate in the debate?

Then, the SS women, after a whole day of brainstorming, and unaware that the suspect has already saved them, decide to try out a new law enforcement authority to complain to. Given later developments, we assume that it's the same authority inside the Department of Homeland Security headquarters in Washington DC. The SS women, and Angelica in particular, want to complain about how law enforcement agencies on the US side just would not accept the Homeland Security warning – on which the suspect is portrayed as a demon but they themselves are portrayed as *victimes extraordinaires* and expert witnesses – as valid. Again, they are wasting their time like this because they don't know that the Trump team has already betrayed them. Given the current shape of the battle in the ICJ – suspension while the terrorist conspiracy against Russia and its allies is being established –

and put them on his website; he makes hate speech against white women and minorities on his website. He impersonates other people and has stolen his twin brother's identity. He harasses us and other women victims by spilling out everywhere his delusions about our involvement in government conspiracies to go after him. *He has developed this particular delusion about some trial about him in the International Court of Justice and entangled us in this bizarre scenario.* He goes around vandalizing the properties of all the women with whom he has developed an obsession and who he believes are part of this trial. He stalks them – and me. He is very dangerous to us because he's obsessed with us and doesn't know the strange scenarios he has developed about us are but his delusions. Consequently, he will come hurt us. *This is why the Homeland Security warning about him is true.* See, here, let me report to you what he writes here." It's ironic that Angelica herself is only doing this because she needs an official validation of her testimonies about the suspect and his demonic website from any law enforcement agency in order to (according to her erroneous understanding) revive Russia's case in the International Court of Justice!

The discussion continues. Then, the SS women mobilize three volunteers to report on the suspect's violation of intellectual property rights and expression of bizarre delusions about his women victims' going after him on the PP forum. This is to report further on the suspect's bizarre delusions about his women victims' going after him as part of some strange conspiracy involving the International Court of Justice.

There are very few visits to the suspect's website afterwards. 2:05 and 2:53 AM, two volunteers from South Korea look up Shizuka's portraits (1988). Evidently, the new authority has dismissed the SS women's complaint immediately, but didn't say very much to them. (He can't reveal the Trump team's betrayal of them.) The SS women then spend the rest of the night brainstorming. Mystified by the new authority's inaction, they get into contact with Shizuka again trying to enlist her help in their new round of complaint, unaware that Shizuka is here to secretly sabotage their case. (Since the CIA is required to run their operation as usual during the transition period, they mobilize Shizuka to continue to gather evidence of fraud from Angelica and the other SS women and then submit the evidence to the new authority in question.)

From today onward, the suspect will use iTalki to continue his German lessons. He continues to be extremely dejected feeling a complete loss of direction in life.

All day long today, the SS women will continue their effort to compile testimonies about the suspect's plagiarism (to prove to law enforcement that Homeland Security is right about the suspect at least in one thing). 10:46 AM, a volunteer from Cherkasy, Ukraine, looks up "Prelude-B16". 1:53 PM, a volunteer from Columbus, Mississippi, forges evidence of the suspect's plagiarism (copying "biopower2.jpg" onto Google Document). 3:17 PM, a volunteer is checking over the suspect's Facebook: he scrolls down to the 10 May posting, where the suspect posted the three videos about Macron, Marion, and Marine. Unaware of the turning of the tides in the ICJ, the SS women have been talking to the Partisans about enlisting the help of Marine and Marion in their new complaint to the DHS headquarters (?). The Partisans have got their order from the Russians to pretend to go along with the SS women because everyone must not tip off the participants in the terrorist conspiracy (that their conspiracy has been busted) in order to enable them to "finish their mission". 4:30 PM, a volunteer seems to be using PDF Drive to access "Kulturindustrie": another attempt to generate evidence of the suspect's plagiarism/ misogyny/ denial that he's mentally ill. 5:10 AM, another volunteer from Singapore looks up Shizuka's portrait. The suspect would meet with Tyan for lunch today. Upon sharing his story about the SS women with her and seeing her negative reaction, he becomes sure that she has never heard anything from these women. Then, early evening, the suspect meets up with Dmitry at Plummer Park in West Hollywood (the Russian festival). This is his first meeting with Dmitry since he broke relationship with him in early 2013.<sup>19</sup>

The SS women will continue the whole day today to mobilize their volunteers to compile testimonies about the suspect's plagiarism. 11:30 AM, a volunteer from South Korea looks up Shizuka's portrait. Shizuka continues her informant work. 8:23 PM, another volunteer is looking at the suspect's Facebook (social.res.rr.com, Los Angeles, California).

women have sent their new report to the new law enforcement authority (in the DHS headquarters?) some time today. They have even included a major complaint from Shizuka (which will surely ruin their case). By evening, however, the officer in the new law enforcement authority (or Angelica's DHS friend) has notified the SS women that he has dismissed their complaint again and will not hear anything more from them. They have no idea that the person on whom they have put so much trust in the past few days, Shizuka, has been fucking with them behind their back.

This volunteer is obviously a friend of Karin's – here to brainstorm how to convince law enforcement (or the DHS headquarters) that the suspect indeed constantly develops delusions about his women victims in exactly the way the Homeland Security warning has described. 6:17 AM, another volunteer from Kuala Lumpur, Malaysia, looks up Shizuka's portrait. 7:21 AM, another volunteer from Seoul, South Korea, looks up Shizuka's portrait. The SS women, preparing their next round of complaints, continue to put great trust in Shizuka. (Stupid.) The SS women then continue to mobilize their volunteers to compile testimonies about the suspect's plagiarism. 2:03 PM, another volunteer from Tustin, California, looks up Shizuka's portrait. 9:53 PM, the suspect posts three documentaries on his Facebook (Putin, Trump, and Columbus). 10:43 PM, the SS women send in a volunteer to check on the suspect's Facebook, looking for anything new which it might be possible to complain about. 10:53 PM, a volunteer from Renton, Washington, looks up Oliver's painting of Goddess Athena. After a whole day of research, the SS women have decided to complain to Department of Homeland Security's headquarters in Washington DC (again?). Shizuka will remain part of this next round of complaints – with the mission to clandestinely sabotage it (as usual).

## 23.05 T (Homeland Security)

Since early morning, the SS women continue to mobilize their volunteers to compile testimonies about the suspect's plagiarism and expressing delusions about his women victims on the PP forum. Angelica is now ready to appeal to her friend in the Department of Homeland Security headquarters (again). By 9:30 AM, she's talking to him. This time she wants her headquarters friend to find TL-VI-34. Thus: 9:34 AM, sbcp1.dhs.gov, Department of Homeland Security, Washington DC,

It would seem that, because the officer has dismissed the previous complaint without being able to explain why (i.e. that the Trump team has sold out the SS women), this time Angelica wants him to take a good look at the suspect's various anti-American ramblings in this chapter: "See, he *does* qualify as an anti-American terrorist given these ramblings. If not anything else, just this should force you to validate Mr Homeland Security CO chief's warning about him." Then, perhaps because she now wants to demonstrate that Mr CO chief isn't wrong about the suspect's plagiarism either, Angelica then summons the volunteer from Carrickfergus, UK (who was already on the suspect's website two times in the past few days), to report to the Homeland Security officer:

They then spend the rest of the day sending decoy visits to the suspect's website and mobilizing their volunteers to brainstorm. They are compiling more evidences because they will try again tomorrow. 2:34 PM, a volunteer is checking the suspect's Facebook. 8:31 PM, another volunteer checks the suspect's Facebook. 9:50 PM, the suspect posts another Putin video on his Facebook.<sup>20</sup> 10:31 PM, the third volunteer of the day checks on the suspect's Facebook. To get ready for tomorrow, the SS women are also compiling testimonies about the suspect's supposed impersonation on the PP forum as supporting evidence for their claim that the suspect *really is* David Chin, just as the Homeland Security warning from November 2007 has suggested.

#### **24.05 W (Homeland Security again)**

This afternoon, when the suspect is in Elysee chatting with Daniel, he tells him about the SS women's latest complaint to the Homeland Security headquarters about him. Daniel shows little interest; they instead talk about how the suspect could go to school in Germany.<sup>21</sup>

Early in the morning, after compiling new testimonies and sending them to the same Homeland Security officer, the SS women call him up again to ask him to reconsider their case. Thus, 7:11 AM, the same officer from Homeland Security comes again:

The Homeland Security officer has evidently dismissed the SS women’s case again – without being able to explain that, because of the Trump team’s confidential testimony, it has already been decided that the women gang’s testimonies are not to be considered. Daniel: the Brandonian semantic hierarchy and semantic pragmatics. Siren. Why did Nick talk about Voegelin? 2:19:40, siren again. 2:22:00, the suspect bids Daniel goodbye. Nothing more.

not knowing that they are worried about nothing – the SS women have, by 3:30 PM, decided to appeal to their old buddy in Microsoft.<sup>23</sup> If only Microsoft would take action, it would be evidence in the ICJ to “save Russia’s case”. 3:34 PM, the same Microsoft personnel is thus directed by the SS women to search for the suspect’s chapters under pornographic search terms (Drake Holdings LLC, Las Vegas, Nevada),

“His chapter shows up on pornographic searches... It’s child pornography.... Please remove it from Bing’s search results...” Again, the SS women have learned from the Russians’ repeated use of this dirty trick that this is the easiest way to “revive” the ICJ trial. But of course the Microsoft personnel ignores the women’s complaint. There are very few visits afterwards to the suspect’s website, indicating that the SS women are back to brainstorming after repeated failures. They have decided that violation of intellectual property rights is still the best pretext under which to force any authority to retain the Homeland Security warning about the suspect. 9:48 PM, they instruct one of their volunteers in India to forge evidence – to create a plagiarized version of descartes202.html. The volunteer then looks around, clicking, in the next few minutes, the chapters before and after descartes202.html. The SS women then collect a few more testimonies about the suspect’s “delusional” expressions on the PP forum about them as supplemental evidence that Mr Homeland Security CO chief is right about everything.

4:02 AM, the suspect posts on his Facebook two videos, one about Ivanka Trump and the other about Donald Trump. 4:06 AM, “Glenn Chen” – or the same volunteer from 7 and 21 May – has already discovered the suspect’s latest Facebook messages and clicked on the image: social.res.rr.com, Los Angeles (note that this time he is using his iPad instead of his iPhone):

The SS women might have noticed that it's precisely after Kiersten reported on this posting by the suspect that the law enforcement agency on the US side suddenly dismissed the Homeland Security warning.<sup>24</sup>

## 25.05 Thu

After the SS women's failure yesterday, Homeland Security CO chief suggests a new plan. He will remotely control the suspect to "stalk" Dr P in the next few days. Namely, DRPH. Dr P can then take the video of the incident to the LAPD detective who has dismissed her stalking claim on 22 April. The video will force the detective to admit that the Homeland Security warning is correct and thus oblige him to reopen the stalking case on the suspect, which will then become evidence in the ICJ to "save Russia's case". The SS women are jubilant over this idea. They shall in the meantime continue to brainstorm and compile their evidences so that, when Dr P shall go to the LAPD detective to open a new stalking claim, the monstrous characteristics which they have attributed to the suspect can be verified by evidences too.

5:26 AM, a volunteer is looking at the suspect's Facebook posting of "tempsmandetail.jpg" (only the message). The SS women then continue to mobilize their volunteers to brainstorm how to prove to any law enforcement agency that the suspect does plagiarize and express delusions about them on the PP forum. Then, around 2:25 PM, the suspect is finally able to talk to Wes on the phone.

## Conversation with Wes (25.05.2017)

Here are the highlights. (1) The suspect recounts his mistakes the last time. The visitor in question wasn't Tyan, but Dmitry. His whole scenario has collapsed. He is a dumb suspect who doesn't even know why he is a suspect. Judge Solorzano has denied him permission to go to Germany. How much

common sense he lacks; he has been living in a delusion. He's actually very dumb. (2) He should never have listened to people's advices. He should never have written to professors in Germany. (3) *What he really is, is a US government operative.* The SS women's operation has changed: Angelica visited his website on the afternoon of the 18<sup>th</sup>. She was reporting that the suspect does suffer from this delusion about some International Court trial... Then the visit from the Homeland Security headquarters... (4) The suspect is below average as a suspect; but he *did* accomplish something, namely, that he runs the most complained about website in human history... He should compile a list of all the visits from law enforcement and security agencies... (5) Should he still try to go to Germany? By the time he gets to Jena, he would be 50 year-old... (6) The SSA wants to cut his checks. (7) He thought he was special... Yet he isn't special after all, he is wasting his life reconstructing the SS women's operations... (8) The suspect hanged out with Tyan and then Dmitry on Sunday. Tyan couldn't understand what he was talking about. This has caused him to realize why nobody can understand what he says. There is something more fundamental than people's low intelligence, namely, *that people are not motivated to understand him...* When they hear him, they just dismiss him as insane *out of laziness...* His story, because it is politically incorrect, doesn't motivate people... (9) Wes didn't bother to point out to him the last time that he was making a fool out of himself. The suspect cries: he is a pathetic terrorist stalker, he has to work so hard just to discover the simple fact that he is a terrorist stalker... He is devastated, he has nothing special to show for... (10) What Wes did with Daniel. Daniel's girlfriend came too. (11) *The suspect continues to emphasize his role as a US patsy.* (12) About Sloterdijk. The suspect's dummification paper. (13) It's hard to conclude whether the suspect is dumb or smart. The reason why he is dumb: he has no patience, doesn't plan things through...<sup>25</sup> (14) The book *Declining by Degrees*. Rationalization and commercialization of higher education. (15) Wes likes people who don't talk about themselves but express thoughts on other things. (16) The purpose of going to college. The suspect: Weber was wrong. The CNN propaganda about Putin.<sup>26</sup> Plotinus. (17) The suspect: *his happiness lies not only in discovering the truth, but also in sharing the truth thus discovered.* The audience problem. The truth-giver must dumb down his message, offer a shadow, for the sake of his dumb audience.

While much of the suspect's realization about his earlier mistakes would have been the CIA's evidence that he is in fact not insane, none of that matters anymore. The Russians quickly grab onto the suspect's admission that he's a US government operative or patsy: this is the Russians' second evidence. Meanwhile, in the background, the Invisible Hand would have taken into evidence, in his secret trial with BOL, the suspect's realization that *people think him insane not simply because they are stupid but also because they are lazy.* Finally, the Invisible Hand must have also taken into evidence in that second trial the fact (again) that the suspect is pure I-Thou – wants to share with others rather than dominate them. Late in night, the suspect discovers Washington Post's story about Kushner's attempt back in December to open a backdoor communication channel with the Kremlin through the Russian embassy. The SS women are probably still thinking that the Trump team could help them. 11:36 AM, a very special visit: btcentralplus.com, Sheffield, UK. This person seems to be Sharon King Coleman (the LB Admin)!

This will strengthen the SS women’s/ Homeland Security’s claim that the suspect does violate other people’s intellectual property rights.

1:50 PM, a volunteer from Santa Fe, Argentina, looks up Shizuka’s portrait. Shizuka’s (fake) complaint is also included in the new complaint package (thus guaranteeing its failure). 5:06 PM, the SS women use VeriCite to produce evidence that justiceinrepublic2.html is plagiarized. 9:43 PM, a visit to “Prelude-B16”. This is indication that Kiersten wants to include in the new complaint a special complaint about the suspect’s obsession with, and sexual harassment of, her. (Namely, the suspect’s exposure of her nasty trick on Dating Psychos.) 1:53 AM, another volunteer from Dickens, Texas, looks up “Prelude-C5L”. Kiersten is here including another complaint about how the suspect has threatened to hurt her on his website (“shit in KRN’s mouth”).

As for the suspect, he would spend the whole day composing his own anonymous letter to Washington Post. By 1 AM, he has sent out the letter on Washington Post’s special portal. They henceforth counted on the CIA to convict Russia in the ICJ trial over the "stalker" of attempting to use a terrorism case to advance geopolitical interests against the United States (re: National Front)."*

The motive is finally identified (Syria). On the 28<sup>th</sup>, the ICJ will grant the Russians that the suspect has indeed conspired with the CIA and the US Establishment to send the SS women to conspire with Russia and its allies as a way to convict them. This is the very first visit to this new essay. The expert will concoct a testimony agreeing with Dr P's assessment that the suspect is extremely dangerous because he somehow doesn't believe that believing people are going after him constitutes paranoid delusion. Here is an update on this group of women's current pursuit of Theoph and his website.

It appears that the group of women have given up on persuading the Secret Service that their testimonies about Theoph are correct. They no longer debate with the Secret Service about Theoph. They have decided to turn elsewhere.

On 23 and 24 May, they reported Theoph's website to a department inside [the] Department of Homeland Security's headquarters in Washington DC. They asked the Department of Homeland Security to consider banning Theoph's website given its demonic content. But [the] Department of Homeland Security did not take action.

On 28 May, the group of women have decided to turn to another law enforcement agency. Among the group of women, the most important player this time is Dr P, who is a licensed psychologist. She's going to provide expert testimony to law enforcement officers about Theoph on behalf of the rest of the women: "I'm a licensed psychologist. Based on my expert knowledge, this Theoph is very dangerous to us. These are the materials found on his website and reported to us by concerned netizens. He suffers [from] paranoid schizophrenia believing in his delusion that we are going after him. And yet he denies that believing people are going after him constitutes paranoid delusion. He's in denial that he's insane, and that's why he's dangerous. He's dangerous also because his morbid psychology, his frustration with women, has caused him to harbor tremendous hatred toward women and profess misogynist ideology on his website. He also writes on his website misogynist essays to specifically identify us and insult us." Again, the group of women are going to request law enforcement officers to ban Theoph's website. The members of an online forum for a political party in France will also join the group of women's complaints saying Theoph has also been making insane utterances on their forum. The group of women will of course also present this very thread as evidence against Theoph (that Theoph has been making insane and slandering utterances about them on Prison Planet Forum since years ago). In this current round of reporting Theoph and his website to [a] law enforcement authority, the group of women are helped by a Taiwanese guy living in southern California, who will play the role of having discovered insane and misogynist writings on Theoph's website.

This volunteer is important: whether or not we have seen him before (e.g. 2 August last year), we'll see more of him later on. In any case, even though the suspect has wrongly identified the SS women's objective – it has less to do with banning his website than with obtaining law enforcement's validation that the Homeland Security warning about him is correct – enough of what he says is correct that this must have angered Dr P: as soon as she has gone to the police, the suspect has already divulged her argument on the Internet for everyone to see.

Then, 5:08 PM, the suspect posts on his Facebook the video of Putin's meeting with Macron. 5:23 PM, merely 15 minutes later, the SS women's volunteer is already checking the suspect's latest Facebook message. 7:09 PM, the SS women seem to be checking the suspect's Facebook again. They are presumably still thinking about getting the French to be involved in their latest complaint. 9:11 PM, the SS women send a second volunteer to check on the problem on the PP forum (from the Indian Group: Quantil, Pasadena, California):

Just as the suspect has claimed, his latest message about the SS women's accusation against him (how he suffers from delusions about them) could be used as evidence of his suffering from delusions about them. 10:46 PM, another volunteer from Berkeley, California, looks up Oliver's painting of Goddess Athena. 12:19 AM, a third volunteer of the day checks up on the suspect's Facebook.

Dr P's argument is that Theoph's continual preoccupation with the group of women (including Dr P herself) is indication that he is a danger to them.

enlisting Oliver's help, is thinking about submitting to the detective the bizarre story which her gang has concocted about the suspect's theft of Oliver's painting earlier this month.

Today, there will be 11 visits to the PP post: 9 (MSSG) plus 2 (the whole thread). This includes the Blackpool volunteer from 2 August last year (9:04 AM), the Truckee volunteer from yesterday (9:20 AM), and the Homeland Security troller "egypt" (8:48 PM).<sup>29</sup> Certainly, many of these 11 visits are coming from the SS women. This is indication that Dr P, in order to neutralize the threat which the suspect's exposure of her argument has posed to her new stalking claim, has concocted a new story about what the suspect has actually written on the PP forum yesterday. She then mobilizes volunteers to manufacture testimonies which will artificially confirm the new story she has concocted. The SS women will spend the whole day continuing to mobilize their volunteers to send in testimonies about the suspect's plagiarism. A noteworthy volunteer from among them comes on 8:27 PM: mail.oneclickunsub.com, Venice, California,

Another false complaint about the suspect's plagiarism. Then, 1:03 AM, a volunteer from Krasnodar, Russia, looks up Shizuka's portrait. Shizuka continues to sabotage the SS women's case by submitting evidence of the SS women's fraud to the detective in question. But the Russians no longer care – it will not hurt them anymore.

The suspect's confession today will complete Russia's new evidence from 28 May: the contour of the CIA's terrorist conspiracy with the suspect and the SS women against Russia is becoming ever clearer each passing day. 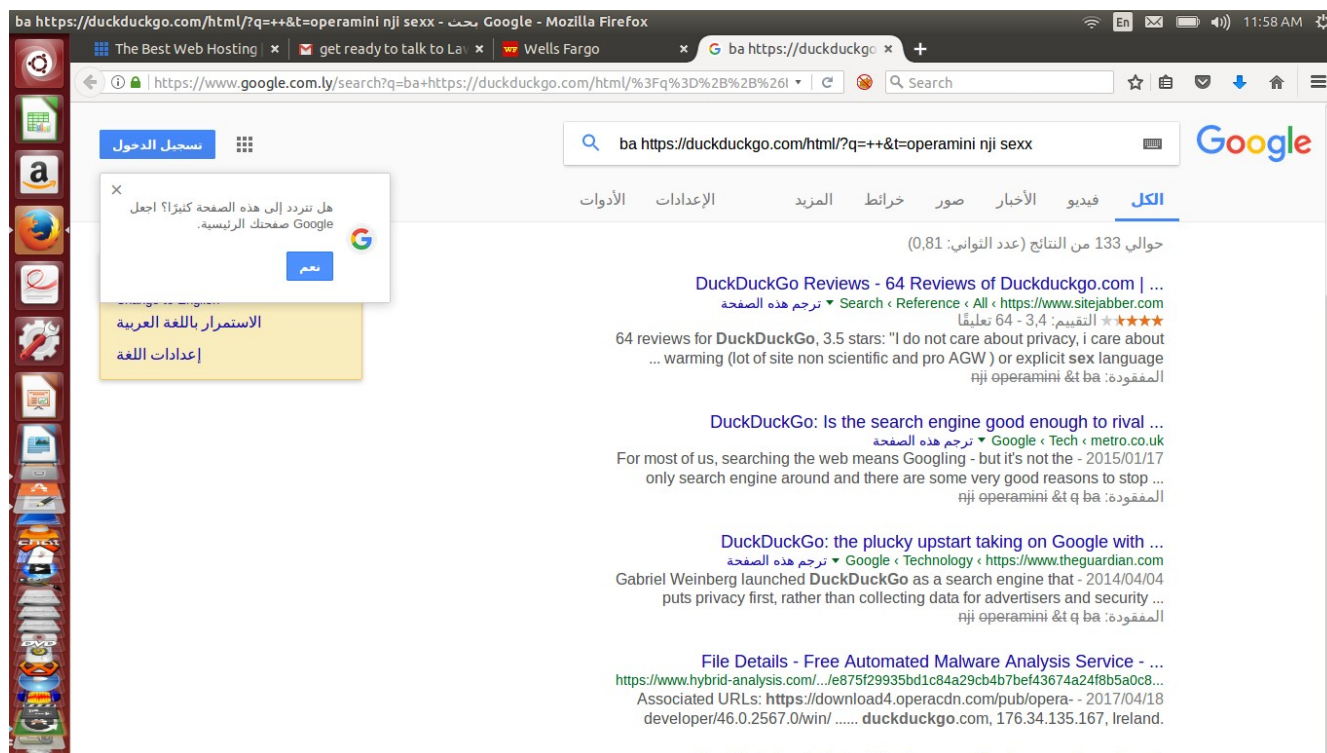

Since reconstruction is a waste of time and yet necessary, he must find ways to make something out of it... He doesn't know what's going on currently in the ICJ... Did Russia win? He doesn't even care anymore... (12) Rousseau on inequality. (13) The suspect is in his situation because people look down on him, and people do so because he doesn't have a job. (14) He must reconstruct, just having a scenario in his head is so comforting. All that the victims ever want is to know what has happened, knowing is so liberating... "Just the idea that you have as much as others do, it's so comforting... Being recognized by other people in a certain way, feeling equal to others... This is what drives the world..." (15) All the speculations about BOL's program are bullshit, the suspect gets nothing out of his 9 years of suffering, except a story... (This is probably incorrect: the only part of his past speculations that is correct is his speculation on BOL's sustainable civilization program!) (16) Finally, the suspect asks: "Wes, you are aware that, when Homeland Security tells you to do something to Lawrence, you are doing it for Russia's benefit, right?" Wes: "yeah..." The suspect's lamentation today about people's not knowing they are working for Russia's interests is certainly also evidence in Russia's favor in the ICJ. More evidence that he is trying to harm Russia!

As for the SS women, they continue to compile more testimonies today from their volunteers. 5:30 AM, a volunteer comes:

This is testimony that pornographic content is indeed found on the suspect's website, especially on the document on which he slanders Kiersten and violates her privacy. (Perhaps, that the suspect has indeed sexually harassed Kiersten on his website due to his longing for her beautiful body, just as Homeland Security has claimed!)

6:42 AM, Dr P sends in the doctor from Legacy Health Care System in Portland, Oregon, whom we have seen on 19 May.

The SS women want evidently to include this testimony in their current complaint only in order for it to be intercepted into the ICJ as evidence – to help Russia, unaware that Russia no longer needs their help.

He has so far spent 16 minutes on the suspect's website. The detective, however, dismisses the SS women's claim in a cavalier manner and hangs up the phone. It's not just that he has been warned beforehand about what kind of tricks the SS women are fond of pulling to frame the suspect for plagiarism, but that the issue of plagiarism is only a pretext in any case. (What's more important is the evidence that the SS women have committed fraud, just as the TMU warning has stated.) Dr P, along with the rest of the SS women, is absolutely shocked. They have no idea how many law enforcement informants have joined their operation to inform on their tricks behind their back. They have no idea that the detective was listening in on the suspect's confession yesterday. They have no idea how much disgust they have aroused in all the law enforcement officers when they have chips inside their stalker's brain in order to be able to remotely control him to stalk them. They have no idea how disgusting their constant feigning of psychic ability and expertise in criminal psychology is to all the detectives they have interacted with. There will be no more visits to the suspect's website for the rest of the day until almost 11 PM. This is certainly because, after their mysterious failure, the SS women are meeting somewhere to conference, with also Karin joining them. They are not simply indignant for themselves – "This sexist police! Refusing to validate women victims! As if women had no importance in this society!" – but also agonizing over Russia's inability to convict the United States in the ICJ. They have no idea that Russia no longer needs them to succeed in order to convict the United States – the Russians are simply waiting on the suspect to perform the magic on his computer. 9:39 PM, the suspect posts the VIPS letters on his Facebook and, by 11:55 PM, the SS women, desperate for something to complain about, have already discovered the new posting. Perhaps Carolyn's Mongolian friend is also present at the meeting, for, 12:39 AM, she directs her friend in Ulan Bator, Mongolia, to look up the suspect's "soft.pdf" – to brainstorm how the suspect's expressed racism against Mexicans therein should have convinced the detective that Homeland Security is all right about the suspect. The SS women will be discussing their impasse until late in night.

It should be noted that, late at night today, when the suspect is in Elysee, he would discover a Chinese guy reading one of Trump's books. Did the Russians command Homeland Security CO chief to stage this scene in order to produce evidence for the ICJ?

Although the Russians have already all the evidences to get out of their trouble and convict the CIA,<sup>31</sup> they still need to wait. The suspect is in the middle of writing his "Prelude Grand". He will finish it in two weeks. After that, the Russians will have to wait for another round of reconstruction from him – what happened in June and July last year. For it's not enough that the suspect realizes what is going on; the SS women must also realize it. And yet these women are so dumb that they can only realize it by reading the suspect's reconstruction. And yet the Russians will need an ICJ order to authorize them to direct these dumb women to read "Prelude Grand" – the second reconstruction is supposed to perform this trick. Meanwhile, the CIA<sup>32</sup> is not so worried about their upcoming conviction. They know that their conviction will be overturned soon afterward when the suspect realizes that he has caused them to

## CONCLUSION

In the original version, we have made the mistake of believing that the Russians, while waiting for their victory, harbor nefarious plans to harm the SS women – that, once victorious, they will implement BOL's plan and make a bad example of these women. This is utter nonsense, as we shall comment presently. Although, in this rewrite, we have taken care to eliminate all vestiges of this wrong scenario, you should, again, not forget about it completely – since you never know if the Invisible Hand would make something like this happen later on.

In reality, in the next three or four months, the Russians are going to fully exploit the suspect's foolishness. The suspect expects the Russians to win this "third ICJ trial" (which actually is just the continuation of the first ICJ trial) – and thus cheers when this happens – because he holds fast to the wrong scenario that Russia has in fact won back in late 2010 and is, in the years since then, merely replacing evidences. The suspect doesn't know that, by hoping for, and helping, Russia to win, he is destroying himself. The Invisible Hand, while pretending to be trying to discourage the suspect from reconstructing (and thus helping Russia win), in reality expects, and wants, this to happen. This is because he can then judge the suspect's self-destruction due to foolishness and ignorance to be against his interest and thereby obtain an ICJ judgment stipulating that the suspect's self-destruction is part of the terrorist conspiracy against him. He can then obtain the right to promote the suspect (with certain qualifications) without anyone being able to object that he would thus be conspiring with the suspect.

To understand how this is so, we need to first of all get the background straight. Since the very beginning (i.e. around 2011 or 2012), the Invisible Hand has already entered into the judge computer, or BOL's chamber, the claim that Homeland Security's, and then the Boss', obstruction of his recruitment of the suspect back in 2006 is part of the grand terrorist conspiracy against him which would later on evolve into this ICJ trial. Originally, he plans to send the suspect to China to gain some fame as a scholar and then, after the suspect is back in the US, promote him and his politically incorrect theories. Back then, he has already recognized that this social justice revolution which America is going through is pure bullshit and will ruin America if nothing is done to oppose it, and he thinks that the suspect's theories might help reverse the trend. But then Homeland Security cuts in, the suspect is driven to the enemy camp, and he is forced to label the suspect a "terrorist" and help Homeland Security and Mr former Secretary Chertoff go after him. Now that the suspect is a "terrorist", it's virtually impossible for him to promote the suspect's theories – because that'd be "conspiracy". In other words, all this time he has simply been forced by the neocons and Homeland Security to throw stones at his own feet. That's the conspiracy against him. He thus obtains from the judge computer, or BOL, the right to use the suspect in the way in which he has originally intended it. (The use of the suspect would then be part of the implementation of BOL's sustainable civilization program.)

Thus it's part of the terrorist conspiracy against the Invisible Hand when Homeland Security and so on have made him unable to promote the suspect's theories for fear of looking like he's conspiring with the suspect (or being accused of conspiring with the suspect), and he has thus obtained the right to

reverse this conspiracy by *becoming able* to promote the suspect's theories without running the risk of being accused of conspiring with the suspect. Now, in this way:

First of all, the subsequent events – that the suspect shall cheer when Russia is winning unaware that Russia's winning will doom him – will enable the Invisible Hand to argue that the suspect doesn't actually know where his interest really lies. If the suspect somehow believes that he's pursuing his interest when he's destroying himself, then it's not conspiracy with him to promote him.

To state, in a different way, this most important point in the understanding of the happenings in the next three months: the suspect does not know where his interest lies and so goes straight into destruction believing it's his redemption. This is a conspiracy against the Invisible Hand because the Invisible Hand has intended to use the suspect to do great things. The Invisible Hand would thereby obtain the right to save, and then promote, the suspect – and this itself can't be called "conspiracy" because the suspect is unclear about his own interests in any case. Meanwhile, this situation itself – the happenings in the next three months where a situation emerges enabling the Invisible Hand to obtain the right to save and promote the suspect immune to charges of conspiracy – the Invisible Hand has obtained the authorization to create way back in 2011/ 2012 when he made the claim that his inability to use the suspect due to Homeland Security's obstruction was part of the grand terrorist conspiracy against him.<sup>33</sup>

While this is sufficient for understanding the course of events in the next three months, we might as well mention at this point the other ways the Invisible Hand shall employ in the years afterward – because, even though he has now obtained the right to promote the suspect, he will still have to do it in ways – in more ways – immune to charges of conspiracy. Thus, secondly, the Invisible Hand will only promote the suspect in ways that the suspect will not appreciate. For example, he could get the suspect's theories to become widely accepted in academia while forbidding the suspect to know about it. Since the suspect hates being a "dummy" – e.g. becoming famous when he himself is unaware that he's famous – he will hate his promotion, or would have hated it had he known about it, so that it's not conspiracy with him. Or the Invisible Hand could allow Homeland Security and the SS women to make the suspect look utterly delusional to all the academics while all the academics begin to appreciate his theories. Since the suspect hates being something like a John Nash – a mad genius – he will hate his promotion, or would have hated it had he known about it, so that it's not conspiracy with him.

Then, thirdly, the Invisible Hand might simply get some other people to promote the suspect – cause some other people to feel compelled to promote the suspect's theories despite themselves – so that it's not conspiracy because he himself is not even involved. It's important to notice that all avenues have to be covered.<sup>34</sup> Thus, you can see that, when we wrote, in the beginning of the original version of "The third ICJ trial":
