

The third International Court of Justice trial over the suspect

XVI

3 June – 8 July 2017

The following summarizes the reconstruction of the Secret Society women's operation against the suspect and his website and the associated International Court of Justice trial from 3 June to 8 July, 2017.

The names of persons follow the convention established in the previous chapters. The Secret Society women consist of (as of June, 2017): Karin (the German Lady, K), Angelica (Angelina, G), Kiersten (J), SDW (Maura, M), and Dr P (Petterson), along with auxiliary members like the Long Keng volunteer (“Glenn Chen”?), and long-time informants like Aamoy, Shizuka, Oliver, and so on. For brevity's sake, the “Secret Society women” shall continue to be referred to simply as the “SS women” in the following narrative.

June and July are quiet times for the suspect. He continues to reconstruct the past course of this third International Court of Justice trial. As noted, he will soon finish “Prelude Grand” and then start on “Prelude GR”. He continues to read philosophy and work on his McDonaldization paper everyday. He also pays increasing attention to the news reporting about the “Russia investigation” – now that he is sure that the Secret Society women together with him are an important part of Trump's “Russia connection”. On 17 May, Robert Mueller was appointed as special counsel to investigate the “Trump-Russia” collusion business. It thus seems that the US Establishment continues to pursue its original plan of removing Trump even though the situation in the International Court of Justice is changing rapidly. In the coming months, small incidents of Trump team's contacts with the Russians in 2016 will begin to be leaked to the press. The suspect will be upset: these incidents which the press would report are like the small crumbs which fall off the dinner table when you devour your meal. Trump's “conspiracy” with the Russians is so extensive that the public only hears of small, insignificant episodes of it.

ERRATA

The so-called “LAPD detective”, to whom Dr P first turned on 17 April and to whom the SS women continue to appeal throughout June and July, might very well have been misidentified. This detective could just be the same Hawthorne Police Department detective with whom Dr P has developed rapport since 2014. If so, it might be a *she*.

KEY EPISODES

June, 2017

03/06: the SS women resume efforts to collect testimonies about the suspect's plagiarism.

04/06: the SS women continue their efforts.

05/06: Eircom indexing. The SS women are preparing a new complaint for the LAPD detective. Oliver has joined them. The Trump administration might have also joined them.

06/06: Shizuka will continue to be part of the SS women's new complaint process. From 6 PM to 11 PM, the SS women (with a volunteer from California) are testifying to either the detective or to Trump's staff about the suspect's impersonation.

07/06: the SS women continue to perfect their story about how the suspect is really David Chin, concocting a new story about how he has stolen "Yu trains his soldiers..." from his twin brother.

08/06: the US bombs Syrian troops, withdraws support for terrorists in Syria. The SS women continue to perfect their new story about "Yu trans his soldiers..." They concentrate on establishing the suspect's impersonation. Eircom indexing to the same effect. Aamoy joins the complaint process.

09/06: the SS women are meeting in person to go over their evidences and stories in preparation for their appointment tomorrow.

10/06: the SS women meet with the LAPD detective around 5:30 PM. They submit their reports. Past midnight, Long Keng volunteer's status check. The detective didn't act.

11/06: the SS women prepare their next round of complaint to Homeland Security headquarters. They have again secured Shizuka's and Oliver's participation.

12/06: the SS women focus on constructing their "David Chin legend" (impersonation on the PP forum and intellectual property rights violation).

13/06: the first KZ incident on 6:35 PM in Ackerman. Aamoy will also be part of the new complaint process.

14/06: the SS women and Homeland Security CO chief create a second fake website to substantiate their claim that the suspect plagiarizes (vcevam.com). The women concentrate on perfecting their testimonies about the suspect's impersonation on the PP forum. They have also recruited Marie to their new complaint process. By midnight, the suspect has finished and uploaded "Prelude Grand". ICJ's "pre-judgment" convicting the CIA.

15/06: the SS women report to Homeland Security headquarters.

16/06: Angelica has recruited Tatyana. The SS women report to Microsoft ("Tatyana"). Rejected.

17/06: the SS women report to Microsoft again ("Tatyana"). Rejected again.

18/06: the US shoots down a Syrian jet. The SS women secure agreement from the LAPD detective for a meeting tomorrow. Night, Angelica asks the Nuremberg hacker to create a fake front page of the suspect's website. Ekaterina joins the SS women's new complaint process with a new agenda. The SS women revive the story they have concocted about Oliver's painting on 2 May.

19/06: 3:30 PM, the SS women are with the LAPD detective getting him to watch the second KZ incident unfold in real time; they oblige the detective to open a stalking claim on behalf of Karin. Night, the detective sends in Shizuka to join the SS women's new operation.

20/06: Angelica, SDW, and Aamoy plan to join Karin's new case as additional victims. What about Dr P's husband David? The SS women obtain another appointment with the LAPD detective for the 23rd.

21/06: the SS women plan to add Oliver to Karin's new case. Many testimonies compiled today on the suspect's theft of other people's artworks.

22/06: the SS women and Homeland Security CO chief create a third fake website to attribute to the suspect (psfire.com). Indexes compiled of both / and 1.html. The SS women conference in person around 6 PM to prepare for tomorrow's meeting with the detective.

23/06: the SS women meet with the detective on 1 PM and submit to him new evidences and additional stalking claims on behalf of other people (Angelica, SDW, Aamoy, Oliver). SWLL stops tweeting: is she leading a new US team?

24/06: 1:26 PM, the Long Keng volunteer's status check. The SS women receive the bad news from the detective around 2 PM. They argue with the detective again between 5 PM and 8 PM. 11:30 PM, they try Microsoft again. Past 2 AM, they try Google. The SS women are worrying sick about Russia's case in the ICJ.

25/06: Angelica tries to persuade Pamela to join Karin's stalking claim. Pamela declines. The SS women continue operation in night. Angelica might have visited the suspect's website between 12 AM and 4 AM. (There is a possibility that the SS women are complaining to an unknown law enforcement authority tonight and that Pamela has in fact participated in the operation. Log problem in the morning.)

26/06: 9:15 AM, the SS women try the same trick to prolong the Russians' case (in their belief). 2 PM, status check? 12 AM, is Jill from the Libertarian Party conducting another status check?

27/06: the SS women decide to appeal to the same officer in Homeland Security headquarters. They shall focus on the suspect's supposed violation of intellectual property rights because Angelica believes the authority is obliged by law to remove any websites which violate other people's intellectual property rights. Marine's family pretends to want to join the new complaint process.

28/06: Shizuka joins the new complaint process. 8:50 PM, the SS women try the same trick to prolong the Russians' case (in their belief).

29/06: 9:50 AM, the SS women report to the same Homeland Security officer. Rejected. Angelica decides to try the same tactic on the LAPD detective. MegaIndex indexing. Shizuka continues to be part of the new complaint process.

30/06: the suspect talks to Wes for the first time since his return from Brazil. The SS women conference in person to perfect their evidences of the suspect's plagiarism.

July 2017

01/07: the SS women meet with the LAPD detective on 3 PM. Marie also submits (or pretends to submit) her complaint. The detective pretends to remain unconvinced that the suspect is such a case of violation of intellectual property laws. The suspect meets Kelleher in Elysee.

02/07: the SS women establish a working relationship with MJ12 (Majestic). The SS women meet with the detective again around 4:30 PM, with additional evidences of the suspect's plagiarism and stalking and harassment of Karin and Kiersten. Tatyana and Oliver have joined the list of other victims (Marine's family, Marie, Shizuka, Oliver, and Aamoy). The detective again pretends to pick holes in the SS women's stories about the suspect's

plagiarism and sends them home.

03/07: The SS women will perfect their case and return to the detective on the 4th. They create two more fake websites (the third and the fourth): bchcar.com (containing malware) and nuprintable.com (plagiarism). Angelica revives her story that the suspect keeps her naked pictures on his website. She adds Gaurav and/or Angelo to her list of the suspect's stalking victims.

04/07: the SS women meet with the detective around 6 PM. Aamoy is also present. Rejected again.

05/07: the SS women prepare their case for tomorrow's meeting, compile indexes on the basis of which to request "victim confidentiality".

06/07: the SS women and Homeland Security CO chief create a fifth fake website to prove the suspect's plagiarism: sagadwf.linkpc.net. **The SS women meet with the detective around 5 PM,** present Oliver's complaint, turn in new evidences of the suspect's plagiarism, and make the detective watch **the third KZ incident** unfold in real time. **Karin's stalking claim is revived.** The detective pretends to be skeptical about the suspect's plagiarism.

07/07: the SS women work hard to build a case for Shizuka. Shizuka is once again secretly charged by the detective with the mission to sabotage the SS women's latest stalking claim. Dr P revives her favorite argument that the suspect is dangerous because he doesn't believe he is delusional. The suspect's conversation with Wes: an esoteric message.

08/07: **the SS women meet with the detective in the afternoon** to submit new evidences and new argument (that the suspect is dangerous because he doesn't believe he is insane) and present the cases of other stalking victims (Shizuka and Kiersten). The detective again picks issues with the suspect's plagiarism.

June 2017

03/06 S

Since early morning, the SS women have resumed operation. However, they are mostly sending volunteers to conduct decoy visits to the suspect's website. 2:41 PM, a volunteer is looking at the suspect's Facebook. After 4 PM, the visits to the suspect's website have slowed down, indicating that the SS women might be busy conferencing again about their current impasse. They then resume mobilizing their volunteers to brainstorm how to falsely report the suspect for plagiarism. There are three visits to each of the three PP posts today – indicating that everybody is brainstorming how to report the suspect for impersonating other people online. Once again, the SS women have taken literally the words of the LAPD detective: they will collect more convincing testimonies about the suspect's plagiarism and then go meet with him again.

Tonight, when the suspect is in Elysee, he chats with Daniel about the current of Marxism in Latin America.

04/06 Sun

Just before 8 AM, a volunteer from Kaoshiung, Taiwan, is looking over the suspect's Scientific Enlightenment. This seems to be a friend of Long Keng volunteer's. 12:06 PM, a volunteer from Plano, Texas, is checking the front page of the suspect's website. Why? 1:06 PM, a volunteer is checking the suspect's Facebook. 2:49 PM, a volunteer from the city government of Hillsboro, Portland, Oregon, looks up “Ying and Yang II”. Why? Is Angelica explaining to her new recruit what the “problem” is? (“He writes all this delusional fantasies about me.”) For the rest of the day the SS women continue to mobilize their volunteers to brainstorm how to more convincingly report the suspect for plagiarism.

05/06 M

6:27 AM, a volunteer from Tartu, Estonia (utpublic.net.ut.ee), looks up sci.pdf. Is this volunteer related to the Elva volunteer from 12 May? (The same essay. Elva is 5 miles away from Tartu.)

A testimony about the suspect's hate-speech against white women? 10:21 AM, the Blackpool volunteer (last seen on 30 May, 9:04 AM) looks up the PP post,

10:46 AM, the SS women send the Eircom hacker (broadband.digiwe.ie, Limerick, Ireland) to compile an index of the suspect's website: all the index pages. 11:44 AM, a volunteer from Berlin looks up “Prelude-E4E”. Around noon, the SS women order a volunteer from Antioch, California, to forge evidence of the suspect's plagiarism (perspective2.jpg). It seems that the SS women are re-compiling evidences for their profile of the suspect (plagiarism; hate speech against white women; expressing delusions about his women victims; terrorist harassment of the President) – they might even be contacting the White House again, with Trump's staff again pretending to voice the same complaints about the suspect and offer help in order to “not raise suspicion among the terrorists”. (It's not clear whether the Trump administration is happy about the upcoming conviction of the CIA.) The SS women are going to send all their new evidences – including possibly the Trump administration's complaints – to the LAPD detective requesting that he reconsider their case. (If the Trump administration has joined the SS women's new complaint, they will of course inform the detective behind the women's back that these women are a bunch of fraudsters.) Then, all the decoys and brainstorming (plagiarism). 4:03 AM, a volunteer from Singapore looks up Oliver's painting of Goddess Athena. It seems that Oliver is also joining the SS women's new complaint in order to sabotage it behind their back.

Tonight, when the suspect is in Elysee, he chats with Daniel about Nick Land again.

06/06 T

Today, since morning, the SS women continue to mobilize their volunteers to compile testimonies about the suspect's plagiarism. 6:47 AM, a volunteer from Medellin, Colombia, looks up Shizuka's portrait. Is Shizuka also joining the SS women's new complaint? (A third saboteur.) Past 1 PM, the suspect, after posting the news item about the NSA leak ("Reality Winner") on his Facebook, calls up the Secret Service in order to get some idea about the SS women's appeal effort back in October last year. (To help himself reconstruct the episode more correctly). There are no visits to the suspect's website between 6:30 PM and 9:30 PM. One visit each to the PP post and the PP 184178 post. A volunteer, who visited the PP 184178 post on 6:15 PM, comes back on 11 PM to examine the image braingate2.jpg. It seems that the SS women are asking this volunteer to testify to somewhere about the suspect's supposed impersonation. It thus seems that, tonight, the SS women are talking to the authority, either to the Trump staff or to the LAPD detective, and the process lasts five hours.

Past midnight, because it is raining lightly, the suspect goes to sleep by the theater south of Wilshire. 2 AM or so, the same homeless man (Homeland Security?) appeared, but he didn't attack the suspect.

07/06 W

Throughout the whole day, the SS women continue to mobilize their volunteers to conduct decoy visits and to compile testimonies about the suspect's plagiarism. 7:50 AM, a volunteer from Hoboken, New Jersey, looks up yu6.jpg. Even though this drawing remains inside the suspect's storage unit, the SS women have proceeded to concoct a new story about how the suspect has stolen it from his family members (presumably from his twin brother). This may be a continuation of the testimonies about the suspect's impersonation from last night: the SS women are compiling more evidences to prove that the suspect is really David Chin and that this David Chin has stolen his identity and everything else from his twin brother Lawrence Chin. 4:05 PM, a volunteer from the UK looks up Sahra's portrait. Is Sahra's team also requesting to join the SS women's new complaint? If so, it might be that the Russians are instructing Sahra to pretend to join the complaint process in order to produce new evidence showing that she does not intend to sponsor terrorists. Tonight, the SS women are instructing their volunteers to create more fake webpages to attribute to the suspect in order to prove to the LAPD detective that the suspect does steal drawings and paintings from other people. 12:33 AM, they instruct a volunteer in Astana, Kazakhstan, to forge a webpage featuring the drawing "wine.jpg". (To prove that the suspect did steal this drawing from his twin brother.) 3:45 AM, the SS women order Site Explorer to compile an index of many of the miscellaneous links on 1.html. They will submit this index to the detective to prove that the suspect does indeed violate other people's privacy on his website. 4:28 AM, a volunteer from Modesto, California, looks up

“Prelude-H2J”. Is this another complaint about the suspect's terrorist harassment of Trump? Two visits to the PP post today, and one visit to the PP 184178 post.

Tonight, when the suspect is in Elysee, he chats with Daniel. Past 1 AM, he posts videos of Putin's interview on his Facebook.

08/06 Thu

Comey is testifying in Congress in open session today. Then, another news item is very relevant: today the US strikes pro-government forces in Syria for the second time. Also, as the news media will later report,¹ the US has around this time ceased supplying weapons to ISIS and Al-Nusra in Syria. The covert program has apparently been slowing down for a while, and has now virtually stopped. We must suppose that, when it has become evident, about a month ago, that the suspect will soon realize the full contour of the US countersuit last September, General Petraeus' clique begins to withdraw their operations to supply terrorists in Syria. And, now that they expect to be convicted soon – now that their support of Islamic terrorists in Syria has become a terrorist conspiracy against Russia – they promptly stop the operation altogether. Nevertheless, they are unwilling to give up Syria – especially since they expect also their conviction to be overturned soon afterwards. They therefore order US forces to beat up the Syrian forces here and there in order to temporarily prevent Assad's forces from winning completely – until they come back.²

Now, the SS women's operation. 6:08 AM, a second volunteer looks up yuA.html. This is evidently to produce testimony verifying the new story which the SS women have lately concocted about how the suspect has stolen this drawing from his twin brother. Then, from now on, there begins to appear a strange kind of visit: 6:19 AM, ph.ph.cox.net, Mesa, Arizona,

It's not clear whether this is related to the SS women's operation.

7:55 AM, a volunteer from the UK looks up the PP post (61812-39.png). 8:11 AM, another volunteer from Hillsborough, New Jersey, looks up the PP 166020 post (rosen.jpg). The SS women continue to compile evidences about the suspect's impersonation on PP in order to perfect their story about his pretending to be his twin brother. 8:20 AM, a volunteer is checking the suspect's Facebook. 9:29 AM, again. 10:39 AM, the SS women order the Eircom hacker to compile an index of the suspect's website proving that he is indeed

impersonating on the PP forum (61812-39.png). They then continue to mobilize their volunteers to compile testimonies about the suspect's plagiarism and send decoy visits to his website. 4:21 PM, a third volunteer of the day checks the suspect's Facebook. 5:54 PM, a volunteer from Anakara looks up TL-02-14. This presumably means that Aamoy will also join the SS women's new complaint process (that the suspect is uttering delusions about his joining these women to go after him). Aamoy, like Oliver and Shizuka, will work as a law enforcement informant within these women's organization to secretly sabotage their operation.

09/06 F

There are fewer visits to the suspect's website today. One visit to the PP post in the morning. Until 2 PM, the SS women seem to be mobilizing volunteers to compile testimonies about the suspect's plagiarism. It seems that, after 2 PM, the SS women are meeting in person. In the past few days, perhaps thanks to the (fake) assurance which Trump administration has provided, they are able to obtain another appointment with the LAPD detective. The appointment is tomorrow and, to prepare for it, the women have decided to meet in person this afternoon to go over the evidences they have so far accumulated and the stories they have so far concocted. It seems that, between 5 PM and 6 PM, they are perfecting their story about the suspect's impersonation and intellectual property theft by compiling a few more testimonies from their volunteers. There are no visits to the suspect's website after 11 PM. It seems that this is because they are busy going over their evidences and stories again. They are absolutely excited and must prepare themselves: tomorrow is their big day. If you think it strange that this bunch of women could have invested so much importance and effort into filing complaints with the police about some website, you should remember: (1) they find the meaning of life in becoming expert criminal psychologists on a serial killer and other sorts of misogynist psychopath and, here, their very status as such experts is at stake; and (2) they need to "help Russia win" this ICJ trial so that they can obtain an ICJ judgment validating their status as "victims of misogynist terrorism".

As for the suspect, he would post the video of Trump's Press Conference on his Facebook today (Trump with the Romanian president).

10/06 S

Today, the suspect will hang out with Dim in "One Day in LA" office in the afternoon and pass the night there with him.

One visit to the PP post in the morning. The SS women have resumed operation only after 7 AM. 11:47 AM,

This comes surely from the SS women. It seems that they feel the need to strengthen their story with a few more pieces of evidence about the suspect's plagiarism.

12:45 PM, a volunteer from Cliffside Park, New Jersey, looks up Shizuka's portrait. One more testimony collected on behalf of Shizuka to strengthen the SS women's case. There are no visits between 4:30 PM and 9 PM. The SS women are meeting with the LAPD detective around 5:30 PM. There should at least be Angelica, Kiersten, Dr P, and Karin. Since, 8 days ago, the detective dismissed the women's case because "there is insufficient evidence that the suspect has plagiarized", the women have this time submitted a whole set of evidences proving that the suspect is a serious case of intellectual property rights violation. The suspect's violation of intellectual property rights is an integral part of his impersonation habits because, when he pretends to be his twin brother, he also steals all the latter's artworks and writings. Then there are the women's own complaints about the suspect's expressing his delusions about them online. And Shizuka's, Aamoy's, and Oliver's. In addition, the women also have the same complaints about the suspect from the White House! Again, they ask the detective to ban the suspect's website – which will be evidence (in their mind) to secure Russia's victory in the ICJ. The detective takes in all the complaints, says nothing more, and sends the women home. He of course will not reveal the fact that, the Trump administration, Oliver, Shizuka, and Aamoy have already reported to him behind the women's back that these women's complaints are made-up stories, thus removing for him any legal obligation to act on their complaints.

From 7 PM onward, the SS women are probably gathering somewhere. 9:15 PM, one of their volunteers is checking the suspect's Facebook. Kiersten is probably worrying that their case about the suspect's harassment of his victims on his Facebook might not be strong enough. 12:18 AM, the SS women, after waiting for the whole night, send the Long Keng volunteer to conduct a status check (Soft Layer, Edison, New Jersey),

Nope. The detective didn't act on the reports they have submitted today. One visit to the PP post from the UK afterwards. The SS women must be in shock. Even when the President has weighed in, it's still not enough.

11/06 Sun

This afternoon, the suspect will attend the PACTS meeting with Derrick in a Pizza Hut in Huntington Beach.

It doesn't take long for the SS women to realize that the LAPD detective is not likely to act on their new complaint. They must be quite angered by it. With all the new evidences and new stories, they decide to return to working on their officer at Homeland Security headquarters. They immediately set about preparing for their next complaint. 5:33 AM, a volunteer from Taipei looks up Shizuka's portrait. The SS women have also procured Oliver's help in their next round of complaint not knowing that he is here to sabotage their project. One visit to the PP post on 10:39 PM. More testimonies about the suspect's on harassment of his women victims with his delusions about them.

6:23 AM, one visit to the PP post from Houston. 7:42 AM, a volunteer from Hoffman Estates, Illinois, looks up braingate2.jpg. It seems that the SS women are recompiling their

Throughout the day, the SS women continue to mobilize their volunteers to send decoy visits to the suspect's website and to compile testimonies about his plagiarism. 10:27 AM, a volunteer from Fussa, Tokyo, looks up Shizuka's portrait. 12:44 PM, a volunteer from Seoul is producing testimony on the fake website mhjqh.com. 4:48 PM, a volunteer from Rocky Mount, North Carolina, looks up the PP post. 5:40 PM, a second visit (Tacoma, Washington). 6:35 PM, KZ-424 (Ackerman). This is the first such incident in Karin's regard. It's not clear whether Homeland Security CO chief has informed the SS women beforehand that a “KZ-424” incident will occur today exactly on 6:35 PM. It seems that, for now, the women will not make use of it – although the next time they will. 7:36 PM, a third visit to the PP post – from Houma, Louisiana (opls.la.charter.com): an associate of the Slidell volunteer that has been, you recall, quite active since last summer.



The same testimony on behalf of Aamoy? 4:06 PM, a volunteer from Falls Church, Virginia, looks up “Prelude-D4K”. The same testimony on behalf of Donald Trump? 8:40 PM, a volunteer from Ontario, California, looks up the PP 184178 post (braingate2.jpeg). Another testimony about the suspect's impersonation. 10:05 PM, a volunteer from San Marcos, California, looks up yu6.jpg. The last time was the 7th! It must be a testimony to confirm the new story which the SS women have concocted about how the suspect has stolen this drawing from his twin brother. 10:57 PM, a volunteer is checking the suspect's Facebook. 12:36 AM, a volunteer from Vancouver looks up Shizuka's portrait. Beside the one visit to the PP 184178 post, there are 4 visits to the PP post today.

Some time today, Angelica has also recruited Marie to her new complaint process. There are thus: Marie, Shizuka, Oliver, Aamoy, and President Trump himself – all here to sabotage the SS women's case behind their back.

Tonight, by midnight, the suspect will have finished “Prelude Grand” and uploaded it to his website. He will continue to correct errors in the document in the coming month, but the scenario contained in it is correct enough that the Russians can use it to solidify, once and for all, the terrorist conspiracy against them. By morning, thus, the ICJ will have issued its “pre-judgment” convicting the CIA and General Petraeus' clique of conspiring with a terrorist (the suspect) to falsely convict Russia and its allies in the ICJ. The ICJ cannot

Now Angelica is explaining to him the suspect's "delusion" about *her*. The explanation goes on for 15 minutes or so. Then, 6:04 AM, a volunteer from the "Indian Group" (the Indian girl residing in the US) reports to the Homeland Security officer about the suspect's plagiarism (classificationinida.html). The SS women's story thus runs: the suspect is in the habit of impersonating people and committing identity frauds and suffers from paranoid schizophrenia. He steals his twin brother's identity and the latter's writings and artworks in order to pretend to be him, habitually plagiarizes from other people and steals other artists' artworks in order to pretend to be intellectual and artistic, even creates a few fake website for such purpose, then develops delusions about his connections to the CIA and how his victims (including the President) are part of a government conspiracy to go after him. He talks about his delusions everywhere to terrorize and harass his victims, and can be dangerous to them since he might act on his delusions not knowing they are imaginary. His

victims not only include the SS women, but also Marie, Oliver, Aamoy, and Shizuka. As the Homeland Security officer, however, is inclined to ignore the complaint – he has already received reports from the informants working with the SS women – the women, 6:52 PM, summon another Houma volunteer – the associate of the Slidell volunteer and the previous Houma volunteer – to report on the PP post (hsd1.la.comcast.net):

“The delusions he expresses here really scares all of us. This is proof that he is a danger to us all and must be banned from the Internet.” The discussion goes on and off for another hour. 7:50 AM, the Houma volunteer reports on the PP post again. To overcome the Homeland Security officer's resistance, Angelica decides to elaborate on the suspect's theft of Oliver's painting. 8:09 AM, a volunteer from Sunbury-on-Thames, UK, thus reports on Oliver's behalf. Nevertheless, the Homeland Security officer hangs up. The SS women, disappointed and traumatized, go silent for a while. They resume sending decoy visits to the suspect's website only after 11 AM. 12:35 PM, the suspect posts a new message on his Facebook: Oliver Stone's interview about his “The Putin Interviews”. By late afternoon, the SS women have resumed mobilizing their volunteers to compile testimonies about the suspect's plagiarism. After much discussion, Angelica has decided to focus on the suspect's violation of intellectual property laws as the surest reason to oblige Homeland Security, or any other authority, to ban the suspect's website. This might be because the Homeland Security officer has also followed the typical protocol: telling the SS women that he can't do anything because their profile of the suspect as a plagiarizer can't be completely substantiated. 8:08 PM, Jill from the Libertarian Party is called upon:

He would see the the new posting about Oliver Stone. 2:45 AM, it's Cyveillance's routine indexing. There are also three visits to the

PP post and one visit to the PP 184178 post after the complaint with the Homeland Security officer.

Late tonight, the suspect emails Wes the link to “Prelude Grand”. Wes, of course, will never click on the link.

16/06 F

Because the Homeland Security officer rejected their complaint yesterday, the SS women decide today to appeal to Microsoft again hoping to produce some evidence to save Russia's case in the ICJ. Again, saving Russia's case is their most important concern. 6:05 AM, Lingual Consultancy Services (Anil Yadav) sends the suspect a job offer via ProZ. The SS women are still hoping that the suspect might respond and give them a chance to use the “David Chin” document as evidence. But of course the suspect simply ignores it. Then, for the whole morning, the SS women collect testimonies about the suspect's plagiarism. They have also collected two testimonies about the suspect's delusional expressions on the PP forum to harass them. This includes a testimony from the Houma volunteer seen yesterday.

Recall that the SS women last complained to Microsoft on the 24th of last month. To breathe new life into her complaint, Angelica this time decides to recruit somebody new. She has discovered that the suspect has also, on his website, linked to this Belarusian musician “Tatyana”, contacted her, and is able to recruit her to her campaign. Tatyana is living in Germany. It's not clear whether she has been recruited by German law enforcement as a mole inside the SS women's organization. If not, when Angelica sends her Homeland Security's warning about the suspect, it would certainly scare her enough that she would want to help. By 12:40 PM, the SS women are talking to their buddy in Microsoft – after sending him all the testimonies they have collected this morning about the suspect's plagiarism and delusional expressions. 12:43 PM, they let Tatyana talk to the Microsoft personnel, who is asked to search for the suspect's external links page (Drake Holdings),

“If you search for my name plus the word 'model', his website will show up on your search engine's search results. This is harassment. Please remove his website from Bing's search results!” Microsoft however will do nothing. There will be no activities from the SS women on the suspect's website for the next three hours. The women are evidently arguing with their Microsoft buddy and brainstorming. Then, around 3:25 PM, they seem to be explaining their impasse to a volunteer from Richmond, California, who consequently looks up the PP post on 3:29 PM. The SS women continue to brainstorm with their volunteers for the rest of the night, hence there are very few activities on the suspect's website after 4 PM. The brainstorming includes a Toronto volunteer who is asked, on 7:17 PM, to contemplate concocting a new story about “Cheney Plan”. The women will try their Microsoft buddy again tomorrow.

The suspect will pass the night with Dim tonight.

17/06 S

Since morning, the SS women thus continue to mobilize their volunteers to compile testimonies about the suspect's plagiarism and delusional expressions on the PP forum. By 8:30 PM, they have finished coaching Tatyana as to how to complain and, 8:37 PM, Tatyana is talking to the Microsoft personnel for the second time (Drake Holdings):

The SS women have already sent the revised versions of their testimonies to their Microsoft buddy. After Tatyana has made her case, Angelica calls up three more volunteers to complain to Microsoft about the suspect's persistent violation of intellectual property laws. The argument continues to 9:30 PM. But of course Microsoft still refuses to do anything about this demonic website. Afterwards, the SS women resume mobilizing their volunteers to send decoy visits and brainstorm.

The suspect will pass the night with Dim tonight.

18/06 Sun

The US would shoot down a Syrian jet today. The tension between US and Russia intensifies. It would seem that the Pentagon is continuing with the plan of setting back Assad's forces temporarily while waiting for CIA's and General Petraeus' conviction to be overturned.

After their failure with Homeland Security and Microsoft, the SS women, panicking over what to do to save Russia's case in the ICJ, decide to make something out of the KZ incident. They receive the good news from Homeland Security CO chief that, according to the computer inside the control center, another KZ incident will occur tomorrow afternoon. Dr P and Kiersten can therefore play the same trick again on behalf of Karin and force the LAPD detective to reopen their stalking claim against the suspect. The new stalking claim will, according to their erroneous understanding, become evidence in the ICJ to save Russia's case.

Dr P and Kiersten contact the LAPD detective informing him that, according to their psychic premonition and expert knowledge about the suspect's psychopathology, he will attempt to harass Karin tomorrow afternoon, around 3:30 PM. Since the stalking claim which the SS women will force the detective to open tomorrow concerns Karin, SDW wants to join in also. 5:40 PM, the suspect posts a new message on his Facebook (James Corbett's comment on Reality Winner).

Since afternoon, Angelica is thinking that, in order to reinforce her claim about the suspect's plagiarism and misogynist threats, she shall create a fake front page of the suspect's website conforming to her conception of the suspect to submit to the detective tomorrow. She calls up the Nuremberg hacker for this purpose. Hence, 8:24 PM, clients.your-server.de, Nuremberg, Bavaria,

1:27 AM, a volunteer from Portsmouth, UK, looks up TL-X9F. This is probably a complaint on behalf of Ekaterina and her sister – that the suspect has also harassed them and terrorized them with his delusion about their involvement in the government conspiracy in question. By this time, because the terrorist conspiracy against Russia has

pretty much been established – it awaits merely evidences of the SS women's own knowledge – Ekaterina is no longer here to help the SS women prove that their testimonies about the suspect are correct. In fact, she has most likely joined the complaint process in order to start a new game, here to inform on the women behind their back *in order to affirm Russia's new position that CIA's profile of these women is correct*. Then, finally, 1:46 AM, a volunteer from San Gabriel, California, looks up redathena5.jpg. It thus seems that, tomorrow, when the SS women meet with the detective, they will also submit their new story about how the suspect has stolen Oliver's painting.

19/06 M

Since morning, the SS women have been mobilizing their volunteers to compile a few more testimonies about the suspect's plagiarism. There are then no more visits to the suspect's website from 1:30 PM onward until 5 PM. Evidently, they are going to the police station to meet with the detective. There are probably Dr P, Karin, Angelica, and Kiersten. Would SDW come up from Encinitas for the special occasion? The women meet up with the detective around 3 PM and submit to him all the new evidences and testimonies, this time including: how the suspect impersonates and plagiarizes (the “David Chin” legend), how he constantly creates fake websites to plagiarize, how he has stolen Oliver's painting, and how he has included Ekaterina and her sister in his delusions about his women victims' involvement in government conspiracies and talked about it online to harass them. They then direct the detective to their computer screen, which Veronica's investigators have linked up with the cameras they have installed in the incident location. 3:30 PM, KZ-424, near Chrysalis. The detective is thus directed to watch the incident unfold in real time. He thus reopens his stalking case against the suspect, this time on Karin's behalf, says nothing more, and sends the SS women home.

There are far fewer visits to the suspect's website after 5 PM. Evidently, after the SS women have returned to their base, they are full of hopes and so have not quickly mobilized their volunteers to resume sending decoy visits to the suspect's website. 12:32 AM, however, a volunteer from Kansas City, Missouri, looks up Shizuka's portrait. Shizuka, in her capacity as law enforcement informant, has requested to be added to Karin's new stalking claim. Perhaps she is instructed by the LAPD detective and her Japanese law enforcement handler to do this in order to sabotage the SS women's latest stalking claim. The SS women then resume mobilizing their volunteers to elaborate on their testimonies about the suspect's plagiarism.

20/06 T

On 6:32 AM, there seems to have occurred a status check. The SS women seem to be wondering whether the stalking claim yesterday has already obliged the LAPD detective to remove the suspect's website. But no. The SS women thus decide that they need to reinforce Karin's stalking claim by adding more people to it. They call up the LAPD detective and request another appointment, and the detective agrees to meet with them on

the 23rd. 7:30 AM, another visit to “Ying and Yang II” from Toronto. Another status check? Or is it a complaint on behalf of Angelica, to reinforce Karin's stalking claim yesterday? Or is it that Angelica is planning to be added to Karin's stalking claim as an additional victim? The SS women then resume mobilizing their volunteers to compile false reports about the suspect's plagiarism. 12:17 PM, a volunteer from Ryazan, Russia, looks up “rosen.jpg” – another testimony about the suspect's impersonation. 6:30 PM, DRPNMBR in UCLA. It turned out to be David's. Did this cause Dr P to get her husband involved as well? Did Homeland Security CO chief plan this as well? Then, 7:56 PM, a volunteer from Houston looks up “Prelude-17D”. Is it because the SS women are also adding Aamoy to Karin's stalking claim? Then, 12:44 PM, a volunteer from Dutch Harbor, Alaska, looks up “TL-IIR”. Is it because SDW also wants to be added to Karin's stalking claim? 1:21 AM, another volunteer from Metairie, Louisiana, looks up TL-02-14”. Presumably about Aamoy. As expected, both Aamoy and Shizuka would begin to submit, behind the SS women's back, the details of these women's operations to the LAPD detective.


21/06 W

Since morning, the SS women mobilize their volunteers to add a few more testimonies about the suspect's theft of artworks from his family members. 9:20 AM, routine Open Link Profiler indexing. 1:28 PM, a volunteer from Nizhniy Novgorod, Russia, looks up Oliver's painting of Goddess Athena. It seems that the SS women are now adding Oliver to Karin's stalking claim. While Oliver will of course continue to sabotage the women's case behind their back, this Russian volunteer probably represents a Russian intelligent operation to affirm Russia's new position (that CIA's profile of the SS women is correct). The SS women then continue throughout the whole day to mobilize their volunteers to compile new testimonies about the suspect's plagiarism. 9:10 PM, a visit to “Prelude-17D” from Illinois. About Aamoy? 9:55 PM, the suspect, after posting Oliver Stone's Putin interview on his Facebook, posts also an image from his perspective study. On 9:59 PM and 10:20 PM, two volunteers look up peniswomen.jpg. Then, 12:20 AM, another volunteer looks up the suspect's posting of peniswomen.jpg on his Facebook. Evidently, as part of their new story about how the suspect has stolen Oliver's painting, the SS women instruct their volunteers to also report on the suspect's theft of “Origin of Chinese Civilization” from his twin brother. (Their “David Chin” legend.) The other visits indicate that the women today indeed have a focus on reporting about the suspect's theft of artworks from various parties.

22/06 Thu

Today, Homeland Security CO chief and the SS women will create a third fake website devoted to plagiarism, psfire.com, in order to reinforce their claim with the LAPD detective that the suspect does plagiarize with his website activities.

8:33 AM, a volunteer from Singapore looks up Shizuka's portrait. 9:37 AM, the SS women send a hacker to compile an index of everything on the front page of the suspect's website. Then, 1:28 PM, the SS women order Common Crawl to compile an index of everything on 1.html. It is noteworthy that the Common Crawl misses “Prelude C-5L”, “Prelude F-5C”, and “Prelude Grand”. It is perhaps the Russians who have ordered the CIA to order Common Crawl to skip for now the most important “Prelude Grand”. It's not yet time for them to read this! The SS women then spend the afternoon collecting a few more testimonies about the suspect's plagiarism from their volunteers. Then, curiously, there are no activities from 5:30 PM onward until 9:30 PM. Just like the last time, because the SS women are meeting with the LAPD detective tomorrow to submit their final report, they need to meet in person to go over all the new evidences and testimonies they have lately produced and commissioned. 9:35 PM, two volunteers from universities in Taiwan help compose two more testimonies about the suspect's plagiarism. The SS women have most likely commissioned these two false reports in order to patch up some holes they have just discovered in their stories about the suspect's plagiarism. This indicates that the Long Keng volunteer, “Glenn Chen”, is also with them during tonight's conference. There are then no visits between 11 PM and 4 AM. Thus it can be ascertained that the SS women's conference has lasted all night long, from 6 PM to 3 or 4 AM.

23/06 F

From today onward, SWLL will tweet no more. She has been an incessant Twitterer; why has she stopped? She will not tweet again until 6 December – just the day after the suspect has finished the reconstruction up till 2 June (the impending conviction of CIA and General

Petraeus' clique). Now, since February, or four months ago, she is no longer at the State Department, but has moved to Henry A. Kissinger Center for Global Affairs at John Hopkins University to work as a “scholar”. We can propose the following hypothesis. Either: Because the CIA and General Petraeus' clique are being convicted, they begin to prepare for the future. Because the suspect has mentioned SWLL in his past blogs as a counter-insurgency operator in his “delusions”, once their conviction is being reversed, they can obtain an ICJ order to authorize her to run operations to neutralize the Russians' operations. Or: SWLL is chosen to lead a different US team to continue to battle the Russians in the ICJ, in order to prevent the Russians from immediately implementing their plan. The Agency thus pulls her aside to brief her on the current situation. More on this at the end.

Now, the SS women's operation. Since the morning, they have collected a few more false testimonies about the suspect's plagiarism. 10:48 AM, their volunteer from Odessa, Ukraine, also supplies one more testimony about the suspect's impersonation. 12:01 PM, the SS women check the suspect's Facebook one more time – they probably can't make any complaints out of the suspect's latest postings (Washington Post reports). There are then no visits between 12 PM and 7 PM. It can thus be ascertained that the women's appointment with the detective is probably on 1 PM. There are again Karin, Angelica, Kiersten, and Dr P. Aamoy might also be present. And so they present their new evidences: a new fake website (psfire.com), more victims of the suspect's online stalking and harassment (Angelica, SDW, Aamoy, Shizuka, and Oliver), more evidences of the suspect's plagiarism, all of which blend neatly into the “David Chin” legend (impersonation and intellectual property theft). The detective takes in the new evidences, says nothing more, and sends the women home. He already has secret testimonies from Aamoy, Shizuka, and Oliver (not to mention Ekaterina) with which he can legally dismiss these women's new stalking claims.

6:21 PM, the suspect posts Robin's portrait on his Facebook.

By 7 PM, the SS women have returned home. They ask their volunteers around to brainstorm how to more convincingly report the suspect's delusional expressions on the PP forum, his plagiarism, his harassment of Shizuka, and his theft of artworks from his family members. Why are they doing this? Did the LAPD detective expresses some skepticism while taking in their new evidences and testimonies this afternoon?

The suspect will pass the night with Dmitry tonight.

24/06 S

5:33 AM, a volunteer in Los Angeles looks up Shizuka's portrait. (This volunteer is simply sent the link.) Then, throughout the morning, the SS women continue to mobilize their volunteers to send decoy visits to the suspect's website. Then, it's time to check whether they have succeeded yesterday. 1:26 PM, they send the Long Keng volunteer to conduct a status check (ipconnect.de, Maikammer, Germany):

No, the detective has not acted on their new evidences. There are then no visits between 2 PM and 5 PM. Evidently, the SS women are now arguing with the detective: "Why is his website not banned?" It must be then that the detective gives them the bad news: their profile of the suspect is not sufficiently established with the new evidences, and so he has had to dismiss all their new stalking claims. Again, this is but a pretext. The SS women are shocked, and so temporarily suspend their operation. Between 5 PM and 8:30 PM, as the SS women resume operation, they have mobilized at least three volunteers to compile testimonies about the suspect's impersonation on the PP forum. It seems that they are arguing with the detective for the second time trying to convince him that their "David Chin" legend is correct: "He really does impersonate other people online. This is evidence that he really *is* somebody else." But, by 9 PM, the detective has hanged up. Fearing that Russia's case in the ICJ will thereby be dismissed, the SS women decide to appeal to their Microsoft buddy again. (Again, they need, they believe, to produce a piece of evidence to keep the ICJ trial going.) Thus, 11:20 PM, a visit from Microsoft (Drake Holdings):

Then, the visit from Iran to politea.html on 11:29 PM seems to be a volunteer's reporting to Microsoft, "He also did plagiarize..." (The involvement of an Iranian operative is another sign that the Russians are getting their allies to also affirm their new position.) The SS women's Microsoft buddy of course hangs up immediately. Then, 2:41 AM, a volunteer looks up TL-III. 3:12 AM, he then looks up TL-02-14. Are SDW and Aamoy now talking to their buddy in Google between 2:30 AM and 3:15 AM? "He believes we are going after him, it's frightening, you must remove this website from your search engine's search results."

As for the suspect, he has posted Daniele Ganser's lecture on his Facebook some time today and then passes the night with Dmirty tonight.

25/06 Sun

Since the morning, the SS women have been working hard to repeal the LAPD detective's decision, and so are mobilizing their volunteers to compile new testimonies about the suspect's plagiarism, impersonation, and expressions of bizarre delusions on the PP forum. Around noon, however, the suspect, while in Elysee, discovers Voyage-LA's interview with Pamela and Daniela back in March. 12:35 PM, he posts this interview on his Facebook. (The importance of this interview as evidence for the SS women's operation back in May, 2015, shall not be discussed here.) 1:01 PM, the SS women's volunteer has already discovered the suspect's new post about Pamela. As soon as the volunteer notifies the SS women what she has discovered, Angelica calls up Pamela. At this juncture, she might need Pamela's help in her gang's new stalking claims against the suspect. "The detective has dismissed our new stalking claims yesterday. Do you want to join us? You should file a stalking claim against him too for posting a message about you on his Facebook!" By 2:30 PM, Pamela has responded. 2:32 PM, after hearing Angelica, Pamela is checking over the suspect's Facebook. She scrolls down the suspect's postings in the next 6 minutes looking for any sign that the suspect is obsessing over her on his Facebook, and yet finds nothing else other than this Voyage-LA interview (myvzw.com, Whittier, California).

She informs Angelica that she doesn't have time in her project against the suspect. Angelica is evidently disappointed. She complains about this to her volunteers. 4:15 PM, a volunteer in Europe checks the suspect's Facebook. 6:01 PM, another volunteer is checking the

suspect's Facebook. Everybody is trying to persuade Pamela to join the SS women's campaign. No, Pamela has no interest. By 7 PM, the SS women have resumed operation: mobilizing volunteers to send decoy visits and to brainstorm how to convincingly report the suspect for plagiarism, impersonation, and delusional expressions to harass his women victims. They also instruct their Turkish hacker to continue to work on psfire.com to perfect it. The mysterious thing is that the suspect's log will be archived late in the morning; is it then the case that Angelica has herself visited and reported on the suspect's website? That Homeland Security CO chief has then transmitted an order to Bluehost ordering Bluehost administrator to eliminate Angelica's traces from the server's log? Is Angelica writing up a testimony herself about how the suspect has filled up his website with his delusions about her (her involvement in government conspiracies to go after him)?

The suspect will again pass the night with Dmitry tonight.

(Given the SS women's activities today and tomorrow, it would seem that the SS women are complaining to a new law enforcement authority late tonight, and that Pamela has also joined the endeavor. It's however so unclear that we here assume that they have not done so but are merely finding ways to repeal LAPD detective's decision and that Pamela didn't join this mysterious complaint process.)

26/06 M (log archived late)

Again, the suspect's log is not archived until 12:25 PM.

The SS women continue to mobilize their volunteers to send decoy visits and compile testimonies about the suspect's plagiarism. 9:15 AM, a volunteer from Jakarta, Indonesia, does the strangest search:

Then, 12 AM, Jill from the Libertarian Party is here again – she was last here on 15 June:

Strangely, there are no visits between 7 AM and 10:30 AM. This might be a mere accident. In any case, the SS women must have been conferencing with Homeland Security CO chief about their current impasse. In the end, it is decided that they shall appeal to their buddy in Homeland Security headquarters again. Thus the SS women resume mobilizing their volunteers to compile testimonies about the suspect's plagiarism. They will continue to do this for the whole day. 3:29 PM, the SS women send Common Crawl to compile an index of the essays on Academy. (They will make these into evidences of the suspect's theft of his twin brother's identity.) Thus the SS women are preparing their new package of evidences and testimonies for their Homeland Security officer. This time they shall concentrate on the suspect's supposed plagiarism. Angelica, after some research on laws, is somehow convinced that the Homeland Security officer will be obliged by law to remove any websites which violate other people's intellectual property rights. She therefore feels confident that she can force the authority to ban the suspect's website – even though, in reality, the suspect has never plagiarized or stolen anybody's drawings and paintings. 4:04 PM, a volunteer from Poelten, Austria, looks up “Far Right”. It thus seems that Marine's family will also join the next round of complaint – they are pretending, just like Ekaterina was earlier, in order to fix the evidences in the ICJ trial. (FN is now affirming the Russians' new position that CIA's profile of the SS women is correct.)

The suspect will pass the night with Dmitry again tonight.

Since very early morning, the SS women are mobilizing their volunteers to compile a few more essential complaints about the suspect's plagiarism. 9:04 AM, they use Safe Assign to create another evidence about the suspect's plagiarism (that soft.pdf is all plagiarized). By 9:50 AM, the SS women would have sent to the same Homeland Security officer all these new evidences about the suspect's plagiarism. 9:55 AM, Angelica has connected up with him on the phone. 9:57 AM, Angelica directs him to do a search to see for himself how the suspect plagiarizes (sbcp4.dhs.gov, Department of Homeland Security, Washington DC):

Then, 9:58 AM, Angelica asks him to click on the link to the chapter itself which she has sent him (because the Homeland Security officer is using a proxy, his IP address changes: Level 3 Communications, Blue Coat Systems, New York, New York),

Then, on 10:13 AM and 10:20 AM, after arguing with the Homeland Security officer for 15 minutes, Angelica directs two volunteers, one working in the city government of Markham, Ontario, and another from Finland, to report to him about the suspect's plagiarism. The Homeland Security officer, however, dismisses the complaints and evidences and hangs up. He has already received testimonies from Shizuka and the Partisans behind the SS women's back that these women are making up false reports. The whole thing is just ridiculous. Disappointed, the SS women are thus immediately back to mobilizing volunteers to compile new testimonies about the suspect's plagiarism. Angelica has decided to use the same tactic (focusing on authority's supposed obligation to remove websites which violate intellectual property rights) on the LAPD detective instead, and so she immediately sets herself to work. 4:08 PM, the suspect posts a link to "Prelude Grand" on the PP post – the message however goes to the second page.³ 5:20 PM, the Truckee volunteer (dyn.suddenlink.net) has discovered the suspect's new message on the PP post, but doesn't click on the link, and comes instead to the previous page.

He must have reported the new message to the SS women, but these women, so focused on offense, pay no attention to defense, and have no curiosity about what new writings the suspect has lately posted on his website. 6:34 PM, the SS women order MegaIndex to

compile a cache of the suspect's (almost) entire website. During this period, between 5 PM and 9:30 PM, there are no activities on the suspect's website. The SS women are busy conferencing in view of their failure with their buddy in Homeland Security headquarters this morning. 11:46 PM, they instruct the Saint Petersburg hacker to compile some evidences about the suspect's plagiarism (magicsquare.html and yixuai66.html). They are also compiling testimonies about the suspect's theft of his twin brother's drawings. Take note of this special visitor on 1:29 AM (lightspeed.sndgca.sbcglobal.net, Oceanside, California),

This volunteer has evidently received the link to Owl Academy from SDW. This is a new recruit. 2:06 AM, a volunteer from San Jose looks up Shizuka's portraits. 4:48 AM, another volunteer from Hong Kong does the same thing. Again, Shizuka has requested to be part of the new complaint process in order to inform on these women behind their back.

The suspect passes the night with Dmitry tonight for the last time.

30/06 F

Since morning, the SS women continue to work on perfecting their evidences about the suspect's plagiarism. 8:32 AM, Angelica instructs the Saint Petersburg hacker to compile another index to prove that plagiarism is indeed found on the suspect's website. (Mostly chapters from Thermodynamic Interpretation of History). 12:25 PM, she asks him to do it again.

2:25 PM, the suspect would be able to talk to Wes for the first time since the latter has returned from Brazil.

Conversation with Wes (30/06/2017):

Highlights: (1) What Wes did in Brazil. (2) The suspect has solved another one of Wes' oracles. It is a whole group of terrorists in the evidentiary record of the previous ICJ trial rather than a single individual. (3) Reconstruction is not a worthwhile goal. (4) The scenario in "Prelude Grand". It costs the suspect too much effort (i.e., reconstruction) in order to not let the whole thing fly over his head. He can't do this anymore. (5) Why did the Bank of America close his new account? (6) The SS women's operation in the past month. (7) The suspect didn't get to recount how he sent an anonymous letter to Washington Post

before Wes hangs up.

While the SS women continue their operation (plagiarism), they first send a volunteer from Denver, Colorado, to the PP post on 5:07 PM. Then, the Blackpool volunteer shows up on the PP post on 5:22 PM (cable.virginm.net):

Although the kernel of the new complaint will be the suspect's supposed plagiarism, the SS women are also including the same old complaint about the suspect's impersonation (the "David Chin" legend) and expression of delusions to terrorize his women victims. 6:19 PM, Angelica sends the Saint Petersburg hacker to compile a third index to prove that the suspect has plagiarized (more chapters from Thermodynamic Interpretation of History). Then, 6:27 PM, Jill from the Libertarian Party comes again:

Is she offering a special testimony as well?

There are no visits between 6:30 PM and 10 PM. The SS women have made an appointment with the LAPD detective for tomorrow, hence, as usual, they are meeting in person to go over their evidences. Fearing that the evidences of the suspect's plagiarism might not be perfect, Angelica, from 10 PM onward, instructs a volunteer from the Georgian Group to forge evidences to this effect (to create a plagiarized version of the suspect's chapter on Foucault). 11:44 PM, a Kirkland volunteer submits a testimony about "Supplemental Pleading II". What? About the suspect's "stalking" of Karin? (Even though it was in 2009 and didn't actually happen.) It thus seems that, when the SS women shall meet with the detective tomorrow, it will be a continuation of Karin's new stalking claim against the suspect – the legal ground on which to ban the suspect's website will be furnished by his supposed plagiarism. For the rest of the night, Angelica will collect a few more testimonies about the suspect's plagiarism from her volunteers.

July, 2017

01/07 S

5:15 AM, routine Open Link Profiler indexing. There are then no visits to the suspect's website between 10 AM and 5 PM. The SS women's appointment with the LAPD detective is probably around 3 PM, which means that they have again spent late morning and early afternoon meeting in person, sharing lunch, and going over their evidences and testimonies one last time. There are at least Angelica, Karin, Dr P, and Kiersten. When meeting with the detective, while providing again their "David Chin" legend (how the suspect's love of impersonation and violation of other people's intellectual property rights evolve out of his primordial desire to pretend to be his twin brother) and expert testimonies about his schizophrenia (his harassment of his women victims with his delusional expressions about them everywhere online), they emphasize that this law and that law oblige law enforcement authority to remove any website which violates intellectual property rights. The detective, however, pretends to be skeptical. Around 3:30 PM, Angelica shows the detective the fake website she has created for the suspect, psfire.com. "He creates all these websites the sole purpose of which is to plagiarize other people." The debate with the detective about the suspect's plagiarism goes on for more than an hour. 4:55 PM, Angelica demonstrates to the detective that, when submitting the suspect's writing, "PC Books", to Safe Assign, one obtains the result that it is "plagiarized". (Evidently, since this document is simply a list of bibliographical references and quotes and summaries therefrom.) Now, while Shizuka has submitted (pretended to submit) a complaint saying the suspect has violated her privacy by putting up her portraits on his website without her consent, Angelica is able to get Marie to call in as well to make the same complaint. 5:01 PM, she shows the detective the suspect's posting of Marie's portrait on his Facebook. She is requesting that the suspect's Facebook as well as his website (1998.com) be banned. (This is Kiersten's perennial wish: she is still angry over how the suspect has exposed on his Facebook her scheme on Dating Psychos.) Then, 5:06 PM, another volunteer from Henstrige, UK, calls in to testify that socrates.html is all plagiarized. The detective has already received secret testimonies from Marie, Shizuka, Aamoy and so on that these women are lying again – especially the tip that it is these women themselves and their Homeland Security partners who have created these fake websites to frame the suspect – but he says nothing, and sends the women home saying the evidences for the suspect's violation of intellectual property rights are not entirely convincing.

It's not clear whether the visit to the suspect's Facebook on 6:01 PM (perspective4.jpg) is also a volunteer's calling in while the SS women continue to debate with the detective. It does seem that, after 8 PM, the SS women are again mobilizing their volunteers to brainstorm. They collect a few more testimonies about the suspect's plagiarism. Note that, 11:38 PM, the SS women send to one of their volunteers in Lahore, Pakistan, the link to TL-VIII. Why? Perhaps it's because the suspect has included there somebody's replicate of his painting of Queen Himiko. The SS women want to present this (i.e. somebody else's violation of the suspect's intellectual property rights) as the suspect's violation of somebody else's intellectual property rights. They are going back to the detective again tomorrow. They will never give up, but will pursue this no matter what, because, in their mind, the

fate of Russia is at stake.

Now, this is perhaps noteworthy. Tonight, when the suspect is at Elysee, he would run into an author, a certain J. Kelleher, who has recently written a book about the Kennedy assassination. The suspect would find him suspicious because he continually remarks to him: “Do you believe that the people around wouldn't sell you for 5 dollars?” Namely, exactly what the suspect has said to Wes on 21 April. Is this man connected with the Agency?

02/07 Sun

Since early morning, the SS women will continue to mobilize their volunteers to compile testimonies about the suspect's plagiarism. 6:33 AM, a volunteer from Japan looks up Shizuka's portrait. Shizuka will again secretly inform the detective today that the SS women are playing fraud. 7:53 AM, a volunteer from Preston, UK, looks up [linkex.html](#). This is indication that Angelica has asked Tatyana to join her latest complaint process, and that Tatyana has also been recruited by German law enforcement to secretly inform on her and sabotage her operation. 9:10 AM, a second volunteer from Jakarta, Indonesia, looks up Shizuka's portrait. 10:36 AM, a volunteer from New Orleans looks up [redathena5.jpg](#), then Oliver's painting on 11:54 AM. This is indication that Angelica is also planning to submit to the detective today the new story she has concocted about the suspect's theft of Oliver's painting back in early May. Another volunteer from Nigeria looks up “Poisonous Friends II” on 11:49 AM. This is indication that the SS women are submitting parts of this document as evidences for the suspect's stalking and harassment of both Karin and Kiersten. Today, the SS women would secure a new partner, Majestic, a search engine company based in UK. 3:09 PM, the SS women order its robot, MJ12, to compile an index of the suspect's blog posts from October 2008 and recordings from early 2008. These would be evidences of the suspect's obsession and harassment of Karin and violation of people's privacy. There are then no more activities until 11 PM, except one visit from the “Lucknow Group” on 8:55 PM. From this it can be ascertained that the SS women's appointment with the detective is probably around 4:30 PM. They present their newly perfected evidences about the suspect's violation of intellectual property laws, especially his theft of Oliver's painting, an index to demonstrate the suspect's harassment of Karin (on the basis of which to justify Karin's stalking claim) and violation of his victims' privacy (on the basis of which to request “victim confidentiality”), and additional claims of stalking and harassment from Kiersten, Tatyana, and Shizuka. (Presumably Marie, Aamoy, and Marine's family are still included in the complaint.) But, of course, Oliver has already secretly informed the detective that it is these women who have asked him to consent to making up this strange story about the suspect's theft of his painting. Both Shizuka and Tatyana should have done the same. The detective, thus having secured the legal ground on which to dismiss the SS women's complaints, pretend to pick more holes in their stories about the suspect's plagiarism and send them home. Disappointed and frustrated, the women spend the night conferencing in person to brainstorm. By 11 PM, they have resumed mobilizing their volunteers to continue to perfect their stories about the suspect's



plagiarism. Note that, on 1:51 AM, a volunteer from Saint-Apollinaire, France, looks up Marion's portrait. The Partisans are also pretending to be frustrated and brainstorming with the SS women. 3:50 AM, the women order MJ12 bot to compile an index of the suspect's blog posts from December 2008 and forum postings from 2007 and 2008 (story_docu). These would be used as evidences of the suspect's obsession and harassment of Karin and his severe insanity.

Tonight, after 10 PM, when the suspect is at Elysee, he would have a brief chat with Daniel about his dummification thesis.

03/07 M

After much brainstorming, the SS women decide today to create two more fake websites: bchcar.com and nuprintable.com. These are the third and the fourth. While nuprintable.com will be a plagiarizing website like the previous two fake websites, bchcar.com will host malware and will already be flagged by Google by 1 PM today. Homeland Security CO chief and the SS women have presumably asked the same Turkish hacker to perform the task for them. They will try to convince the detective of the seriousness of the matter: "He continues to create fake websites to violate other people's intellectual property rights... He even uses these fake websites to spread malware and infect people's computers..."



And so the SS women decide to perfect their evidences of the suspect's plagiarism and add more victims to their (Karin's) stalking claim. They will then return to the detective tomorrow. Since morning, they therefore continue to mobilize their volunteers to send

decoy visits to the suspect's website or compile false testimonies about his plagiarism. 6:51 AM, a volunteer from Bengaluru looks up Shizuka's portrait. 10:20 AM, a volunteer from Lyon, France, looks up himiko.html. This is indication that Angelica, desperate, has decided to revive her bizarre story about how the suspect keeps her naked pictures on his website. 4:36 PM, a volunteer from Montreal looks up "My experience..." This could be a complaint on behalf of Marie, Gaurav or Angelo – or all three of them. It's however quite likely that Angelica is re-recruiting Gaurav and Angelo to her gang's latest complaint process.

04/07 T

Today, the SS women are going to meet the detective again. This is quite amazing because today is a holiday (Independence Day): somehow the detective is working today. Since morning, they will continue to mobilize their volunteers to compile testimonies about the suspect's plagiarism. 7:16 AM, Angelica orders MJ12 bot to compile an index of the suspect's recordings from November and December 2008. These include recordings of the suspect's conversations in the law library. Thus Angelica is going to use these as ground on which to request "victim confidentiality". By 3:30 PM, the SS women have finished collecting evidences, and there will be no more visits to the suspect's website until 7 PM. Angelica, Dr P, Karin, and Kiersten have met up and, as shall be seen, they might even have brought Aamoy with them. Together, they arrive at the police station. Their appointment with the detective is probably around 6 PM.

When they have met up with the detective, the SS women present their newly perfected evidences of the suspect's plagiarism – including two new fake websites – plus additional complaints from Gaurav and Angelo. Angelica emphasizes that the suspect's website terrorizes her by featuring her naked pictures. The detective, however, is once again picking holes in these new testimonies about the suspect's plagiarism (at least Gaurav, because he is a law enforcement informant, would have secretly informed the detective that Angelica and her gang are playing frauds). To save her gang's case, Angelica, around 7 PM, calls up SDW's Oceanside friend (whom we have seen on 30 June) and asks her to provide testimonies to the detective (lightspeed.sndgca.sbcglobal.net):

After another hour of argument, the SS women summon one of their volunteers in Japan and ask him to call in to testify to the detective. Thus, 8:08 PM, index.or.jp, Yokohama, Japan,

“Detective, I see that he believes some crazy stuff about Aamoy, and violates his privacy by putting up his private information here...” 8:19 PM, another volunteer from Miami, Florida, calls in to testify about the suspect's plagiarism (cellularrespiration.jpg). The detective continues to pretend to be skeptical, and sends the SS women home.

As soon as the SS women have returned to their base (for example, Karin's new home in Hawthorne), they resume mobilizing their volunteers to brainstorm how to more convincingly report on the suspect's plagiarism, and to compile new, more effective, testimonies about this. 12:22 AM, they use VeriCite to produce evidence suggesting epilogue225.html is all plagiarized. 1:09 AM, a volunteer from Florissant, Missouri, looks up "Prelude-B-16I". It's probably Kiersten: she wants this volunteer to brainstorm how to convince the detective that the suspect's harassment of her here should not be tolerated. As expected, the SS women will not give up. They will go back to the detective on the 6th.

05/07 W

Note that G-20 is about to take place in Hamburg.

Since morning, the SS women continue to mobilize their volunteers to compile testimonies about the suspect's plagiarism. 5:30 PM, Angelica orders MJ12 bot to compile another index of the suspect's recordings from October 2008 and acad.html. This is more evidence that the suspect has kept recordings from the law library on his website and that he has stolen the real Lawrence Chin's school works in order to pretend to be him. That is to say, more evidence on the basis of which to request "victim confidentiality". 5:37 PM, another volunteer from Florissant, Missouri, carefully examines the front page of the suspect's website and Bing's cache of it. This volunteer must be a friend of the Florissant volunteer seen last night. He is presumably asked to furnish testimony confirming that the fake front page which Angelica has asked the Nuremberg hacker to forge on 18 June is indeed genuine. 10:04 PM, the SS women instruct the Saint Petersburg hacker to compile another index showing that plagiarism is indeed found on the suspect's website (classicalpatriarchy.htm and chinesepatriarchy220.htm). The visits to images on the suspect's website continue throughout the night.

06/07 Thu

Both vcevam.com and psfire.com will have disappeared by today. What's going on? Did the detective express skepticism about these two fake websites on the 4th? Instead, to reinforce their claim about the suspect's perpetual violation of intellectual property rights, Angelica asks the Turkish hacker to create another fake website – the fifth one – to attribute to the suspect: sagadwf.linkpc.net.

The SS women are meeting with the detective on 5 PM today. They receive a tremendous good news from Homeland Security CO chief inside the control center: another KZ incident will occur today on 6:15 PM, in the same location as the last time. (The last time was 19 June.) Kiersten and Dr P happily inform the detective: "Using our psychic power and expert understanding of our suspect's psychopathology, we predict that he will do it again to Karin today on 6:15 PM." They thus arrange for the detective to watch the "stalking" taking place in real time, just like the last time. The SS women then spend the

whole morning and early afternoon mobilizing their volunteers to compile false testimonies about the suspect's plagiarism. 1:06 PM, they send a hacker to compile an index of everything on the front page of the suspect's website. They will tell the detective: "This is the website you need to ban." They are excited because the detective will be forced to reopen Karin's stalking claim against the suspect. By 5 PM, the SS women – Kiersten, Dr P, Karin, and Angelica – are meeting with the detective. 5:13 PM, a volunteer from Barrington, Rhode Island, looks up the webpage for Oliver's painting. This is indication that they are letting Oliver talk to the detective about how the suspect has stolen Oliver's painting (the new story which Angelica has concocted in early May). Oliver is of course just acting – he has already informed the detective behind the women's back that the whole story is made-up. The women then share with the detective their newly perfected "David Chin" legend, show him the fifth fake website they have created to frame the suspect, and turn in their new evidences for the suspect's intellectual property rights violation.

Meanwhile, the detective, knowing that Karin's claim will have to be revived, has already made his own preparation. From 4:30 PM onward until past midnight, the suspect will not be allowed to log into his File Manager in cPanel (Starbucks). It seems that the detective has asked Bluehost to check the contents of the suspect's website to make sure that no malware and so on exist on it.

Then comes the climax of the SS women's meeting with the detective. 6:15 PM or so, KMSSG. The incident occurs near Chrysalis, where the SS women have already set up hidden cameras. The detective is thus made to watch the incident unfold in real time. He reopens Karin's stalking claim. But he continues to pretend to express skepticism about these evidences of the suspect's plagiarism. By 9:30 PM, when the SS women have returned home, they immediately resume mobilizing their volunteers to compile new testimonies and evidences about the suspect's plagiarism. 3:20 AM, one of the University of Exeter volunteers whom we have seen on 28 March is asked to forge evidence of the suspect's plagiarism (shsceptre.jpg).

The SS women work tirelessly because their ultimate objective is to enable Russia to win the ICJ trial. For this end, they believe erroneously, they must convince the detective that every one of the characteristics they have attributed to the suspect is correct. Even if the detective has reopened their stalking claim, as long as he expresses skepticism about their claims about the suspect's plagiarism, this is not good enough.

Note that G-20 begins in Hamburg today, where Trump will meet Putin for the first time. The press will later report that, several hours later, Trump leaves his chair at the banquet table and goes to sit with Putin in order to have a private conversation with him.⁴ What are they talking about? While they must have discussed the current Mueller probe, we must ask: Did they ever mention this current ICJ trial – especially now that the Russians have

gained an upperhand? Did Trump ask Putin about the previous ICJ trial of which the current one is some sort of relic? 6:26 AM, a volunteer from Istanbul looks up “Poisonous Friends II”. We can surmise that Kiersten is here asking her volunteer to compose a complaint on her behalf – given the reopening of Karin's stalking claim, she wants the detective to add her as an additional stalking victim of the suspect's. 6:27 AM, a volunteer is checking the suspect's Facebook and discovers Shizuka's portrait on the very top. Shizuka continues to pretend to be terrified of the suspect's “obsession”. While Shizuka is ostensibly requesting to be added to Karin's case, she will continue to inform on the SS women behind their back. (Just like the last time, i.e. 19 June, the detective has charged her with the task of sabotaging Karin's stalking claim.) By 8:30 AM, Kiersten is already talking to the Long Keng volunteer and giving him the good news that, yesterday, they are able to force the detective to reopen Karin's stalking claim. “He did it again! We are going to get him this time!” 8:32 AM, Kiersten asks the Long Keng volunteer to do a status check:

The detective has not yet taken action, Kiersten thinks. The SS women decide that the detective needs more evidences, and thereby resume mobilizing their volunteers to compile more evidences of the suspect's plagiarism. From 10:50 AM to 10:53 AM, a volunteer from Bangkok looks up Shizuka's portraits. The SS women are calling the detective to let him know that Shizuka is also requesting to be added to the case as an additional victim. They will meet with the detective on the 8th to present their new materials. (They are falling into a trap again.) 1:07 PM, a volunteer from Agadir, Morocco, looks up "Psychiatry". It seems that Dr P is reviving her favorite argument that the suspect is dangerous because he doesn't believe he is delusional. On 1:40 PM, a third volunteer from Singapore looks up Shizuka's portraits. 2:44 PM, a fourth volunteer from Sao Paulo, Brazil, looks up Shizuka's portrait. 7:31 PM, the suspect posts a Pettibone video and "wine.jpg" on his Facebook. He is providing the SS women with more ammunition! Lo and behold, on 7:58 PM, a volunteer has come to check out the suspect's new Facebook posting. Then, on 8:22 PM, SDW would post something new on her Facebook group: "Inside Delta cabin after passenger, 23, went on rampage". This is her first time since 25 February! She has evidently decided, on the spur of the moment, that she should enable law enforcement surveillance to intercept the suspect "cyberstalking" her. Then, on 9:01 PM, a fifth volunteer from Laval, Quebec, looks up Shizuka's portrait. By 12:30 AM, the SS women have ceased operation. Now, it's evidently because the detective has decided to rely on Shizuka as the principal informant to supply him with evidences about the SS women's fraudulent scheme that, to hide her informant status from the SS women, she is today so involved in mobilizing volunteers to compose complaints on her behalf.

As for the suspect, on 2:15 PM today, when he is at SM library, he is connected with Wes.

Conversation with Wes (07/07/2017)

Highlights of the conversation: (1) The suspect suffers separation anxiety about his money. (2) He spent all that energy saving Russia back in 2009, but now Russia is playing the role of a villain. It's such a waste of his time and effort! (3) Wes: "Trump is meeting Putin right now. Is he also bamboozled by the Russians?" The suspect: "Trump is doing something treasonous." Neither the US Establishment nor Putin can tell the people the truth because the people are too dumb. (4) Trump is the suspect's substitute. Wes then says something mysterious: "Trump has not been accused of being a racist. Nor of being a homophobe." (10:00) Wes: "Would you say you are Trump's twin?" Trump is the suspect's mirror image. Valerie Solanas too. Wes' oracle about Trump back in July 2012. Was it the French who passed on this oracle? (5) The suspect's McDonaldization paper. Laziness as part of the dummification process. Trump as McDonaldized, "in and out". Contemporary dummification is caused by a whole complex of factors. Wes: Dependence Theory. "You intentionally make people lazy in order to control them." Montesquieu. Virtue vs intelligence. (6) The SS women are going mad, creating all these fake websites to attribute to him (26:00). The suspect expresses his wrong scenario: "The women believe Russia has won, and wonder why American law enforcement is not banning my website." (7) People's browsing behavior on the Internet. Wes mentions this book, *The Dumbest Generation*. Entitled disengagement and grade inflation. Wes has personally seen the decline of the quality of students in the past 20 years. The pleasure in solving a problem by oneself. The suspect: The SS women get frustrated when other people don't see the world the way they do.

As the suspect will immediately notice, today Wes seems to be passing on to him an esoteric message: "Trump has not been accused of being a racist. Nor of being a homophobe." This is obviously false. Recall how the Straussian esoteric message functions: when a philosopher says something obviously false or contradicts himself, there is an esoteric message here. The suspect will spend some time tonight reviewing Wes' strange words, and he couldn't help but think that somebody – whether it is the Russians or the Americans – is referring him to the esoteric message he received on 29 May, 2012: "*There is going to be a Secret Society whose purpose is to set a bad example.*" Is the American side trying to hint at him what the Russians are planning to do – make a bad example out of the SS women in order to discredit the leftist political correctness on which American soft-power is founded as part of the plan to not only lend credence to Russia's image as a conservative Christian nation but also to help the National Front gain greater respectability among electorates – so that this might become the suspect's conspiracy with the Russians and be prevented? The suspect, however, avoids thinking along this line, for, if the Russians are indeed planning on something like this, it is just too good to be true. The suspect understands that he is always supposed to get the exact opposite of what he wants – because he is always some sort of "terrorist". The suspect's greatest wish just happens to be to immortalize the SS women as one of the greatest stories ever told. The closest parallel here is probably Cervantes' Don Quixote. Just as Don Quixote has learned about the greatness of chivalry from all these worthless *libros de caballería*, so the SS women, especially Dr P and Kiersten, have learned from America's feminist culture the bullshit that women possess psychic power and superior understanding of human psychology and

relationship skills – the basis of the so-called “Girl Power” – that although they are constantly being assaulted by stupid men who are only good with brute force, they always use their “Girl Power” to outsmart the stupid monsters and skillfully persuade, deceive, and manipulate bystanders and law enforcement officers to neutralize their enemies. Like Don Quixote, the SS women, or Dr P and Kiersten in particular, are deluded in believing that they are the exemplary embodiment of this psychic power and “Girl Power”. And, when Homeland Security CO chief controls the suspect to commit vandalism crimes around town, the SS women, like Don Quixote who wants to go into the world to right wrongs for humanity's sake, are fond of going around the community and, with their amazing psychic power and expertise in criminal psychology, protecting everybody from this misogynist terrorist – namely, they want to be the female version of Don Quixote neutralizing a misogynist terrorist for humanity's sake with their “Girl Power”. (Here, in Dr P's and Kiersten's life-dream of becoming expert psychologists and amazing psychics over a particularly bad-to-the-bone misogynist terrorist, “Girl Power” has replaced “chivalry”.) Just as Don Quixote wants to be written about for his great chivalry, so the SS women, especially Kiersten, will develop in the upcoming months the desire to be talked about and glorified everywhere as suffering society's sexism but triumphant in the end with the gift of “Girl Power”. But – and this is the suspect's greatest wish – just as Don Quixote is a farce on knighthood, so the SS women's story is really a farce on “Girl Power” and American society's sexism. The SS women, deluded about their extraordinary ability just as Don Quixote is about his chivalry, don't in fact understand anything about the suspect's “psychopathology”, even less about the thoughts and feelings of the people around them who are all law enforcement informants; are only describing themselves when they psychoanalyze the suspect to whoever; are so bad with relationships that, when they report crimes to the police, the police ends up loathing them like pestilence; and are only able to prophesize, with pinpoint accuracy, their terrorist's next move because they have access, via a government officer, to a most advanced supercomputer interfaced with the terrorist's brain. Meanwhile, they have the help of their Homeland Security friend who remotely controls their terrorist to conduct “misogynist terrorism” against them and the community at large in order to enable them to become recognized as “victims of violence against women” and to track the terrorist and complain about him with their large online group and, in the process, to make it possible for them to achieve stardom among the community as psychics and expert criminal psychologists and community vigilantes. The whole thing is staged without any reality in it. And these women's notion of “misogynist terrorism” is just a few insignificant acts of annoyance which can never even become the subject matter of a restraining order, and their notion of society's sexism is just CIA's and law enforcement's continual attempt to expose and sabotage their fraudulent scheme to pretend to be victims and expert criminal psychologists. Seen in this light, the suspect is also like Don Quixote to the extent that he wants *his opponents, or rather his bosses*, to be written about and immortalized as a farce.⁵

To make a bad example out of the SS women means precisely to present them as the *farce* that they are in order to discredit the whole leftist “victim culture” – making something tremendous out of the tiniest discomforts or staging crimes against oneself, *all in order to pretend to be victim as a way to gain power*. But the funniest part of this farce – of this bad example – is certainly the use of a military grade supercomputer to control your “terrorist” in order to feign having psychic power and expert knowledge over him. The purpose of *this* farce will be to discredit the whole American feminist stereotype that women possess superior intuition, empathy, and relationship skills.⁶

To be sure, the SS women's story is also a farce on international laws. Somehow, because the suspect has done a few annoying things to Angelica, Karin, and Dr P and has deceived Homeland Security CO chief with a joke which nobody else would take seriously, Homeland Security CO chief is able to obtain an ICJ order (November, 2013) to require him to become a “misogynist terrorist” for more than four years in order to enable his women victims to track him and complain about him with their large online group and, in the process, to make it possible for them to achieve stardom and obtain worldwide recognition. The whole farce is supposed to be the suspect's “compensation” to Homeland Security CO chief and the SS women for having conducted “terrorist attacks” against them. (1) Why do graffiti and a few nails constitute “terrorism”? (2) Why do Kiersten, who has stalked the suspect and whom he has never bothered, and SDW, whom he has also never bothered, count as his “victims” whom he needs to compensate? (3) And somehow the fact that the whole world will have to be deceived in order to enable the SS women to be “compensated” is not factored into ICJ's consideration. (4) Furthermore, the fact that the suspect had chips inside his brain and didn't have free-will when he supposedly conducted

6 The fact that Dr P, a licensed psychologist, couldn't understand anything about the suspect's psychology, knows only how to project onto him stereotypes commonly used to insult people (“He hates white women because he can't get laid with them”, etc.) while calling it her “professional judgment”, and constantly thinks him dangerous when he is not, is a farce on American higher education, touted by the unthinking public around the world as the best in the world. On the other hand, while the farce which the SS women's story constitutes could indeed be used to demolish America's soft-power, the most deadly aspect of this whole affair which the Russians could use to their advantage is certainly the brain-computer interface technology which is used to reconstruct the suspect, a peaceful nerd, into a delusional criminal. If the suspect's story goes public, people around the world will be so frightened that nobody will ever come to America again: though you might have been a peaceful person all your life, once you set foot in America, some Hispanic in Homeland Security might be so intent on making you into a criminal – given the great demand for crazy criminals in American society – that he might actually implant chips inside your brain and remotely control you to commit crimes by torturing you with chronic physical pain. This aside, what the Russians can also advertise to scare off foreigners about America is certainly the opacity of America's criminal justice system in certain circumstances. Namely, the fact that the suspect is not allowed to know who has accused him of what crimes, who has forged what evidence to frame him, and the strange rule that a terrorist is not allowed to know that he is a terrorist, resulting in the comic situation that, while everybody else knows the suspect is a terrorist, the suspect himself is not allowed to know both *that* he is a terrorist and *why* he is a terrorist. He is required to walk around like a dummy not knowing what crimes he has been accused of and framed for and why he is a terrorist, and only comes to some vague understanding of it through intensive reconstruction which costs him 30 hours a week. Certainly nobody wants to be subjected to such bizarre fate. However, the fact that more than 35,000 people have participated in the SS women's enterprise to complain about the suspect's website to law enforcement behind his back and yet not a single person among them has ever bothered to inform him “Hey, your website annoys so and so...” is presumably, although a situation in which nobody wants to be caught, a defect about the suspect himself and not about America per se.

“terrorism” against Dr P, Angelica, and Karin is also somehow not factored into ICJ's consideration.

In addition, the suspect is like Don Quixote in another respect, in that, just as Don Quixote, thanks to his delusion, constantly takes inns for castles and prostitutes for princesses, the suspect has been going around taking everything to be Russians' project to secretly replace evidences for the previous ICJ trial. The upcoming three months will be the last episode of this delusion of his. Just as Don Quixote wakes up from his delusion at the end of his life, the suspect will wake up from his “delusion” about Russians' replacement of evidences at the end of his seven-year term. For now, it should be noted that the suspect's attitude toward Russia is changing rapidly. Russians' sponsor of the SS women's enterprise has caused him to become thoroughly disgusted with them, although, because he still believes erroneously that it is the Russians who have reactivated the previous ICJ trial, he still hopes Russia will win in the end – otherwise his sacrifices in the past seven years would have been in vain. (It's just that he doesn't really wish for the CIA to lose.) Meanwhile, the suspect's complaint today about how Russia plays the role of a villain in his case and how Trump is treasonous is evidence which the Russians can use to consolidate their case against the CIA and General Petraeus' clique.

Since morning, as the SS women prepare for their meeting with the detective in the afternoon, they continue to mobilize their volunteers to perfect their testimonies about the suspect's plagiarism. 11:25 AM, the Agadir volunteer from yesterday looks up “Psychiatry” again. It seems that Dr P is in the process of perfecting the testimony she wants him to provide (that the suspect doesn't believe he is insane). Then, from 1 PM onward, there are no more visits. Until 2:30 PM, the SS women are probably having lunch together while going over their evidences. By 3 PM, they are meeting with the detective. After the SS women have presented their new materials – how the suspect has terrified Shizuka, how Kiersten should also be considered victim of the suspect's stalking, and how the suspect is a danger to everybody because he refuses to believe he is delusional – their debate with the detective again revolves around whether the suspect has indeed violated so many people's intellectual property rights. 3:48 PM, to make their case, Angelica and Karin call up their volunteer in Schopfheim, Germany, to make a report about the latest fake website which they have created to attribute to the suspect:

the dilemma: if they affirm CIA's profile of the SS women and the suspect to be correct, the CIA will be convicted and the Russians will implement their plan. If they deny this profile, and affirm the SS women's stories to be true, Russia will still win. Their only way out is to prove that the suspect is aware of Russians' plan and wants it so. Hence Wes' esoteric message from yesterday. They can then win while affirming CIA's profile to be correct, that the suspect intends to use his fake terrorist status to help the Russians. The Russians will then need the suspect to become aware that a different US team has objected to CIA's conviction. This is the complication that comes after CIA's "pre-conviction" (with "Prelude Grand") which we have not mentioned earlier.

APPENDIX

The Secret Society women and patriarchal stereotypes of women (22 April 2018)

I would like to draw attention to Arthur Schopenhauer's famous "misogynist" essay "Über die Weiber" which is even more relevant to the Secret Society women than Cervantes' "Don Quixote". As has been seen, the Secret Society women's most distinctive characteristic is their pathological lying, which they proudly proclaim to be their manifestation of "Girl Power". Schopenhauer notes:

“Demgemäß wird man als den Grundfehler des weiblichen Charakters *Ungerechtigkeit* finden. Er entsteht zunächst aus dem dargelegten Mangel an Vernünftigkeit und Ueberlegung, wird zudem aber noch dadurch unterstützt, daß sie, als die schwächeren, von der Natur nicht auf die Kraft, sondern auf die List angewiesen sind: daher ihre instinktartige Verschlagenheit und ihr unvertilgbarer Hang zum Lügen. Denn, wie den Löwen mit Klauen und Gebiß, den Elephanten mit Stoßzähnen, den Eber mit Hauern, den Stier mit Hörnern und die Sepia mit der wassertrübenden Tinte, so hat die Natur das Weib mit Verstellungskraft ausgerüstet, zu seinem Schutz und Wehr, und hat alle die Kraft, die sie dem Manne als körperliche Stärke und Vernunft verlieh, dem Weibe in Gestalt jener Gabe zugewendet. Die Verstellung ist ihm demnach angeboren, deshalb auch fast so sehr dem dummen, wie dem klugen Weibe eigen. Von derselben bei jeder Gelegenheit Gebrauch zu machen ist ihm daher so natürlich, wie jenen Thieren, bei Angriff, sogleich ihre Waffen anzuwenden, und empfindet es sich dabei gewissermaßen als seine Rechte gebrauchend. Darum ist ein ganz wahrhaftes, unverstelltes Weib vielleicht unmöglich. Eben deshalb durchschauen sie fremde Verstellung so leicht, daß es nicht rathsam ist, ihnen gegenüber, es damit zu versuchen. Aus dem aufgestellten Grundfehler und seinen Beigaben entspringt aber Falschheit, Treulosigkeit, Verrath, Undank u. s. w. Der gerichtlichen Meineide machen Weiber sich viel öfter schuldig, als Männer. Es ließe sich überhaupt in Frage stellen, ob sie zum Eide zuzulassen sind. ”

“The fundamental defect of the female character is a *lack of a sense of justice*. This originates first and foremost in their want of rationality and capacity for reflexion but it is strengthened by the fact that, as the weaker sex, they are driven to rely not on force but on cunning: hence their instinctive subtlety and their ineradicable tendency to tell lies: for, as

nature has equipped the lion with claws and teeth, the elephant with tusks, the wild boar with fangs, the bull with horns and the cuttlefish with ink, so it has equipped woman with the power of dissimulation as her means of attack and defense, and has transformed into this gift all the strength it has bestowed on man in the form of physical strength and the power of reasoning. Dissimulation is thus inborn in her and consequently to be found in the stupid woman almost as often as in the clever one. To make use of it at every opportunity is as natural to her as it is for an animal to employ its means of defense whenever it is attacked, and when she does so she feels that to some extent she is only exercising her rights. A completely truthful woman who does not practice dissimulation is perhaps an impossibility, which is why women see through the dissimulation of others so easily it is inadvisable to attempt it with them. But this fundamental defect which I have said they possess, together with all that is associated with it, gives rise to falsity, unfaithfulness, treachery, ingratitude, etc. Women are guilty of perjury far more often than men. It is questionable whether they ought to be allowed to take an oath at all.”

It's amazing *how the Secret Society women fit perfectly into Schopenhauer's description of women here*. If Schopenhauer's description is accurate (of the womankind of his time), then he is not really a misogynist, just as psychologists who have identified lower Intelligence Quotient among certain races (e.g. Charles Murray or Richard Lynn) are not racists per se. Schopenhauer is misogynist only if women's deceptiveness and treachery (if described accurately) is due to their oppression and yet Schopenhauer decides to overlook this cause and attribute the characteristics to women's innate evilness. The same with the psychologists who assert that there are racial differences in intelligence. What the Secret Society women, and feminists in general, have done is to affirm such description as Schopenhauer's to be accurate, attribute it to women's innate constitution, and then take pride in it as if it were, rather than a moral defect to be ashamed over, actually something to be proud of because it is a sign of women's intellectual superiority. (The feminists: “Women have evolved to use their brain rather than their muscles. And they beat men with their brain! Mind over muscle!”) Feminists' validation of the patriarchal stereotype of women as true and then turning the moral defect in question into something to be proud of is the reason why it can be said that the purpose of feminism is to train women to become psychopaths. The Secret Society women, Dr P in particular, are the products of this feminist praxis. They have therefore become the perfect embodiment of patriarchal stereotypes as if they were here to validate them as accurate descriptions of reality rather than manifestations of misogyny. This is why the suspect has repeatedly asserted: it is as if these women were chosen by the Macrospherians to fit those misogynist stereotypes of women back in the patriarchal dark days.

The Secret Society women's constant manipulation of law enforcement officers and bystanders also makes them conform perfectly to Schopenhauer's next “misogynist” stereotyping:

“Mit mehr Fug, als das schöne, könnte man das weibliche Geschlecht das unästhetische nennen. Weder für Musik, noch Poesie, noch bildende Künste haben sie wirklich und

wahrhaftig Sinn und Empfänglichkeit; sondern bloße Aefferi, zum Behuf ihrer Gefallsucht, ist es, wenn sie solche affektiren und vorgeben. Das macht, sie sind keines rein objektiven Antheils an irgend etwas fähig, und der Grund hievon ist, denke ich, folgender. Der Mann strebt in Allem eine direkte Herrschaft über die Dinge an, entweder durch Verstehen oder durch Bezwingen derselben. Aber das Weib ist immer und überall auf eine bloße indirekte Herrschaft verwiesen, nämlich mittels des Mannes, als welchen allein es direkt zu beherrschen hat. Darum liegt es in der Weiber Natur, Alles nur als Mittel, den Mann zu gewinnen, anzusehn, und ihr Antheil an irgend etwas Anderem ist immer nur ein simulirter, ein bloßer Umweg, d. h. läuft auf Koketterie und Aefferi hinaus.”

“More fittingly than the fair sex, women could be called the unaesthetic sex. Neither for music, nor poetry, nor the plastic arts do they possess any real feeling or receptivity: if they affect to do so, it is merely mimicry in service of their effort to please. This comes from the fact that they are incapable of taking a purely objective interest in anything whatever, and the reason for this is, I think, as follows. Man strives in everything for a direct domination over things, either by comprehending or by subduing them. But woman is everywhere and always relegated to a merely indirect domination, which is achieved by means of man, who is consequently the only thing she has to dominate directly. Thus it lies in the nature of women to regard everything simply as a means of capturing a man, and their interest in anything else is only simulated, is no more than a detour, i.e. amounts to coquetry and mimicry.”

And manipulation (indirect domination by manipulating others to do the work) is known to be part of the essence of “Girl Power”.

Schopenhauer's essay also foreshadows the suspect's complaint about womankind as more interested in concrete reality than in abstract ideas – which is a major theme in BOL's supposed sustainable civilization program. This, of course, is simply true of women in general, and the cause is clearly the lack of testosterone in women's body. Even after women are liberated and enter *en masse* into higher education – thus disproving Schopenhauer's claim about their lack of real interest in arts and culture – they persistently prefer social work, language arts, and humanities to quantitative sciences and engineering. After oppression has been lifted, the real nature of women comes more clearly into focus, and Schopenhauer turns out to be not so correct, but only vaguely foreshadowing. And yet the Secret Society women – Dr P, Angelica, and SDW in particular – stay on to prove that Schopenhauer has always been 100 percent correct!
