# II. The "Syrian nuclear terrorism scandal" Part II

The following is the second part of a rewrite of the original "The Syrian nuclear terrorism scandal", first composed in 2014. It reconstructs Homeland Security's actions against me and their debate with the CIA from October 5 to November 1, 2013. Let me first make a general remark about the period under consideration.

The rest of the October was marked mostly by the attempts of Mr Homeland Security CO chief and the Pyramid to get the doctors around me to hospitalize me so that, when they should then request law enforcement to ban my website, I wouldn't know about it. I must say that I'm not entirely clear as to why my website must be banned. In the preceding and the following I have explained that it was to prevent the CIA from ever using my story to convict Russia once they should ever reactivate the previous ICJ trial. But the question then arises: if Homeland Security could always prove that their warnings about me were correct, why would they worry about whether I had any website? I now suspect that it's because getting law enforcement to ban my website could itself prevent the CIA from reactivating the previous ICJ trial – and that, perhaps, it's because anything that is once banned by the authority could never be used in the ICJ as evidence.

The following rewrite might not read so smoothly because, when, toward the end, my developing a completely erroneous scenario about what was going on has become the essential aspect of the narrative about myself, I tend to desist from describing this erroneous sceanrio since I have already preserved it unchanged in the "original version". The original version is really 20 percent truth mixed up with 80 percent fiction. The rewrite here, hopefully, is at least 80 percent truth.

A question that gnaws at me from the original version is whether the Pyramid had really escaped to Mexico during this period. Upon reconsideration, I here suggest that she did. She flew to Mexico probably around October 4, right after Mr Homeland Security CO chief had obtained an ICJ judgment qualifying her as a victim of my terrorism. She showed up in Guadalajara on October 6, may have moved around in Mexico in the following days (such as going to Mexico City), and then came back to Los Angeles on October 22. This differs from my original, wrong, conception in that, back then, I thought she came back to Los Angeles on November 1.

## October 5 (Saturday)

Unable to sleep in early morning. 9 AM, waking up early and feeling severe restlessness as if on psychotropic medication (akathisia). I suspected (most likely erroneously) that I was acquiring the symptoms which the Pyramid was experiencing because the computer in the control center was making her into my substitute and was therefore making sure that we suffered something in common. Again, the Monkey was doing all this in order to make me develop further delusional beliefs. It is however simply reasonable to assume – if you know anything about the Pyramid at all – that, because of all the excitement, she had been unable to sleep well, and that the Department of Homeland Security would find a psychiatrist to prescribe her psychotropic medication to calm her down and help her sleep better. She was today probably complaining about the medication's side effect (akathisia).

"I suppose that, despite her tremendous good luck at the moment, she would not be able to sleep well in any case, because I would be suffering sleep deprivation all the way until November 22, when the US government had officially disconnected me from the Pyramid in the computer which was connected to both of us. (The fantasy that she was my substitute was no longer necessary then.)"

Again, pure bullshit to make myself look delusional.

## October 6 and 7 (Sunday and Monday)

To make sure that I was not wrongly excited, I thought I needed to verify my notion that the Pyramid and her sister were detained. I passed by House 1630 on 5:30 PM and noticed Veronica's car in the drive way. Her husband's pickup truck was absent. Another brand new vehicle was parked on the drive way. (The investigator's?) There was nobody in the back yard. Then another private security guard (Hispanic) in red pickup was guarding the front of the house. He pointed his cellphone at me to continually film me. Obviously, nothing bad had happened to Veronica at all. And I didn't cover my mouth this time either. The Monkey was programming me to be lazy for a specific reason.

I came back to Tom N Toms and wrote out the blog post you see for October 7. It was of course just all the wrong scenarios I had at the time about what was going on, which Mr Homeland Security CO chief would certainly introduce into the ICJ tomorrow as evidence not only of my schizophrenia but also of my intent to harm Dr P and the Pyramid with my "false reports" about terrorism.

That night, I went to "collect damages" in east Los Angeles, and, on my way back, I checked out House 1630 again. It was 10:40 PM. The lights by the backdoor of the front house were on; the lights by the front door of the front house were on; Miguel's pickup in front of Veronica's sedan on the drive way (the usual order was reversed). The lights in the living room of the front house were on. Four trash cans were pushed out onto the street. A security guard greeted me at the house approximately 30 feet away from the address. I was thus sure that nothing bad had happened to the Pyramid and her sister.

When I returned home, I discovered a suspicious visit to my website: 11:43 PM, 189-210-155-250.static.axtel.net: Guadalajara, Mexico:

Could this really be the Pyramid, who had really gone back to her hometown Guadalajara in Mexico and was visiting my website from there? Mr Homeland Security CO chief had developed a plan: seeing that I was "stalking" Veronica's family again, he decided to use her to file a restraining order against me with the express purpose of suppressing my website. He thus called up the Pyramid in Mexico, and instructed her to pretend to search for my website and take a brief look at the folder containing the video diaries which I had shot of myself while in Nicaragua. The Pyramid had always thought that these videos were good evidence that my website was a bunch of violent contents. Under the instruction from Mr Homeland Security CO chief, she thus made her false reports to the TMU, saying my website contained violent videos. You should of course by now be sure of Mr Homeland Security CO chief's purpose: once he shall intercept the false reports into the ICJ as evidence while my website got banned, the CIA would have no evidence to submit to the previous ICJ trial while the trial would remain locked.

Mr Homeland Security CO chief then called up the HK Hacker in Hong Kong to do the same. I thus discovered the HK Hacker's visit on 2:34 AM: 119.62.48.34 (China Unicom Yunan Province Network).

He then came to my blog, with the search terms (Baidu) "cut myself again."

The HK Hacker was then instructed to report to the TMU that "violent content" (self-mutilation) was found on my blog. (Of course this person could in fact be the HK Hacker's friend in China, and not the HK Hacker himself.)

Next, on 3:30 AM, while I was in my room checking over all these visits, a Hispanic guy wandered into my apartment building and knocked on my door. I was stupid enough to open the door. He pretended to be drunk and to have wandered into the wrong place. I immediately threw him out. It didn't occur to me immediately that he was sent here by the private security company which Veronica had hired. Soon afterward, however, it occurred to me that these incidents, only hours apart, were related and quite alarming.

The Hispanic guy who knocked on my door was wearing a hidden camera. His mission was to gather evidence proving that I did live in room xxx in my apartment building. Why? Because in the morning Veronica's investigators were going to the police to obtain a temporary restraining order on me, and they would have to present proof that the person living in room xxx was indeed the same person caught in their security cameras early evening tonight. Veronica was not simply going to file a restraining order against me. She would also ask the police, and the judge, to suppress my website. This was why both the Pyramid and the HK Hacker had searched for my website tonight. The strange thing was that I had not done anything around Veronica's house in the past month and a half and a mere "cut myself again" could not possibly qualify my website as containing "violent content". How can they possibly get the police to approve such request for a TRO? And the judge? I thought at the time that Mr Homeland Security CO chief had simply ordered the police to accept Veronica's request for a TRO and then ordered the judge to approve it. They could be ordered to take Veronica's complaint at face value: This guy has shown up at my property repeatedly, and he poses messages on his website detailing his violent intent toward us, himself, and others. They could be ordered not to check the authenticity of the claim (such as by going to my website themselves). Veronica would therefore obtain the police's, and the judge's, agreement that I was an extremely dangerous and violent delusional individual who must not be allowed to talk about women on the Internet. In reality, as you can imagine, it was simply the TMU's stamp on Chaya's warning which did the trick (and perhaps also the Homeland Security warnings about me).

At the time, because I didn't know about Homeland Security's real intent and wasn't aware that my scenarios were all wrong, I thought Homeland Security was simply trying to suppress my website in order to cover up the "national security secrets" about the CIA, France, and Russia as delineated on my blog. I thought:

Former Secretary Chertoff had been using techniques like this – to prevent me from spilling out national security secrets by employing the mental health profession to label me crazy and the law enforcement to label me a "pedophile" – since 2007. Mr Homeland Security CO chief and his thugs only came to their job after 2010. They knew nothing about the fact that I had already had plenty of experience with this kind of dirty tactics; they were using it because they read about it from their operational manual, not because they had actually as much experience with it as I had. The manual says: "When the suspect is in possession of national security secrets, silence him by using the mental

health profession and law enforcement to detain him for ordinary mental illnesses or convict him of ordinary crimes, with the side effect of discrediting him or preventing him from speaking without giving out the secret that we have wanted to silence him because of his knowledge of national security secrets. In this way we will have censored our target while not violating his First Amendment right to free speech." Since I was all too familiar with the American manner of suppressing freedom of speech by clandestine means, I immediately knew what Homeland Security was up to, and wrote down on my blog my prediction that, in a few hours, Veronica would file a restraining order against me in the Los Angeles County superior court:

"Now, as I'm writing this, it is 7 AM, October 7, Monday; in two hours Veronica and her investigators should be meeting with the Sheriff. The Sheriff will serve me the TRO either this afternoon or tomorrow morning. The only possible way for me to avoid this – to avoid the suppression of my website – is if this very posting might dissuade Veronica from filing the TRO against me: if I predict her action correctly, it might make her accusation of me as dangerously deranged look less credible."

And, sure enough, Mr Homeland Security CO chief called off the operation as soon as he saw my blog post from his computer screen inside his operational center. Not because my scenarios were correct – unbeknownst to me, these were the same Homeland Security thugs and not any new comers – but simply because he could not possibly let me know – let alone predict – what's going to happen. He would instead try something else, as you shall soon see.

Moreover, the visit from Guadalajara had me rethink: Given the Pyramid's distaste for adventures in unfamiliar places, if she had a choice, she would definitely choose to go to Mexico rather than France. If the Pyramid was in Paris by herself, she would break down into insanity within a few hours. Wes was trying to deceive me. And so, at night (October 7), I posted another notice on my blog correcting myself and stating that the Pyramid had gone to Mexico to stay "safe from me".

Meanwhile, the Monkey inside the control center continued to provoke me and frustrate me. My Microsoft Word froze up repeatedly throughout the day. Near 10 PM, my access to Sky Drive was denied – after I had posted the above-mentioned blog post. My external hard drive froze up two times, were disconnected two times. The third time I was successful. I was again provoked to extreme anger, and had to again collect damages to release my tension – while everyone was watching me closely. This is precisely the Monkey's goal: to make everyone think me dangerous – just as Homeland Security had claimed.

#### October 8 (Tuesday)

Mr Homeland Security CO chief had shared with the Pyramid his new plan: in the morning, a certain authority (either the TMU, the county judge, or a state judge) would be shown evidences that I had been stalking the Pyramid and her family, that my website contained nothing but violent content and threats against them, and that I used it to harass the Pyramid's family, and would accept the evidences on face value thanks to Chaya's warning. She would then issue an order for Cloud Flare to block my

website. The Pyramid was staying up all night to do another round of false complaining about my website to the TMU – under Homeland Security's instruction as to what to report. The Pyramid absolutely loved her job. In addition to being validated as a "victim" by law enforcement, she now got to fulfill her fantasy, actualize her "religion", by telling the police that I was violent and delusional and mentally retarded – without the need to confront reality and without the police being able to disagree with her anymore.

Then, on 4:20 AM, the HK Hacker or his China friend visited my blog again with the same search term: 220.181.51.147 (CHINANET Beijing Province Network),

Since none of the other components of my blog were showing, it was clearly the same computer as yesterday. Since the HK Hacker or his friend was instructed by Homeland Security to make the same false complaint about my blog, he himself was not interested in reading through the blog posts. He clicked on the link, and just repeated to the police over the phone what he was taught to say: violent, delusional.

I woke up around noon to discover a surprise for me: my website could no longer be seen. I immediately turned on my recorder: "websitedowncallbluehostsouthwstrn 10 8 13 1209-701PM.MP3". I checked my visitors' log, and concluded – based on the complete lack of visits, even by robots, from 9 AM onward – that Cloud Flare had disabled my website around 9 AM or so. I deactivated Cloud Flare on my website, and my website was restored around 12 PM. Sky Drive was disconnected from my laptop again – and my laptop has never connected to Sky Drive since then. See the screenshots and the other qualifications I included on my blog post of 10/16/13. A certain authority, based on the two additional false reports, had given the order to Cloud Flare, and my website was offline for three hours. But Bluehost had not received the order, and so did not block my website. For some reason, Mr Homeland Security CO chief did not go back to the judge to ask for a second order for Bluehost as well. Why? Evidently because I immediately wrote an email of inquiry to Cloud Flare asking them if they had "received the judge's order". This was bad for Mr Homeland Security CO chief. He had always had a very high standard when it came to me, namely, that the suspect was not allowed to know that a restraining order had been filed against him and that his website had been taken offline. Some of you might think this objective very strange: why, when you file a lawsuit against someone, do you not want him to know; why, when you want to take down someone's website, do you not want him to know? And how can you possibly do that? Can you burn down his house without his knowing? Can you chop off his hand without his knowing? But, as you know, nothing was more important to Homeland Security than the requirement that I stay a dummy not knowing how they had ruined my life – because they thought me a "subhuman". The "subhuman" is not allowed to know what human beings know. When you arrest a human being, you simply arrest him, because you do not set

yourself the goal of hiding his arrest from him: a human being is allowed to know that the authority has taken down his website or has accused him of something or has arrested him. But when you attempt to arrest or censor a subhuman, you must not let him know that he has been arrested or censored or sued – because, everyone knows, a subhuman is not allowed to know what human beings know. Mr Homeland Security CO chief and his thugs thus had to give up the plan of getting law enforcement or the court to ban my website and go back to their drawing board.

We are touching upon a very important theme in this narrative, and so it might be better to refer to some well-known literary precedents in order to illuminate it. Whether it is Homeland Security or the Pyramid's family, when they perceive me as a "subhuman", they are basically seeing me as "Lennie" in John Steinbeck's *Of Mice and Men*. His best friend George knows that, because he is mentally retarded and cannot understand how he poses a grave danger to everybody around, he should be put to death clandestinely without knowing how it has happened. And so, in the end, George shoots him painlessly in the back of his head. This is how Homeland Security and the Pyramid's family are prepared to deal with me. They feel compelled to act in this manner, however, not out of any humanitarian spirit, but in order to establish themselves as superior to me.

We must assume that, according to some secret US laws and procedures, a certain type of people — whom I have termed here "subhumans" — are of such unworthy nature that they are not allowed to know even what is right and what is wrong, whether they have done something wrong to offend the state, and whether they are in the process of being punished. They are not allowed to know *anything*. How this kind of laws and procedures have come about I don't know; I just know that the US government treats offenders with a mysterious inconsistency: whistleblowers like my favorite woman Sibel Edmonds are deemed worthy enough to know that they have become a threat to the state because of the knowledge they possess about the state. They are thus officially gagged, and are allowed to know that they are gagged. Even the public is allowed to know that they are gagged. They are considered by the US government to be "normal humans". Well, Edward Snowden is allowed to know that he has offended the state by sharing his knowledge about the state carelessly with outsiders. But in my case, I am deemed unworthy to even know that I have become a threat to the state and am in the process of being neutralized. What's so different about me? This is the factual basis on which I assert that "subhumanism" is part of the official US national security policy.

After being nervous for a while, I went to my appointment at Southwestern Research. My clinical trial did not yet seem to have been affected by the terrorist investigation. I was a little worried that Homeland Security might have already warned Dr M, not about my terrorist activity, but about my supposed attempt to hunt down the Pyramid. I thus told him a little about the situation, as you can hear in the recording. His answer seemed to indicate that he had some awareness of it, but was not so alarmed. After that I went to the Santa Monica Public Library. Then, Dr R suddenly called me around 5 PM: She was "back". When I asked her what happened to her, she replied: "stomach flu". Apparently, her interrogation and recruitment had lasted almost six days. She then claimed she wanted to see me on Thursday, 1:30 PM. I tentatively agreed, although I had an inkling that something was wrong. Apparently, between 2 PM and 4 PM, Mr Homeland Security CO chief had figured out a new plan: to order Dr R to lure me to an appointment, and then, once I showed up, to hospitalize me. Thereupon,

law enforcement or the county judge could order Bluehost to take down my website. Mr Homeland Security CO chief would then (perhaps via Dr P) order the doctors in the psychiatric hospital to keep me there – permanently: and to feed me with so much anti-psychotic medication that I would for a long time remain in a vegetative state. In this way, the CIA would be permanently prevented from reactivating the previous ICJ trial. Besides, patients were not allowed to use their computers in the mental hospital, so that I would never find out that my website had disappeared and could never continue to write my story.

Unaware of the magnitude of the danger in store for me – I thought the whole matter was "Microspherian" and so nothing to worry about: thanks to the Monkey's deliberate attempt to confuse my perception of reality – I continued to "collect damages", tonight in Beverly Hills.

## October 9 (Wednesday)

Two suspicious visits came today from my postings at Prison Planet Forum: First, 12:16 PM, 129.113.230.156, doesnotexist.utpa.edu, The University of Texas, Pan American.

The chapter had already become defunct.

Then, on 4:49 PM: 66.153.174.96, 96.174-pool-cable-he.sccoast.net, Horry Telephone Cooperative, Conway, South Carolina.

This posting was not made by me but by somebody else, who copied my entire chapter and pasted it onto Prison Planet Forum.

At the time I was thinking that Karin's "complaint team" had continued to massively complain to Prison Planet Forum moderators demanding that all my posts be removed – this, in anticipation for my "lock away" tomorrow. It's not clear whether I was correct. Perhaps Karin's volunteers were simply making more false reports about my online traces elsewhere to the TMU.

Then, 9:12 PM, a strangest visit: 61.238.255.242: 061238255242.static.ctinets.com.

Strangely, the IP addresses 61.238.255.xxx belong to China Agriculture Development HK Ltd, Good Harvest IND BLDG. These kinds of strange visits from the strangest places – there had hardly been anyone visiting my website from Hong Kong in the past two and a half years, let alone from something like "China Agriculture Development" – I automatically attributed to the HK Hacker or his associates. Besides, the HK Hacker was practically the only person around who still used Windows XP: he ran all his hacking software (like HTTrack) on his old computers, as you have seen.

I collected damages in East Los Angeles tonight, focusing all my resentment on Hispanics because the Pyramid and her father – the sources of all my misfortunes – were Mexicans. (And Mr Homeland Security CO chief himself seemed to be Hispanic.) I noticed a Hispanic man sitting in his pickup truck waiting for me to make my move. He looked like one of those investigators hired by Veronica. Soon a police car showed up circling around, seemingly looking for me in the darkness. Apparently, Mr Homeland Security CO chief was a little worried that I might not show up tomorrow. Recall that he had now recruited Veronica's investigators into his operation. He ordered the investigators to lie in wait for me in the neighborhood where I was about to do bad things. He then ordered the police to patrol the area. If I vandalized someone's car, for example, the police might catch me, and the investigator would pretend to be an accidental witness to confirm for the police that I was the culprit: the same tactic Karin had used. If I were taken in by the police, they would check my records and discover that I had a psychiatrist Dr R; the police – so Mr Homeland Security CO chief would instruct them – would then call up Dr R, and Dr R would advise the police to hospitalize me on 5150. Then, again, once in, I would never get out of the hospital. That was the plan, but I was careful enough to avoid being caught. Upon returning home, I also broke two bottles at the Law Library.

## October 10 (Thursday)

The visit from HK Hacker, the police action – these had tipped me off. Since I had already guessed that Dr R would be ordered to hospitalize me if I showed up in her office, I purposely slept late, woke up almost 1 PM, and left a message for her telling her that I slept late and so couldn't make it in time ("mssgtodrroachtolib\_10\_10\_13\_105-315PM.MP3"). Instead, I went to the Santa Monica Public Library.

I was further confirmed in my inkling when, in the afternoon, I checked my visitors' log and discovered that somebody in Illinois had visited my website on 11:19 AM this morning: 198.228.228.168 (akrmspsrv2ts426-dmz.mycingular.net), Chicago:

Could this be my cousin Evelyn, who was still in Chicago? Such is my scenario. As soon as Mr Homeland Security CO chief shared with the Pyramid his new plan (to hospitalize me), she contacted Evelyn. Both she and Homeland Security concurred: with an additional complaint, from my own family members, about my being delusional and violent and wanting to hurt her, her case with the mental health authority could be further strengthened (to hospitalize me permanently and remove my website). Evelyn, still taking me for a piece of trash, was only too willing to help out in a plan to dispose of me in the mental hospital. The Pyramid and Mr Homeland Security CO chief thus instructed Evelyn this morning, two hours before my appointment with Dr R, to visit my story about the Pyramid, and to report to Dr R saying the story was full of violent and delusional content and contained threats against the Pyramid. Evelyn did so – of course she had never bothered to read a single paragraph from my story. (There was no possible way that she, a medical doctor, would understand anything I wrote on there anyway.) She must be in her office at the moment, and so looked at my story from her phone.

Dr R noted down my cousin's report, and must be rather sad that she would have to put me away soon. She'd rather not have to follow Homeland Security's order; but, if she refused, she would be arrested. When she got my message, she must be rather relieved. She should now be aware of the fact that I was aware of Homeland Security's orchestration from behind the scene. When I came to Westwood, on 6:18 PM, she was then instructed by Homeland Security to call me: drroachcallnolinuxgroup\_10\_10\_13\_618-736PM.MP3. She wanted to re-schedule another appointment with me, 4:30 PM next Thursday. If you hear her talking, you will not notice anything is wrong. Homeland Security had carefully instructed her to talk and act normal as if nothing were going on.

Meanwhile, after studying inside the UCLA library, I collected damages in Beverly Hills again.

#### October 11 (Friday)

This late afternoon I shaved off my long beard at a barber shop in downtown LA. When I exited, I noticed a surveillance agent outside the barber shop waiting for me. He was wearing surveillance devices. Homeland Security needed to make sure that they had the most up-to-date images of my appearance. I collected damages in Brentwood tonight.

This volunteer thus looked at three video diaries all within the same minute. As you have seen, the Pyramid considered these Nicaragua videos to be the best indicators of the delusional state of my mind.

## October 12 (Wes)

After I woke up around noon, I strolled to Tom N Toms as usual. While there, I had a phone conversation with Wes, talking about "Macrospherian Russia's" intention to punish the Pyramid, her reconnection with her father, and the current quarrel with Russia in the ICJ as only a "sting operation". Completely erroneous conception, except perhaps for the Pyramid's reconnection with her father who was inside the control center at the moment: this might indeed have occurred.

You must note in this conversation one of Wes' most enigmatic pronouncements, that the Macrospherians (whoever they were) *could* make the Pyramid fall in love with me by simply making her believe I was someone else, someone she could actually fall in love with (30:00 in the recording). Was Wes instructed by his CIA handler to say this? Perhaps a prediction of what would eventually happen in the future?

This kind of hint was another evidence – in addition to SDW's gang-stalking experience – that some particular CIA clandestine service official who was involved in fighting off Homeland Security's onslaught was actually doing so in full awareness of the fact that the whole affair was being orchestrated by the computer under the Monkey's control in such wise that it would eventually end in their favor, namely, that the lost ICJ trial would eventually be reactivated. Again, this must be the Invisible Hand and his clique. They had already "seen the future"....

Night, when I was buying food at the organic market in Westwood, the security guard kept a watchful eye on me. It's possible that many of the security guards in the city had already been alerted by Mr Homeland Security CO chief about my extraordinarily malicious nature, delusional mind-set, and danger to the general public, and briefed about my changed appearance since this morning. They could all have received instruction from him to watch over me as an extremely dangerous terrorist and a serial stalker of women.

# October 13 (Sunday)

In the afternoon, when I was on the bus going to Santa Monica, there was increased surveillance on me. (More surveillance on the bus than usual.) Evidently because, now, Homeland Security was investigating me as a domestic terrorist. I wanted to attend the Quantum Physics Discussion Meetup on 5 PM. Arriving, I was told that our group organizer, Vanessa, was "sick". Did Homeland Security go to recruit her?

Then, a security guard intentionally greeted me with a fake smile when I was walking out of UCLA around 10:20 PM. It could be that, because I had noticed the security guard's watchful eyes on me last night, today Mr Homeland Security CO chief had instructed all security guards in the city to be extracourteous to me in order to not raise my suspicion.

I began to suspect that, because the Pyramid, Dr P, and Kiersten were classified by Mr Homeland Security CO chief not only as the victims of my terrorism but also as "experts" on my psychopathology, they were granted access by the Department to the intercept of my conversation with Wes yesterday. This is a very important theme in this story. My "victims" would eventually acquire such power over me that they were practically my God. Some kind of "victims". Something else of note today is that SDW posted on her blog some ranting that was full of rage. Did something happen to her in my regard?

# October 14 (Monday)

More suspicious visits. First, on 10:19 AM:

This IP address was traced to Los Angeles/ Manifee, California. I had always suspected this person to be my cousin Evelyn, who must have, between October 10 and 13, returned to California to join my aunt Jennifer (her mother). But today I'm no longer sure about this.

Then, on 1:03 PM, Karin's team seemed to be using EVULN malware scanner to check my website folder "howihave73bg4/frankfurt08".

The folder contains my emails with Wes, January 2008. At the time, this was my scenario: after hearing yesterday the interception of my phone conversation with Wes, the Pyramid became angry with him as well, for suggesting a way to punish her (making her believe I would be the one she would fall in love with). And so she began thinking of exacting vengeance on Wes as well. Thus she found Wes' old email address on my website, and downloaded it onto her own computer. Before downloading, she asked the HK Hacker how to make sure I didn't embed malware in my files. The HK Hacker referred her to EVULN. Today I'm no longer sure of this scenario. The Pyramid would not be angry with Wes because

Mr Homeland Security would have told her that Wes was also his informant against me (namely, here to forge evidences to frame me). Thus, I'm not quite sure what this EVULN business was about.



The volunteer seemed to be located in Tennessee (nsvltn.spcsdns.net). This is another sign that Karin's gang had already recruited Shizuka to their team. (Note that I have not been logging all the visits to my portraits of Shizuka.)

Moreover, as you can see below, Cluster Maps recorded a visit to my website from Monterrey, Mexico, on 4:29 PM on this day. I however couldn't find any visit at this time on the Apache Server's log.



At the time I assumed that, because Pyramid had read from my blog that I knew she was in Guadalajara, she had moved again to Monterrey. Today, I'm not quite sure if this scenario was correct.

Meanwhile, I had been suffering from stomach ache since Friday, October 11.

#### October 15 (Tuesday; Wes)

I spent the afternoon in the public library in downtown to continue my reading of George Soria's *Grande revolution française*. Taking a break, I called up Wes. Amazingly, I was able to reach him. Here are the essentials in this conversation.<sup>1</sup> Note that both the CIA and Homeland Security were listening carefully to me in order to obtain evidences favorable to their respective cases.

Thus when I was talking about how the French had won and had now started to replace evidences — this weird, wrong, theory I had developed, obviously under the Monkey's programming to make me look delusional — that was Mr Homeland Security CO chief's evidence that I was indeed a schizophrenic. So was my wrong theory about the need to replace the evidence which showed that evidences had been replaced (7:30). The Monkey must be rejoicing inside the control center to hear me speaking such gibberish. And so was my wrong understanding of the current situation with the Pyramid, how she really believed that Russia had lost and how she suffered from mental deficiency unable to understand that the Russians and the UN wanted to punish her. This was certainly Mr Homeland Security CO chief's evidence that my women victims assertions about me were correct, that

I really did harbor bizarre delusions about the women I was obsessed with. And the Pyramid would certainly rejoice over the fact that I had developed such wrong conceptions about her. Again, I had simply failed to understand the magnitude of the current crisis for me: the whole matter lacked reality for me because I was under the assumption that it was just a game set up to replace evidences and so had no reality in it.

Then take note of my comment about the possibility of reconciling with whites, but not with Hispanics. This was absolutely malicious, for, soon, Mr Homeland Security CO chief and the Monkey would require me to concentrate attacking white Anglos – I was always required to be, and do, just the opposite of what I wanted to be and do. Meanwhile, all my derogatory comments about Mexicans were also Mr Homeland Security CO chief's evidence that I was a virulent white supremacist or racist (in this case, racist against Mexicans).

Note that Wes was under order to go along with my erroneous beliefs in order to reinforce them – the usual procedure for dealing with a terrorist, namely, devising an environment or saying things that would fit his beliefs. And so Wes began talking about the Pyramid's being a "mirror image" of myself. Again, it must be the Invisible Hand et al who had instructed him to say this. On the surface, the Invisible Hand was going to use the same argument to counter Mr Homeland Security CO chief in the ICJ: that, because people were instructed to say to me only things that would fit my belief, I was continually misled onto totally wrong scenarios, but that this was completely different from true delusions. The Invisible Hand would then use my discussion about Trotsky and the French Revolution as evidence that I was in fact very rational and hardly delusional. But we must also suppose that he had a hidden purpose as well. Namely, once the previous ICJ trial should be reactivated, these gibberish, jokes, deceptions, and delusional beliefs might become the basis on which to replace evidences in such a way as to make the Pyramid take up my status as the terrorist suspect.

In the end, I want to make two comments, first about my amazement about the deficiency in the structure of the Pyramid's brain – that she somehow couldn't grasp the fact that, if she messed up other people's life, other people would try to "get her" – even though, as noted, this was easily seen as evidence that I did frequently develop delusions about my women victims and was indeed a virulent racist. Although my statement about their messing up the United Nations' projects, etc., were wrongheaded, the Pyramid's family was presumably aware that they had enabled France to object in 2010 and caused Russia to lose the chance to recover its former power – and thus caused me to be stuck in this Homeland Security limbo forever. Somehow the Pyramid was amazed by the fact that I would now want to exact vengeance on her. This deficiency in her brain development you have already seen in her complete lack of any comprehension of "logistics" required for people's actions, and it of course also applied to Kiersten, Karin, and Dr P. This assessment of mine of course fails to do justice to the fact that the Pyramid was practicing her absurd morals only on me because she thought somebody as disposal (ugly and unmanly) as I was didn't deserve to be the object of ethical considerations. Namely, the problem was that she lacked the education to enable her to comprehend what is of value (that intelligence is important and that I am a genius). Please note that my comment to Wes about what was really troublesome about stupid people – that they always thought good people to be bad people and bad people to be good people and so on – was entirely correct, even if I was wrong about what exactly

was going on at this moment. This theme – that people are no longer able to act ethically because of the deterioration of their intelligence and brain power – consisted in the fact that the tradition of human rights has done irreparable damages to people's ability to accurately assess their worth – and the worth of other people.

Then I want you to pay close attention to Wes' comment that, when the Pyramid and I were added together, we would produce an average (50:00). It has seemed to me that Wes was in fact here naming the whole game in which I was about to be entangled. Even toward the end, with hindsight, because everybody was doing his or her best to conceal the facts about my circumstances from me, my understanding of the situation was only vague and fuzzy, as you see here, even though I am a genius who can understand things better than everybody around me. Meanwhile, because the Pyramid and her gang were all retarded "postmodern women", although nobody concealed anything from them, they also only understood their situation vaguely and with imprecision. Thus, by suppressing the potential of a genius while providing for the mentally retarded, you get a genius operating on the same level as the mentally retarded: both have become "average". This is what the United States had become, first after the onslaught of political correctness, where equality assumes greater importance than merits, and then after the neoconservative revolution, where loyalty is valued more than merits. The entire American society has now been inverted, where the incompetent are charged with the most important tasks, and where the competent are excluded from society and required to live on welfare; where stupid people are allowed to go to school and learn, and where intelligent people are not allowed to go to school; where Apes with IQ less than 80 are given access to the most sensitive national security secrets and charged with the task of guarding the nation (like the Department of Homeland Security), but where educated human beings (like those in the CIA) are given secondary status in all things regarding national security – and where monkeys like the Pyramid and Kiersten are accorded with utmost protection and given access to details of other people's private lives and national security matters, but where a genius like me is disregarded as junk and criminal and denied access to knowledge about anything, even factual details about his very survival. The "revolt of the masses" (Jose Ortega y Gasset) has been completed; America is now officially the "Planet of the Apes". The result is of course the continual decline of the overall quality of the work being performed by the population: as people like the Pyramid, Dr P, and Kiersten are becoming the norm among the American population, you wonder how America can survive as a nation. The answer is that America is surviving only by importing talented immigrants from the Asian Pacific, India, and other places on the Eurasian continent. Namely, by draining away the brain power of the rest of the world while it wastes its own brain power away. This is important because this is part of the story of the "consumerization of society" – which the Macrospherians have presumably an interest in reversing as the essence of any "terrorist conspiracy".

At the end of the recording you will hear me taking notice of a Hispanic man wearing dark sunglasses who kept staring at me while I was talking on the phone. The man did not look Homeland Security. Was he Veronica's investigator? He could even be from the Mexican intelligence – since, when the Pyramid entered Mexico, Homeland Security would certainly have notifed them that she was the victim of a terrorism case and was escaping from the tremendously demonic terrorist. The Mexican intelligence might have become involved in the dispute between Homeland Security and the CIA, and so sent in an agent to watch over me to see what the fuss was about. (The Mexican intelligence of

course remembered me from the first half of 2009.) Since the Mexican intelligence was usually more loyal to the CIA than to their own country, Homeland Security might be trying hard to grab the Mexicans onto their side.

Meanwhile, Karin's "complaint team" continued their work. First of all, from 5:57 AM onward, some robot was indexing several hundred files on my website within five minutes: 62.76.187.89. The IP address was traced to Russia.

At the time I was convinced that this was Xin Pan. He lives in Boone, North Carolina, very close to Ashland, North Carolina. He had of course been recruited by Veronica into the new "complaint team", via the weight of Department of Homeland Security. His Targeted Forums had never come back online. Mr Homeland Security CO chief would certainly have instructed Xin to report falsely to the TMU that my blog contained violent and delusional material threatening the Pyramid's safety. To confirm it was Xin, I emailed him on the next day to ask him to visit my website, and I obtained his information on my log on October 17, 6:22 AM: 66.169.72.89: 66-169-72-89.dhcp.ahvl.nc.charter.com. I was thus right.

While the ISP server was the same, the computer was different. Thus, what I thought was Xin Pan was probably just his friend. On the early evening of October 15, Xin was apparently visiting my website together with his friend as he was ordered to help the Pyramid in her case against me.

Tonight, the Monkey continued to torture me from the control center. On 8:30 PM, my laptop froze up, freezing up my Microsoft Word. Reboot, and it was still freezing. I was not able to work until 9 PM. Provoked to go collect damages later on, which was the Monkey's goal. I thus did "bad things" in downtown tonight.

11:30 PM, Starbucks Westwood. A detective showed up to watch over me. It was not just to keep the Pyramid safe – because I knew again that she was visiting my website, and this time from Mexico – but probably also because I had just logged onto meetup.com to check up on Karin's meetup groups. Law enforcement would continue to seriously investigate me as a dangerous serial stalker of women until the CIA should succeed in "turning them".

When I was returning home, the Monkey decisively signaled to me in order to further disrupt my perception of the current situation. More on this later.

Something very important to note is that SDW shared someone else's photograph on her Facebook page today: "Bear-baiting legal in South Carolina?" From now on SDW would begin posting all sorts of photographs related to cruelty against animals or animal adoption. And yet, if you search through her

Facebook entries in all of 2013 before today and in 2012, you will not find a single posting about animals. From this, I would erroneously conclude several months later that, today, the FBI had successfully recruited SDW as an informant inside Kiersten's Secret Society, and that the first thing her FBI handler instructed her to do was to post on her Facebook something related to animal rights issue as a way to signal to me about my current situation. Since this conclusion is completely wrong-headed, I shall not recount this anymore.

# October 16 (Wednesday)

When I got home, I couldn't wait putting the latest revelation from the control center onto my blog. Thus, around 4 AM or so, I posted the blog post you see for October 16. All this nonsensical talk about "the Pyramid's stupidity as evidence to explain why my conspiracy with the CIA to harm Russia was busted in 2009" must have been used by Mr Homeland Security CO chief as evidence that I was really delusional. Note that, even when I was completely nonsensical due to my erroneous understanding as to how the previous ICJ trial had ended, there was some truth in what I was saying: instead of "in order for France to beat Russia, my website cannot be removed", the situation was really: "in order to reactivate the previous ICJ trial and convict Russia, the CIA cannot have my website removed by anyone."

Now, suspicious visits. 6:24 AM, 31.193.51.78, Eolas Hosting, France. Geobytes: Italy.

It's amazing that Karin's team had already found my latest blog post merely two hours after it was posted.

Karin's team's second visit to my latest blog post. Karin, the Pyramid, and Dr P must be delighted by my wrong scenarios about the Pyramid. They would present this blog post to the TMU as evidence that I had developed serious delusions about my women victims.

Note that, on 2:23 PM, Kiersten posted two tweets, the first two since July 29!

Before 3:33 PM, all my postings "Four women try to knock down my website..." were called up on Facebook. What's going on here?

I was feeling terrible over the fact that I had lost two appointments already with Dr R. Remembering that I was supposed to see Dr R on 4:30 PM tomorrow. I wasn't sure if Homeland Security was still onto the trick now that I had exposed it on my blog. So, around 5 PM, I called up Dr R and left a message with her, telling her that I would only show up tomorrow if she called me back and gave me assurance that she would not arbitrarily hospitalize me: "leavmssgdrroach\_10\_16\_13\_504-507PM.MP3". I thought this would work; and yet the Homeland Security thugs, even seeing me exposing their plan, still would not give it up. Mr Homeland Security CO chief had simply no choice: he and his thugs didn't know how else to "get me" (without my knowing, that is). They thus instructed Dr R to ignore my request. Dr R never called me back tonight.

Karin had her meetup tonight. On 11 PM, she sent out a bulk email telling everyone she had talked about the Arab film festival during the meetup.

# October 17 (Thursday)

Before going to bed, some time after 5 AM, I left another message for Dr R ("leavmssgdrroach\_10\_17\_13\_514-517AM.MP3"), hoping that she would, by the time I woke up past noon, have given me the assurance to allow me to see her without worries. This never happened. Instead, Mr Homeland Security CO chief and his thugs thought that, if I heard nothing from Dr R, I might still show up at the appointment believing that all was just my paranoia. They thus set out to prepare the legal process of getting Dr R to hospitalize me. Therefore, when I arrived at Tom N Toms around noon to check my log, I noticed this suspicious visit on 12:41 PM, to my blog post of 7/14/12 ("How to avoid mind-controlled suicidal thoughts"): 67.160.42.186, c-67-160-42-186.hsd1.wa.comcast.net, Seattle, Washington.

You have seen this volunteer visiting the same blog post on October 1 – he must be a very important associate of Karin's or Kiersten's. He must be on the phone with Dr R at this moment telling her that it was urgent to hospitalize me because I was expressing terrible suicidal ideation on my blog. (It was false reporting, and so the fact that he was looking at a blog post from July 2012, more than a year ago, did not matter.) He must also be telling Dr R that the pictures of my wounds on my blog were so disturbing that my website must at once be removed. This was a last minute false-reporting to prepare the ground for my hospitalization.

Again, after seeing this visit, and since I didn't hear anything back from Dr R, I wasn't going to show up on my appointment with her. I reached Westwood around 4 PM or so, and did not bother to go any further. Instead, I went inside the UCLA library. Thus, along with Mr Homeland Security CO chief, the Pyramid was, again, infinitely disappointed. She had now been in Mexico for twelve days; and, since she just saw that I knew also that she had come to Monterrey from Guadalajara, she had just moved again to Mexico City, where her other relatives were located. The problem was that this girl was not just "whining girl extraordinaire", but also "home girl extraordinaire". She had never traveled to another country beside Mexico because she never left home. She had no curiosity about the world and other peoples, and never traveled. After merely two weeks in Mexico, she was terribly missing the familiar environment of her Los Angeles houses. Yet she would not come back to the United States unless I was permanently hospitalized and my website removed. Thus, by skipping trap after trap, I was making the Pyramid feel increasingly trapped in Mexico itself. She did not enjoy staying with her distant relatives at all.

On 6 PM, Dr R called me: "IMPdrroachcall\_10\_17\_13\_603-608PM.MP3". You must hear the recording for yourself. Dr R was instructed by Mr Homeland Security CO chief to ask me why I believed she would hospitalize me because the clandestine operation master simply didn't know what to do: how to make me trust Dr R? He wanted to hear my explanation. And she was instructed by him to lie that the voice-mail system had malfunctioned. Then, it sounded almost as if she was trying to pass onto me a "secret message". She yelled: I will only put you away in the hospital if you say to me you are gonna kill yourself! This, remember, was what the Seattle volunteer had just reported hours ago, and Dr R seemed to be trying to give me a hint about the dirty trick.

On 9:23 PM, another person in Seattle (c-24-19-118-9.hsd1.wa.comcast.net, Tacoma, Washington) had tracked down the comment I had left at Kevin Ryan's blog "Dig Within" last month, and followed the link to my website.<sup>2</sup>

This of course could be the same Seattle volunteer earlier today, now simply using his iPad instead of his MacBook. Then, on 9:27 PM, he found my "Supplemental Pleading, 1" through a Google search.

He was evidently asked by Karin's gang to do more discovery of my online postings: since Homeland Security, to keep the whole operation in secret, could not show their own faces and could only direct

the show from behind the scene, Karin and her team members had to find all my traces online with their own effort.

From this day onward there were also a massive number of visits to Jennifer Day's picture on my website (search term "Jennifer Day"). This is a sign of something very important: to win their debate with Homeland Security, the CIA had gone to the TMU and recruited them. Under the CIA's direction, the TMU shall now investigate the Pyramid and her gang members in order to uncover how they were making false reports under the cover of "victim confidentiality". The CIA would then take the investigation results into the ICJ as evidence that Mr Homeland Security CO chief's "star witnesses" had in fact been lying all the way so that these Homeland Security's warnings about me could not be regarded as valid. The first informant the TMU shall send into the women's organization was of course Jennifer Day.

Meanwhile, I continued to collect damages in East LA, targeting Hispanics because of my utter hatred toward xxxxxxxx.

The person was a Comcast customer in Georgia (c-67-191-244-73.hsdl.ga.comcast.net). Geobytes gives his location as Atlanta, Georgia. Again, you can tell that this person was not a "natural" visitor simply by looking at his behavior. He came to my "The story behind…" through a Google search, and all he ever did was read a few lines in three minutes while telling the police on the phone about how I was saying delusional things and making threats and then scroll down to the bottom of the page to click on the link to my blog. He had no interest in the content of my writings, but was simply repeating to the police what he had been told by Kiersten, the Pyramid, or Homeland Security CO chief to say I wrote.

The IP address belonged to GCI Internet, Anchorage, Alaska. The person was sent a link to my blog in her Yahoo mail account; in the email she was also asked to Google for my blog, and she did so on 11:07 PM. The person was either SDW's former roommate Ann, whom she knew from her time in Palm Springs in 1997 and who currently lived in Alaska, or Ann's friend in Alaska. As Kiersten and so on praised SDW for her good work lately, SDW called up her former roommate who was now back in Alaska, and recommended her to Kiersten. Kiersten immediately approved Ann's membership in her Secret Facebook group and shared with her Homeland Security's latest warnings about me to galvanize her. Kiersten sent her the link to my blog, and instructed her to Google for it. Ann did so – assuming it's not Ann's friend – and reported to the TMU about seeing me writing delusional and threatening materials on my blog about the Pyramid and Kiersten. Keep a close eye on Ann, for she or her friend would appear regularly from now on.

## October 19 (Saturday; Wes)

Waking up past noon, I went to Tom N Toms. I then set out for Sabor (Hollywood) to run my monthly Military History Discussion Meetup. It was around 3 PM, and I noticed this Russian man holding a bag marked "Amsterdam". I wrongly believed this might just be a SVR agent sent here to test me, and the bag would cause me to wrongly believe that Ekaterina had been in Amsterdam interning at the Gazprom's international headquarters there – when, in reality, it was her sister's husband who was working there. Now, at the Meetup, as usual, only Ralf and Yuzo showed up. Amazingly, neither of them seemed to have been recruited by Mr Homeland Security CO chief as informants against me. Unaware of the magnitude of the crisis at hand, I had a good time chatting with Yuzo. Around 5:30 PM, Wes suddenly called me (from 2:21:00 onward): "IMPmilhistorywesmysperm 10 19 13 259-643PM.MP3". Wes denied that the Pyramid had filed any restraining order against him. (Of course not.) Note then my mention of the control center's continual signaling about "16", or "November 16" and my erroneous conception about our being established as conspirators against France. Then note my mention of another meaning of "seven" and the movie "Seven" and Wes' mention of the movie "Twelve Monkeys" (2:30:00). I didn't know that it was just the Monkey who was trying to deceive me into looking crazy: all these signals about "seven" and so on meant nothing at all (at least not for the moment). Then my remark that Homeland Security's stupidity had finally taught me that it was not that I was so intelligent, but that everyone else was so stupid, because everyone else was regressing to the

state of Apes. I was a relic from the past. This, again, would be an important theme in this story. For Mr Homeland Security CO chief, however, I had just furnished him not only with more evidence of my complete insanity, but also with confirmation of Kiersten's (wrong-headed) assessment that I suffered from Narcissistic Personality Disorder (my grandiosity). Wes mentioned "Idiocracy": how technology was making people stupid (from 2:34:00 onward). I would always wonder whether Wes was clandestinely steering my thoughts along the lines of the Macrospherian program for sustainable civilization. Then my suggestion that the UN Study Group might want to extract my genes to impregnate women in order to preserve human intelligence. Ha! Another perfect confirmation of Kiersten's assessment of me. Next, take note of my mentioning, for the first time, what I thought to be the Macrospherians' concern with the problem of "perpetual peace" (from 2:49:00 onward). The typical fascist concern with the problem that "peace is boring" – that peace destroys the substance of the human spirit and that "war is the health of the state" – is not without substance to those Macrospherians who had come from the Left, as I'd imagine. Related to this was my subsequent topic, how human beings are regressing back to the state of apes – and how the planet earth is regressing back to the Planet of the Apes – by sitting in front of computers continually (3:17:00). Note finally my comment about our "finishing our mission" under the French's command, the Pyramid's being my substitute, and how the French had implanted the "You die" chips into the bodies of these Homeland Security thugs (3:01:00). Mr Homeland Security CO chief would certainly rejoice over the fact that I had developed so many stupid "delusions" about him and his team members.

This "Robert Coleman" would come again on October 27 and would attempt to contact me then. What was most likely going on was that Coleman, a conspiracy theorist based in the US, was a friend of Khalezov's, and that, now that Karin's team had recruited Khalezov to complain about my website, they informed Coleman that, because I suffered from schizophrenia, I had developed this delusion about Khalezov and then spilled it out on my website to embarrass him. I had always wondered whether this was Liz (Parr).

Then, on 11:30 PM, while in the Starbucks in Westwood, when I wanted to check my visitors' log, my access to Bluehost was blocked. I immediately suspected that it was Mr Homeland Security CO chief who had blocked it in order to enable the Pyramid to visit my website without my being able to check it. The Pyramid must thus be looking at my website at the moment and reporting me to someone saying I was writing violent and delusional material on my website and planning to harm her in Mexico. At the time I thought she was talking to Dr R, since I had retained an appointment with her for Thursday. I thought that she was making false reports to Dr R to persuade her to hospitalize me three days in

advance. I was impressed by Homeland Security CO chief's mediocre intelligence. Again, by blocking my access to my Bluehost account, he was warning me that danger was coming. His actions to hide things from me always ended up tipping me off instead.

I collected damages tonight on Santa Monica Blvd near Western. One of the Hispanic men, after driving over some nails, stared at me angrily. As noted, Mr Homeland Security CO chief had blocked my access to my account just in order for the Pyramid to thoroughly visit my website. (I assume here that this was not a volunteer located in Pakistan, but merely a proxy based there.) Since it was a Windows XP computer, the Pyramid was probably doing it from a cybercafé in Mexico City. (Windows XP was still in common use in cybercafes nowadays.) Mr Homeland Security CO chief and his thugs were so intending on succeeding this time that they had "cheated", namely, used their control over the Internet infrastructure to route the Pyramid's visits through a server in Pakistan in order to deceive me. Again, I was absolutely stupefied by how stupid Mr Homeland Security CO chief was: he had in fact made the Pyramid's visits even more conspicuous. By blocking my access to my website he had informed me that the visits which occurred during this time must be extremely important – it could only be the Pyramid. Now, suddenly, somebody from Pakistan visited my website, and behaved in the most unusual manner: whereas people's attention span was so short nowadays that a complete stranger virtually never spent more than a minute on my website and never

went beyond the webpage or document on my website to which the search engine had taken him or her, this person spent almost half an hour on my website, looking through so many different pages, and came not through any search engines but by visiting directly. Why would somebody from Pakistan suddenly discover my website and show such immense interests? Given the context – the operations on me in the preceding weeks – was I expected to believe this? Mr Homeland Security CO chief actually thought he could deceive me like this. If he had routed the Pyramid's visits through France or Germany, he might have some chance of deceiving me. But he just had to choose among the countries from which no visits had ever come to my website – almost as if he purposely wanted me to suspect something. I was absolutely shocked by how intelligence had so deteriorated in my "fellow human beings" that, by not letting my intellect deteriorate like theirs had, I had practically become a different species to them. And yet, these apes were in control of the planet's communication infrastructure. Again, America as the Planet of the Apes.

On 2:54 PM, when I was eating my lunch in the Korean restaurant next door to Tom N Toms, I called up Southwestern Research to cancel my appointment with Dr M. This is recorded in: "callbreecancel\_10\_22\_13\_254-256PM.MP3". It was the office manager Breanna who answered the call. I just lied that I was sick. Breanna insisted on re-scheduling our appointment to Thursday, 3 PM. I perfunctorily agreed, even though I had no intention of ever showing up at Southwestern Research again. I went instead to my storage facility to put in my latest backup DVDs. I was not surprised by the fact that Homeland Security had suddenly tremendously increased their surveillance on me: the number of surveillance agents sitting around me on the Metro train had at least doubled. Again, Mr Homeland Security CO chief simply didn't know what to do now that I had missed another trap. Could he really expect me to show up on Thursday?

After storage, I came to the public library in downtown to continue my reading of George Soria's *Grande révolution*. Then the Monkey programmed me to write down on my diary something delusional again: "Realized how Mr Buenrostro could have messed with the computer system again: even after all manners of working of the computer system in the ICJ have been taken into evidence, it should be noted that, since all evidences are stored in digital forms, these data, if preserved on optical discs or hard drives, could change over time (deteriorate), causing the evidences to 'naturally disappear'. Presumably, if 'evidences' are stored in Solid State Drive..." It's not clear whether this was a hidden purpose here in my thus deluding myself to make myself look crazy.

On 4:35 PM, another suspicious visit to my website: 83.84.16.90, 5354105a.cm-6-5a.dynamic.ziggo.nl, the Hague, Netherlands.

She would come to my website several more times later, with the same IP address. It looks like Kiersten and the Pyramid had found another new member. Today however I have to wonder whether this person might be a friend of Ekaterina's sister Maria.

Tonight I purposely collected damages in Brentwood, in the vicinity of Dr P's office, and broke a bottle in front of her office building. I was thinking that, hopefully, I could persuade Homeland Security to keep up "special protection" of these brainless women. Since there was no way to avoid the senseless operations on me, I thought I might make something positive out of it, namely, provoke Mr Homeland Security CO chief to waste as much government's money as possible. I would begin to think like this in regard to the Pyramid as well.

Past midnight, more suspicious visits. Namely, the Den Haag person came again:

## October 23 (Wednesday)

Upset with Homeland Security for destroying my extra source of income, before I went to bed, on 3:55 AM, I wrote an email to David, asking him if he could refer a private therapist to me. I wrote this in order for Mr Homeland Security CO chief to see it. I had noticed that, since these Homeland Security people were stupid as usual, they might actually think that, after I had known that they were instructing Dr R, and even Dr M, to hospitalize me on made-up reasons, I might still believe I could simply go around the problem by finding some other therapist – as if they would not just instruct the new therapist to do the same. Well, they really were that stupid.

On 8:46 AM, a very important visitor, looking for the three screenshots I had eliminated from my blog post of 9/19/2013: 108.231.165.225, 108-231-165-225.lightspeed.irvnca.sbcglobal.net,

These were the screenshots of my Google searches for the Pyramid's name. But who was this person? I had always thought it was Kiersten. Recall that her IP address from 2012 was: 99-111-26-72.lightspeed.irvnca.sbcglobal.net. But the phone almost looked like the Pyramid's. Was the Pyramid already back in Los Angeles?

Then, on 9:42 AM, David replied me, saying he was in the San Francisco Bay area at the moment but did know some therapist to refer me to. He asked me about my requirement (insurance, etc.). Apparently, Mr Homeland Security CO chief did fall for my trick. Since Kiersten had wide connections in the therapeutic community in Los Angeles, he had asked her, as soon as she woke up (usually around 7 to 8 AM), to find a therapist for me and then relate the information to David. Mr Homeland Security CO chief was planning to use the same trick: Kiersten and the Pyramid would feed the therapist with the same false information about my mental condition and intention to harm her and oblige her to hospitalize me as soon as I should show up on our first appointment. This was why David replied me so fast. (He had been contacted by Homeland Security and instructed to get into contact with Kiersten immediately and then reply me.)

When I woke up past noon, came to Tom N Toms, and saw David's reply, I felt joy inside. On 2:30 PM, I immediately replied to David, and then wrote to my mother: "Hi Mom, I also want to tell you that I'm in the process of changing to a private therapist. It is recommended to me. I don't have enough money to do that right now. Can you deposit 300 in my account so that I can proceed with the recommendation?" As you can see, I was expecting the Homeland Security thugs to order my mother to give me money for the new therapist; then, when I should get the money, I would just forget about the whole therapy business, in which case, I would have made 300 dollars to compensate my loss at the clinical trial. And, guess what, on 2:56 PM, my mother replied, saying angrily that she would deposit the money by the end of the month. Within twenty minutes, Mr Homeland Security CO chief had ordered her to give me money. I was surprised, however, by the fact that Homeland Security was

simply telling her to dig money out of her own pocket, for this was presumably why she couldn't give me the money immediately: she was having financial difficulty at the moment. After this, I rode the bus to UCLA, fully confident that I wouldn't suffer financial loss this month because of Homeland Security.

Don't you love it when your nation's guardians are so intellectually inferior to you that you can play them around more easily than your neighbor's dogs? Unfortunately, this was not to be. Both David and my mother suddenly broke off contact with me, and I wouldn't see any deposit in my bank account until October 30. Perhaps Mr Homeland Security CO chief did see through my tricks after all (after some reflection).

Meanwhile, you must try to imagine the situation with Dr M from yesterday. He was already skeptical; when Breanna informed him that I wasn't showing up, he was even more skeptical of the story with which the Pyramid and Homeland Security were feeding him. This guy was clearly tipped off about the danger and so was not showing up. This simply didn't look like the behavior of someone who was so delusional, obsessive, and violent that he was no longer in touch with reality.

On 6:20 PM, Dr R suddenly called me. I couldn't answer the call in time, and she didn't leave a message. But it obviously had something to do with the fact that I'd never bothered to show up at her appointment again. Clearly, both Mr Homeland Security CO chief and the Pyramid were quite frustrated.

At the time I really did believe that it was Evelyn, because the OS and ISP information matched her iPhone's. But what was she doing in Boston? The person would come again on October 27, and it was in fact not Evelyn. Just another report to the TMU on the Pyramid's behalf. Meanwhile, I collected damages on Beverly Blvd and on Santa Monica / Western. Another Hispanic man who got nailed was looking for me, probably Veronica's investigator again. When I went to the Law Library to beak a bottle, another one of Veronica's investigators was waiting for me in his car in front of the place. The Monkey had told the Pyramid's team where I would be tonight, and they sent the investigator in to film me doing my things, so that the Pyramid's colleagues in the Law Library could also become galvanized against me. This is a tactic which would become quite significant later on: the Monkey could see on his computer screen where I would be in the future before I even decided where to go. This was one of the functions (the simulation of the target person's thought-process in the future) which the CIA had purposely not disabled in order that Kiersten and Dr P could exploit this advantage to pretend to their audience that they had psychic power and were able to predict my every move beforehand.

## October 24 (Thursday; LUG and "Aamoy")

Obviously working for Karin's team – who else in the world would know my name and search for it? Another report to the TMU.

At the same time, I was preparing my latest blog post of 10/24/13 in which I would identify (or so I thought) most of the members of the Pyramid's new "complaint team". On 5:20 AM, the control center struck me. My Asus laptop shut itself down just when I was about to post this latest blog post, destroying my Open Office draft. It was however recovered upon rebooting. The Monkey was provoking me again.

I would spend the afternoon in UCLA, checking over my newly burned DVDs on the Ubuntu computer in the Linux Users Group lounge. My time there is recorded in: "IMPlinuxusergroupsouthwstrn 10 24 13 235-628PM.MP3". I would immediately be caught up in the conversation going on among these geeks. First, the cases of nouns in inflected Indo-European languages. Then somebody's plan to replace government bureaucracy with software. I jumped in with enthusiasm with my knowledge about Sentient World Simulation and the use of computers to run the entire world through the brain-chip system (from 8:00 onward). I finished my explanation of Cheney's utopia by 18:00. I then went on about how this newer computer technology had rendered central command and central planning even more efficient than laissez-faire (20:00). Then I made more analogies with the evolution of computer technology. I didn't know at this point that these LUG geeks had already been recruited by Homeland Security to work for Karin's team (i.e. shown the warnings about me and introduced to my other "victims"). The LUG leader, Aamoy (Gupta), was monitoring me carefully from his hideout in the UCLA dormitory (through the webcam installed on the wall). More on this below. I then called up Southwestern Research to tell Breanna that I was withdrawing from the clinical trial (36:00). I lied that I had gone to the east coast for family business in order to prevent Dr M from ever sending the police to my apartment to hospitalize me on 5150. (If Dr M was still required by Homeland Security to hospitalize me, he would have to pretend that he believed that I was in the east coast; otherwise he would give out the fact that he was in secret contact with the government which had informed him, based on its surveillance on me, that I was lying and was still in Los Angeles.) I then continued my work on LUG's Ubuntu machine. I even surfed onto my website to see how it would appear in a Linux system. I then collected damages near the USC area.

Curiously, the IP address was traced to UCLA's residence hall (s3050-198.resnet.ucla.edu). Some UCLA student was visiting my website from the university's dormitory in the middle of the night! Since there was no possible way that someone so physically close to me would find such rarely visited website – no stranger in Los Angeles, let alone from UCLA, had ever seen my website – and since the person came to my website directly without going through search engines, he could only have discovered it by examining the cache on the UCLA's network of all the websites visited on its machines. This person was Aamoy, as noted. The visit was evidently artificial; he was clearly told something about me, such that he was duty-bound to check what websites I was looking at on the LUG machines – and to see what the fuss was about. After all, I had visited my website on the UCLA's network a thousand times before, and had never aroused the attention of any UCLA network administrators. This is how I had for the first time come to the conclusion that everyone in the LUG had also been recruited by Homeland Security to make false reports about me to law enforcement (that I exhibited delusional and violent tendencies and was hosting violent and delusional content on my website). I thought this must be why one of the LUG members kept entreating me to "sign up for an account at LUG" – because they had had to pretend to not know who I was and to only "accidentally" discover my "bizarre manner" and "disturbing website".

Now this "Aamoy" – who would play a major role later on in Kiersten's Secret Society – was originally from Australia, was studying engineering at UCLA, was also the president of UCLA Robotics, and had a minor in French. From his dwelling in the Residence Hall, as noted, he always kept an eye on the movements inside the LUG lounge through the webcam feed on the LUG homepage and had remote access to the activity log on the computers inside the lounge.

It's not clear to me when the Homeland Security thugs came to warn Aamoy and his LUG buddies that the outsider who was hanging out in their lounge was a delusional individual who was stalking this group of women and was therefore under police investigation. Clearly, after I was gone, the LUG people spent the whole night discussing me with the Homeland Security thugs and their star witnesses – Dr P, Karin, Kiersten, and Veronica – right there in the UCLA dormitory. Aamoy was warned that I had this very "dangerous and delusional" website and, seeing that I had visited my own website on the LUG machine, he checked it out, just to see for himself what dangerous content was on it. It was to learn about the danger I posed and the extent of my delusional mind that he was looking at the "short summary" of my story. Aamoy and his LUG buddies were then given the passwords to join Kiersten's Secret Facebook Group. Aamoy had become something like the women's mole in UCLA, watching over me for them in case I should ever show up here again.

Obviously, Mr Homeland Security CO chief had intercepted my order for the second time.

This is a visit using the Ubuntu machine at the Linux Users Group lounge – the very machine I had used yesterday to check my DVD and my website. This was another reason why I was led to believe that the LUG members had been recruited by Homeland Security to join the "complaint team" and make false complaints about my website to the relevant authorities. The more realistic scenario however was that Aamoy had informed the whole LUG that "the guy who showed up yesterday was under police monitoring for stalking this group of women and had a website full of delusional materials, including those devised to harass his stalking victims", and that some LUG member, who got curious, decided to check over the browsing history on the Ubuntu machine I used yesterday and then

clicked on my website in the scroll-down. Everybody was of course instructed not to show signs of their being alerted about me if I should ever show up again.

Then, on 6:11 PM, there was another very suspicious visit: 108.48.181.172, pool-108-48-181-172.washdc.fios.verizon.net. Maryland, College Park.

Another new member to Karin's group, making a false report to the TMU on behalf of Kiersten.

I was on bus 2 going on Sunset to go to UCLA. The bus stopped in West Hollywood and, while waiting for the next bus, I thought I might collect some damages in this area. Around 7 PM or so, a Homeland Security agent purposely drove his car to run over some nails so that he could call the police on me. This was an operation, and I ran away in horror. I immediately caught the bus going to UCLA. By the time I came to Ackerman, I thought I had figured out how the operation worked: The police would be instructed by Mr Homeland Security CO chief to respond to the call about nails, to check for similar reports in the past, and to discover that I had once been arrested for a warrant in late July, in which incident "tires" were noted and a certain "Dr R" was contacted. The LAPD would then call up Dr R, who would then be instructed by Homeland Security to tell the police that I was extremely delusional and dangerous at the moment and needed to be hospitalized, and that I had been threatening women on my website, which needed to be taken down. Tomorrow morning, the police would storm my apartment room and hospitalize me on 5150. The only way to neutralize this operation, I thought, was to write it down quickly on my blog. And I did so: which is the blog post you see for October 26. Since Homeland Security's priority was for me to not know what had happened, they would supposedly cancel this operation and wait for the next chance. But to be extra safe, I had decided not to sleep at home. I went home past midnight to change my things and then came back to Westwood around 4 AM to pass the early morning in the Starbucks there, which was open 24 hours. I was most likely paranoid over nothing here: Mr Homeland Security CO chief was just trying to get me detained by the police so that Dr R could work her magic from behind the scene and cause me to be sent to the mental hospital – all because I wouldn't show up on any of my appointments.

## October 26 (Saturday)

By 7 AM, when Ackerman was open, I would leave Starbucks and sleep on the sofa in Ackerman. I would wake up there past noon. That's how I thought I had avoided Homeland Security's operation to use Dr R to hospitalize me.

David also replied me today, denying I could possibly be under a "terrorist investigation" but claiming willingness to help me purchase M-Discs. But he specifically advised me not to buy this item. 3 dollar per disc, a rip-off, he said. Then he asked: "Is there something special about M-Disc?" Did Homeland Security instruct him to ask me why I wanted these discs as part of the "investigation"? Then, on 8 PM, I wrote back that I wanted the discs because they would last 1,000 years. Mr Homeland Security CO chief got his answer, presumably.

Then, even Melody (from FFCHS) wrote me on 2:34 PM, "wondering how I was" and "wanting to say Hi". Since Melody never responded to any of my emails to her, it's highly suspicious that she would suddenly write to me out of the blue, even when I didn't write to her. Thus, she must have also been contacted by Homeland Security or the TMU – which means that she must have seen the demonic Homeland Security warnings about me which would have forever changed her perception of me. The problem is, again, that most people simply don't know that government agencies would just fabricate bullshit out of thin air! Now I would suppose the reason why Mr Homeland Security CO chief instructed Melody to contact me was that, since I was now out of reach for Dr R, I needed to be in contact with more people in order to provide him with the opportunities to instruct anyone to call the police to take me to the mental hospital on 5150.

By night fall, when I was in Starbucks, Westwood, I came up with another wrong theory that someone else had come in to help Homeland Security, and I thought it was the CIA. I thus quickly posted a new post on my blog, "Four women try to knock down my website, part 12", which you see as my entry for October 27. Complete bullshit. But this was the CIA's evidence that, clearly, my problem was not any delusional disorder, but simply that I kept guessing and guessing wrongly. Meanwhile, what I said in the blog post about "bureaucratic vandalism" and then the Pyramid's ridiculousness was very insightful – even if it didn't quite apply to reality (!): "If you, in India, threaten to hack her computer when she lives in California, she will hire armed guards to guard her house. If you point out to her that, by hacking her computer, you cannot possibly harm her personally, and that the armed guards are therefore a waste of money, it will make no difference in her response. She will still waste her money on armed guards. This is how OCD works. This is why wasting her money, or causing her to waste tax-payers' money, is extremely easy. Just know something about her, and she will mobilize a vast amount of resources to protect herself in ways that are completely irrelevant."


After studying and posting and writing in Starbucks, I rode the bus back to downtown. While the "collection of damages" was ever more urgent, I felt increasingly inhibited because of Homeland Security's actions. I loitered around the Union Station to collect some minor damages only – including throwing six bottles into the Hispanic auto shops. Completely insignificant things. But I then came to Walgreens to collect my Zyprexa but then quickly dumped the thousand dollar medication into the trash cans – as a way to waste tax-payers' money. Then I returned to Westwood and stayed in Starbucks all night. I still didn't dare to pass the night at home.

#### October 27 (Sunday)

I was still in Starbucks, Westwood, sitting in front of my computer, around 6:30 AM, when I discovered a strange email from this aforementioned "Robert Coleman". He said he had found my website during a search for information about 911 attacks on the Pentagon and the World Trade Center, and wanted me to provide him with "full citations and the initiation/ disposition dates of these three lawsuits as well as links to their court record at the ICJ". The email was sent to me on 5:56 AM. He had apparently visited the same blog post of mine on 3:04 AM:

Today I seriously suspect that it was Khalezov who had asked his friend Coleman to ask me this question – even while his friend Coleman was helping Karin's gang by complaining to the TMU about how I had slandered Khalezov on my website. Because Khalezov never knew why his Russian or Chinese handler instructed him to make up this "Third Truth", he had been wondering whether I was telling the truth about him. But of course, no matter how much he searched, he could never locate any records about this ICJ trial I kept mentioning. And so he had to ask me. I never responded – and never would. Coleman didn't expect that I would immediately realize this was a trick – again, because, in my past five years of running my website, nobody had ever shown any interest in my story. Anyone who did was suspect, especially at this juncture. I then surfed onto SDW's blog and noticed her outburst from October 13. I suddenly felt so sympathetic toward her and yet was amazed by her intentional design to isolate herself in order to worsen her situation. I thus posted a comment:



By 8 AM, I had gone to Ackerman to sleep. After waking up around 2 PM, I went inside the Research Library, Suddenly, Wes called me, recorded in: "IMPweskilldhsapemorality 10 27 13 347-458PM.MP3". I first went over my current situation with him: my anger over Homeland Security operations, over being forced to withdraw from my clinical trial and my sessions with Dr R... Then my ideal conception of "proper punishment" for the Pyramid... Then the need for the "Macrospherian revolution" to kill off these Homeland Security apes... (23:00). Then my wrong theory about Dame Higgins' "neutralization of her own terrorist harm", which was not only incorrect, but also sounded insane enough as to reinforce Mr Homeland Security CO chief's degrading estimation of me as a "subhuman". Again, I was deceived by the control center's signals to believe in erroneous scenarios so as to look crazy. Note then that, here, for the first time, I introduced the Nietzschean notion "Ape Morality" (39:00). You have already seen me expounding this principle earlier: "Do unto others whatever you feel like, but never let others do unto you anything you don't like, however slight". Note, next, my remark about the Macrospherians' concern with the most terrible consequence ("pitfall") of peace and prosperity: the atrophy of normal human functions (34:00). I had been led by the computer in the control center onto this theme since before my conversation with Wes on October 19, and now I had at last developed it explicitly. I have always wondered whether I had indeed hit on a major concern of the Macrospherians: the problem of the enormous atrophy of the human mind which had occurred under the postmodern life-style (*Lebensführung*) of consumerism – and you have seen me talking about it already in the aforementioned blog post of mine for October 27, there to explain why women were so stupid. Again, we will expound on this continually later on, especially in the concluding remarks on this episode. You will see that all those problems which have been the running theme in the preceding. the "simplification of the human mind", the "atrophy of humanity", and "Ape Morality", are mere different facets of the same phenomenon: the "simplification of humanity" which we will presently summarize. Next, note my comment about my cousin Evelyn on 44:00, and, in relation to that, the three types of morality, "Human Morality", "Ape Morality", and "Christian Morality". More on this later as well. In this connection, Wes repeated Nietzsche's famous distinction between "Master Morality" and "Slave Morality". Specifically, that "Slave Morality" is characterized by the perpetual attempt to blame others for one's own misfortunes: It's always someone else's fault, the system's fault, whereas "Master Morality" is characterized by the perception of one's misfortune as having been caused by one's own failures (50:00). Wes was steering my thoughts onto this characterization presumably because the "Slave Morality" orientation (it's always someone else's fault) is the modus operandi of the Pyramid – and Dr P and Kiersten as well, of course. Again, it will be seen that all these things "hang together" (zusammenhängen): "Ape Morality", the "atrophy of the mind", the "simplification of humanity", and the "Slave Morality" orientation. Then I hit on the theme of my understanding of my situation: the Apes want to destroy the last Human remaining by dumping him in the mental asylum, etc. (56:00). Finally, my comment about the Pyramid's complete unconcern with the value of art, etc., because she could only notice the existence of her own instincts. I might, under extreme circumstances, contemplate killing my supremely talented artist friend Oliver, but to destroy his works after he is killed – that is "unthinkable", for, when the works are good, these are treasures of humanity. This sort of "UNESCO" mentality" is completely alien to ordinary people like the Pyramid, for Apes are by nature never concerned with the "education of humanity". Questions like, "What if the world misses out on the truth", have never preoccupied her simple "monkey mind". As I will note later on, my story – and my

life story – is eventually sort of like China's Cultural Revolution: the Red Guards went on a frenzy of destruction of China's cultural treasures and persecution of the country's intelligentsia because they were young and uneducated – like the Pyramid and her gang. Or like the way in which peasants in Tsarist Russia, when rebelling and taking over their landlord's house, would burn away the expensive paintings hanging on their master's wall, all because they didn't understand what those things were about. At last, take notice of those mistaken, nonsensical notions which I had been deceived by the Monkey in the control center to express in this conversation, that Homeland Security would be "intercepted" by the Macrospherians should they succeed in hospitalizing me, that the CIA was training Homeland Security, that Homeland Security must have experienced strange external forces which had prevented them from doing certain effective things, such as altering the server logs for my website. Once again, this is the kind of nonsense which must have really delighted Mr Homeland Security CO chief: he was not only happy that I couldn't understand what was going on, but also because this non-understanding was his evidence of my insanity. Meanwhile, all my philosophical discussion with Wes was the CIA's evidence that I was in fact quite intellectual and hardly the simple schizophrenic such as the Homeland Security warnings about me had asserted.

Afterward, I went to the Starbucks in Westwood Village. I thought of something, and so, on 6:45 PM, I left a message for Dr R to give her a fake address as "my new address". This should prevent her from calling the police on me to hospitalize me. When I went back inside Starbucks, I discovered an alarming visit on my log: 198.228.200.173, nycmspsrvz2ts331-dmz.mycingular.net. It's the same Boston person seen on October 23.

I again wrongly assumed it was Evelyn. Since I had just talked about punishing her in my conversation with Wes less than three hours ago, I assumed what had happened was that Homeland Security had instructed Wes to call my cousin Cindy (whose contact information I had given to him before) warning her I wanted to hurt Evelyn and then Cindy to contact Evelyn. In reality, this was just the same Boston volunteer making a report to the TMU or holding a discussion with Karin's team members.

## October 28 (Monday)

Again, I did not stay home to sleep. I went home to change my cloth, and then left home around 4 AM and rode the bus back to Westwood. Unfortunately, I forgot to bring my keys out and so was locked out. This meant I would have to return home soon and meet with my landlord. I was at Starbucks using the Internet on 6:33 AM. By this time David had emailed me to tell me he had found the therapist for me, a certain "Sherly Khodadad". I checked out this "Sherly" on Google searches, and then wrote to my mother feigning: Are you ready to deposit the money? I did find a very good private therapist....

(Presumably, if I ever contacted this Sherly, she'd be instructed to put me in the hospital.) It was 7:18 AM. I then went home, and called up my landlord Ms Choi to ask her to open the door to my room. It was the 28th, time to pay her the rent in any case. However, I was extremely nervous. It was quite possible that law enforcement would have been instructed by Mr Homeland Security CO chief to instruct her to call the police and ask them to take me away on 5150. And so, I waited for Ms Choi on the street corner rather than inside the apartment building – just in case she would bring the police with her, I could run away undetected. She showed up, opened the door for me, and I wrote her the check. I was relieved that nothing happened. I didn't know that the Homeland Security operation to hospitalize me on 5150 was not going to work like that. I then rode the bus back to UCLA – I certainly wasn't going to sleep at home. I went inside Ackerman to sleep on the sofa there. I woke up in the afternoon, and then spent the rest of the day inside the UCLA Research Library. I would be checking my website's log around 6 PM. I noticed two suspicious visits – in reality, three.

The first is a strange, massive visit from 12:55 PM onward: 71-86-7-54.dhcp.slid.la.charter.com. The person started with a Google search which took him to my chapter on Orphism in my Scientific Enlightenment:

He then looked at almost every page on my website, which was extremely unusual and alarming, until 1:21 PM. Please refer to the Apache server log for my website for the month of October. The visit was traced, at the time, to Birmingham, Alabama, but the canonical name clearly indicates that the person was in the vicinity of New Orleans, Louisiana. I have to suspect that this was Alexis (de Bram), one of Karin's close friends, if you recall. Alexis kept going back and forth between Los Angeles, San Diego, and New Orleans, and he was just here in San Diego on September 27 for his birthday party. Presumably he had since then gone back to New Orleans.

Both Alexis and the volunteer from Washington State Department of Corrections were obviously charged with reporting my (supposed) plagiarism to the TMU (to get the TMU to confirm that the Homeland Security's profile of me as a plagiarizer was indeed correct).

Did she come back from Mexico on the night of October 22? Even though, on October 22, I avoided hospitalization by canceling my appointment with Dr M? So was the Pyramid at somebody's home on the morning of October 23? Kiersten's or Karin's? And was the Pyramid at still another person's house today?

The case you refer to may have been expunged from the ICJ records. The Information Department at the ICJ does not have any record of a lawsuit like the ones you described among China, United States and Russia, as shown in the email chain in Appendix 2 below.

If you cannot provide an official document from the ICJ that states the full citation of the lawsuits(s) you refer to, then you may not be able to interest anyone in your claims.

There was no possibility that my new post on Snowden could have gone "viral" within a few hours. It was obviously because Homeland Security had instructed somebody in Kiersten's group to report it to the TMU, namely, how I had also developed bizarre delusions about Snowden.

By now, the debate in the ICJ was about to reach a climax. Under the direction of the CIA and the FBI, the TMU had recruited many informants within the Pyramid's gang who had gathered up much evidences about how all the gang members, under Homeland Security's direction, had been making false reports to the TMU about my website (especially about my plagiarism). The CIA was now ready to present the new evidences in the ICJ. But the Invisible Hand had to disprove one more claim of the Pyramid's, namely that I was dangerous to people. He had thus prepared a first test for me tonight. On 8:47 PM, when I was exiting Ackerman, a black guy sneaked up from behind me continually asking me for a cigarette. He so provoked me with his persistence that I yelled at him and insulted him ("Why do you bother to live?"). But nothing more than that. The black guy was just an actor whom the TMU had sent in to provoke me. Since I didn't make any move, that was the first evidence that I wasn't physically dangerous. Then, either tonight or tomorrow night, the Invisible Hand would stage another test of this kind near my home, which episode I somehow couldn't locate among my recordings. What had basically happened was that, as I was walking home, a Hispanic guy came over to ask me to fight him. I got scared and ran way: hence evidence that I wasn't physically dangerous to people.

Now, startled by the actor's provocation, I was terribly upset, most importantly because I would have to stay out of my home again tonight just in case Dr R might be instructed to ask the police to come fetch me to the hospital. I called up Wes briefly around 9 PM to make sure he hadn't called my cousin Cindy. Refer to the recording of my night: "ucladhsharasscallwesaboutevelyn\_10\_29-30\_13\_847PM-1243AM.MP3" (from 3:40 onward). Note my emphasis: "She did it on purpose, wanting me to know that she had visited my website." It was in fact not Evelyn who had visited my website, and I would soon develop another wrong theory to explain all these recent visits. (See the original version.) I would spend the rest of the night inside the UCLA library to check my website on its computers, to do my reading, etc.

Now, on 11:36 PM, the earlier Valencia volunteer came again:





When I came home to exchange things, I would notice the visits of this Valencia volunteer and develop this wrong theory (in accordance with what I had just told Wes). Namely, that the visit was orchestrated to look like it came from the Pyramid's family's third house in Lancaster (near Santa Clarita). The purpose was to let me know that he had looked at it and make me believe that it was the Pyramid who had just come home and was checking over my website. As soon as I saw this entry, I should realize that the TMU would establish me as harassing the Pyramid with my website if I wrote anything about her return to California on my blog. (Knowing that she suffered from OCD and didn't want to be "known", I would be exploiting her "mental illness" to torment her.) I thus really did believe for the next two days that the Pyramid had already come home. (I was most likely correct about this, although not for the right reason.)

I then discovered, on SDW's blog, that she had just put up a very strange post, as if she had been instructed by the authority to communicate a "secret message" to me.



Now my wrong belief was reinforced because I thought it was SDW's FBI handler who had instructed her to post this knowing that I checked her blog pretty frequently – especially when somebody looking like the Pyramid had just visited my website from her blog. I thus thought that, given the "international crisis" at hand (my wrong understanding), the TMU or the FBI were warning me to back off, that intentional broadcast of the Pyramid's whereabouts on the Internet did constitute harassment and stalking ("unreasonable publicity given to the other's private life"; "cyber stalking is the use of the Internet... to stalk another person"). It seemed to me that the TMU was sick and tired of the whole business and wanted me to cease provoking the Pyramid with my blog posts. Suddenly getting afraid, I made no mention of the Pyramid's home-coming on my blog in the next few days. I was simply bedazzled by the fact that SDW was indeed contacted by law enforcement and the women's gang about me. She must have carefully followed the instruction given her to hide the whole business from me. On September 21, worried that Kiersten and the Pyramid might alert her about my being this psychopathic stalker, I left a comment on her blog wanting to clarify myself, and, within 10 minutes, she posted a reply to tell me that nobody had contacted her – even though Homeland Security must have already shown her their demonic warnings about me. Well, Mr Homeland Security CO chief would certainly have instructed her to keep the whole business a secret from me. There was nobody left in my life who hadn't yet been recruited against me.



It must be said that, today, I have understood that, in reality, nobody was trying to communicate any "secret message" to me tonight, and that SDW had been firmly in the bosom of Homeland Security and so definitely wouldn't write anything on her blog to signal anything to me. I was misinterpreting the "signs". What was really going on was that the CIA was about to pull out their wild card in the International Court of Justice.

## October 30 (Wednesday)

All these strange visits were obviously directed by Mr Homeland Security CO chief: after enough people had reported to the TMU that Homeland Security's 2007 warning about me was really correct – that I did frequently develop delusions about famous people – there was no point in sending in more people to look at my latest blog post.

Then on 4:22 PM, Breanna called and I did not respond. Did Homeland Security CO chief instruct Dr M to contact me again?

I was in Starbucks, Westwood, tonight. I suddenly had a thought that I should check into the latest news on the political situation in Mexico. Perhaps it would yield some clues about what was going on behind the scene in regard to the operations on me. When I found the website politicareal.mx – it was 9:24 PM – I was surprised to see a latest commentary by a certain Lizeth Castro, "La posicion de los partidos en la reforma fiscal". This was the beginning of the bizarre wrong scenario I would develop about what was going on with the Pyramid which would occupy my mind for the next few years and which you can still read about in the original version.

#### October 31 (Thursday)

When I got home, I spent the few hours before sleeping looking through my diary entries. By 4 AM, I had understood that the Mexican intelligence CISEN had cut in around October 23 or 24. Thus, my bizarre wrong scenario.

Now, on 8:40 AM, a strange visit from Russia appeared on my visitors' log:


It was 8:40 PM where he was. Central Ops produced, for this IP address, the canonical name: ip-12-51.unn.ru. It was traced to Nizhny Novgorod State University (some sort of national research university), in Nizhny Novgorod Oblast, which is in Moscow's vicinity. This man was another specialist whom the Russian intelligence SVR had recommended to the Pyramid's gang to testify on their behalf that my brain chips story was indeed my schizophrenic delusion.

Meanwhile, I woke up around noon, and went to Tom N Toms to check the visitors' log of my website. I thus took note of the fact that, until 1:26 PM, there were still no visits to my new blog post on Snowden. I became ever more convinced that my blog post had been blocked. (This was not the case.) I also took note of another suspicious visit on 9:55 AM:

The visit came from Montreal: modemcable036.89-176-173.mc.videotron.ca. It must be somebody related to Angelo or Gaurav. Just another report to the TMU about how I had harassed Gaurav or Angelo by mentioning their names on my bizarre website.

In Tom N Toms, I continued to work. First, believing that my blog post on Snowden was blocked, I posted a message about my (wrong-headed) theory on Prison Planet Forum:



I then continued to investigate the "Mexican connection". I did a search for the person I thought to be the "Link", Blanca Perez Buenrostro, and discovered that she had passed away already. I then discovered that the IP address for Prison Planet Forum had changed. I was so baffled: did it have something to do with me?

After Tom N Toms, I went to the UCLA Research Library to continue my reading of the first volume of Issac Deutscher's biography on Trotsky. Then, on 10:40 PM, my mother visited again:

Because what I thought was the authority's warning to me continued to exert effect on me, I made no serious attempt to collect damages tonight. When I was riding the bus home from Westwood, I stopped by Alvarado and, in the Hispanic neighborhood there, broke two bottles, no more. A third bottle failed to break.

#### November 1 (Friday, LAX shooting)

After I woke up around 1:30 PM and had my coffee in Tom N Toms, I rode the Metro to my storage facility. I was under tremendously heavy surveillance while on the Metro, surrounded at every moment by three or four Homeland Security surveillance agents. I have recorded my afternoon in:

"IMPbuycapsprayackermanwesfrenchwinnewcomr\_11\_1\_1\_13\_158-838PM.MP3". I first ate lunch at the cafeteria next door. I put my newly burned DVDs into the storage, and rode the Metro back to downtown – still under heavy Homeland Security surveillance. Suddenly, the conductor announced through the speaker that the shuttle service to the airport (LAX) was suspended and that the airport was shut down because of "police activities" (1:06:30). I immediately realized, wrongly, that the Pyramid didn't come home on Tuesday, but today, and that this was why the airport was being evacuated. Only later would I find out from the news that a "shooting incident" had occurred at the airport. From then on, my bizarre wrong scenario, of which I shall not speak anymore here.

There were very few visits to my website today, and I shall only list them in the next chapter. Here I will concentrate on myself. When I had returned to downtown, I got on bus 14 to go to Blick Art to buy caps for my spray cans (2:08:00), after which I got on the bus again to go to UCLA. I called Wes on 3:47:00, but his answering machine was turned off. I walked into Ackerman's TV lounge around 6 PM (3:55:00). When I heard the news about what had happened in LAX on 4:04:00, my jaws almost dropped. I was sure that Homeland Security had staged this disaster just for the Pyramid. Scared, I began to think that I should definitely pretend knowing nothing about it.

Then, on 7:20 PM (5:21:30), Wes suddenly called me. His CIA handler must have prepared him for hours before sending him onto the phone with me. Wes purposely mentioned that I owed him 100 dollars; my reply that it was 300 was probably the CIA's evidence that I was not in the habit of lying. Note my description of the "CISEN expert" from 5:26:00 onward. It was the bizarre wrong scenario I had been developing, but this was no longer Mr Homeland Security CO chief's evidence of my delusional mind, but rather the CIA's evidence that I was merely wrong or misled or deceived. Then note, from 5:34:00 onward, my realization that other people actually had a different notion about what had happened with the previous ICJ trial. Indeed! Now the CIA would again note down that my bizarre speech about "evidence-replacement", etc., was caused by "false beliefs", rather than by my supposedly delusional mind. That is, I was simply mistaken, or made an error in my analysis of the happenings around me, which all the people around me, because they were not educated, had mistaken for "mental delusion". Furthermore, the CIA had, as you shall see, now evidence that it was the computer inside the control center which was actively creating signs in my environment to reinforce my false beliefs. Then Wes asked me on 5:52:00 about the meaning of the LAX shooting. While Wes was instructed to ask me this because Mr Homeland Security CO chief expected me to speculate again that it had something to do with me (hence evidence of my delusional mind), I avoided answering this question because I didn't want to incur more problems by admitting that I knew that it was staged to protect the Pyramid. Ha! Note also on 5:57:00 my remark that "it is all orchestrated to make you realize that the world is not as you have imagined it." This was very likely a correct statement about the Macrospherian program, although, at the time, it would not have made any sense to anybody. Then Wes seemed to be giving me a hint on 6:01:00, the "book on classical choice theory which cost 2000 dollars". He was referring to Classics of Social Choice, edited by Iain McLean, Arnold B. Urken, and Jona Hewitt (1995). I didn't know what this was about at the time, but, later, when I checked on this book on Google Books, I would notice the reference to Condorcet ("Condorcet's Essai of 1785", p. 27). Was Wes trying to remind me of the all-female "jury", and the Mini-Trial, from April 2010? I suspect that the CIA had instructed him to produce this hint in order to tip me off about the fact that the

International Court of Justice was about to decide whether I was really a danger to the Pyramid – whether the Homeland Security warnings about me were really correct. Then another hint from Wes on 6:08:30: "You should not wear a mask." It seems that Wes was trying to tell me, again in a round-about way, that the CIA was about to examine the Monkey's computer in the control center to gather evidences as to how he had been remotely controlling me, and that I should not try to hide myself and my thoughts. (I just did when Wes asked me about the meaning of the LAX shooting.) Finally, note my defense in regard to my writing about the Pyramid's exploits on my website (from 6:11:00 onward). Why didn't the Pyramid just write her own rebuttal or sue me for defamation, if my "delusion" about her was really the issue? Clearly, the "protection of her reputation" was not her motive, and, clearly, the police had already proven to her (with subpoena of Google's search records) that her reputation was not even damaged. I assumed that the Pyramid's motivation was none other than the actualization, in the external world, of the fantasy world which existed only in her head, namely the scenario: I'm the virgin Snow White, intelligent, special, good, desirable, pure, most valuable, and yet fragile, and, because of this, I'm being physically sought after and threatened by a sexually perverted, large size and dark skinned male monster, who is delusional, stupid, worthless, disposable, and physically so much more powerful than I, such that the world has to turn itself upside down to take him down and preserve me. In reality, I had miscomprehended the situation because I had never seen the Homeland Security warnings about me which had portrayed me as so immensely dangerous that everyone, upon seeing them, would inevitably interpret the nuisances that I caused as signs of impending grave danger – and also because I had as yet no awareness of the true political motive behind Homeland Security's actions (to seal off the previous ICJ trial and protect their boss M. Chertoff at all cost).

This is what I suppose has happened today. After proving in the ICJ that the Pyramid's gang's reports to the TMU about my website were all false and that I wasn't in fact dangerous to anyone, the CIA decided on one last proof – and broke into the control center to find the Monkey sitting in there programming me and tormenting me. This was the definitive evidence: that I had made up the Syrian nuclear terrorism story because I was deceived by the Monkey into believing that I needed to do this to replace evidences, and that it was the Monkey who had been programming me, over a two-year period, to harass his daughter with bottles and commit minor vandalism crimes every night – and that it was he who had been hurting me to prompt me to cut myself and signaling me to mislead me to believe in all these bizarre scenarios so that I could look crazy and be mistaken for suffering schizophrenia. The entire basis for Mr Homeland Security CO chief's warnings about me and the ICJ judgments he had obtained against me had disintegrated and his star witnesses had been proven to be a bunch of liars. Mr Homeland Security CO chief would follow in and argue with the CIA about this for 5 days – the stake was just too high for him: if he lost, then the CIA could reactivate the previous ICJ trial right there. Amazingly, he would somehow win the debate on November 6 and take definitive command of the Monkey and the control center for his benefits.
